WHEREAS by a Royal Commission under the hand of His Excellency the Governor in Council dated the twenty-second day of May, one thousand eight hundred and eighty-two, the undersigned was appointed a Commissioner to inquire into the claims of all or any Aboriginal Native claiming to be owners or otherwise beneficially interested in any of the reserves set apart for Native purposes in the Provincial District of Wellington, or into the purposes and objects for which such lands may have been intended, and in pursuance of such inquiry to take evidence on oath or otherwise, and to report to the Governor on the same:

Now, therefore, in pursuance of such commission and direction I do hereby give notice that I shall on Tuesday, the first day of August and following days, at the Maori Hostelry, Wellington, hold an inquiry into the claims of the said Natives to the lands mentioned in the Schedule hereunder written, and do call on all such Natives claiming ownership or beneficial interest in such lands to appear at the above mentioned date and place at ten o'clock in the forenoon.

SCHEDULE.

WELLINGTON.

Town acres Nos 1 to 28, 37, 39, 41, 43 and 45, in Polhill's Gully and its vicinity.

Part of Block XV., containing 4 acres and 35 perches; part of Block XV A., containing 35 acres 1 rood and 24 perches; and part of Block XV B., containing 18 acres and 35 perches,

HUTT DISTRICT.

All the unallotted portions of Sections 1, 2, 3, 16, and part of 20, Lower Hutt.
Section 11, Horokiwi Road District.

NGAURANGA.

Section 6, and part of Nos. 7, 8, and 9.

PANUITANGA.

uiuinga ka ahei ia te whakarongo korero i runga i to oati, kore oati ranei, a ki te tuku i tona pukapuka whakaatu ki a te Kawana.

No reira i runga i taua Komihana me nga kupu tohutohu mai ki a au, ka panuitia e ahau, tera ahau e noho ki te Tari Maori i Poneke, a te Turei te 1 o nga ra o Akuhata, 1882, me nga ra i muri atu, ki reira uiui ai i nga take o aua Maori ki nga whenua kua whakahuatia i roto i te Kupu Apiti i raro iho nei, a he tono tenei ki nga tangata Maori e ki ana e whai take ana ratou, e whiwhi ana ranei i te painga i runga i aua whenua pera, ki era atu tangata hoki e ki ana he take o ratou ki aua whenua, kia haere ake ratou ki taku aroaro i te ra me te kainga kua whakahuatia i runga ake nei, ki te whakatuturu i o ratou take me o ratou paanga ki aua whenua.

TAKIWA O HERETAUNGA.

Era wahi katoa o nga Tekiona 1, 2, 3, 16 me tetahi wahi o 20 i Heretaunga (Lower Hutt) kahore ano i whakataua.

Tekiona 11 i te Takiwa o Horokiwi (Horokiwi Road District).

NGAURANGA.

Tekiona 6 me tetahi wahi o nga Tekiona Nama 7, 8, me 9.
