Land taken for Road in the Lower Mahurangi Highway District, Auckland.

(L.S.) JAMES PRENDERGAST, Administrator of the Government. A PROCLAMATION.

WHEREAS the land described in the Schedule hereto is required to be taken under "The Public Works Act, 1876," and "The Public Works Act 1876 Amendment Act, 1878," for a certain work, to wit, the construction of a road in the Lower Mahurangi Highway District, Provincial District of Auckland:

And whereas the Lower Mahurangi District Board has laid before the Governor the memorial and map mentioned in and signed and certified as required by the said Acts:

And whereas the two hundred and twenty-ninth section of "The Public Works Act, 1882," enacts that any public work authorized under the authority of any Act repealed by this Act or of any Act or Ordinance repealed by "The Public Works Act, 1876," and any land required to be taken, purchased, or acquired for such work, or anything commenced under any such authority as aforesaid, may be continued, taken, purchased, or acquired, executed, carried out, enforced, and completed under the provisions of this Act:

Now, therefore, I, James Prendergast, the Administrator of the Government of the Colony of New Zealand, in exercise and pursuance of the powers and authorities in me vested by sections eleven and two hundred and twenty-nine of "The Public Works Act, 1882," and of every other power and authority in anywise enabling me in that behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes of a road; and that, from and after the day of the date hereof, the land so described shall become absolutely vested in fee-simple in Her Majesty, discharged from all mortgages, charges, claims, estates, or interests of what kind soever, for use as a road.

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL.

WHEREAS by the twenty-first section of "The Land Act 1877 Amendment Act, 1879," it is enacted that the Governor in Council may fix the terms and conditions upon which the lands comprised in any village settlement shall be disposed of, and the mode of payment for the same: And whereas the Governor has, by Proclamation in the New Zealand Gazette, bearing date the twenty-first day of December, set apart the lands enumerated in the Schedule hereto for sale as a village settlement:

Now, therefore, His Excellency the Administrator of the Government, in pursuance and exercise of the powers and authorities conferred upon him by the hereinbefore in part recited Act, and by and with the advice of the Executive Council of the Colony of New Zealand, doth hereby fix the following terms and conditions upon which the said village settlement shall be disposed of, and the mode of payment for the same, that is to say,—

4. The purchaser of any of the lands described in the Schedule hereto, upon the full payment of the purchase-money, will be entitled to his Crown grant, to be issued in the usual way upon payment of the fees prescribed by law. **Dec.** 21.]

IN exercise and pursuance of the powers and authority vested in him by "The Public Domains Act, 1881," His Excellency the Administrator of the Government of the colony, by and with the advice and consent of the Executive Council thereof, doth hereby revoke a certain Order in Council dated the fourteenth day of December, one thousand eight hundred and eighty, making delegation of certain powers in manner as therein appears, and doth, with the like advice and consent, by this present order, delegate, but only with respect to the piece or parcel of land described in the Schedule hereto, all the powers under or conferred by sections five and twelve thereof, to the under-mentioned persons, who shall be known as the Sheffield Domain Board :--

WHEREAS by the twelfth section of "The Public Domains Act, 1881," it is, *inter alia*, enacted that the Governor, by Order in Council, may from time to time delegate all or any of the powers by the said Act conferred, save as is therein mentioned, to any person or persons for any period, and subject to such stipulations as may be specified in such order, and that every such delegation may from time to time in like manner be altered or revoked: And whereas pursuant to "The Public Reserves Act, 1881," by an Order in Council of even date herewith, the land described in the Schedule thereto is declared to be brought under the operation of and to be subject to the provisions of the said "Public Domains Act, 1881:"

Exempting from Duty Jordan and Sheppard's Bonding Warehouse, Port of Tauranga.

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL.

WHEREAS by section five of "The Customs Duties Consolidation Act, 1882," it is enacted that the occupier of any warehouse appointed for the free warehousing and securing goods therein liable to duty under the Customs Acts shall pay an annual duty on such warehouse as in the said enactment is set forth; and also it is thereby further enacted that the Governor in Council may, subject to certain exceptions, exempt from the payment of such duty the owner or occupier of any such warehouse : And whereas application has been made for a license for a warehouse situate on Allotment number two hundred and fifty-eight of Section number one, in the Township of Tauranga, of which Richard Coles Jordan and Edward Sheppard are the owners or occupiers, and it is expedient that the owners or occupiers of the said warehouse should be exempt from payment of the annual duty aforesaid :

Now, therefore, in exercise and pursuance of the said power and authority, and with the advice and consent of the Executive Council of New Zealand, I, James Prendergast, Knight, Chief Justice, the Administrator of the Government of the said colony, do hereby order that the occupiers and owners of the said warehouse shall be exempt from payment of the annual duty chargeable thereon under the Act hereinabove recited.

Now, therefore, His Excellency the Administrator of the Government of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, and in pursuance and exercise of the power and authority granted to him by section seventeen of "The Harbours Act, 1878," section four of "The Harbours Act Amendment Act, 1879," and of all other powers and authorities enabling him in that behalf, doth hereby prescribe that the dues and rates specified in the Schedule hereto shall be charged and taken, on and after the date of this Order in Council, for the use of the date of this Order in Council, for the use of the Akaroa Wharf, and the wharf locally known as Daly's Wharf, aforesaid.

Authorizing William Robert Williams to build a Wharf in Wellington Harbour.

At the Government House, at Wellington, this fifteenth day of December, 1882.

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL.

WHEREAS by the sixteenth section of "The Harbours Act, 1878," it is enacted that in any harbour where no Harbour Board is in existence the Governor in Council may authorize any person to construct harbour works (other than the reclamation of land from the sea, or any harbour, or the construction of any graving dock, dock, or break-water in any harbour or in the sea), and to use and occupy such part of the foreshore, or of any tidal land or tidal waters, as may be necessary for the construction or use of such harbour works in any harbour where no Harbour Board is in existence: And whereas by the seventeenth section of the said Act it is also enacted that every such Order in Council shall be made upon such terms and conditions as the Governor in Council thinks fit, and the rights thereby conferred shall only be granted for a limited period, not exceeding in any case fourteen years, and may at any time be altered, modified, or revoked: And whereas by the one hundred and fifty-second section of the said Act it is further enacted that, where it shall appear to the Governor in Council that any harbour works are required for the use, benefit, or convenience of the public within a harbour under the control of a Harbour Board, and that such Board cannot conveniently execute or carry out such works, then, and in any such case, the Governor in Council may exercise the powers vested in him by the sixteenth, seventeenth, and eighteenth sections of the said Act:

And whereas William Robert Williams desires to build a wharf, for the use, benefit, and convenience of the public, in Wellington Harbour, which harbour is within the control of the Wellington Harbour Board; but the said Board cannot conveniently execute or carry out such work; and the said William Robert Williams has applied to the Governor in Council for the issue of this order:

in Council for the issue of this order: And whereas the said William Robert Williams has deposited plans of the said wharf (marked M.D. 710 and 711) at the office of the Marine Department at Wellington, in the manner prescribed by the one hundred and fifty-sixth section of the said Act, and, it having been made to appear to the Administrator of the Government in Council that the proposed work will not be or tend to the injury of navigation, the Administrator of the Government in Council hath this day approved of the said deposited plans, subject to the modification noted on plan marked M.D. 711, and subject to the conditions set forth in this Order in Council :

Now, therefore, the Administrator of the Government of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in Robert Williams.

s. d. him by the said Act, and by and with the advice and consent of the Executive Council of the said colony, doth hereby authorize the said William Bobert Williams to build, in Evans's Bay, Wellington Harbour, for the use, benefit, and convenience of the public, a wharf, in accordance with the said plan marked M.D. 711, and in the position shown on the said plan marked M.D. 710, and to use and occupy such portion of the foreshore or of any tidal land or tidal water as may be necessary for the construction and use of such wharf, subject to the following conditions, that is to say,—

1. That all persons shall, at all reasonable times, either in the daytime or at night, have free and full liberty to use the above-mentioned wharf, after the same shall have been completed in accordance with the said plans, and to have ingress to and upon the said wharf, and egress therefrom, and regress thereto, as occasion may require.

2. That every person, authority, or thing exempt from harbour dues under the one hundred and thirtysecond section of the said Act shall also be exempt from all dues or payments in respect of the said wharf or the use thereof.

3. That the said William Robert Williams shall maintain and keep the above-mentioned wharf and all erections thereon in good order and repair, and shall at all times permit to be erected and exhibited therefrom any lights for the guidance of vessels, and shall maintain at his own cost any such lights: Provided that no light shall be exhibited until after it has been approved of by the Minister.

4. That any person authorized by the Minister may at all reasonable times enter upon the said wharf and any buildings erected thereon, and view the state of repairs thereof; and that, upon such Minister leaving at the last known address of the said William Robert Williams a notice in writing of any defect or want of repair in such wharf or buildings, requiring the said William Robert Williams, within a reasonable time to be therein prescribed, to repair the same, the said William Robert Williams shall, with all convenient speed, cause such defect to be removed or such repairs to be made.

5. That the said William Robert Williams will not erect or suffer to be erected on the said wharf any building or structure whatever, except with the consent of the Minister.

6. That nothing herein contained shall authorize the said William Robert Williams to do or cause to be done anything repugnant to or inconsistent with any law relating to the Customs, or any regulation of the Commissioner of Trade and Customs, or with any provisions of "The Harbours Act, 1878," or its amendments, or any regulations made thereunder, and that are now or may hereafter be in force.

and that are now or may hereafter be in force. 7. That the ballast of all vessels loading at the said wharf shall be taken away by the said William Robert Williams and deposited above high-water mark, or at such place as may be approved of by the Wellington Harbour Board.

8. That the rights, powers, and privileges conferred by this Order in Council shall continue in force for fourteen years, computed from the date of this Order in Council, unless in the meantime such rights, powers, and privileges shall be altered, modified, or revoked by competent authority.

9. That the rights, powers, and privileges conferred under or by virtue of this Order in Council may be at any time resumed by the Governor without payment of any compensation whatever, on giving to the said William Robert Williams six calendar months' previous notice in writing. Any such notice shall be sufficient if given by the Minister, and delivered at the last known address of the said William Robert Williams. DEC. 21.]

10. That the said William Robert Williams shall Additional Regulations under "The Electric Tele-ot sell, mortgage, lease, or otherwise part with, graph Act, 1875." not sell, mortgage, lease, or otherwise part with, charge, or encumber the said wharf, or any right or privilege hereby conferred upon it, without the consent in writing of the Minister.

11. Nothing contained in this Order in Council shall be deemed to prevent its revocation at any time and without any notice in case the said William Robert Williams shall-

(1.) Commit or suffer a breach of the conditions hereinbefore set forth, or any of them; or

(2.) Cease to use or occupy the said wharf.

And publication in the New Zealand Gazette of an Order in Council containing such revocation shall be sufficient notice to the said William Robert Williams, and to all persons concerned or interested in the said wharf, that this Order in Council, and the rights and privileges thereby conferred, have been revoked and determined.

- Messages containing over three hundred and seventy-five words but not more than one thousand words, and forwarded by, or addressed to, the proprietor or publisher of any morning newspaper, at the rate of two shillings per hundred words.
- For every additional one hundred after the first one thousand words, at the rate of sixpence per hundred words or fraction thereof.
- No telegraph office which closes at 5 o'clock p.m. shall, however, be reopened for the transmission of any such message for less than a payment of seven shillings and sixpence, which will cover the cost of transmitting a message of three hundred and seventy-five words.

Messages intended for newspapers on the list of night-stations, when forwarded on behalf of the United Press Association, addressed to the several newspapers served by the Association, will be liable to the following charges :-

At the rate of sixpence per hundred words or fraction thereof, together with an additional fee of seven shillings and sixpence for reopening the office at night, and any further charge in respect of overtime that may have to be paid at offices other than the original forwarding office in connection with the transmission of the message and vides.

The additional payment to be made in all cases by the applicant.

At least six hours' due notice must be given to the General Post Office, Wellington, of the desire to have a five o'clock office reopened at night for transmitting Press news.

Short messages, not exceeding one hundred words in length, will be received at telegraph offices closing at 5 p.m., for transmission after office hours, but in time for publication the following morning, addressed to the proprietor or publisher of any morning newspaper published in towns where telegraph Offices

WHEREAS by the fifth section of "The Dan-gerous Goods Act, 1882" (hereinafter called "the said Act"), it is enacted that the Governor in Council may, from time to time, declare that petro-leum or any distillate or other product thereof, or any of the articles or products coming within the meaning of petroleum as defined in the said Act, shall come within the provisions of the said Act, or any one or more of such provisions, notwithstanding that they do not give off an inflammable vapour at a temperature of less than one hundred and ten degrees of Fahrenheit's thermometer: And whereas the article or product known as "kerosene" is a distillate or product of petroleum, and it is expedient to declare that it and other distillates or products of petroleum shall come within the provisions of the above in part recited Act:

Now, therefore, His Excellency the Administrator of the Government of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, and in pursuance and exercise of the powers and authorities vested in him by the said Act, doth order and declare that, on and after the date hereof, kerosene and any other distillate or product of petroleum shall come within all the provisions of the said Act, excepting the provisions of section ten thereof, notwithstanding that they do not give off an inflammable vapour at a temperature of less than one hundred and ten degrees of Fahrenheit's thermometer; and, with the like advice and consent as aforesaid, doth further order and declare that the provisions of this Order in Council shall apply to all parts of the colony.

THE following amended Standing Orders of the Houses of the General Assembly relative to Local Bills are published for general information. F. E. CAMPBELL, Clerk of Parliaments,

16th October, 1882.

1. Local Bills are those which, not being Private Bills, affect particular localities only.

2. No Local Bill shall be read a second time unless notice shall have been given of the said Bill in the locality to which the Bill refers. Such notice shall state explicitly the object which such Bill is intended to effect, and shall have been published once at least in each of three successive weeks before the second reading in a newspaper circulating in such locality.

3. At the time of the first publication of such notice, a copy of the Bill shall be deposited in the Resident Magistrate's Court of the district, and shall be open to public inspection.

4. When it is intended in such Bill to take power to deal with any lands, plans or surveys of such lands, (objections against such lease.

with the Bill.

5.
