*Alteration of Boundaries of Road Districts and Counties under Subsection 8 of Section 3, "Road Boards Act, 1882."*

A PROCLAMATION.

BY virtue and in exercise of the powers and authorities vested in him by subsection eight of section three of "The Road Boards Act, 1882," and of every other power and authority enabling him in that behalf, His Excellency the Administrator of the Government of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, doth hereby alter the several boundaries of the Road Districts of Mount Wellington, Mercer, Otahuhu, Taotaoroa, Waitoa, New-castle, Wangaehu, Wanganui and Waitotara, Rangitikei, Masterton, Featherston, Taratahi-Carterton, Pokororo, Pangatotara, Takaka, Cheviot, Halswell, Little River, Peninsula, Balmoral, Waipori, Clydevale, and Aparima, and doth hereby proclaim, order, and declare that the boundaries set forth under their respective titles in the First Schedule hereto shall, as from the first day of January, one thousand eight hundred and eighty-three, be the boundaries of the said several road districts respectively; and, by and with the like advice and consent, His Excellency the Administrator of the Government doth hereby alter the boundaries of the Counties of Manukau, Piako, Waikato, Whakatane, Cook, Wairarapa West, Wairarapa East, Waitaki, Waihemo, Peninsula, Taieri, Bruce, Clutha, and Tuapeka, and doth hereby further proclaim, order, and declare that the boundaries set forth in the Second Schedule hereto under their respective titles shall, as from the first day of January, one thousand eight hundred and eighty-three, be the boundaries of the said several counties respectively.

FIRST SCHEDULE.

EDEN COUNTY.

*Mount Wellington Road District.*

Commencing at the south-western angle of Allotment No. 12A, Parish of Waitemata; and bounded towards the North by the southern boundary-line of the said Allotment No. 12A, and by the south-western boundary-line of Allotment No. 26A, said Parish of Waitemata, and that boundary-line produced to the centre of the College Road; thence by the centre of the said College Road in a northerly direction to a point in line with the southern boundaries of Allotments Nos. 49 and 50, Parish of Waitemata aforesaid; thence to and by the southern boundaries of the said Allotments Nos. 49 and 50 to the southern angle of the last-named allotment; thence along the western boundary of the Mount Wellington Reserve to its north-western angle; thence by a right line to the middle of the Scoria Reserve Road; thence to and along the southern boundary of Allotment No. 44, across a road-line, and along the southern boundary of Allotment No. 39, Parish of Waitemata aforesaid, to the Tamaki River; thence towards the East and South-east by the Tamaki River; thence towards the South by the Manukau County, hereinafter described; thence towards the West by Manukau Harbour and Hamlin's Creek to the Great South Road; thence across the Great South Road aforesaid; thence towards the South-west by the Great South Road aforesaid to the Harp of Erin Inn; thence towards the North-west by a straight line from the Harp of Erin Inn aforesaid to the western angle of Allotment No. 25 of Section No. 12 of the Suburbs of Auckland, and by the south-eastern boundary of the said Allotment No. 25 to the south-western angle of Allotment No. 12A, the starting point: exclusive of the lands and highways comprised within the boundaries of the Township of Panmure, excepting so much of the main road called

or known by the name of the Panmure and Howick Road as traverses the said township.

MANUKAU COUNTY.

*Mercer Road District.*

All that area in the Provincial District of Auckland, situate in the Maramarua and the Opaheke Survey Districts, bounded towards the North-east by the centre of the Great South Road from the Maungatawhiri River to the junction of said road with the Pukorokoro Road; and thence towards the North-west continuing along the centre of the last-mentioned road till it intersects the south-western boundary-line of Allotment No. 37, Parish of Koheroa; thence in a right line to the south side of said road; thence towards the South-west and South-east by the said Allotment No. 37 to the Pukorokoro Road aforesaid; thence in a right line to centre of last-named road; thence towards the North along the centre of Pukorokoro Road aforesaid to its intersection by the south-western boundary-line of Allotment No. 39, said Parish of Koheroa; thence again towards the South-west by a line to and by the south-western boundary of said Allotment No. 39 to its north-western angle; thence again towards the North-west by northern boundary-line of Allotment No. 39 aforesaid and by the southern boundary-lines of the Wharekawa No. 2 Block to the Maramarua Stream; thence again towards the South-east and South-west generally by the said Maramarua Stream to the Waikato River; thence by the right bank of the said Waikato River to the mouth of the Maungatawhiri River; and thence generally again towards the North-east and North-west by the said Maungatawhiri River to the place of commencement: including all islands in the Waikato River between the Maramarua and the Maungatawhiri Rivers.

MANUKAU COUNTY.

*Otahuhu Road District.*

Bounded towards the North by the County of Manukau, as the said county is described in the First Schedule to "The Counties Act, 1876;" thence towards the East by the Tamaki River to the Great South Road; thence towards the South-west by the Great South Road aforesaid, and by the boundary between Messrs. Hall and R. Robertson to the Manukau Harbour, at a creek running to Mr. John Fairburn's farm; and thence towards the North-west by the Manukau Harbour.

PIAKO COUNTY.

*Taotaoroa Road District.*

All that area in the Provincial District of Auckland, situate in the Cambridge Survey District, bounded towards the North-east and East by Te Pae o tu Rawaru, Te Tapui, Te Puketutu, and Te Hinuwera No. 3 Blocks to the Waikato River; thence towards the South and South-west by the said Waikato River to the western boundary-line of Allotment No. 335 of the Parish of Hautapu; thence towards the West by the said western boundary-line of Allotment No. 335, across a road-line, and by the western boundary-line of Allotment No. 230, Parish of Hautapu aforesaid, to the Karapera Creek; thence towards the North by the said Karapera Creek to the south side of a road-line forming the north-western boundary of Allotment No. 276, Parish of Hautapu aforesaid; thence towards the North-west by last mentioned road-line to the northernmost angle of Allotment No. 276, Parish of Hautapu aforesaid; thence again towards the North-east by the north-eastern boundary-lines of said Allotment No. 276, and of Allotments Nos. 275, 274, 273, 272, 271, 270, 269, 268, 267, and 266, all of the Parish of Hautapu aforesaid, to the confiscation boundary-line; thence again

towards the North-west by the said confiscation boundary-line to Kopuahau; thence again towards the South-west by the said confiscation boundary-line to the south-eastern boundary-line of the Maungani Block; thence again towards the North-west by the south-eastern boundary of the said Maungani Block, by the south-eastern boundary of the Maungakawa Block, and by part of the south-western boundary of the Tawawhakapuoro Block to Te Pae o tu Rawaru, the place of commencement.

PIAKO COUNTY.

*Waitoa Road District.*

Bounded towards the North by the southern boundary-line of Thames County, as the same is described in the First Schedule to "The Counties Act, 1876," from the south-western corner of said Thames County to the Waihou or Thames River; thence towards the North-east by the said Waihou or Thames River to the termination of the north-western boundary of the Turanga-o-moana Block; thence towards the South-east by a right line from the point last named to the Waitoa River, at the termination of the south-eastern boundary of the Pourewa Block; thence southerly by the Waitoa River aforesaid to its confluence with the Mangapapa River, and by the said Mangapapa River to the north-eastern boundary of Te Tapui Block; thence by the north-eastern and western boundaries of the said Te Tapui Block to the Taotaoroa Road District, hereinbefore described; thence by the northern and north-western boundary-lines of the said Taotaoroa Road District to the north-eastern boundary of the Waikato County, hereinafter described; and thence towards the South-west and West by the Waikato County aforesaid to Thames County, the place of commencement.

WAIPA COUNTY.

*Newcastle Road District.*

Bounded towards the North-east by the Waikato River from the southern side of the road forming the eastern boundary of the Township of Newcastle to the north-western boundary of the Parish of Pukete; thence towards the South-east by part of the north-western boundary of the Parish of Pukete aforesaid from the said Waikato River to the centre of the road which forms the eastern boundary of Allotment No. 91 of the Parish of Horotiu; thence again towards the North-east by the centre of the last-named road and by the centre of the road which forms part of the northern boundary of Allotment No. 146 and the whole of the northern boundary of Allotment No. 147 of the Parish of Pukete, and by said road continued south-easterly to the north-eastern angle of Allotment No. 90 of the parish last named; thence southerly by the centre of the road which forms the eastern boundary of Allotment No. 90 aforesaid, the eastern boundaries of Allotments Nos. 91, 93, 94, and 96, to the northern boundary of the Parish of Tuhikaramea; thence towards the South by the centre of the road which forms the northern boundary of the Parish of Tuhikaramea aforesaid to the north-eastern angle of Allotment No. 82 of the Parish of Tuhikaramea aforesaid; thence towards the East by the eastern boundary of Allotment No. 82 last mentioned and the eastern boundaries of Allotments Nos. 83, 84, 85, and 86 to the centre of the road which forms the eastern boundaries of Allotments Nos. 67, 66, 54, and 55 of the parish aforesaid, and by the centre of the said road last described to its junction with the road at the south-eastern angle of Allotment No. 55 aforesaid; thence towards the South by the centre of the road forming the south-western boundaries of Allotments Nos. 55, 53, 52, 51, 48, 47, 46, and 45 of the Parish of Tuhikaramea aforesaid, and by the centre of

the road forming the south-eastern boundaries of Allotments Nos. 26, 25, 24, 23, 22, 21, 20A, 20, 19, and 18 of the parish aforesaid to the Waipa River; thence towards the West by the said Waipa River northerly from the centre of the road which forms the south-eastern boundary of Allotment No. 18 aforesaid to the southern side of the road leading from the Waipa River aforesaid to the Waikato River aforesaid (said road-line forming the eastern boundaries of Allotments Nos. 566, 563, 562, 561, 560, 559, and 558, all of the Township of Newcastle, the southern boundaries of Allotments Nos. 226, 225, 224, 223, 222, and 221, Township of Newcastle aforesaid, and the eastern boundaries of Allotments Nos. 172, 171, 170, 169, 168, 167, 166, 165, 163, 161, 160, and 159, Township of Newcastle aforesaid).

#### WANGANUI COUNTY.

##### *Wangaehu Road District.*

Bounded towards the North-east by West Taupo County, as the same is described in the First Schedule to "The Counties Act, 1876;" thence towards the South-east and towards the North by East Taupo County, as the same is described in the said First Schedule to "The Counties Act, 1876;" thence towards the East and the South-east generally by the centre of the Wangaehu River to its mouth; thence towards the South-west by the shore of Cook Strait to the mouth of the Wanganui River; thence towards the North-west by the centre of the said Wanganui River and by the County of Taranaki, as the same is described in the First Schedule to "The Counties Act, 1876," aforesaid, to West Taupo County, the place of commencement.

##### *Subdivision No. 1.*

The boundary commences on the bank of the Wanganui River at the north-west corner of Campbell Town; thence it proceeds easterly along the northern boundary, and southerly along the eastern boundary of the said town to the south side of No. 2 Road-line; thence easterly along the south side of the said road-line to the north-east corner of Section No. 33, Block VI., Ikitara Survey District; thence southerly in a straight line to the south-west corner of Section No. 34, said block and survey district; thence easterly in a straight line to the north-east corner of Section No. 107 of aforesaid block and survey district; thence southerly in a straight line to the south-west corner of Section No. 146, Block X., aforesaid survey district; thence easterly in a straight line to the south-east corner of Section No. 147, Block XI., aforesaid survey district; thence northerly and easterly so as to include Section No. 251; from the north-east corner of the said Section No. 251 it turns southerly to the Wangaehu River, including Sections Nos. 251 and 290 of the aforesaid Ikitara Survey District; thence it proceeds south-westerly along the centre of the Wangaehu River aforesaid to its mouth; thence north-westerly along the shore of Cook Strait to the mouth of the Wanganui River; and thence north-easterly along the centre of the Wanganui River aforesaid to a point opposite to the north-west corner of Campbell Town aforesaid; and thence to the said north-west corner of Campbell Town, the place of commencement.

##### *Subdivision No. 2.*

The boundary commences at the south-east corner of Section No. 42, Block VI., Ikitara Survey District; thence it proceeds northerly along the eastern boundary of the said Section No. 42 and its production to the north side of No. 2 road-line; thence easterly along the north side of the said road-line to the south-east corner of Section No. 194, Block VIII., said Ikitara Survey District; thence northerly to the south-west corner of Section No. 247, said Block

VIII.; thence easterly along the northern boundary of Section No. 248, Block XII., Ikitara Survey District aforesaid, to the Wangaehu River; thence south-westerly along the centre of the said Wangaehu River to a point opposite to the south-east corner of Section No. 290 in Block XI., Ikitara Survey District aforesaid; and thence to and along the eastern boundaries of Subdivision No. 1, hereinbefore described, to the starting point.

##### *Subdivision No. 3.*

The boundary commences at the south-west corner of the Waipakura Native Reserve; thence it proceeds easterly along the south boundary of the said reserve to the source of the Kukutu Stream; thence south-easterly in a straight line to the north corner of Section No. 295, Block III., Ikitara Survey District; thence southerly to the south-east corner of Section No. 42, Block VI., said Ikitara Survey District, so as to include within its limits Sections Nos. 295 and 293, said Block III., Sections Nos. 292, 272, 116, 115, and 114, Block II., Ikitara Survey District aforesaid, and Sections Nos. 113, 112, 57, and 42, Block VI. aforesaid; thence westerly along the northern boundaries of Subdivision No. 1, hereinbefore described, to the Wanganui River; thence northerly along the centre of the said Wanganui River to a point opposite to the south-west corner of the Waipakura Native Reserve aforesaid; and thence to the said south-west corner of the Waipakura Native Reserve, the starting point.

##### *Subdivision No. 4.*

The boundary commences at a point on the Wanganui River where the north-eastern boundary-line of the Upokongoro Block No. 1 strikes it; thence it proceeds southerly to the north-east corner of Subdivision No. 3, hereinbefore described, so as to include Upokongoro Block No. 1 aforesaid, Section No. 280, Waipakura Survey District, and the Waipakura Native Reserve; thence westerly along the Kukutu Stream to the said River Wanganui; and thence it proceeds along the centre of the River Wanganui aforesaid to a point in line with the north-eastern boundary-line of the Upokongoro Block No. 1 aforesaid; and thence to the north-eastern boundary-line of that block, the starting point.

##### *Subdivision No. 5.*

The boundary commences at a point in the centre of the Wanganui River where the north-east boundary-line of Upokongoro Block No. 1 produced strikes it; thence it proceeds northerly along the centre of the said Wanganui River to the intersection of Wanganui River aforesaid by the south-western boundary-line of West Taupo County, as the same is described in the First Schedule to "The Counties Act, 1876;" thence south-easterly along the said south-western boundary-line of the said West Taupo County; thence south-westerly and easterly along the north-western and the southern boundary-lines of East Taupo County, as the same is described in the First Schedule to "The Counties Act, 1876," to the centre of the Wangaehu River; thence southerly along the centre of the said Wangaehu River to the Otaika Block; thence westerly along the northern boundary-lines of the Wanganui purchased block and the Makirikiri Stream to the south-west corner of Section No. 279, Waipakura Survey District; and thence northerly along the eastern boundary-lines of Subdivision No. 4 to the starting point.

##### *Subdivision No. 6.*

The boundary commences at the north-east corner of the Waipakura Native Reserve; thence it proceeds easterly along the southern boundaries of Subdivision No. 5, hereinbefore described, to the centre of the Wangaehu River; thence southerly

along the centre of the said Wangaehu River to a point in line with the north-western boundary-line of Section No. 245, Block V., Wangaehu Survey District; thence to the north-west corner of the said Section No. 245; thence westerly in a straight line to the eastern corner of the Waikupa Native Reserve; thence north-westerly along the north-east boundary of the said Waikupa Native Reserve to the Kaukatea Stream; thence westerly along the said Kaukatea Stream till it intersects a line bearing east (magnetic) from the south-east corner of Section No. 292, Block II., Ikitara Survey District; thence westerly along such line to the eastern boundary of Subdivision No. 3, hereinbefore described; and thence northerly along the eastern boundary-lines of said Subdivision No. 3 and Subdivision No. 4, also hereinbefore described, to the starting point.

*Subdivision No. 7.*

Bounded towards the North by Subdivision No. 6, hereinbefore described; towards the East by the centre of the Wangaehu River; towards the South by Subdivision No. 2, hereinbefore described; and towards the West by Subdivision No. 3, also hereinbefore described.

WANGANUI COUNTY.

*Wanganui and Waitotara Road District.*

Bounded towards the North-west and South-west by the Patea and Taranaki Counties, as the same are described in the First Schedule to "The Counties Act, 1876," from the mouth of the Waitotara River northerly to the Wanganui River; thence towards the North-east and South-east by the right bank of the said Wanganui River to its mouth; and thence towards the South-west by the shore of Cook Strait to the mouth of the Waitotara River aforesaid, the place of commencement: excluding the Borough of Wanganui.

*Subdivision No. 1.*

The boundary commences at a point on the left bank of the Waitotara River where the northern boundary-line of the Waitotara purchased block strikes it; from thence it proceeds easterly along the said northern boundary line of the Waitotara purchased block to the north-east corner of Native Reserve No. 2; thence southerly to the south-east corner of Section No. 59, Block XIII., Nukumaruru Survey District, so as to include within its limits the said Native Reserve No. 2, and Sections Nos. 43, 44, 61, 60, and 59, said Nukumaruru Survey District; thence turning westerly along the shore of Cook Strait to the mouth of the Waitotara River; and thence northerly along the centre of the said Waitotara River to a point in line with the northern boundary-line of the Waitotara purchased block aforesaid; and thence to the starting point.

*Subdivision No. 2.*

The boundary commences at the north-east corner of Native Reserve No. 2 (Waitotara Block); thence it proceeds easterly along the northern boundary-lines of the Waitotara purchased block, of the Kai Iwi Block, and of the Kaiwatu and Koatanui Block to the Mangaone Stream; thence southerly along the said Mangaone Stream, along the Kai Iwi Stream, and along the western boundary-line of the Wanganui purchased block to the sea; thence turning westerly along the shore of Cook Strait to the south-east corner of Section No. 59, Block XIII., Nukumaruru Survey District (Waitotara Block); and thence northerly along the eastern boundary-lines of Subdivision No. 1, hereinbefore described, to the starting point.

*Subdivision No. 3.*

The boundary commences at the north-western corner of Section No. 241, Block I., Westmere Survey District, right bank of the Wanganui River; from thence it proceeds easterly to the eastern corner of Section No. 15, Block V., said Westmere Survey District, so as to include within its limits Sections Nos. 241, 245, 239, 244, and 170, said Block I., Sections Nos. 157, 156, 91, 90, 89, 108, 85, and 84, Block II., Westmere Survey District aforesaid, Sections Nos. 83, 82, 81, 80, and 15, Block V., Westmere Survey District aforesaid; thence it proceeds southerly and easterly along the north-western and south-western boundary-lines of the Wanganui Town Belt to the Wanganui River; thence along the bank of the said Wanganui River to its mouth; thence westerly along the shore of Cook Strait to the mouth of the Mowhanau Stream; and thence northerly along the south-eastern boundary-lines of Subdivision No. 2, hereinbefore described, to the starting point.

*Subdivision No. 4.*

Bounded towards the North-west and West by the Patea County and the Taranaki County, as the same are described in the First Schedule to "The Counties Act, 1876," from the northernmost corner of Subdivision No. 1, hereinbefore described, northerly to the Wanganui River; thence towards the North-east and East by the right bank of the said Wanganui River to the north-eastern corner of Section No. 202, Block XIII., Waipakura Survey District; thence towards the South-east by lines so as to include Sections Nos. 203, 204, 207, also the application of S. Gray for 115 acres, the Ngaturi Native Reserve, and Sections Nos. 70 and 71, said Block XIII., Sections Nos. 61, 136, 135, 113, 112, 111, 110 and 109, Block II., Westmere Survey District; thence towards the South-west by Subdivision No. 3, hereinbefore described; thence again towards the North-west by Subdivision No. 2, hereinbefore described; and thence again towards the South-west by the said Subdivision No. 2 and by Subdivision No. 1, hereinbefore described, to the Patea County boundary aforesaid, the place of commencement.

*Subdivision No. 5.*

The boundary commences at the north-east corner of Section No. 202, Block XIII., Waipakura Survey District, right bank Wanganui River; thence it proceeds southerly along the right bank of the said Wanganui River to the north-east boundary-line of the Wanganui Town Belt; thence north-westerly and south-westerly along the boundary-lines of the said Town Belt to the eastern corner of Section No. 15, Block V., Westmere Survey District; thence north-westerly along the north-eastern boundary-lines of Subdivision No. 3, hereinbefore described; thence northerly and easterly along the south-eastern boundary-lines of Subdivision No. 4, hereinbefore described, to the starting point.

RANGITIKEI COUNTY.

*Rangitikei Road District.*

Bounded towards the North-west, North-east, again towards the North-west, and towards the North by the Wanganui County, as the same is described in the First Schedule to "The Counties Act, 1876," from the mouth of the Wangaehu River to the westernmost boundary of the County of Hawke's Bay, as described in the First Schedule to "The Counties Act, 1876;" thence again towards the North by the said Hawke's Bay County to the Ruahine Range; thence towards the East by summit of the said Ruahine Range to a point due east from the source of the Kawhatau branch of the Rangitikei River; thence towards the South by a right line due

west to the said source of the Kawhautau branch (the same line being the northern boundary of Manawatu County); thence towards the South-west by the Kawhautau branch aforesaid to its confluence with the Rangitikei River, the same branch being the north-western boundary of the said Manawatu County; thence towards the South-east by the centre of the said Rangitikei River to its mouth; and thence again towards the South-west by the shore of Cook Strait to the mouth of the Wangaehu River, the place of commencement: exclusive of the Borough of Marton and the Town Districts of Bull's and Lethbridge.

*Subdivision No. 1.*

Bounded towards the North and North-east by lines so as to include Blocks CXVII., CXVIII., CXIX., CXX., CXXI., CXXII., CXXIII., CXXIV., CXXV., CXXVI., and CXXVII., Sections Nos. 44, 43, 38, and 36, all of Rangitoto Survey District, Blocks 268, 269, 271, and Section No. 36A, Rangitoto Survey District aforesaid; thence towards the South-east by the centre of the Rangitikei River to its mouth; thence towards the South-west by the shore of Cook Strait; and towards the North-west by lines so as to include said Block CXVII., and Blocks CLXV. and CLXVII., Koitiata Survey District, and by a line being the production of the north-west boundary-line of the last-named block to the shore of Cook Strait.

*Subdivision No. 2.*

Bounded towards the North by the Turakina River, by the Makirikiri Stream, and by lines so as to include Sections Nos. 25, 23, 21, 19, 17, and 43, Koitiata Survey District, and Sections Nos. 45, 47, 48, 49, 50, 51, and 52, Rangitoto Survey District; thence towards the East by lines so as to include Sections Nos. 56, 57, 57A, and 58, said Rangitoto Survey District; thence towards the South-east and North-east by lines so as to include Block XCIX., Rangitoto Survey District aforesaid, and Blocks CXV. and CXVI., Koitiata Survey District aforesaid; thence again towards the South-east generally by the north-western boundary of Subdivision No. 1, hereinbefore described; and thence towards the South-west by the shore of Cook Strait to the mouth of the Turakina River, the place of commencement.

*Subdivision No. 3.*

Bounded towards the North by lines so as to include Sections Nos. 34, 35, 36, 40, 41, 42, 45, 46, 51, 52, 53, 55, and 12, Rangitoto Survey District, and Block VI.; thence towards the South-east by the centre of the Rangitikei River to the northern boundary of Subdivision No. 1, hereinbefore described; thence towards the South and South-west by the said Subdivision No. 1 and by Subdivision No. 2, hereinbefore described; and thence towards the South-west and North-west generally by the said Subdivision No. 2 to the north-west corner of Section No. 34 aforesaid, the place of commencement: excluding the Town District of Bull's.

*Subdivision No. 4.*

Bounded towards the North by the ocean from Waitahanui to Cape Runaway; thence towards the North-east by a right line to the summit of Mount Hikurangi; thence towards the South-east by right lines from hill to hill along the summit of the watershed between the Bay of Plenty and the East Coast to Trig. Station 139; thence to and through Trig. Station 140 to the Motu River; thence by the centre of the said Motu River to the north-western boundary of the Motu Block; thence by the said north-western boundary of the said Motu Block to its north-west corner, at the Koranga River; thence towards the North-east by the centre of the said Koranga River to its source; thence by a right line to Maungatapere; thence again towards the South-east by a right line to Maungapohatu; thence by a right line to Puketapu; thence towards the South by a right line to the most northerly point of the Waikaremoana Lake; thence by a right line towards the junction of the Rangitaiki River and the main road from Napier to Tapuaeharuru till it meets a right line joining the summits of the Tatarakino and Tawhiwhau Mountains; thence towards the West by the last-mentioned line to Tawhiwhau; thence by a right line to the south-east angle of the Tauranga County, as the said Tauranga County is described in the First Schedule to "The Counties Act, 1876;" and thence by the eastern boundary of the Tauranga County aforesaid to Waitahanui, the place of commencement.

COOK COUNTY.

Bounded towards the North-west and West by the south-eastern and eastern boundaries of the Whakatane County, hereinbefore described, from Puketapu to Cape Runaway; thence towards the North and East by the ocean, to Paritu; and thence towards the South by a right line to the junction of the Ruakituri and Huangaroa Rivers, and by the centre of the said Ruakituri River to Puketapu, the place of commencement.

WAIARAPA WEST COUNTY.

Bounded by a line commencing at the source of the

Waingawa River; thence following the centre thereof to its junction with the Ruamahanga River; thence following the centre of the Ruamahanga River downwards to a point where the Ruamahanga River is touched by the southern boundary of Section No. 16; thence following the said southern boundary to where it touches the Taueru River; thence following the centre of the Taueru River upwards to the south-western corner of Section No. 95; thence following the southern boundary of said section and of Sections Nos. 105, 104, 103, 102; thence by a line bearing due south (magnetic) to the northern boundary of a section in Native occupation, and marked on the plan of the county as Te Kahu; thence easterly and south-easterly following the boundary of said section to its junction with Section No. 69; thence following the western boundary of Sections Nos. 69 and 49 to a point 110 chains 25 links distant from Ngatukoko; thence by a line bearing  $350^{\circ} 37'$ , and distance 82'40 links; thence by a line bearing  $13^{\circ} 34'$ , distance 26'25 links; thence by a line bearing  $25^{\circ} 40'$ , distance 37'35 links; thence by a line bearing  $5^{\circ} 14'$ , distance 19'50 links; thence by a line bearing  $16^{\circ} 17'$  to where it intersects the southern boundary of Section No. 52; thence following the southern boundaries of Sections Nos. 52, 63, 75; thence along the eastern boundary of Section No. 76 to the Wainuioru River; thence following the centre of the Wainuioru River upwards to its junction with the Kuamahunga Stream; thence following the Kuamahunga Stream to the southern corner of Section No. 130; thence by a line bearing  $95^{\circ}$  to where it strikes the Kaiwhata River; thence along the centre of the Kaiwhata River to the ocean; towards the East and South to Taourakira Head by the ocean; towards the West by the Hutt and Manawatu Counties to the point of commencement.

#### WAIARAPA EAST COUNTY.

Bounded towards the South from the source of the Waingawa River by the Wairarapa West County, as hereinbefore defined; towards the East from the mouth of the Kaiwhata River to the mouth of the Waimata Stream by the sea; towards the North by the Waipawa County; and towards the West to the point of commencement by the Manawatu County.

#### WAITAKI COUNTY.

Bounded towards the North-east by Waimate County, as described in the First Schedule to "The Counties Act, 1876," from the northern corner of Run No. 261 to the ocean; thence towards the South-east and East by the ocean to the northernmost point of Block III., Moeraki Survey District; thence again towards the East and towards the South by the said Block III., Moeraki Survey District, to the eastern corner of Section No. 7, said block and survey district; thence towards the South-west by the west side of a road-line through Blocks IX. and XI., Moeraki Survey District aforesaid, to the north-east corner of Block VI., Moeraki Survey District aforesaid; thence again towards the South by said Block VI. to the eastern boundary of Block XII., Moeraki Survey District aforesaid; thence towards the West and again towards the South by the said Block XII. to the intersection of the northern boundary-line of Block XII. aforesaid, by the eastern boundary-line of Section No. 4, Block XIV., Moeraki Survey District aforesaid; thence again towards the West by the said eastern boundary-line of said Section No. 4, and that boundary-line produced across a road-line; thence again towards the South-west by the northern side of the last-mentioned road-line through said Block XIV. and Block XV., Moeraki Survey District aforesaid, to the south-eastern boundary-line of Block III., Waihemmo Survey District, near Trig. Station M;

thence towards the North-west by said Block III.; and again towards the South-west by Block III. aforesaid, by Block V., Waihemmo Survey District aforesaid, and by the summit of the Kakanui Mountains, through the Maruenua Pass to Kyeburn Hill; thence again towards the South and South-west by the summit of the Mount Ida and Hawkdun Mountains to a point due east from Mount St. Bathans; thence again towards the South by a line drawn due west to the said Mount St. Bathans; thence again towards the South-west and North-west by the summit of the range through Lindis Pass to Longslip Hill; by the summit of that range to Mount Ward, and by Westland County, as described in the First Schedule to "The Counties Act, 1876;" thence towards the East and North-east by Geraldine County, as also described in the First Schedule to "The Counties Act, 1876," to the northern corner of Run No. 261, the starting point: exclusive of the Boroughs of Oamaru and Hampden.

#### WAIHEMO COUNTY.

Bounded towards the North by the Waitaki County, hereinbefore described, from Kakanui Peak to the ocean; thence towards the East by the ocean to Pleasant River; thence towards the South and West by Pleasant River and Annan's Creek to the Main North Road; thence towards the West by the said Main North Road to where it last crosses the said Pleasant River; thence again towards the South by Pleasant River aforesaid; thence again towards the West by a line running due north to Taieri Peak; thence again towards the South by a right line running due west to the Waikouaiti River; thence by the said Waikouaiti River to the southern boundary-line of Block I., Highlay Survey District; thence by Budle Survey District to the western boundary of Run No. 121B; thence towards the South-east by said Run No. 121B and the Nenthorn Creek; thence again towards the South by Run No. 307, and by a line being part of a right line drawn from the Hummock to the Taieri River in line with the south-western corner of pre-emptive right (Gardner and Main's), Strath Taieri Survey District; thence by the centre of that river to Horse Burn; thence by the centre of that stream to the Fork, and by a right line from the said Fork to Flat Hill; thence by the summit of a leading ridge to the main road; thence by a line to the nearest branch of the Shag River, flowing south-westerly, by that river to its source; and thence by a right line to Kakanui Peak, the starting point: exclusive of the Borough of Palmerston.

#### PENINSULA COUNTY.

Bounded towards the North-west and North by the Otago Harbour; towards the East and South by the ocean to the south-eastern angle of the Borough of Caversham; thence towards the South-west by the said Borough of Caversham; thence towards the North-west by the Borough of St. Kilda; and thence again towards the South-west by the said Borough of St. Kilda to the said Otago Harbour.

#### TAIERI COUNTY.

Bounded towards the North-west and North-east by Maniototo County, as described in the First Schedule to "The Counties Act, 1876," from Lammerlaw to the Taieri River; thence again towards the North-east by the Waikouaiti County, also described in the First Schedule to "The Counties Act, 1876," from the said Taieri River to Swampy Hill; thence towards the South-east, South, again towards the South-east, towards the North, again towards the South-east, and again towards the North-east by the Boroughs of Maori Hill, Roslyn, Mornington, and Caversham respectively, and by the south-western
