Notice of Times and Places for investigating Claims.

NOTICE is hereby given that the claims on behalf of themselves and others, of the several persons whose names are mentioned in the first column of the Schedule hereunder written, to the several blocks of land of which the names and locality are mentioned in the second column, the boundaries of which are published in the third column will be investigated at Kaiapoi, on the 14th day of September next, and following days.

The maps of such of these lands as has been surveyed, can be seen at the Office of the Chief Surveyor, Christchurch.

1	H. K. Taiaroa	The mouth of the Waihora River, Canterbury	Commence at the Whakamatakiuru, thence along the shore of the lake, following its shores to the mouth of the Waihora River, and following the other shores of the lake to Whakamatakiuru.
2	H. K. Taiaroa	Taieri, Block B, Otago	Commence at the mouth of the Taieri, thence by the straight line of Block C, till it reaches the top of the range at Pirirawa, to the boundary of Block A, from thence along the European line to the mouth of the Taieri.
3	H. K. Taiaroa	Mangahoe, an inlet of the sea, Otago Heads	Commence at the mouth of the Mangahoe inlet at the eastern side; thence by the seabeach on Section 25, Block B; thence to where the water stops; from thence in a northerly direction, and then by the other side of the inlet to Te Anakakihi; thence to Titikorako, including the whole of the Mangahoe inlet, and the islands of Tuhiraki and Kapo.
