A PROCLAMATION.

A PROCLAMATION.

WHEREAS by "The Town Districts Act, 1881" (hereinafter called "the said Act"), it is, among other things enacted that the inhabitants of any locality not constituted a borough under "The Municipal Corporations Act, 1876," wherein there are not less than fifty householders, may apply by petition to the Governor praying that such locality may be constituted a town district under the said Act; and that no such locality shall exceed two square miles in area, and no one point in such area shall be distant more than four miles from any other point therein, except in the case of military townships; and that in every such locality not less than two-thirds of the number of the resident householders shall concur in any such petition, and each signature to such petition shall be verified by the attestation of some respectable witness; and that such petition shall set forth accurately the boundaries of the locality to which such petition may refer; and also that, on the receipt of any such petition, the Governor may, by Proclamation, declare that the provisions of the said Act shall come into force within such locality, and that the same shall be a town district under the said Act; and further that such Proclamation shall accurately define the boundaries of the district in accordance with the description contained in the petition, and shall declare the name by which such district shall thereafter be known:

And whereas a petition has been presented to the Governor, by the inhabitants of the locality mentioned and described therein, praying that such locality may be constituted a town district under the said Act:

And whereas not less than two-thirds of the number of resident householders in the said locality have concurred in the said petition, and it is expedient that a Proclamation should be issued under the said Act for the purposes hereinafter set forth:

Now, therefore, I, William Francis Drummond Jervois,

Now, therefore, I, William Francis Drummond Jervois, Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the hereinbefore in part recited Act, do hereby proclaim and declare that the provisions of the said Act shall come into force within the locality or district mentioned and described in the Schedule hereto (the same being the locality men-

tioned and set forth in the said petition so presented as aforesaid), and that the same shall be a town district under the said Act; and, in further pursuance and exercise of the said power and authority, I do hereby declare that the said district shall hereafter be known by the name of "The Ngaruawahia Town District," and I do appoint that the Board of Commissioners for the said district shall consist of five in number.

SCHEDULE.

ALL that area in the County of Waipa bounded towards the North and North-east by the Waikato River; thence towards the South-east by the Newcastle Road District; thence towards the South-west and North-west by the Waipa River to the place of commencement.

Merging of Waikaia Road District.

That this Council do hereby, by special order, declare the Road Board of the Waikaia Road District to be dissolved, and the said road district to be merged in Southland County, all the conditions of subsections (1), (2), and (3) of Section 37 of "The Counties Act, 1876," having been duly complied with on the 21st January, 1880.

I declare that the above special order was duly made, and was passed on the 10th August, 1883, under the provisions of "The Counties Act 1876 Amendment Act, 1882."

SPECIAL ORDER passed at a Meeting of the Southland County

Council, held on the 13th July, 1883.

That, in pursuance of the powers granted by sections 9 and 10 of "The Road Boards Act, 1882," this Council do hereby, by special order, alter the boundaries of the Otaraia and Tuturau Road Districts by transferring from the Otaraia Road District to the Tuturau Road District all that area of land estimated to contain 9,500 acres, be the same more or land estimated to contain 9,500 acres, be the same more or less. Bounded by a line commencing at a point on the Waiarekiki Stream due West of Trig. Station N, Tuturau Survey District, and running due East through said Trig. Station N to the eastern boundary of Tuturau Survey District; thence by a line running due West to a point on said line due North of Trig. Station T, Wyndham Survey District; thence by a line running due West to a point on said line due North of Trig. Station T, Wyndham Survey District; thence by a line running due North to and across Mimihau Stream; thence in a North-westerly direction by said Mimihau Stream to its junction with the Waiarekiki Stream; thence in a Northerly and again in a North-westerly direction by the said Waiarekiki Stream to the starting-point. The said alteration to take effect as on and after the 15th day of August, 1883.
