Altering Boundaries of Counties of Waitemata and Rodney.

WM. F. DRUMMOND JERVOIS, (L.S.) Governor.

A PROCLAMATION.

N exercise and pursuance of the powers vested in me by section seven of "The Counties Act 1876 Amendment Act, 1882," and of all other powers and authorities enabling me in that behalf, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, do hereby proclaim and declare that, from and after the ninth day of October, one thousand eight hundred and eighty-three, all that portion of land mentioned and described in the First Schedule hereto shall be added to the County of Waitemata, and that from and after the aforesaid date the boundaries of the said County of Waitemata shall be those set forth in the Third Schedule hereto, and that from and after the aforesaid date the boundaries of the County of Rodney shall be those set forth in the Second the County of Rodney shall be those set forth in the Second Schedule hereto.

FIRST SCHEDULE.

Description of Land taken from the County of Rodney and added to the County of Waitemata.

ALL that area in the Provincial District of Auckland bounded towards the North-west by the Parishes of Makarau and Puhoi, and by a line along the middle of the Waiwerawera River to its mouth; towards the East by the ocean to the Orewa River; thence towards the South and South-east by Orewa filter; thence towards the South and South-east by that River and Waterloo Creek to the northern corner of Section No. 225, Parish of Waiwera; thence by that section and Sections Nos. 58, 14, and 50, said Parish of Waiwera, to the north-western corner of the last-mentioned section; thence by a right line to the south side of the road at the northern corner of Section No 253, Parish of Pukeatua; thence by the southern side of the road forming the north-western boundary of Section No. 253 aforesaid and the north-western boundaries of Sections Nos. 252, 251, and 250, Parish of Pukeatua aforesaid: thence by the eastern side of the western boundaries of Sections Nos. 252, 251, and 250, Parish of Pukeatua aforesaid; thence by the eastern side of the road forming the western boundary of the last-mentioned section and of Section No. 249; thence by the southern side of the road forming the northern boundaries of Sections Nos. 94, 93, 92, 91, 89, 88, 87, 86, 85, and 84 of the last-mentioned parish; thence towards the East by the last-mentioned section to the north-eastern corner of Section No. 306, Parish of Pukeatua; thence again towards the South and towards the Pukeatua; thence again towards the South and towards the South-west by the Waipapa-Kauri Stream to its confluence with the Kaukapakapa River; thence by that river to the eastern boundary-line of Section No. 64, Parish of Kaukapakapa; thence towards the West by that section and the

south-western and north-western boundary-lines of Section south-western and north-western boundary-lines of Section No. 65 of the last-mentioned parish; thence by Sections Nos. 62, 59, 56, 51, and 26, all of the Parish of Kaukapakapa aforesaid, to the north-eastern corner of the last-mentioned section; thence towards the North and East by the northern and eastern boundary-lines of Section No. 27; thence again towards the North by Section No. 28, Parish of Kaukapakapa aforesaid, to the Parish of Waiwera; thence again towards the West generally by the parish of Kaukapakapa aforesaid, and the Parish of Makarau aforesaid.

SECOND SCHEDULE.

COUNTY OF RODNEY

Is bounded towards the North generally by Hobson and Whangarei Counties; towards the North-east and South-east by the ocean to the Waiwerawera River; thence towards the South by a line along the middle of that river to the Parish of Waiwera, and by that Parish to the Parish of Makarau; thence towards the West and South-east by the latter parish and by a line along the middle of the Makarau River to Kaipara Harbour; and towards the South-west by that harbour and the Wairoa River to Hobson County aforesaid.

THIRD SCHEDULE.

COUNTY OF WAITEMATA

Is bounded towards the North-west, North-east, and again towards the North-west by Rodney County, hereinbefore described, and the Hauraki Gulf; towards the East by the said Hauraki Gulf; towards the South and again towards the East by Waitemata Harbour, and by a line along the middle of the Whau Creek to the Whau Portage Road, and by that road to Manukau Harbour; towards the South-east by the said Manukau Harbour; and towards the South-west and again towards the North-east by the ocean and Kaipara Harbour to Rodney County aforesaid.

Given under the hand of His Excellency Sir William Francis Drummond Jervois, Lieutenant-General in Her Majesty's Army, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Wellington, Is bounded towards the North-west, North-east, and again

Colony, at the Government House, at Wellington, this ninth day of October, in the year of our Lord one thousand eight hundred and eighty-three.

THE following by-laws, made by the Newmarket Road Board, are published in accordance with "The Road Boards Act, 1883."

EDWD. T. CONOLLY, (in absence of the Colonial Secretary.)

By-Laws Nos. 1 and 2 of the Newmarket Road Board, acting as the Local Board of Health, adopted by the Board at a Meeting held on the 24th Day of September, 1883.

1. Each and every occupier of any premises in the New-market Road District shall cleanse every earthcloset belonging to such premises at intervals of not more than fourteen days.

2. Each and every occupier of any premises in the said road district shall, at intervals of not more than seven days, remove or cause to be removed from the said premises all filth, dust, ashes, and rubbish.

And if any such occupier shall allow any such earth-closet to remain uncleansed for any period exceeding four-teen days, or shall not within seven days remove or cause to be removed from the said premises all such filth, dust, ashes, and rubbish, then and in any or either of such cases such occupier shall be deemed guilty of an offence against Part II. of "An Act to amend the Law relating to Public Health," 1876, and shall be liable for any costs or expenses to be incurred for remedying such default, as particularly to be incurred for remedying such default, as particularly provided for in said Part II. of said Act, and to a penalty of not exceeding the sum of ten pounds.

The above by-laws were this day passed by the Newmarket Road Board, acting as the Local Board of Health.

By-law made by the County of Waitaki.-Width of Tires, &c.

COUNTY OF WAITAKI.—BY-LAW NO. 5.

A By-law to regulate the Width of Tires, &c.

SPECIAL ORDER made by the Waitaki County Council.

In pursuance of the provisions of "The Counties Act, 1882," the Council of the County of Waitaki doth hereby order as follows: that is to say. follows; that is to say,-

1. On and after the gazetting of this by-law the width of the tires of all the wheels of every vehicle drawn on any of the county roads by five or more than five horses shall be not less than six inches; and any person offending against the provisions of this section shall be liable to a penalty not exceeding ten pounds.

2. It shall be lawful for any member of the Waitaki County County, or for any person acting under the authority of the Council, or for any policeman or constable, to examine and measure the width of the tires of the wheels of any vehicle, cart, dray, wain, wagon, or other carriage affected by the first section of this by-law; and every owner or driver of any such cart, dray, wain, or wagon, or other carriage, after such measuring and examination shall have been lawfully required, refusing to permit such examination and lawfully required, refusing to permit such examination and measuring, or turning or driving out of the road in order to hinder, evade, or avoid such examination and measuring, or

in any way hindering or obstructing the same, shall, for every offence, be liable to a penalty not exceeding five pounds. 3. Nothing herein contained shall apply to any vehicle upon springs used exclusively for carrying passengers or other persons and their luggage, or for the carriage of Her Majesty's mails, or for the conveyance of any piece of heavy machinery which cannot be taken apart without great

machinery which cannot be taken apart without great expense, loss, or inconvenience.

4. Every vehicle carrying, or constructed to carry, goods or merchandise of any kind whatsoever for hire, and every vehicle carrying passengers for hire, in actual use on any county road shall have the Christian name and the surname and place of abode of the owner thereof painted on some conspicuous part on the off-side thereof in white letters on a black ground such letternet heights have been seen as conspicuous part on the off-side thereof in white letters on a black ground, such letters not being less than one inch in length and of a proportionate breadth; and the owner of any such vehicle who shall neglect to have such name and place of abode painted as aforesaid, or who shall have the same so painted incorrectly, shall forfeit and pay for every such offence a sum of not less than five shillings nor more than five pounds: Provided that for every day that any such vehicle shall continue to be used as aforesaid and to have the name and abode unpainted or incorrectly painted as aforesaid, the owner thereof shall be deemed to have committed a fresh offence.
