Altering Boundaries of Counties of Bruce and Clutha.

A PROCLAMATION.

IN exercise and pursuance of the powers vested in me by "The Counties Act 1876 Amendment Act, 1882," and of all other powers and authorities enabling me in that behalf, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, do hereby proclaim and declare that from and after the first day of February, one thousand eight hundred and eighty-four, all that portion of land mentioned and described in the First Schedule hereto shall be added to the County of Bruce; and that from and after the said date the boundaries of the said County of Bruce shall be those set forth in the Third Schedule hereto; and that from the date aforesaid the boundaries of the County of Clutha shall be those set forth in the Second Schedule hereto respectively.

FIRST SCHEDULE.

LAND TAKEN FROM THE COUNTY OF CLUTHA AND ADDED TO THE COUNTY OF BRUCE.

ALL that area in the Provincial District of Otago, bounded towards the North-east, East, and South-east by a line along the middle of the Matau branch of the Clutha River; and towards the South-west and North by a line along the middle of the Koau branch of the said Clutha River.

SECOND SCHEDULE.

COUNTY OF CLUTHA.

BOUNDED towards the North by Tuapeka County from a point in the middle of the Back Creek, in Rankleburn Survey District, due west from Trig. Station D, said survey district, to the middle of the Clutha River; towards the East and North-east by a line along the middle of the said Clutha River and the Koau branch thereof to the mouth of the said Clutha River; towards the South-east by the ocean to Chasland's Mistake; towards the South-west by a right line to Blackhorn Hill; thence again towards the South-west, North-west, and North by the summit of the watershed over Bleak Hill to Catlin's Cone; thence again towards the

North-west by a right line to the source of the Waipahi River; thence towards the South and again towards the South-west by a line along the middle of the said Waipahi River to a point due east from the north side of a road traversing Section No. 4, Block XL., Waipahi Survey District; thence by the said road to the eastern boundary-line of the Waikaka Survey District; towards the West by the said Waikaka Survey District to its northern boundary-line; towards the South by the Waikaka Survey District aforesaid to the eastern boundary-line of the Chatton Survey District; again towards the West by the eastern boundary-line of the said Chatton Survey District and that line produced to the middle of the Leithen River; again towards the North-east by a line along the middle of the said Leithen River to its confluence with the Pomahaka River; again towards the North-east and North-west by a line along the middle of the said Pomahaka River to its confluence with the Back Creek, and by a line along the middle of the said Back Creek to the place of commencement.

THIRD SCHEDULE.

COUNTY OF BRUCE.

BOUNDED towards the North-east by Taieri County; towards the South-east by the ocean from the mouth of the Taieri River to the mouth of the Clutha River; towards the South-west by Clutha County; and towards the North-west by Tuapeka County.

Given under the hand of His Excellency Sir William Francis Drummond Jervois, Lieutenant-General in Her Majesty's Army, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at the Government House, at Wellington, this second day of January, in the year of our Lord one thousand eight hundred and eighty-four.

A PROCLAMATION.

WHEREAS by "The Town Districts Act, 1881" (hereinafter called "the said Act"), it is, among other things, enacted that the inhabitants of any locality not constituted a borough under "The Municipal Corporations Act, 1876," wherein there are not less than fifty householders, may apply by petition to the Governor praying that such locality may be constituted a town district under the said Act; and that no such locality shall exceed two square miles in area, and no one point in such area shall be distant more than four miles from any other point therein, except in the case of military townships; and that in every such locality not less than two-thirds of the number of the resident householders shall concur in any such petition, and each signature to such petition shall be verified by the attestation of some respectable witness; and that such petition shall set forth accurately the boundaries of the locality to which such petition may refer; and also that, on the receipt of any such petition, the Governor may, by Proclamation, declare that the provisions of the said Act shall come into force within such locality, and that the same shall be a town district under the said Act; and further that such Proclamation shall accurately define the boundaries of the district in accordance with the description contained in the petition, and shall declare the name by which such district shall thereafter be known:

And whereas a petition has been presented to the Governor, by the inhabitants of the locality mentioned and described therein, praying that such locality may be constituted a town district under the said Act:

And whereas not less than two-thirds of the number of resident householders in the said locality have concurred in the said petition, and it is expedient that a Proclamation should be issued under the said Act for the purposes herein-after set forth:

Now, therefore, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the hereinbefore in part recited Act, do hereby proclaim and declare that the provisions of the said Act shall come into force within the locality or district mentioned and described in the Schedule hereto (the same being the locality mentioned and set forth in the said petition so presented as aforesaid), and that the same shall be a town district under the said Act; and, in further pursuance and exercise of the said power and authority, I do hereby declare that the said district shall hereafter be known by the name of "The Hastings Town District," and I do appoint that the Board of Commissioners for the said district shall consist of five in number.

SCHEDULE.

ALL that area in the Provincial District of Hawke's Bay, bounded towards the North-west by a line commencing at a point in the middle of the road from Hastings to Omaha, otherwise known as the Havelock Road, 6400 links, distant in a north-westerly direction from the intersection of the middle of the said road by the centre line of the railway from Napier to Waipukurau, and proceeding thence North-easterly at a right angle to the Havelock Road aforesaid, 5000 links; thence towards the North-east by a line at a right angle, 12800 links; thence towards the South-east by a line at a right angle, 10000 links; thence towards the South-west by a line at a right angle, 12800 links; and thence again towards the North-west by a line at a right angle, 5000 links, to the place of commencement.

SPECIAL ORDER.

THAT this Board, by special order, delegate to the Wallace County Council the powers conferred on the Board by "The Road Boards Act, 1882," of making and levying rates, subject to the following conditions:—

1. That the Council levy a rate of $\frac{1}{4}$ d. in the pound.
2. That the moneys received from such rate be applied to the payment of interest and sinking fund on Road Board loan, and all expenses attendant on making and collecting such rate or rates.
3. That, after the aforesaid charges are provided for, the balance of moneys received be expended upon the most necessary district roads within the Aparima Road District.
4. That the Board's account, also the account of subdivisions, be kept separate as heretofore.
5. That this special order cease to be operative upon the merging of the Road Board into the county, or upon the passing of a resolution by this Board revoking this special order.
