A PROCLAMATION. WHEREAS a petition was presented to the Governor, signed by not less than three-fifths of the county electors contained within that portion of the County of Wanganui included within the boundaries particularly set forth in the First Schedule hereto, and which said portion comprises in the whole an area of more than two hundred thousand acres in extent, and contains more than one hun-dred county electors: And whereas the said portion prayed the Governor to constitute the said portion of the County of Wanganui a new county: And whereas such petition has been publicly notified as by law required: Now, therefore, I, William Francis Drummond Jervois, the

been publicly notified as by law required : Now, therefore, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, by virtue and in exercise of the powers vested in me by "The Counties Act, 1876," do hereby proclaim and declare that the aforesaid portion of the County of Wanganui shall, as from the first day of March, one thousand eight hundred and eighty-four, constitute a new county, to be called the County of Waitotara; and that the boundaries of the said new county so constituted shall be those particu-larly set forth in the First Schedule hereto; and the said new county is hereby constituted accordingly.

And I do further proclaim and declare that the said County of Waitotara shall be divided into four ridings, to be called the Waitotara Riding, the Westmere Riding, the Brunswick Riding, and the Tokomaru Riding, the boundaries whereof shall be those particularly set forth in the Second Schedule hereto.

And, in exercise of the like power and with the like advice and consent as aforesaid, I do further proclaim and declare that the number of members of the County Council of the said County of Waitotara shall be : For the Waitotara Riding, two members ; for the Westmere Riding, two members ; for the Brunswick Riding, two members ; and for the Tokomaru Riding, one member ; and that the election of such members shall take place and be held on the twenty-second day of March one thousand eight hundred and eighty-four. FIRST SCHEDULE. COUNTY OF WAITOTARA.

BOUNDED towards the North-west and West generally by book best covaries the North-West and West generaty by the Counties of Patea and Taranaki from the ocean to the Wanganui River; thence towards the North-east and East by a line along the middle of that river to its mouth; and towards the South-west by Cook Strait to the place of commencement.

SECOND SCHEDULE. WAITOTARA RIDING

COMPRISES all that area included in Subdivisions Nos. 1 and 2 of the Wanganui and Waitotara Road District, as described in the New Zealand Gazette No. 42, 18th May, 1883.

WESTMERE RIDING.

Comprises all that area included in Subdivision No. 3 of the Wanganui and Waitotara Road District, as described in the New Zealand Gazette No. 42, 18th May, 1883.

BRUNSWICK RIDING.

Comprises all that area included in Subdivision No. 5 of the Wanganui and Waitotara Road District, as described in the New Zealand Gazette, No. 42, 18th May, 1883.

I, the undersigned, Chairman of the Patea County Coun-cil, hereby certify that the following resolution was duly passed at a meeting of the Council held on the 3rd January, 1884 :--

OKUTUKU ROAD DISTRICT.

Commencing at the most northerly angle of Section No. 461, Okutuku; and bounded generally towards the East by the road forming the eastern boundaries of Sections Nos. 461, 462, 463, 282, and 283, by the road forming the southern boundaries of Sections Nos. 72, 71, and 76, and the western boundaries of Sections Nos. 65 and 347 to the Momahaki Stream, by the last-mentioned stream until it reaches the eastern boundary of Section No. 61, 60, 57, 55, and 44 (crossing all intervening public roads); bounded generally towards the South by the main road from Wanganui to Waverley from the south-eastern angle of Section No. 44, Okutuku, to the eastern boundary of the Waverley Town District, by the said eastern boundary, by a road forming the eastern boundary of Section No. 42 until the said road reaches the Mangatangi Stream, and thence by the Mangatangi Stream Commencing at the most northerly angle of Section Noboundary of Section No. 42 until the said road reaches the Mangatangi Stream, and thence by the Mangatangi Stream to its junction with the Kohi Stream; bounded generally towards the West by the Kohi Stream from its junction with the Mangatangi Stream to the boundary-line between the Provincial Districts of Wellington and Taranaki, and by the last-mentioned boundary-line to the point of com-mencement (crossing all intervening public roads).

By-law respecting Pedlars and Hawkers made by the Grey County Council.

BY-LAWS FOR LICENSING PEDLARS AND HAWKERS.

1. EVERY person trading or carrying on the business of a pedlar or hawker within the County of Grey shall apply to the Grey County Council for a license authorizing him or her to do so, and the Council shall, if it thinks fit, grant such license.

Such license shall be an annual license, and be in force
Such license shall be an annual license, and be in force
for twelve months from the date of the issue thereof.
The fee to be paid for every such license shall be—for a pedlar the sum of £2 10s., for a hawker the sum of £5.
The County Clerk shall cause the names of all persons to whom licenses are granted to be entered in a book to be heat for that numbers.

kept for that purpose. 5. Such license shall be issued by the Chairman on behalf of the Council on payment to the County Treasurer of such license fee.

license fee. 6. Any person committing a breach of these by-laws shall be liable, on conviction, to a penalty not exceeding $\pounds 5$. 7. A pedlar shall be deemed to mean any person who sells goods, wares, jewellery, or merchandise, and who carries such goods, wares, jewellery, or merchandise on foot. 8. A hawker shall be deemed to mean a person who sells goods, wares, jewellery, or merchandise, and carries such goods, wares, jewellery, or merchandise on horseback or by vehicle for sale. 9. Any person solely engaged in selling works of literature

9. Any person solely engaged in selling works of literature shall be exempted from payment of a license fee.
