Fixing Shooting Season for Native and Imported Game, License Fec, &c., Auckland District.

IN exercise of the powers vested in me by "The Animals Protection Act, 1880," and "The Animals Protection Act Amendment Act, 1881," I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, do hereby notify that pheasants and Californian and Australian used much tables or bibled within the Australian hereby notify that pheasants and Californian and Australian quail may be taken or killed within the Auckland District, consisting of the Auckland Provincial District, excepting the Counties of Cook, Whakatane, Tauranga, East Taupo, and Wairoa, from the first day of May, one thousand eight hundred and eighty-four, to the thirty-first day of July, one thousand eight hundred and eighty-four, both inclusive (subject, nevertheless, to the restrictions in the said Act mentioned).
