*Special Order made by Wairarapa East County Council.—  
Boundaries of Ridings altered.*

**T**HE following special order, made by the Wairarapa East County Council, is published in accordance with "The Counties Act 1876 Amendment Act, 1882."

**SPECIAL ORDER** passed by the County Council of East Wairarapa, on the 11th day of September, 1884, altering the Boundaries of the several Ridings in the said County, in accordance with the Provisions of Section 26 of "The Counties Act Amendment Act, 1882."

**WHEREAS** by Proclamation dated 1st February, 1883, and published in the *New Zealand Gazette* No. 12, of that date, the boundaries of the several ridings in the County of Wairarapa East were declared to be those set forth in Schedule II. to that Proclamation: And whereas, since that date, certain new road districts have been constituted within the limits of the said road, by which constitution the boundaries of the several ridings in the county have been so altered as to render it necessary to alter the boundaries of certain ridings in order to comply with the provisions of section 23 of "The Counties Act Amendment Act, 1882:" Now, therefore, in conformity with the provisions of section 26 of the said Act, this Council hereby, by special order, declares, that

in lieu of the boundaries of the Alfredton, Masterton, and Castlepoint Ridings, published in the *New Zealand Gazette* before mentioned, the following shall be substituted:—

**ALFREDTON RIDING (AMENDED).**

Bounded towards the North by the Waipawa County from the Manawatu Gorge to the point where the northern boundary of the Provincial District of Wellington crosses the summit of the Puketoi Range; thence towards the East generally by the summit of that range to Puketoi Trig. Station, by a right line from the last-mentioned trig. station to the north-west corner of Section No. 50, thence by Sections Nos. 50 and 51, Block VII., Puketoi, to the Tiraumea River, by the centre of that river to its confluence with the Waitawhiti Stream, by that stream to Section No. 174, Block XI., Puketoi, by the last-mentioned section and by Section No. 175 of the same block and by the western boundary of the last-mentioned section produced until it reaches the centre of the Taueru River, by that centre until it reaches a point in line with the northern boundary of Section No. 143, Block II., Mangapakeha; generally towards the South by the last-mentioned section and that boundary produced until it meets the dividing line between the College and Educational Reserves, by the Educational Reserve and Section No. 131, Block I., Mangapakeha, by Sections Nos. 21, 17, 18, 101, and 100, Block IV., Kopuaranga, by the centre of a public road and the Wangaehu Valley Road to a point in line with the northern boundary of Section No. 103, Block III., Kopuaranga, and by a right line bearing 295° 30' (magnetic) from the last-mentioned point to the Tararua Range; and generally towards the West by that range to the commencing point.

**MASTERTON RIDING (AMENDED).**

Bounded generally towards the North by the Alfredton Riding, before described, from the Tararua Range to the centre of the Taueru River, by that centre and by Section No. 824, Block III., Mangapakeha; generally towards the East by Sections Nos. 156, 155, 154, and 153, Block III., Sections Nos. 811, 812, and by 869, Block VI., Sections Nos. 870, 871, and 875, across the public road, parts 1 and 2 of Section No. 874, Block X., Sections Nos. 867 and 518, Block XIII., all of the Mangapakeha, by Section No. 524, Block I.,

Rewa, and by Section No. 523, Block IV., Otahua; generally towards the South by Sections Nos. 14, 89, 92, and 96, Block IV., Otahua, and by the centre of the Taueru River to its confluence with the Kerearea Stream; thence generally towards the South-east and South by the Wairarapa West County to the Manawatu County, and by the Manawatu County to the point of commencement: excepting from the above-described area the Borough of Masterton.

**CASTLEPOINT RIDING (AMENDED).**

Bounded towards the North by the Waipawa County from the north-easternmost corner of the Alfredton Riding, before described, to the mouth of the Waimata Stream on the East Coast; thence towards the South-east by the ocean to the Whareama River; thence towards the South-west by the said Whareama River to its confluence with the Waihora Stream; thence again towards the South-east by the said Waihora Stream to the north-east angle of Section No. 679, Rewa Survey District; thence by a right line to the easternmost angle of Section No. 669, said Rewa Survey District; thence again towards the South-west by the said Section No. 669 to the Kaumingi Stream, and by the said Kaumingi Stream to the Taueru River; and thence towards the North-west generally by the Masterton and Alfredton Ridings, before described, to the point of commencement.

I hereby certify that the above special order has been duly passed in accordance with the provisions of "The Counties Act Amendment Act, 1882."

THE following by-laws, made by the Upper Moutere Road Board, are published in accordance with "The Road Boards Act, 1882."

**SPECIAL ORDER.**

THAT, on and after the 1st day of October, 1884, the following by-laws be enforced in the Upper Moutere Road District:—

1. Any person or persons guilty of any of the following offences within the limits of the Upper Moutere Road District shall, upon conviction of any such offence, be liable to forfeit and pay any penalty not exceeding the sum of 40s. for any one offence.

2. No person shall place, or cause to be placed, any obstruction in or upon any roadway, street, footpath, or reserve, by allowing any vehicle or animal to remain in, upon, or across the same, or by placing thereon any goods or material of any kind, or by erecting fences in, upon, or across any roadway, footpath, street, or reserve, without having pre-

viously obtained the written consent of the Clerk of the Board.

3. No person shall place any obstruction in, upon, or across any ditch, drain, creek, river, or watercourse of any kind, by throwing therein any material whatsoever.

4. No person shall set fire to any timber, scrub, bush, or other combustible matter which may be liable to damage any road, street, footpath, or reserve.

5. No person shall remove, or cause to be removed, any soil, gravel, sand, stone, or timber from any roadway, street, footpath, reserve, nor from the bed or banks of any creek or watercourse, without having previously obtained the written consent of the Clerk of the Board.

6. No person shall permit any cattle to stray or depasture, whether under the tendence or control of any person or persons, or not, in or upon any road or street, or the sides thereof, within the limits of the Upper Moutere Road District.

7. The word "cattle" shall, for the purpose of these by-laws, be deemed to include horses, mules, asses, sheep, goats, and swine, of all ages and of either sex; and to apply to any one of such animals, as well as to a mob or herd.

8. The words "road, street, footpath, reserve," shall mean any road, street, footpath, and reserve under the control or management of the Upper Moutere Road Board.
