#### A PROCLAMATION.

WHEREAS by "The Town Districts Act, 1881" (hereinafter called "the said Act"), it is, among other things, enacted that the inhabitants of any locality not constituted a borough under "The Municipal Corporations Act, 1876," wherein there are not less than fifty householders, may apply by petition to the Governor praying that such locality may be constituted a town district under the said Act; and that no such locality shall exceed two square miles in area, and no one point in such area shall be distant said Act; and that no such locality shall exceed two square miles in area, and no one point in such area shall be distant more than four miles from any other point therein, except in the case of military townships; and that in every such locality not less than two-thirds of the number of the resident householders shall concur in any such petition, and each signature to such petition shall be verified by the attestation of some respectable witness; and that such petition shall set forth accurately the boundaries of the locality to which such petition may refer; and also that, on the receipt of any such petition, the Governor may, by Proclamation, declare that the provisions of the said 'Act shall come into force within such locality, and that the same shall be a town district under the said Act; and, further, that such Proclamation shall accurately define the boundaries of the district in accordance with the description contained in the petition, and shall declare the name by

boundaries of the district in accordance with the description contained in the petition, and shall declare the name by which such district shall thereafter be known:

And whereas a petition has been presented to the Governor, by the inhabitants of the locality mentioned and described therein, praying that such locality may be constituted a town district under the said Act:

And whereas not less than two-thirds of the number of resident householders in the said locality have concurred in the said petition, and it is expedient that a Proclamation should be issued under the said Act for the purposes hereinafter set forth:

Now, therefore, I. William Francis Drummond Jerweis the

Now, therefore, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the hereinbefore in part recited Act, do hereby proclaim and declare that the provisions of the said Act shall come into force within the locality or district mentioned and described

in the Schedule hereto (the same being the locality mentioned and set forth in the said petition so presented as aforesaid), and that the same shall be a town district under the said Act; and, in further pursuance and exercise of the said power and authority, I do hereby declare that the said district shall hereafter be known by the name of the Amberley Town District, and I do appoint that the Board of Commissioners for the said district shall consist of seven in

ALL that area in the Provincial District of Canterbury bounded towards the North by Section No. 3165, Block I., Teviotdale Survey District; towards the East by Sections Nos. 2763 and 2762; thence by a right line across the Double Corner Road to the north-eastern angle of Section No. 2759; thence towards the North-east by Section No. 5576; towards the South-east by Section No. 2758, a right line crossing the Main North Road to the northern angle of Section No. 11425, and by said Section No. 11425, Block I., Teviotdale Survey District; towards the South-west by the north branch of the Kowai River; towards the North-west by the Lawcock Road, which intersects Section No. 7989, Block XII., Grey Survey District, to its junction with Douglas Road; thence towards the North-east by that road to the south-eastern angle of District, to its junction with Douglas Road; thence towards the North-east by that road to the south-eastern angle of said Section No. 7989; thence across the road and by Section No. 2766; again towards the North-east by Dock Creek to the south-eastern side of the Amberley-Bluff Railway-line; again towards the North-west by said railway-line; and towards the West by the Main North Road to the point of comparement. commencement.

SPECIAL ORDER made by the Cook County Council on the 11th September, 1884.

Resolved, That, in compliance with the prayer of a petition duly notified and presented to this Council on the 14th August, 1884, this Council doth hereby order that the boundaries of the Waikohu and Turanganui Road Districts shall be amended, and the Waimata Road District constituted; the several boundaries being as hereinafter set forth in Schedules 1, 2, and 3, accompanying this special order.

#### SCHEDULE No. 1.

Waikohu Road District .- Amended Boundaries.

Waikohu Road District.—Amended Boundaries.

All that area in the Provincial District of Auckland bounded towards the North by a right line from Trig. Station No. 139, Arowhana Survey District, to Trig. Station No. 178, and thence by a right line to Trig. Station No. 170; thence towards the East generally by a right line to Trig. Station No. 168, and thence by another right line to Trig. Station No. 184, and by a right line from the latter station to the northernmost angle of the Waimata North Block; thence by the south-eastern boundary-lines of the Waihora No. 2 Block to the southernmost angle of that block; thence by the northern, north-western, and south-western boundaries of the Waimata West Block, and the eastern, south-eastern, and south-western boundaries of the Ngakoroa Block, and by the latter boundary produced to the middle of the Waipaoa River, and by the middle of that river to its confluence with the Waikaahu Stream; towards the South and South-west generally by the last-named stream and the Waikakariki Stream to the north-eastern corner of the Okahuatiu No. 2 Block; thence by that stream to the Wharekopae No. 1 Block; thence following the eastern boundaries of the Wharekopae No. 2 Block and the north-enstern boundaries of the Wharekopae Block to Maungatapara; thence by the south-western boundary of the Waikohumatawai Block to the Koranga River, and by a line along the middle of that river to the westernmost angle of the Motu Block; and thence towards the North-west by the north-western boundary-lines of the Motu Block and the north-western boundary-lines of the Motu Block and the north-western and northern boundaries of the Motu Block, and the north-western and northern boundaries of the Motu River; thence by a line along the middle of that the the Motu River; thence by a line along the middle of that western and northern boundaries of the Motu No. 1 Block to the Motu River; thence by a line along the middle of that river to the place of its intersection by a right line produced in continuance of a line drawn between Trig. Stations Nos. 140 and 139; and thence by the aforesaid line and the line between the last-mentioned trig, stations to the place of commencement. commencement.

SCHEDULE No. 2.

Turanganui Road District.—Amended Boundaries. All that area in the Provincial District of Auckland com-mencing at the northernmost angle of the Ngatawakawaka

Block. Bounded towards the North by the northern boundaries of the Ngatawakawaka and Mangatokerau Blocks and daries of the Ngatawakawaka and Mangatokerau Blocks and the boundary of the latter block produced to the middle of the Uawa River, and by the middle of that river and the northern boundary of the Anaura Block to the sea; towards the East by the sea to the middle of the Pouawa River; towards the South-west generally by the middle of the Pouawa River aforesaid to a point in the same being the termination of a right line produced southerly in continuance of the western boundary of the Whangara Block; thence by the line aforesaid, and by the western boundaries of the Whangara Block aforesaid, the western boundaries of the Whangara Ro. 1 Block, and the western boundaries of the Waiomoku No. 1 Block and the Kowhata Block to the north-western corner of the latter block; thence by part of the southern and the whole of the western boundaries of the Taumatarata Block, part of the south-western boundary of the Mangapapa Block, the south-western boundary of the Rangikohua Block, and the southern boundary of the Rangikohua Block, and the southern boundary of the Arakihi Block to the eastern boundary of the Waikohu Road District, hereinbefore described; and towards the West by part of the eastern boundary of the Waikohu Road District aforesaid as far as Trig. Station No. 168, and thence by the south-eastern boundaries of the Waingaromia No. 2 Block to the place of commencement. by the south-eastern boundaries

#### Waimata Road District.

All that area in the Provincial District of Auckland bounded towards the North-east generally by the south-western boundary of the Turanganui Road District, hereinbefore described; towards the South-east by high-water mark of the sea to Tuahina Point; towards the South-west by high-watermark of the sea, the eastern and north-eastern boundaries of the Borough of Gisborne (as described in Gazette No. 42, 12th May, 1877, folio 526), the north-eastern boundaries of the Poverty Bay Road District, and the eastern boundaries of the Ormond Road District (as described respectively in Gazette No. 42, 18th May, 1883, folio 657) to the eastern boundary of the Waikohu Road District, hereinbefore described; and towards the North-west by part of the eastern boundary of the Waikohu Road District aforesaid to the place of commencement.

That the boundaries of the Tolago Riding be amended as follows: Bounded towards the South by the southern boundary of the Whangara Block to the western boundary of that block; thence by the western boundary of that block to the Taumatarata Block; thence westerly by the southern boundaries of the Taumatarata, Rangikohua, and Arakihi Blocks to the eastern boundary of the Waikohu Riding; towards the West by the Waikohu Riding; towards the North by the Waiapu Riding; and towards the East by the ocean to the point of commencement.
