IIS Excellency the Governor in Council hereby directs it to be notified that, under the powers conferred upon the Governor in Council by "The Railways Construction and Land Act, 1881," a supplementary contract was, on the 11th day of June, 1884, made between Her Majesty the Queen and the Waicola, Linton, and Waiau Valley

Railway Company (Limited), of which the following is the

general purport, namely:
The first six clauses of the contract made on the 9th day of August, 1883, are cancelled, and instead thereof it is agreed that the said railway shall be treated as one section instead

that the said railway shall be treated as one section instead of two sections as in the first contract, that is to say,—

1. The company shall, at its own expense, within five years, construct, and thereafter maintain and work, a line of railway from a point in the Government railway between Otautau and Wairio, situated on Section 23, Aparima Hundred, to a point in the Waiau Township Reserve.
