Colonial Secretary's Office, Wellington, 20th November, 1884. THE following special order, made by the Kaikoura County Council, is published in accordance with "The Counties Act 1876 Amendment Act, 1882."

#### SPECIAL ORDER.

SPECIAL ORDER. THAT this Council resolves that effect be given, in accord-ance with the provisions of "The Counties Act, 1876," and the several amendments thereof, to the prayer of the petition presented, signed by James Gray and 122 other ratepayers, requesting the Council to alter the boundaries of the ridings of the county and to increase the representation of the Suburban and Conway Ridings, and that the necessary steps be taken to have this done by special order, that is to say,— 1. That the ridings shall, as heretofore, be four in number. 2. That the boundaries of the Town Riding shall be ex-tended to include Section 224, Kaikoura Suburban; and return two members as heretofore.

tended to include Section 224, Kalkoura Suburban; and return two members as heretofore. 3. That the Conway Riding shall start from the sea on the south side of the Kalkoura Peninsula; thence by a line northward to the southern corner of Section 256, Kalkoura Suburban; thence by a public road to the north-east corner of said Section 256; thence by the public road known as the Kowhai Road to the north-east corner of Section 111, Kai-Kowhai Road to the north-east corner of Section 111, Kai-koura Suburban, across the public road at that point to the south-east corner of Section 94, Kaikoura Suburban; thence by a public road known as the Red Swamp to the north-east corner of Section 88, Kaikoura Suburban; thence in a south-westerly direction by a public road known as the Schoolhouse Road to the Kowhai River: and include all country, runs, and reserves south of the Kowhai, and at pre-sent otherwise included in the Conway Riding, returning by the boundaries of such country to the starting point on the south side of the aforesaid Peninsula; and return two Councillors.

4. That the Suburban Riding shall embrace all the sec-tions west of the road commencing at the north-east corner 4. That the Suburban Kiding shall embrace all the sec-tions west of the road commencing at the north-east corner of Section 263, Kaikoura Suburban, and proceeding from thence to a point on Beach Road at the north corner of Section 152, Kaikoura Suburban; thence westerly along a public road to the north-west corner of Section 153, Kai-koura Suburban; thence in a north-westerly direction to the corner of Section 177, Kaikoura Suburban; thence by the public road to the Waimanarara Stream; thence by the said stream to the present boundary of the Suburban and Clarence Ridings; thence by the Said boundary to the sea; thence by the sea to the present Town Riding boun-dary; thence by the said town boundary to the starting point: returning three members. 5. That the Clarence Riding shall include all the remain-ing portion of the county to the northward of the Suburban Riding; returning two members as at present. **SPECIAL** ORDER made at a Meeting of the Omaka Road Board, held on the 8th November, 1884.

THAT on and after the 1st day of May, 1885, the following by-laws be enforced in the Omaka Road Board District :---

By-law No. 1.-Regulating the Width of Tires, &c.

By-taw No. 1.—Regulating the Width of Tires, &c. (a.) The width of tires of all the wheels of every vehicle drawn by three or more horses on any of the roads in the Omaka Road Board District, such roads being either wholly or party macadamized or metalled, or which shall from time to time, or at any time hereafter, be either wholly or partly macadamized or metalled, shall not be less than  $4\frac{1}{2}$  inches in width.

in width. (b.) It shall be lawful for any person, acting under the authority of the Omaka Road Board, at all times to examine and measure the tires of the wheels of any vehicles, and every owner, driver, or person in charge of any such vehicle, or any other person, who shall obstruct or refuse to permit such examination and measurement as aforesaid, or who shall in any way offend against, or commit a breach of, any

of the provisions of this by-law, shall, on conviction thereof, be liable to a penalty not exceeding £2; and every person who shall be convicted of any subsequent offence under this by-law shall be liable to a penalty not exceeding £5 for any such offence.

such offence.
(c.) Nothing herein contained shall apply to any vehicles upon springs used exclusively for carrying passengers or other persons and their luggage, or for the carriage of Her Majesty's mails, or to any vehicle used for the conveyance of any piece of heavy machinery which cannot be taken apart without great expense, loss, or inconvenience.
(d.) Every penalty imposed under this by-law shall and may be recovered in a summary manner.
