A PROCLAMATION.

WHEREAS a petition was presented to the Governor, signed by not less than three-fifths of the county electors contained within that portion of the County of Manawatu included within the boundaries particularly set forth in the First Schedule hereto, and which said portion comprises in the whole an area of more than two hundred thousand acres in extent, and contains more than one hundred county electors: And whereas the said petition prayed the Governor to constitute the said portion of the County of Manawatu a new county, and to set forth the boundaries of the proposed new county: And whereas such petition has been publicly notified as by law required:

Now, therefore, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, by and with the advice and consent of the Executive Council of the said colony, by virtue and in exercise of the powers vested in me by "The Counties Act, 1876," do hereby proclaim and declare that the aforesaid portion of the County of Manawatu shall, as from the first day of January, one thousand eight hundred and eighty-five, constitute a new county, to be called the County of Horowhenua; and that the boundaries of the said new county so constituted shall be those particularly set forth in the First Schedule hereto; and the said new county is hereby constituted accordingly.

And I do further proclaim and declare that the said County of Horowhenua shall be divided into three ridings, to be called the Wirokino Riding, the Otaki Riding, and the Te Horo Riding, the boundaries whereof shall be those particularly set forth in the Second Schedule hereto.

And, in exercise of the like power, and with the like advice and consent as aforesaid, I do further proclaim and declare that the number of members of the County Council of the said County of Horowhenua shall be: For the Wirokino Riding, two members; for the Otaki Riding, three members; and for the Te Horo Riding, two members.

FIRST SCHEDULE.

COUNTY OF HOROWHENUA.

BOUNDED towards the North-east and North-west generally by a line along the middle of the Manawatu River from its mouth to a point in line with the south-western boundary of the Township of Fitzherbert; thence again towards the North-east by a line to and by the said south-western

boundary-line to the summit of the Tararua Range; thence towards the South-east by the Counties of Wairarapa East and Wairarapa West respectively; towards the South by the County of Hutt; and towards the West by the shore of Cook Strait to the place of commencement.

SECOND SCHEDULE.

WIROKINO RIDING.

BOUNDED towards the North-east and North-west generally by a line along the middle of the Manawatu River from its mouth to a point in line with the south-western boundary of the Township of Fitzherbert; thence again towards the North-east by a line to and by the said south-western boundary-line to the summit of the Tararua Range; thence towards the South-east by the County of Wairarapa East; towards the South by the southern boundaries of the Ohau No. 2 and the Ohau No. 3 Blocks; and towards the West by the shore of Cook Strait to the place of commencement.

OTAKI RIDING.

Bounded towards the North by the Wirokino Riding, hereinafter described; towards the South-east by the County of Wairarapa West; towards the South by the Waihonga Block and the Otaki River; and towards the West by the shore of Cook Strait.

TE HORO RIDING.

Bounded towards the North by the Otaki Riding, hereinafter described; towards the East by the County of Wairarapa West; towards the South by the County of Hutt; and towards the West by the shore of Cook Strait.

Given under the hand of His Excellency Sir William Francis Drummond Jervois, Lieutenant-General in Her Majesty's Army, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Governor and Commander-in-Chief in and over Her Majesty's Colony of New Zealand and its Dependencies, and Vice-Admiral of the same; and issued under the Seal of the said Colony, at Christchurch, this sixteenth day of December, in the year of our Lord one thousand eight hundred and eighty-four.

*SPECIAL ORDERS.*

THE following special orders were made at an ordinary meeting of the Waitemata County Council, held on the 5th December, 1884:—

1. That the Outlying District of Ararimu be constituted a road district under "The Road Boards Act, 1882," to be called the Ararimu Road District, the same to be divided into two subdivisions by the Kaipara Railway, to be called respectively the Ararimu and Taupaki Subdivisions. That the Board of the said district consist of eight members; four to be returned by each subdivision.

2. That the Board of the Manukau Road District and the Board of the Titirangi Road District be dissolved, and that provisions be made for the election of a Board of six members for the newly-constituted Manukau and Titirangi Road District, being three for each subdivision.
