THEREAS it is necessary that an election of a member of the House of Representatives of New Zealand

on the third day of June, and the polling, in case it shall be required, to be at the several polling-places on the tenth day of June; and that this our writ, with the name of the person so elected indorsed thereon by you, shall be returned to Us here on or before the nineteenth day of June, 1885.
