New Electoral Districts.

A PROCLAMATION.

WHEREAS the Permanent Commission appointed under the provisions of "The Representation Act, 1887," have this day made their report to me under their hands and seals, setting forth the names and boundaries of the electoral districts fixed by them in accordance with the said Act:

Now, therefore, in pursuance of the provisions of the fifth section of "The Representation Act, 1887," I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, do hereby proclaim the names and boundaries of the electoral districts so fixed by the said Commission to be those respectively mentioned and set out in the Schedule hereto.

SCHEDULE.

BAY OF ISLANDS.

This district is bounded towards the South-west, North, and North-east by the ocean from the Maunganui Bluff on the west coast to the Kowhaitai Stream on the east coast; towards the South-east generally by a grant of land (1,560 acres) to G. Thorne, and Block 583 (in red) to the road forming the north-eastern boundary of Section No. 180, Parish of Owhiwa; again towards the South-west generally by that road and its continuation past Sections Nos. 179, 178, 177, 176, 175, 169, 168, and 167 of the said Parish of Owhiwa to the south-eastern boundary of Section No. 181 of the aforesaid parish, by the last-mentioned section and Sections Nos. 100, 101, 95, 102, 65, 62, 59, 47, 46, 45, 44, and 43 of the Parish of Parahaki to the Huanui Block, by the said Huanui Block, Te Maruata, and the Puketotara Block to the Whangarei River, by the said Whangarei River to a point in line with the north-eastern boundary-line of Section No. 39, Parish of Whangarei, by the said Section No. 39 and Section No. 38 of the said Parish of Whangarei to the Mangahuru Stream, and by that stream to its confluence with the Wairua River; towards the South-east by the last-mentioned river and the Wairoa River to the Kaikohe-Mangakahia and Wairoa River Road; again towards the South-west by that road to where it is intersected by a right line drawn from Trig. Station No. 18 (Te Tarai o Rahiri) to Trig. Station No. 43 (Tutamoe); again towards the South-east by the said line to Trig. Station No. 43 (Tutamoe); and towards the South by a right line passing over Trig. Station No. 119 to Maunganui Bluff.

MARSDEN.

This district is bounded towards the North generally by the Bay of Islands Electoral District, hereinbefore described; towards the East generally by the ocean to the north-eastern corner of Section No. 91, Parish of Waipu, at Bream Tail; towards the South-east by the south-eastern boundary-line of

that section to its south-eastern corner; thence by a straight line to the Kapawhiti Range at a point where the road from Mangawhai to McKenzie's Cove crosses it, by the summit of the Kapawhiti Range aforesaid to its intersection by a line due north from the northernmost corner of the Marunui Block, by that line to the Marunui Block aforesaid, and by that block to the Piroa Stream at the northern boundary of the Parish of Kaiwaka; thence by the said Piroa Stream to the road forming the south-western boundary of Section No. 109 of the said Parish of Kaiwaka; towards the South-east by the said road, and Sections Nos. 108, 107, 106, 77, 86, 87, and a Native reserve, all of the Parish of Kaiwaka aforesaid, to the Kaiwaka River, by that river and the Wairau River to the Great North Road, by that road, the Ohungarere Block (No. 2298), the Waikino Blocks Nos. 2196 and 2196A, the Ohungarere Blocks Nos. 3819 and 3620, and the Okahurewa Block No. 4302; towards the South-west generally by the last-mentioned block, the Tumunui, Huarau, and Pukehuia Blocks, and Te Pahi River; towards the West by the road forming the north-western boundaries of Sections Nos. 84, 80, 79, 78, 93, and 91, Parish of Wairau, and by Sections Nos. 151 and 152, Parish of Paparoa; towards the South by the said Parish of Paparoa; towards the West by the Parish of Matakohe to the Mangonui River, and by that river to the main road from Tokatoka to Waikiekie and Mangapai; again towards the South-east by that road and the Parishes of Omaru and Tokatoka to the Wairoa River; again towards the West by the said Wairoa River to a point opposite to the mouth of the Aratapu Creek; again towards the South by that creek and the Parish of Kopuru to the ocean; and again towards the West by the ocean: including the Hen and Chicken and other adjacent islands.

RODNEY.

This district is bounded towards the North generally by the Marsden Electoral District, hereinbefore described; towards the East generally by the ocean to the Waiwerawera River; towards the South generally by the Parishes of Waiwera and Makarau to the Makarau River, and by the said Makarau River; towards the East and West by high-water mark of the Kaipara Estuary to the Kaipara Heads; and towards the West by the ocean: inclusive of the Great and Little Barrier, Kawau, and other adjacent islands.

WAITEMATA.

This district is bounded towards the North generally by the Rodney Electoral District, hereinbefore described; towards the East by the ocean to the North Head of Waitemata Harbour; towards the South by Waitemata Harbour and the Whau Estuary to Section No. 90 of the Parish of Waikomiti, by that section to the Helensville Railway-line, by that railway-line to the Taupaki Block, and by the southern boundary-line of the said Taupaki Block and the Mokorau River to the ocean: including the Island of Tiritiri.

EDEN.

This district is bounded towards the North by the Waitemata Electoral District, hereinbefore described, and the waters of Waitemata Harbour to the Meola Stream, by that stream to the New Main North Road, by that road to Allotment No. 2F, Eden Terrace, by the said Allotment No. 2F and Allotments Nos. 2E, 2D, 2C, 2B, 2A, and 2, by the street forming the southern boundary of Sections Nos. 2, 3, 4, 5, and 6 of Section No. 6, Suburbs of Auckland; towards the North-east by the Epsom Road District and Allotment No. 12 of Section No. 12 of Suburbs of Auckland; thence by the road forming the western boundary of that allotment, and by the Borough of Onehunga to the Manukau Harbour; towards the South by the waters of the said Manukau Harbour; and towards the West by the ocean.

NEWTON.

This district is bounded towards the North by Allotments Nos. 2, 4, 24, and 27 of Section No. 8 of the Suburbs of Auckland, and by the Richmond Road; towards the North-east by Ponsonby Road and Allotments Nos. 12, 5A, and 2, by Symonds Street and the Kyber Pass Road; towards the South-east and South-west by the Eden Electoral District, hereinbefore described; and towards the North-west by the waters of Waitemata Harbour.

PONSONBY.

This district is bounded towards the West and North by the waters of the Waitemata Harbour; towards the East by the Franklin Road and Ponsonby Road; and towards the South by the Newton Electoral District, hereinbefore described.

AUCKLAND NORTH.

This district is bounded towards the North-west and North by the waters of Waitemata Harbour from Franklin Road to the Railway Wharf; towards the East by Railway Road, Customhouse Street, Emily Place, Princes Street, Waterloo Quadrant, and Symonds Street to Wellesley Street East; towards the South by Wellesley Street East; again towards the East by Queen Street and Grey Street; and again towards the South by Cook Street, Union Street, and Franklin Road aforesaid.

AUCKLAND WEST.

This district is bounded towards the North by the Auckland North Electoral District, hereinbefore described; towards the East by Queen Street and Karangahape Road; towards the South-west by Ponsonby Road; and towards the North-west by Franklin Road.

AUCKLAND CENTRAL.

This district is bounded towards the North-east by Wellesley Street East and the northern boundary-lines of Allotments Nos. 8 and 41 of Section No. 15 of the Suburbs of Auckland; towards the East by the Grafton Road; towards the South by the Kyber Pass Road; again towards the East by Symonds Street and the New North Road; again towards the South and towards the West by the Newton Electoral District, hereinbefore described; and again towards the West by the Auckland West Electoral District, hereinbefore described.

PARNELL.

This district is bounded towards the North and East by the waters of Waitemata Harbour from the Railway Wharf to Slaughterhouse Creek; towards the South generally by that creek and Allotments Nos. 19, 18, and 17 of Section No. 4 of the Suburbs of Auckland; towards the East by the Epsom Road to the Kaipara Railway-line; again towards the South by that railway-line and by the Kyber Pass Road; and towards the West by the Electoral Districts of Auckland Central and Auckland North, hereinbefore described.

MANUKAU.

This district is bounded towards the North by the Parnell Electoral District, hereinbefore described, and Waitemata Harbour; towards the East by Sections Nos. 40A, 39A, 38A, and 45, Parish of Waitemata, by Sections Nos. 12A and 26, by the southern boundary-line of Allotment No. 25 of Section No. 12, all of the Suburbs of Auckland, to the south-eastern corner of that allotment; thence by a right line to the junction of the roads at the Harp of Erin Inn; towards the North-east by the Great South Road to Hamlin's Creek; towards the South by the waters of the Manukau Harbour; and towards the West by the Eden and Newton Electoral Districts, hereinbefore described.

FRANKLIN NORTH.

This district is bounded towards the North-east by Waitemata Harbour and the Hauraki Gulf to the north-west corner of the Waitarawa Block; towards the East by that block, the Pekaraka Block, and the Kiripaki Block to the confiscation boundary-line; towards the South-east by that boundary-line to the road which forms the south-eastern boundaries of Sections Nos. 25 and 24, Parish of Otara, to the Waimako River; thence by that river to the Wairoa River, and by that river to a road passing through Section No. 16,

Parish of Wairoa; towards the South by that road which passes through Sections Nos. 16, 5, 9, 3, 83, 31, and 38, and forms the southern boundary of Section No. 39, to the Parish of Papakura; thence by Sections Nos. 61, 50, 55, 30, 35, 34, and 33, Parish of Papakura, to the main road; towards the South-west by that road to the Papakura Stream, and by that stream to the Pahurehure Estuary; towards the West by the waters of the Manukau Harbour to the Manukau Electoral District, hereinbefore described, and by that electoral district: including the Islands of Waiheke, Rangitoto, Motutapu, Punui, and other adjacent islands.

FRANKLIN SOUTH.

This district is bounded towards the North by the waters of the Waitemata Harbour and the Franklin North Electoral District, hereinbefore described; towards the East by the Firth of Thames to the mouth of the Pukorokoro Creek; thence by a right line to Rataroa Mountain; towards the South by the Parish of Maramarua, the Maramarua River, and the Waikato River to the Parish of Tuakau; towards the West by the Parish of Tuakau to the Main Trunk Railway; again towards the South by that railway to the road which forms the southern boundary of Section No. 47, Parish of Pukekohe West; thence by that road along the southern boundaries of Sections Nos. 47, 49, and 55, and passing through Sections Nos. 52, 44, and 18 to the Waikato River; towards the South-east by the said Waikato River; and again towards the West by the ocean.

COROMANDEL.

This district is bounded towards the West by the Firth of Thames; towards the North and East by the ocean; towards the South by a right line from the mouth of the Waihi River to the summit of Te Aroha Mountain, and by a line thence due west to the Thames River; towards the West by the Thames River and the Firth of Thames to the Hape Creek; towards the North-west by the said Hape Creek to the Borough of Thames, and by that borough to Hape Creek aforesaid, and again by that creek and the Hape North Block No. 2; again towards the West by the last-mentioned block and the Hape North No. 1 Block, and Sections Nos. 2 and 1, Block V., Thames Survey District; towards the South by the said Section No. 1, by the Parareka No. 2 Block, the Kuranui Block, the Pukehinau Block, and the Optomoko Block to the Borough of Thames; and again towards the West by the said Borough of Thames: including Great Mercury, Red Mercury, and other adjacent islands.

THAMES.

This district is bounded towards the North-west, North-east, and South-east by the Coromandel Electoral District, hereinbefore described; towards the South by a right line due west (true), 80 chains; towards the West by a right line to a point 11681½ links distant from Trig. Station F, Thames Survey District, on a bearing of 232° 36' 31" (true); and towards the North by a line proceeding due east (true) to Rocky Mount, on the boundary of the Coromandel Electoral District aforesaid.

WAIKATO.

This district is bounded towards the North-west by the Franklin South Electoral District, hereinbefore described, and the Firth of Thames; towards the North-east by the Coromandel Electoral District, hereinbefore described, and the Thames River to the Wairere Stream; again towards the North-west by that stream and the Maurihiro Block to the confiscation-line; again towards the North-east by the County of Tauranga to the Puwhenua Trig. Station; towards the South-east by a right line thence to the Uraura Trig. Station; thence by a right line to the Waimahana Hot Spring, and that line produced to the Waikato River; and towards the South-west generally by the said Waikato River to a point in line with the north-western boundary-line of Section No. 120, Parish of Pukekura; again towards the South-east by a line across the Waikato River aforesaid, and by the said Section No. 120 and Sections Nos. 121, 122, 124, 125, 126, and 151 of the said Parish of Pukekura; again towards the South-west by the last-mentioned section and Sections Nos. 170, 169, 168, 167, 166, and 165 of the Parish of Pukekura aforesaid; again towards the North-west by Sections Nos. 26, 24, 21, 21A, and 20B of the Parish of Pukekura aforesaid, and by the north-eastern boundary-line of the last-mentioned section produced across the Waikato River; and again towards the South-west generally by that river.

TAURANGA.

This district is bounded towards the North-east and North-west by the ocean; towards the South-east generally by a right line from Cape Runaway to the summit of Hikurangi Mountain, by right lines thence from hill to hill along the summit of the watershed between the Bay of Plenty and the East Coast to Trig. Station No. 139; thence to and over Trig. Station No. 140 to the Motu River; thence by a line along the middle of the said Motu River to the north-western boundary-line of the Motu Block, and by that boundary-line to the western corner of the Motu Block aforesaid at

the Koranga River; thence by a line along the middle of the said Koranga River to its source; thence by a right line to Maungatapere; thence again by a right line to Maungapowhata; thence by a right line to Matakapia Trig. Station (No. 93); thence by a right line to the most northerly point of Waikaremoana; thence by a right line to the junction of the Rangitaiki River and the main road from Napier to Tapuachararu, by the south side of that road to the Tauhara Middle Block, by that block and the Tauhara South A Block to the north-western corner of the Patehe Block, No. 5170; thence by a right line over Te Iringa Trig. Station (No. 60) to the 39th parallel of south latitude; towards the South by the 39th parallel of south latitude to a point due south of the mouth of the Whanganui Stream in Taupo Moana; towards the West generally by a right line to the mouth of that stream, and thence by the western shore of Taupo Moana to the mouth of the Waihora Stream, by a right line thence to the Waimahana Hot Spring, and by the Waikato Electoral District, hereinbefore described; and towards the North-west by the Coromandel Electoral District, hereinbefore described: including Motiti, Matakana, and other adjacent islands.

WAIPA.

This district is bounded towards the North generally by the Franklin South Electoral District, hereinbefore described; towards the North-east generally by the Waikato Electoral District, hereinbefore described; towards the East by the Tauranga Electoral District, hereinbefore described, to the 39th parallel of south latitude; towards the South by the 39th parallel of south latitude; towards the North-west generally by the Wanganui River to its confluence with the Otunui River; towards the West by a line due north to the parallel of 38° 30' south latitude; towards the South by the parallel of 38° 30' south latitude; and again towards the West by the ocean.

EAST COAST.

This district is bounded towards the North-west generally by the Tauranga Electoral District, hereinbefore described; towards the North and East by the ocean; towards the South by the ocean to the mouth of the Waibua River; towards the South-west generally by the said Waibua River to the 39th parallel of south latitude, by the said 39th parallel to where it intersects the Mohaka River in Block II., Mohaka Survey District; thence by the said Mohaka River to its confluence with Te Hoe River, and by the latter river to the north-western boundary-line of the Maungataniwha Block; thence by a right line to the Tauranga Electoral District aforesaid at a point where a right line drawn between Tawhiwhau and Tatarakino Trig. Stations intersects the southern boundary-line of that electoral district: including Portland Island.

TARANAKI.

This district is bounded towards the North and East generally by the Waipa Electoral District, hereinbefore described, and the Wanganui River to the confluence of the said Wanganui River with the Tangarakau River; thence by a right line to the eastern corner of the Mangatuku Block; thence by the southern boundary of that block to its south-western corner; thence by a right line to the eastern corner of the Ahuroa Block, and by the eastern boundary of the latter block to the Patea River; towards the North-east by the said Patea River to a point in line with the northern boundary-line of Block X., Ngaire Survey District; towards the South by a right line to the said Block X., and by that block to the Waingongoro River; towards the South-west by that river to its source, and by a right line thence to the summit of Mount Egmont; towards the West generally by a right line to the source of the Waiwakaiho River, and by that river to the ocean; and towards the North-west by the ocean.

NEW PLYMOUTH.

This district is bounded towards the West and North-west by the ocean; towards the East by the Taranaki Electoral District, hereinbefore described; and towards the South-east by a right line from the summit of Mount Egmont to the source of the Okehu Stream, and by that stream to the ocean.

EGMONT.

This district is bounded towards the North-west by the New Plymouth Electoral District, hereinbefore described; towards the North-east and North by the Taranaki Electoral District, hereinbefore described; towards the East generally by the Patea River and the Borough of Patea to the ocean; and towards the South-west by the ocean.

WANGANUI.

This district is bounded towards the North-west by the Kai Iwi Native Block; towards the North-east generally by the Puketotara Stream to Section No. 246, Block I., Westmere Survey District; thence by the said Section No. 246 and Sections Nos. 247 and 171 of the said Block I., by Sections

Nos. 158, 93, 92, 112, 111, 110, and 109, Block II., of the said Westmere Survey District to the south-east corner of the last-mentioned section; again towards the North-west generally by the said Sections Nos. 109, 110, 111, and 112, and by Sections Nos. 113, 135, 136, and 61 of Block II. aforesaid, by Sections Nos. 71, 70, the Ngaturi Native Reserve, and Sections Nos. 192, 207, 204, and 203, Waipakura Survey District, to the Wanganui River; towards the East generally by the said Wanganui River to a point due west of the mouth of the Kukuta Stream; towards the North by a right line to that stream; thence by the said Kukuta Stream and Section No. 158a, Ikitara Survey District; towards the South-east generally by Sections Nos. 122a, 120, and 292, Block II., of the said Ikitara Survey District, to Long Acre Road, by that road; and Sections Nos. 83, 82, and 81, Block II. aforesaid, and Sections Nos. 80 and 79, Block I., Ikitara Survey District aforesaid, to No. 3 Line, by the said No. 3 Line and Sections Nos. 65 and 44 to No. 2 Line, by the Manawakowara No. 2 Block, the Kohipo, and the Riri-a-te-hore No. 2 Block, and the Waitahanui No. 3 Block to the Great North-western Road, by that road to the Awarua Stream, by that stream to the Wanganui River, and by the left bank of said Wanganui River to the ocean; and towards the South-west by the ocean.

WAITOTARA.

This district is bounded towards the North-west generally by the Electoral Districts of Egmont and Taranaki, hereinbefore described; towards the North by the Electoral Districts of Waipa and Tauranga, hereinbefore described; towards the South-east generally by the summit of the Kaimanawa Range to Trig. Station No. 28, Kaimanawa Survey District; thence by a right line to Trig. Station No. 24, on Te Kotete; thence by a right line to Trig. Station No. 17; thence by a right line to Trig. Station No. 16; thence by a right line to Trig. Station No. 32; towards the South by a right line to the confluence of the Panemango and Tamakomako Rivers; thence by the southern boundary of the Ruanihi Block to Te Rere-a-maru; and thence by a right line to the trig. station on Maungakaretu; again towards the South-east generally by right lines from hill to hill along the summit of the eastern watershed of the Wangaehu River to a line being the production of the north-eastern boundary-line of Block No. 249, Wangaehu Survey District; thence by a right line to the northernmost corner of the said Block No. 249 aforesaid; thence by the north-eastern boundary-line of that block and the north-eastern boundary-line of Block No. 247 to the eastern boundary-line of the latter block, by Blocks Nos. 264, 263, 260, 1 of 258, 252, 210, 211, 56, 76, 75, 74, 284, 283, 197, 196, 194, 70, 69, 63, and 22, all of the said Wangaehu Survey District, by Sections Nos. 21, 25, 28, 32, 36, 35, 34, 37, 98, 97, and 117, Rangitoto Survey District, and Sections Nos. 165 and 167, Kotiata Survey District, and the north-western boundary-line of the last-mentioned section produced to the ocean; towards the South-west generally by the ocean to the Wanganui Electoral District, hereinbefore described, by that electoral district, and again by the ocean.

NAPIER.

This district is bounded towards the North and East by the ocean from the Pilot Station to a point in line with the southern boundary-line of Section No. 586, Town of Napier; towards the South by a right line to and along that section and its production to the Inner Lagoon; towards the West and again towards the South and West by the said lagoon to Pandora Point; thence by a right line to the beacon on the most westerly point of Maori Island; and thence by a right line to the Pilot Station.

HAWKE'S BAY.

This district is bounded towards the North-west by the Electoral Districts of Waitotara and Tauranga, hereinbefore described; towards the North-east generally by the East Coast Electoral District, hereinbefore described; towards the East generally by Hawke's Bay to the Napier Electoral District, hereinbefore described, by that electoral district, and again by Hawke's Bay; towards the South-east generally by the Waikahu, Te Punga, and the Pakowhai Blocks to the Tutaekuri-Waimate Stream, by that stream to the Ngaruroro River, and by that river to a point in line with the south-western boundary-line of Section No. 30, Havelock Suburban; again towards the North-east by a right line to that boundary-line, and by the said Section No. 30 and Sections Nos. 13 and 8; again towards the South-east by Sections Nos. 7, 6, 5, and 4; towards the South-west by the said Section No. 4 and Sections Nos. 14 and 27 to the said Ngaruroro River; again towards the South-east generally by the Ngaruroro River aforesaid to the south-western corner of south suburban section of Havelock No. 8; thence by the southern boundary of that section to Te Aute Road; thence by that road to where it crosses the railway-line at Pakipaki; thence by the railway-line to the Pukekura West Block; thence by that block, the Roto-a-

kiwa Lake, and by the College land; again towards the South-west generally by the last-mentioned boundary and Blocks Nos. 13, 142, 12, 141, 11, and 140, Maraekakahu Survey District, to the north-western corner of the said Block No. 140; thence by a right line to the Mangaonuku River, at the westernmost corner of Block No. 24, Maraekakahu Survey District; thence by a line along the middle of the Mangaonuku River to its source, by Blocks Nos. 3 and 1, Maraekakahu and Wakarara Survey Districts, by Blocks Nos. 1 aforesaid and 5 to the Mangamau River, and by a line along the middle of that river to its source; thence by a right line to the junction of the Makarora River with the north branch of the Waipawa River; thence by a right line to Trig. Station No. 30, on Aorangi; and thence by a right line to Trig. Station No. 32.

WAIPAWA.

This district is bounded towards the North-east and North-west generally by the Hawke's Bay Electoral District, hereinbefore described; again towards the North-east and towards the South-east by the ocean and the right bank of the Porangahau River, by the Mangaoraka Stream to its confluence with the Tangaruhe Stream, and by the latter stream to its source; thence by a right line to the easternmost corner of the Mangatoro Block; thence by a right line over Trig. Station No. 27 to the Mangapuaka Stream at the south-western corner of Block No. 77, in the Mangatoro Survey District; thence by the said Mangapuaka Stream to its confluence with the Wangai Stream; again towards the North-west by the said Wangai Stream to the Whatatuna Stream, and by the said Whatatuna Stream to the southern boundary-line of Block No. 83 in the Takapau Survey District, by that boundary-line to the Mangapurakau Stream; thence by that stream and the Waikopiro Stream to the north-western boundary-line of Block No. 69, in the Takapau Survey District; again towards the North-west by that boundary-line to the south-western boundary-line of Block No. 120, in the Ruataniwha Survey District; thence by the south-western and north-western boundary-lines of that block and the southern and western boundary-lines of Block No. 234 to the Makaretu River, by that river to its source; and thence by a right line due west to the summit of the Ruahine Range; and towards the West by the summit of the said Ruahine Range.

RANGITIKEI.

This district is bounded towards the North-west by the Electoral Districts of Waitotara and Hawke's Bay, hereinbefore described; towards the East by the Waipawa Electoral District, hereinbefore described, to a point due east of the source of the Oroua River; towards the South-east generally by a right line to the source of the said Oroua River, and thence by that river to the Borough of Feilding; towards the South-west generally by the said Borough of Feilding to Section No. 47, Block X., Oroua Survey District, by the said Section No. 47 and Sections Nos. 46, 45, 44, 43, 42, 41, 40, 39, 38, 37, and 53, and the road-line forming a portion of the north-eastern boundary of the said Section No. 53 produced to the road forming the north-western boundary of Section No. 1, Block V., Oroua Survey District; again towards the North-west generally by that road and its continuation to the Town District of Halcombe, by the said Town District of Halcombe, and the road fronting Sections Nos. 66, 67, 68, 69, 70, 71, 72, and 73, Block IX., Oroua Survey District, and Sections Nos. 79 and 81, Block XII., Rangitoto Survey District, and by Sections Nos. 89 and 88 of the said Block XII. to the County of Manawatu; again towards the South-west by the said County of Manawatu to the Rangitikei River; again towards the South-east by the said Rangitikei River to the ocean; and towards the West by the ocean.

MANAWATU.

This district is bounded towards the North-west generally by the Rangitikei Electoral District, hereinbefore described, from the County of Manawatu to the summit of the Ruahine Range; towards the South-east by the Waipawa Electoral District, hereinbefore described, and the summit of the Ruahine Range, across the Manawatu River, and by the summit of the Tararua Range to a point in line with the north-eastern boundary-line of Section No. 274, Arawaru Survey District; towards the South-west by a right line to the said Section No. 274, by that section to the road forming its north-western boundary, and by that road continued past Sections Nos. 263, 261, and 259 of the said Arawaru Survey District, Sections Nos. 258, 288, 257, 255, 181, 182, 183, 184, 185, 186, 209, 208, 204, and 205, Block XV., Kairanga Survey District, to the Manawatu River; towards the South by that river; again towards the South-west and North-west by the south-western and north-western boundary-lines of the Borough of Palmerston North and the road forming the south-eastern boundary of Sections Nos. 1535, 526, 509, 1531, and 508, Block VII., Kairanga Survey District; again towards the South-west by the road forming the southern boundaries of Sections Nos. 13, 12, 11, 10, 9, 8, 7, 6, 5, and 56, Manchester Block, to the railway-line, and by the railway-line to

the Oroua River; thence across that river and by the County of Manawatu to the Electoral District of Rangitikei.

FOXTON.

This district is bounded towards the North-west by the Rangitikei Electoral District, hereinbefore described; towards the North-east generally by the said Rangitikei Electoral District and the Manawatu Electoral District, hereinbefore described, to the summit of the Tararua Range; towards the South-east by the summit of the said Tararua Range; towards the South by the County of Hutt to the watershed between the Waikanae and the Akatarawa Rivers, and by that watershed and the western watershed of the Akatarawa and the Hutt Rivers, over Trig. Stations Maungani and Titi, to Wainui Trig. Station; thence by a right line to the north-eastern corner of Section No. 48, Horokiwi Valley, Block III., Paikakariki Survey District, and by the said Section No. 48 and the southern boundary-line of the Tunupo Block to the ocean; and towards the West by the ocean: including Kapiti Island.

WOODVILLE.

This district is bounded towards the North-east generally by the Waipawa Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South-west by the County of Wairarapa North to the summit of the Puketoi Range; again towards the South-east generally by the summit of the said Puketoi Range to Puketoi Trig. Station; thence by a right line to the north-western corner of Section No. 50, Puketoi Survey District, by that section and Section No. 51 to the Tiraumea River, by that river to its confluence with the Waitawhiti Stream, by the said Waitawhiti Stream to Section No. 174 of the said Puketoi Survey District, by the said Section No. 174, and Section No. 175, and the western boundary-line of the latter section produced to the Taueru River, by that river to a point in line with the northern boundary-line of Section No. 143, Block II., Mangapakeha Survey District, by the said Section No. 143 and its northern boundary-line produced to the dividing-line between the College and the Educational Reserves; thence by the latter reserve, and Section No. 131, Block I., Mangapakeha Survey District; again towards the South-west generally by Sections Nos. 21, 17, 18, 101, and 100, Block IV., Kopuaranga Survey District, by a public road and the Wangaeahu Valley Road to a point in line with the northern boundary-line of Section No. 103, Block III., of the said Kopuaranga Survey District, and by a right line bearing 295° 30' magnetic from the last-mentioned point to the Tararua Range; and towards the North-west by the summit of the said Tararua Range.

MASTERTON.

This district is bounded towards the North-west generally by the Woodville Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South-west generally by the County of Wairarapa South; and again towards the North-west by the summit of the Tararua Range.

WAIRARAPA.

This district is bounded towards the North-east generally by the Masterton Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South-west by Palliser Bay to Cape Turakuru; and towards the North-west by the summit of the Rimutaka Range and the summit of the Tararua Range.

HUTT.

This district is bounded towards the North-west generally by the Foxton Electoral District, hereinbefore described; towards the South-east by the Wairarapa Electoral District, hereinbefore described; towards the South-west generally by Cook Strait and Port Nicholson to a point in line with the north-eastern boundary-line of Section No. 12, Block XII., Belmont Survey District, by a right line to that section; thence by Section No. 12 aforesaid to the Town District of Johnsonville, by the said Town District of Johnsonville, by Section No. 91 (Native reserve), Section No. 13 (Native reserve), Block III., Port Nicholson Survey District, and Section No. 12 (Native reserve), and Sections Nos. 68, 70, and 112 of Block I. of the said Port Nicholson Survey District to Cook Strait; and again towards the North-west by Cook Strait: including Mana Island and Somes Island.

WELLINGTON SOUTH AND SUBURBS.

This district is bounded towards the North-east by the Hutt Electoral District, hereinbefore described; towards the South-east by Port Nicholson to the northern boundary of the City of Wellington; towards the South-west and again towards the South-east by the said City of Wellington to the westernmost corner of Section No. 56, Tinakori District; thence by the Orangikaupapa Native Reserve; towards the South by Section No. 30, Block VI., Port Nicholson Survey District; again towards the North-east generally by the said

Section No. 30, and Sections Nos. 29 and 28, Upland Farm, of the said Block VI., to the boundary of the said City of Wellington, and again by the City of Wellington to a point in line with the western boundary-line of Section No. 685, in the City of Wellington; towards the North-west generally by a right line to that section; and thence by Section No. 33, by Bidwell Street and Wallace Street; again towards the North generally by the Mount Cook Barracks Reserve to Tasman Street, by the said Tasman Street, Drummond Street, the Adelaide Road, by Sections Nos. 746, 14, 13, and 12, by the boundary-line between the College Reserve and the Asylum and Hospital grounds, and by Section No. 6, Mount Victoria, to the boundary of the City of Wellington; towards the West by the City of Wellington aforesaid to Port Nicholson, and by the said Port Nicholson; towards the East generally by the waters of Port Nicholson; and again towards the South-east, South-west, and North-west by Cook Strait.

THORNDON.

This district is bounded towards the West and North-west generally by the Wellington South Electoral District, hereinbefore described; towards the East generally by the waters of Port Nicholson to the Queen's Wharf; thence by Customhouse Street and Willis Street to Dixon Street; towards the South generally by the said Dixon Street, by Woolcombe Street, Abel Smith Street, and a right line from the western corner of Section No. 431 to the south-eastern corner of Upland Farm; thence by the southern boundary of the said Upland Farm to the north-western boundary of the City of Wellington; and thence by the Wellington South and Suburbs Electoral District aforesaid.

TE ARO.

This district is bounded towards the North-west generally by the Thorndon Electoral District, hereinbefore described, to the north side of Grey Street, and by the north side of the said Grey Street produced to the waters of Port Nicholson; towards the North-east by the waters of Port Nicholson to a point in line with the eastern boundary-line of Section No. 220, in the City of Wellington; towards the East generally by a right line to that section; thence by Section No. 221, by Courtenay Place, Tory Street, Vivian Street, and Taranaki Street to Hankey Street; and thence again towards the East and towards the South-west generally by the Wellington South and Suburbs Electoral District, hereinbefore described.

WELLINGTON EAST.

This district is bounded towards the North-west by the waters of Port Nicholson; towards the East and South generally by the Wellington South and Suburbs Electoral District, hereinbefore described; and towards the West by the Te Aro Electoral District, hereinbefore described.

NELSON.

This district is bounded towards the North-west and North by the sea from the lighthouse on Boulder Bank; towards the East by the south-west angle of Section No. 1, Suburban North District; thence by the south-western boundary of said Section No. 1; thence by the north-west, west, south, and east boundaries of Section No. 60, Suburban North District aforesaid, and by the east, south, and part of the south-east boundaries of Section No. 59, Suburban North District; thence by the south-west boundary of Section No. 11, Brook Street and Maitai Districts, to the bank of the River Maitai; thence by the western bank of the said river to a point on the prolongation of the west boundary of Section No. 11, Maitai District; thence along the western boundary of said Section No. 11 to the south-west corner thereof; thence by part of the south boundary of the said section to its intersection with the western boundary of Section No. 20, Maitai District; thence along the said western boundary of said Section No. 20, Maitai District, and the western boundary of Section No. 23, Maitai District, and the north-western boundaries of Sections Nos. 21 and 24, Maitai District; thence along the line dividing Section No. 24, Maitai District, from the Suburban Section No. 1, Brook Street Valley District; thence along the southern boundary of part Section No. 34, Maitai District, Section No. 27, Brook Street Valley District, and the other part of Section No. 34, Maitai District aforesaid; thence along the north-western boundary of part of Section No. 34 aforesaid, Section No. 16, Square No. 18, to a point on a public road forming the north-eastern boundary of Section No. 35, Maitai District aforesaid; thence along the north-western boundary of Section No. 21 and that line produced until intersected by the production of the south-western boundary of Section No. 1, Brook Street Valley and Maitai Districts aforesaid; thence along the said line to a public road, forming the remainder of the south-western boundary of said Section No. 1, Brook Street Valley District aforesaid; thence along the continuation of said public road to the south-western

corner of Section No. 10, Maitai and Brook Street Valley Districts aforesaid; thence along the north-western boundaries of the said Section No. 10, and Sections Nos. 8 and 7, Maitai and Brook Street Valley Districts aforesaid, to the north-western corner of said Section No. 7, Maitai and Brook Street Valley Districts aforesaid; thence along the north-easterly boundaries of Sections Nos. 12, 7, 6, 11, and part of 12, Suburban South District, to the Britannia Heights; thence by the eastern boundaries of Sections Nos. 4 and 1, Suburban South District aforesaid, to the eastern corner of the said Section No. 1, Suburban South District aforesaid; thence along the north-eastern boundary of said Section No. 1, Suburban South District aforesaid, to high-water mark, Nelson Haven; thence by a line to the south-western angle of Fifeshire Island; and thence by the outer edge of the Boulder Bank to the starting-point.

WAIMEA-PICTON.

This district is bounded towards the North-west generally by the sea to the Nelson Electoral District, hereinbefore described, by that electoral district, and again by the sea; towards the North-east and East generally by Cook Strait to the Wairau River; towards the South-east by the said Wairau River to its intersection by a right line drawn between Barefell Pass and Top House, Wairau Valley; towards the South-west by a right line thence to the said Top House; again towards the North-west generally by a right line to the summit of Ward's Pass; and thence by the summit of the watershed between the Wairau River and Tasman Bay to the Red Hills, at the source of the Pelorus River, and by that river to the southern boundary-line of Square No. 18, Maungatapu Survey District; towards the South by the said boundary-line until it intersects a line bearing S. 45° W. from the production easterly for a distance of two miles of the north-eastern boundary-line of Section No. 18, Waimea Survey District; again towards the South-east by the last-mentioned line to the River Lee; and towards the West by the said River Lee, the Roding River, the Wairoa River, and the Waimea River to the ocean: including D'Urville, Arapawa, Rabbit, and other adjacent islands.

MOTUEKA.

This district is bounded towards the North-east by Tasman Bay; towards the East generally by the Waimea-Picton Electoral District, hereinbefore described, and the summit of the St. Arnaud Range to a point near the head-waters of the Motupiko River; towards the South-west by the County of Inangahua; and towards the North-west generally by the Counties of Buller and Collingwood respectively.

BULLER.

This district is bounded towards the North-west by the ocean; towards the North-east generally by Golden Bay and Tasman Bay; towards the South-east by the Motueka Electoral District, hereinbefore described, and the County of Inangahua to the Buller River; and towards the South by the said Buller River to the ocean.

WAIRAU.

This district is bounded towards the North-west by the Waimea-Picton Electoral District, hereinbefore described; towards the East by the ocean to the Clarence River; towards the South-east and South-west by the said Clarence River to its source, and by a right line thence due north to the summit of the Spenser Mountains; and again towards the North-west by the summit of the said Spenser Mountains, the summit of the St. Arnaud Range, and the Motueka Electoral District, hereinbefore described.

INANGAHUA.

This district is bounded towards the North-west and North-east by the Electoral Districts of Buller and Motueka, hereinbefore described; towards the South-east by the Wairau Electoral District, hereinbefore described, and the summit of the Spenser Mountains to the saddle between the Hurunui River and the Teremakau River; towards the South-west generally by a right line thence in the direction of the outflow of the Arnold River from Lake Brunner as far as the summit of the range between the Haupiri River and the Ahaura River, by the summit of the range between the said Haupiri and Ahaura Rivers to their confluence; thence by the Haupiri River aforesaid and by a creek to the Ahaura Lake; thence by the said Ahaura Lake and the summit of the watershed between Nelson Creek and Red Jack's Creek to the Grey River; thence across that river and by the summit of the range between Moonlight Creek and Blackball Creek to the summit of the Paparoa Range, by the summit of the said Paparoa Range to the source of Razorback Creek, and by the said Razorback Creek to the ocean; and again towards the North-west by the ocean.

GREYMOUTH.

This district is bounded towards the North-east generally by the Inangahua Electoral District, hereinbefore described, to a right line drawn between the Hurunui Saddle and the outflow of the Arnold River from Lake Brunner; towards the South-west generally by that line to the said Arnold River; thence by Lake Brunner to Te Kinga No. 3 Trig. Station; thence by the summit of the eastern watershed of New River and of German Gully and the western watershed of Maori Gully to Mount Fox; thence by the summit of the watershed over Mount Riley to Rata-tree Peak; thence by a line due south to Card's Creek; thence by Card's Creek and New River to Road and Railway Reserve No. 6; thence by the said road and railway reserve to the Teremakau River, and by the said Teremakau River to the ocean; and towards the North-west by the ocean.

KUMARA.

This district is bounded towards the North-east generally by the Greymouth Electoral District, hereinbefore described; towards the South-east by the summit of the Southern Alps to Whitcombe's Pass; thence towards the South-west generally by the Pass River and the Hokitika River to the confluence of the Kanieri River; thence by a line running in the direction of the southern end of the Kanieri Lake Water-race Tunnel until intersected by the southern boundary-line of Reserve No. 65 produced through the Big Paddock; again towards the South-west by the last-mentioned line and its production to the ocean; and towards the North-west by the ocean.

HOKITIKA.

This district is bounded towards the North-east by the Kumara Electoral District, hereinbefore described; towards the South-east by the summit of the Southern Alps to Mount Aspiring; towards the South-west by a right line thence to the mouth of the Awarua River; and towards the North-west by the ocean.

CHEVIOT.

This district is bounded towards the North-east and North-west generally by the Wairau Electoral District, hereinbefore described; towards the South-east by the ocean to the Ashley River; towards the South-west generally by that river to its confluence with the Makerikeri River, and by the latter river and Rural Sections Nos. 34532, 33439, 34719, and a road to Rural Section No. 23770; thence by that section and a right line to Mount Grey, and by the summit of the watershed over Mount Karatu, the Okuku Range, Gola Peak, Ashley Head, Seaward Head, Esk Head, and the High Snowy Range to the Southern Alps; and again towards the North-west by the Kumara and Inangahua Electoral Districts, hereinbefore described.

ASHLEY.

This district is bounded towards the North-east generally by the Cheviot Electoral District, hereinbefore described, to the Main Trunk Railway-line, by the said railway-line to the Borough of Rangiora, by the said Borough of Rangiora, and again by the said main trunk railway-line to and across the north branch of the Waimakariri River to Kaiapoi Island; towards the South-east by the said Kaiapoi Island to the Waimakariri River; towards the South and South-west by the said Waimakariri River to a line formerly known as the northern boundary of Run No. 270; and towards the North-west generally by the last-mentioned line and by the summit of the Puketeraki Range and the summit of the range leading to Ashley Head.

KAIAPOI.

This district is bounded towards the North-west by the Cheviot Electoral District, hereinbefore described; towards the East by the ocean; towards the South-east by the south branch of the Waimakariri River (Stewart's Gully); and towards the West by the Ashley Electoral District, hereinbefore described.

AVON.

This district is bounded towards the North-west by the Kaiapoi Electoral District, hereinbefore described; towards the East by the ocean; towards the South-west by the Avon Estuary and the River Avon to the road which forms the north-eastern boundary of Rural Section No. 1068; thence by that road along the northern shore of Horseshoe Lake and the northern boundary of Rural Sections Nos. 1327, 2550, 1140, and 1135 to Hill's Road; thence again towards the East by the said Hill's Road to the road forming the northern boundary of Rural Section No. 1119; towards the South by that road continued to Rural Section No. 313; towards the South-east by Rural Section No. 1048 and the road which forms the southern boundary of Rural Sections Nos. 308, 304, 151, and 1101; thence by the Wairapa Road to Rural Section No. 436; thence by the road forming the western boundary of Sections Nos. 2201, 563, and 115; again towards the East by the road forming

the western boundary of Rural Sections Nos. 12, 85, and 180 to the Main Trunk Railway; towards the North by the said railway to the Borough of Sydenham; again towards the East by the said Borough of Sydenham and Colombo Road to the River Heathcote; again towards the South by the said River Heathcote and the Canal Reserve to Rural Section No. 393; towards the West by the Halswell Junction Road to the Southbridge Railway; and again towards the West by that railway and the Prebbleton and Kaiapoi Junction Road to the left bank of the Waimakariri River.

LINWOOD.

This district is bounded towards the North by the Avon Electoral District, hereinbefore described; towards the East by the River Avon and the road forming the south-western boundary of Rural Section No. 326; towards the South-east by the road forming the western boundary of Rural Sections Nos. 347 and 84; towards the South-west by Ferry Road; towards the West by the City of Christchurch and the East Town Belt Road; again towards the North by the North Avon Road; and again towards the West by Hill's Road to the north-western corner of Rural Section No. 1135.

HEATHCOTE.

This district is bounded towards the North and North-east by the Avon Electoral District, hereinbefore described, and the Heathcote Estuary; towards the South by the said Heathcote River and Tennyson Street to the Borough of Sydenham; towards the West by Colombo Road; again towards the North by Brougham Street; again towards the West by Waltham Road; again towards the North by the South Town Belt of the City of Christchurch; again towards the West by the East Town Belt of the said city; and towards the South-west and West by the Electoral District of Linwood, hereinbefore described.

ST. ALBANS.

This district is bounded towards the West and North by the Avon Electoral District, hereinbefore described; towards the East by the Linwood Electoral District; towards the South by the North Town Belt of the City of Christchurch; again towards the East by the River Avon and Lincoln Road; and towards the South by the Main Trunk Railway.

CHRISTCHURCH NORTH.

This district is bounded towards the North by the North Town Belt; towards the East by the East Town Belt; towards the South by a line along the Middle of Worcester Street produced through Latimer Square and Cathedral Square; again towards the East by the middle of Antigua Street; and again towards the South and towards the West by the River Avon to the North Town Belt.

CHRISTCHURCH SOUTH.

This district is bounded towards the North by the Christchurch North Electoral District, hereinbefore described; towards the East by the East Town Belt; towards the South by the South Town Belt; and towards the North-west by Lincoln Road and Antigua Street to the River Avon.

SYDENHAM.

This district is bounded towards the North by the City of Christchurch; towards the East by Waltham Road; towards the South by Brougham Street; again towards the East by Colombo Road; towards the South-west by Strickland Street, Jackson's Creek, Douglas Jerrold Street, and Bright's Road; and towards the North-west by Lincoln Road.

LYTTELTON.

This district is bounded towards the North generally by the Heathcote Electoral District, hereinbefore described, and the Ocean to Big Bay; towards the South-east by a road passing through Rural Sections Nos. 27872, 33229, 24754, 24758, and 24762 to the southern boundary-line of the last-mentioned section; thence by Rural Sections Nos. 24930, 33464, and 33233 to Rural Section 28291; thence by the northern boundary-line of the last-mentioned section to a road intersecting it; thence by that road and its continuation to the Purau and Akaroa Road; towards the South-west generally by that road and the Mount Herbert Peak Road to the production of a line drawn between Mount Herbert and Herbert Peak; thence by a right line over Herbert Peak to Mount Herbert, by a right line thence through Trig Station L1 to the summit of the Port Hills; towards the West by the summit of the Port Hills to Dyer's Pass Road, by that road to the Heathcote River, and by the Colombo Road to Tennyson Street, in the Borough of Sydenham.

AKAROA.

This district is bounded towards the North generally by the Electoral Districts of Avon and Lyttelton, hereinbefore described; towards the North-east, East, and South by the

ocean; towards the West by Lake Ellesmere and the Selwyn River to the Southbridge Railway-line; towards the North-west generally by that railway to Lincoln Railway-station, by the Lincoln Road to the River Halswell, and by the said River Halswell to Rural Section No. 407; and thence by that section and Rural Section No. 393 to the Avon Electoral District, hereinbefore described.

LINCOLN.

This district is bounded toward the North-east by the Cheviot Electoral District, hereinbefore described; towards the South-east and again towards the North-east by the Ashley Electoral District, hereinbefore described; towards the East by the Electoral Districts of Avon and Akaroa, hereinbefore described; towards the South-east by the River Selwyn and the River Hawkins to the source of the latter, near Trig. Station H, Kowai Survey District; thence by a right line to the southern extremity of Lake Lyndon; thence by the summit of the watershed over Coleridge Pass, Mount Enys, Mount Olympus, and Hamilton Peak to a point due east of Mount Chamberlain; towards the South by a right line to the said Mount Chamberlain; and towards the North-west by the summit of the Southern Alps, over Mount Rolleston and Mount Franklyn.

SELWYN.

This district is bounded towards the North-east by the Electoral Districts of Lincoln and Akaroa, hereinbefore described; towards the South-east by Lake Ellesmere and the ocean; towards the South-west by the Rakaia River to the summit of the Southern Alps; and towards the North-west by the summit of the said Southern Alps.

ASHBURTON.

This district is bounded towards the North-east by the Selwyn Electoral District, hereinbefore described; towards the South-east by the south boundary-line of the Rakaia Ferry Reserve and by Rural Sections Nos. 7131 and 7132 to the Great South Road, by that road to the Main Trunk Railway, and by that railway to the Borough of Ashburton; towards the North-east, South-east, South-west, and North-west by lines so as to include the said Borough of Ashburton, the Town District of Hampstead, and the Town District of Tinwald; again towards the South-west by the River Ashburton and its south branch to its source; thence by a line to and along the summit of the watershed over Mount Arrowsmith, Mount Gould, and Mount Goethe to the summit of the Southern Alps; and again towards the North-west by the summit of the said Southern Alps.

RANGITATA.

This district is bounded towards the North-east and North-west by the Ashburton Electoral District, hereinbefore described; again towards the North-east by the Selwyn Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South-west generally by the Ophi River, the Tumuku River, and the Taumatakahu Creek to the Town District of Arowhenua, by that town district to the Southern Trunk Railway, by that railway to the road forming the north-eastern boundary of Rural Section No. 5961; thence by that road and its continuation past Sections Nos. 11526 and 9031 to the Geraldine Road; thence by that road to Boundary Road, by that road to the Hae Hae Te Moana River, by that river and its east branch to its source; thence by the summit of the watershed over Trig. Stations A, B, and J, Four Peaks Survey District, and Trig. Stations K and L, Opuha Survey District, to and over Fox Peak to the Two-thumb Range, and by the said Two-thumb Range to the summit of the Southern Alps, near Mount Tyndall; and towards the North by the summit of the said Southern Alps.

TIMARU.

This district is bounded towards the North-east by the ocean to a point due east of the mouth of the Otipua Creek; towards the South by a right line to the mouth of that creek; towards the South-west by the Otipua Creek to the road forming the north-western boundary of Rural Section No. 1690; towards the North-west by that road and its continuation to the road forming the south-western boundary of Rural Section No. 2015; again towards the South-west by the last-mentioned road and its continuation to Wai-iti Road; towards the South by the said Wai-iti Road to the road forming the western boundaries of Rural Sections Nos. 4966 and 3989 to the Upper Washdyke Road; again towards the South by the last-mentioned road; again towards the West by a road forming the western boundary of Rural Section No. 3301 and its production to the Washdyke Flat Road; towards the North by the said Washdyke Flat Road to the Main South Road; again towards the North-east by the last-mentioned road to Washdyke Creek, and by that creek and the Waitarakao Lagoon.

GLADSTONE.

This district is bounded towards the North-east generally by the Rangitata Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South generally by the Timaru Electoral District, hereinbefore described, the Washdyke Flat Road, and the road forming the northern boundary of Rural Sections Nos. 10468, 10465, 18253, 17826, 27662, 14825, 17196, 14115, 14116, 14142, 18258, 15761, 15758, 22421, 31993, 26488, 20897, 18871, and 33830 to the Tygho Flat Road, by that road to the road forming the northern boundary of Rural Section No. 18972; thence by that road and its continuation past the said Section No. 18872 and Rural Sections Nos. 18873, 21787, 25588, 20970, and Rural Section No. 28823, through Rural Section No. 3277, and past Rural Sections Nos. 28823 aforesaid, 20634, 28826, 20635, 28824, and 20636 to the southern-most corner of Rural Section No. 25597; thence by the southern boundary-lines of Rural Sections Nos. 25597, 28825, 20259, 28532, 20257, and 28533 to the south-west corner of the last-mentioned section; thence by a right line to the north-east corner of Rural Section No. 28821; and thence by that section and Rural Sections Nos. 30443, 28462, and 21213 to the road forming the western boundary of the last-mentioned section; again towards the North-east by the County of Geraldine to the Pareora River; towards the South generally by the County of Waimate to the Waitaki River; towards the West generally by the County of Waitaki to the summit of the Southern Alps; and towards the North-west by the summit of the Southern Alps.

WAIMATE.

This district is bounded towards the North by the Gladstone Electoral District, hereinbefore described; towards the East by the Timaru Electoral District, hereinbefore described, and the ocean to the Waihao River; towards the South and West by the said Waihao River and its north branch to its source; and thence by a right line to Mount Nimrod.

WAITAKI.

This district is bounded towards the North-east generally by the Electoral Districts of Gladstone and Waimate, hereinbefore described; towards the East by the ocean to the Landon Creek; towards the South-west by that creek to the northern boundary of Block I., Oamaru Survey District; thence by the said Block I. and Block II. to the Oamaru Stream; again towards the East by the said Oamaru Stream to the northern boundary-line of Block IV., Oamaru Survey District; towards the South and again towards the East by the said Block IV., and by Sections Nos. 38, 37, 36, 35, and 34, Block VI., Oamaru Survey District, and the western boundary-line of the last-mentioned section produced to the ocean; again towards the East by the ocean to the creek at the southern boundary of the Quarry Reserve in Block IV., Otepopo Survey District; again towards the South generally by that creek and the Allday Road, being the northern boundary of Sections Nos. 20, 19, 18, 17, 16, 15, 14, 13, 12, 11, 10, and 9, Block III., Otepopo Survey District, and of Sections Nos. 73, 77, 76, 75, 74, and 54, Block V., Otepopo Survey District, to the Main North Road, by that road to the northern boundary of the said Block V., by Block V. aforesaid, and Blocks VIII. and XIV., and the northern boundary-line of the last-mentioned block produced to the summit of the Kakanui Mountains; towards the South-west by the summit of the Kakanui Mountains, through the Maruenua Pass, to Kyeburn Hill; thence by the summit of the Mount Ida and Hawkdun Mountains to a point due east from Mount St. Bathans; thence by a line due west to Mount St. Bathans; and thence by the summit of the range through Lindis Pass over Longslip Hill to Mount Ward; and towards the North-west by the summit of the Southern Alps.

OAMARU.

This district is bounded towards the West, North, and North-east by the Waitaki Electoral District, hereinbefore described, from the western boundary-line of Section No. 34, Block VI., Oamaru Survey District, to the mouth of the Landon Creek; and towards the South-east by the ocean.

WAIHEMO.

This district is bounded towards the North by the Waitaki Electoral District, hereinbefore described; towards the South-east by the ocean and Blueskin Bay to the northern boundary-line of Block II., North Harbour and Blueskin Survey District; towards the South by the said Block II. and a line due west from the north-west corner of that block to the south branch of the Waikouaiti River; again towards the South-east by the south branch of the Waikouaiti River to the northern boundary-line of Block III., North Harbour and Blueskin Survey District; again towards the South by the said Block III. and Block X., Silverpeak Survey District; towards the West generally by the said Silverpeak Survey District to the summit of the Silverpeak Range; thence by the summit of the range over Trig. S, Waikouaiti Survey

District, Trig. W, Silverpeak Survey District, Trigs. R and HH, Waikouaiti Survey District, Trig. E, Hummockside Survey District, and Trigs H and F, Hummockside Survey District, to Little Hummock; thence by a right line to the nearest affluent of the Waikouaiti River, by that affluent to the north branch of the Waikouaiti River; thence by the said north branch to the north-western boundary-line of the Hawksbury Hundred; thence by that line to the Waihemo or Shag River, and by that river to the eastern boundary-line of Section No. 21, Dunback Survey District, by the said Section No. 21 and Sections Nos. 19, 18, 17, and 16 of Dunback Survey District, by Sections Nos. 42 and 27, Block III., Dunback Survey District, to the creek forming the north-eastern boundary-line of the last-mentioned section; thence by the said Block III., and Block V. of Waihemo Survey District, and by the summit of the Kakanui Mountains.

PORT CHALMERS.

This district is bounded towards the North-west and North by the Waihemo Electoral District, hereinbefore described; towards the North-east by Blueskin Bay and the ocean; towards the South-east by Otago Harbour to the south-western corner of Section No. 51, Block IX., North Harbour and Blueskin Survey District; again towards the North-west and towards the South-west by the Borough of North-east Valley to the northernmost corner of Section No. 43, Block VII., North Harbour and Blueskin Survey District; towards the West and towards the South by Block XII., North Harbour and Blueskin Survey District; again towards the West, South-west, and North-west by Block III., North Harbour and Blueskin Survey District; and again towards the South by the last-mentioned block: including the islands in the Otago Harbour and Blueskin Bay.

DUNEDIN WEST.

This district is bounded towards the North by the Electoral Districts of Waihemo and Port Chalmers, hereinbefore described; towards the North-east and South-east generally by the said Electoral District of Port Chalmers to Trig. Station E, Block IX., North Harbour and Blueskin Survey District; towards the South-west and again towards the South-east generally by the East Ward of the Borough of North-east Valley, by the Main North Road and Great King Street to Albany Street; thence by Albany Street to George Street; thence by George Street to Stuart Street; thence by Stuart Street, York Place, and the North Taieri Road to the Town Belt of the City of Dunedin; thence towards the North-west by the Boroughs of Roslyn and Maori Hill to the north-eastern corner of Section No. 1, Block VIII., Upper Kaikorai Survey District; towards the South generally by the said Block VIII. and Section No. 2, Block II., Upper Kaikorai Survey District, to the Balmacewen Road; thence by that road and the Waikari Road to the North Taieri Road, by the last-mentioned road to Whare Flat Road, and by that road to the Dunedin and East Taieri Survey District; again towards the North by the northern boundary-lines of the Borough of Roslyn; again towards the North-west generally by the western boundary-lines of the Borough of Maori Hill to Swampy Hill; again towards the South by Block V., Dunedin and East Taieri Survey District; and towards the West by Silverpeak Survey District.

DUNEDIN EAST.

This district is bounded towards the North-west and North-east by the Electoral District of Dunedin West, hereinbefore described; towards the South-east by the Port Chalmers Electoral District, hereinbefore described, and Otago Harbour; towards the South by Frederick Street, and that street produced to the Otago Harbour.

DUNEDIN CENTRAL.

This district is bounded towards the North generally by the Electoral Districts of Dunedin West and Dunedin East, hereinbefore described; towards the East by Otago Harbour; towards the South generally by Jetty Street and that street produced to Otago Harbour, by Manse Street, High Street, Clark Street, Duncan Street, Arthur Street, Canon-gate Street, Serpentine Avenue, and the Mornington Road to the boundary of the Town Belt of the City of Dunedin; and towards the North-west by the Boroughs of Mornington and Roslyn.

DUNEDIN SOUTH.

This district is bounded towards the North generally by the Dunedin Central Electoral District, hereinbefore described; towards the North-east by Otago Harbour; towards the South by the southern boundary-line of the Borough of South Dunedin and by the Borough of St. Kilda; towards the South-west by South Ward and North Ward of the Borough of South Dunedin, and by Hillside Road to the City of Dunedin; again towards the South-east by the Boroughs of Caversham and Mornington; and again towards the South-west and North-west by the said Borough of Mornington.

ROSLYN.

This district is bounded towards the North by the Electoral District of Dunedin West, hereinbefore described; towards the East by the said Dunedin West Electoral District and the Dunedin South Electoral District, hereinbefore described; towards the South generally by the Borough of Caversham; towards the North-west by the Lower Kaikorai Survey District to Section No. 114, Waikari Survey District; thence by Section No. 130 and Sections Nos. 1, 2, 3, 4, 5, 6, and 7, Waikari Survey District, to the North Taieri Road.

PENINSULA.

This district is bounded toward the North-west by Otago Harbour; towards the East and South by the ocean to the Forbury Road; towards the West by the said Forbury Road and Section No. 13, Block VI., Town District, to Surrey Road, and thence by Cargill Road; again towards the North-west by Cargill Road; towards the North-east and again towards the North-west by the Dunedin South Electoral District, hereinbefore described.

CAVERSHAM.

This district is bounded towards the East generally by the Electoral Districts of Dunedin West, Roslyn, Dunedin South, and Peninsula, hereinbefore described; towards the South by the ocean; towards the West by Block VIII., Dunedin and East Taieri Survey District, to the Main South Road; thence by that road to the road leading along the eastern watershed of the Taieri Plain; and towards the North-west by the last-mentioned road, passing near Abbot's Hill, to the North Taieri Road; and thence by the said North Taieri Road.

TAIERI.

This district is bounded towards the North by Lee Stream; towards the West by the Taieri River; again towards the North by Mulloch Gully to the southern boundary-line of the Silverpeak Survey District, and by that survey district and the Dunedin West Electoral District, hereinbefore described, to Swampy Hill; towards the East by the said Dunedin West Electoral District and the Caversham Electoral District, hereinbefore described; towards the South-east by the ocean; towards the South-west by the Taieri River, the Waipori Lake, and the Waipori River to Block X., Waipori Survey District; thence again towards the West by Blocks X., VIII., and VI. of the said survey district, and by a line due north to Lee Stream.

MOUNT IDA.

This district is bounded towards the North-east by the Waitaki Electoral District, hereinbefore described; towards the East generally by the Waihemo Electoral District and the Dunedin West Electoral District, hereinbefore described; towards the South by the Taieri Electoral District, hereinbefore described, and by Lee Stream to its source; thence by the summit of the watershed to Lammerlaw; thence by the summit of the western watershed of the Upper Taieri River to the north-eastern boundary of Run No. 262; thence by that run and Manor Burn to a point due south of Trig. F, Crawford Hills, Tiger Hill Survey District; thence by the summit of the Raggedy Ranges to the County of Maniototo; thence by the County of Vincent to Mount St. Bathans.

BRUCE.

This district is bounded towards the North-east by the Taieri Electoral District, hereinbefore described; towards the South-east by the ocean; towards the West generally by the Clutha River (Matau Branch) to the Borough of Balclutha, by that borough and the main south road to Trig. Station D, Hillend Survey District; thence by the road along the watershed through Blocks VI., III., and XI., Hillend Survey District, and that road continued to the road at the southern boundary of Section No. 27, Block IX., Waitahuna East Survey District; thence by the latter road and Sections Nos. 25, 21, and 11, Block IX. aforesaid, to the north-eastern corner of the last mentioned section; towards the North-east by Sections Nos. 34 and 29, Block IV., Waitahuna East Survey District, by the road forming the north-eastern boundary of Section No. 3, Block IX., Hillend Survey District, and by that road continued past Sections Nos. 4, 6, 9, and 12, and through Section No. 22, Block IX. aforesaid, Sections Nos. 17 and 16, Block XIII., Hillend Survey District, and past Sections Nos. 2, 3, 40, 13, 16, 20, and 19, Block VII., Hillend Survey District, through Section No. 1 of 17 of the last-mentioned block, and through Blocks XLV., XLIV., XLIII., XL., and XLII., Tokomairiro Survey District, to the Tokomairiro River; thence by that river; and again by Blocks XXV. and XXIII., Tokomairiro Survey District, and Block II., Table Hill Survey District, to the north branch of the Tokomairiro River; thence by that branch to a point due east of Trig. Station F, Table Hill Survey District; towards the South by a right line through the said trig. station to the road forming the western

boundary of Section No. 7, Block VIII., Table Hill Survey District; again towards the North-west by that road and its continuation through Block IX., Table Hill Survey District, through Block IX., Waipori Survey District, through Block X., Table Hill Survey District, through Block IX., Clarendon Survey District, and through Block X., Waipori Survey District, to the north-western boundary-line of the West Taieri Hundred; and thence by that boundary-line to the Waipori River.

TUAPEKA.

This district is bounded towards the North-east by the Mount Ida Electoral District, hereinbefore described; towards the East by the Taieri Electoral District, hereinbefore described; towards the South-east and South-west by the Bruce Electoral District, hereinbefore described, to the northernmost corner of Section No. 26, Block IX., Waitahuna East Survey District; thence by the said Block IX. to the Waitahuna River; again towards the South-east by the Waitahuna River to the Clutha River; again towards the South-west by the Clutha River to Block IX., Beaumont Survey District; towards the North by the said Block IX., and by Blocks I., II., and VIII. of Beaumont Survey District to the Tuapeka River; towards the West by the Tuapeka River to its source; thence by a right line to Lammerlaw.

DUNSTAN.

This district is bounded towards the North-west generally by a right line from Lorn Peak to Cairnmuir Hill; thence by a right line to the Clutha River at Leaning Rock Creek; thence by Leaning Rock Creek to its source; thence by a right line to Leaning Rock Hill, and by the summit of the Dunstan Mountains; towards the East generally by the Electoral Districts of Mount Ida and Tuapeka, hereinbefore described, to the mouth of the Tuapeka River; towards the South-east by a right line thence to the nearest bend of the Pomahaka River, and by that river to its source; thence by the summit of the Umbrella Mountains to a point due east of Rocky Mount; again towards the South by a right line to the said Rocky Mount, and by a right line thence to Lorn Peak.

CLUTHA.

This district is bounded towards the North by the Dunstan Electoral District, hereinbefore described; towards the North-east generally by the Electoral Districts of Tuapeka and Bruce, hereinbefore described; towards the South-east by the ocean to Chasland's Mistake; towards the West generally by a right line to Black Horn; thence by the summit of the watershed over Mount Alfred, Mouseback, and the Chimney to Catlin's Cone; thence by a right line to the source of the Waipahi River, and by that river to its confluence with the Pomahaka River.

WAKAIA.

This district is bounded towards the North by the Dunstan Electoral District, hereinbefore described; towards the East by that electoral district and the Clutha Electoral District to the main road from Matakura to Dunedin; towards the South by that road to the Town District of Matakura; thence by the said Town District of Matakura to the Waimumu Stream, by the said Waimumu Stream to a point due west of the mouth of the Charlton Stream; thence by a line due west to the Hedgehope Stream; towards the West generally by that stream to its source, by a right line thence to Ship Cone; thence by a line due north to the Otamita Stream, by that stream to the Matakura River, and by the said Matakura River; towards the North-west generally by the summit of the watershed between the said Matakura River and the Nokomai River to Lorn Peak.

MATAURA.

This district is bounded towards the North-east by the Wakaia Electoral District, hereinbefore described; towards the East generally by the Clutha Electoral District, hereinbefore described; towards the South by the ocean to Block XIV., Campbelltown Hundred; towards the West by that block and Blocks XI. and VIII., Campbelltown Hundred; again towards the South by the last-mentioned block; again towards the West by Blocks XXII. and II., Invercargill Hundred, to the Waihopai River; again towards the South by that river to Section No. 7, Block IV., Invercargill Hundred; again towards the West by the said Section No. 7, Sections No. 2 of 20, 33A, and 33 of the said Block IV. to the road forming part of the eastern boundary-line of the last-mentioned section; thence by that road continued northerly

to the Makarewa River; towards the North-west by the Makarewa River to its confluence with the Hedgehope Stream; and thence by that stream.

HOKONUI.

This district is bounded towards the North-east generally by the summit of the watershed from Hummock Peak to Eyre Peak; thence by a right line to the source of the Matakura River, by that river and the Wakaia Electoral District, hereinbefore described; towards the South-east by the Matakura Electoral District, hereinbefore described, and the Makarewa River, the New River, and the New River Estuary; towards the South-west by the ocean; and towards the West generally by the County of Wallace to the south-eastern corner of Section No. 186, Taringatura Survey District; thence by that section and Sections Nos. 280, 281, 282, 283, the northern boundary-line of Section No. 209, and the western boundary-lines of Sections Nos. 180 and 46 to Section No. 181; thence by Section No. 181 and Sections Nos. 359, 189, 49, 45, 174, and 129, all of Taringatura Survey District, to the Oreti River; thence by that river to a point due west of Hummock Peak; and towards the North by a right line to Hummock Peak.

WAKATIPU.

This district is bounded towards the North-east and North-west by the Hokitika Electoral District, hereinbefore described; towards the East by the Waitaki Electoral District, hereinbefore described; towards the South-east by the Electoral Districts of Mount Ida, Dunstan, and Wakaia, hereinbefore described; towards the South-west generally by the Hokonui Electoral District, hereinbefore described, to Hummock Peak; thence by the summit of the leading ridge to the Thomson Mountains, and by the summit of the said mountains to Round Peaks; thence by a right line to Mount Eglinton; thence by the summit of the Earl Mountains, and by a right line over the Castle to Cloudy Pass in Bligh Sound; and towards the North-west by the ocean.

WALLACE.

This district is bounded towards the North-east generally by the Wakatipu Electoral District, hereinbefore described; towards the East by the Hokonui Electoral District, hereinbefore described; and towards the South and West by the Ocean.

INVERCARGILL.

This district is bounded towards the North-west by the Waihopai River; towards the East and North by the eastern and northern boundary-lines of the Borough of Gladstone; again towards the East by the Borough of North Invercargill to the Borough of East Invercargill; again towards the North-west by the Borough of North Invercargill; towards the North-east and South-east by the north-eastern and south-eastern boundary-lines of the said Borough of East Invercargill to the Borough of Invercargill; towards the East and South by the eastern and southern boundary-lines of the said Borough of Invercargill; and towards the West by the New River Estuary.

AWARUA.

This district is bounded towards the North-west by the Hokonui Electoral District, hereinbefore described; towards the East by the Matakura Electoral District, hereinbefore described; and towards the South and South-west by the ocean: exclusive of the Invercargill Electoral District, hereinbefore described, and including Stewart and adjacent islands.
