ORDER IN COUNCIL.

At the Government House, at Wellington, this twenty-second day of November, 1887.

Present:
HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS by the one hundred and sixty-seventh section of "The Land Act, 1885," it is enacted that the Governor in Council may fix the terms and conditions upon which the lands comprised in any village settlement shall be disposed of, and the mode of payment for the same:

And whereas His Excellency the Governor of the Colony of New Zealand has, by Proclamation, set apart the lands enumerated in the Schedule hereto for sale as a village settlement:

enumerated in the Schedule hereto for sale as a village settlement:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the hereinbefore in part recited Act, and by and with the advice of the Executive Council of the Colony of New Zealand, doth hereby fix the following terms and conditions upon which the said village settlement shall be disposed of, and the mode of payment for the same, that is to say,—

1. The lands enumerated in the Schedule hereto shall be disposed of as village allotments for cash and small-farm allotments upon deferred payments.

2. The day upon which the lands shall be open for application shall be Wednesday, the twenty-first day of December, one thousand eight hundred and eighty-seven, at the Land Office, Napier.

3. The lands enumerated in the First Schedule hereto shall be sold for cash immediately on purchase, and the lands enumerated in the Second Schedule hereto shall be sold on deferred payments.

4. The lands which are disposed of by sale upon deferred payments shall be subject to the provisions relating to suburban lands of Part III. of "The Land Act, 1885."

5. No person shall be allowed to acquire more than one section upon either immediate or deferred payments.

6. The prices stated in the Schedules hereto shall be the prices at which the lands shall be open for application.

7. If there should be more than one application for any village allotment in the First Schedule the right to purchase the same shall be determined by auction amongst the applicants only; and if there should be more than one application for any small-farm allotment in the Second Schedule

the right to occupy the same shall be determined by lot amongst the applicants.

8. Each applicant for a deferred-payment section in the Second Schedule will be required to make the declaration prescribed by section one hundred and thirteen of "The Land Act, 1885," and shall at the time of application deposit with the Receiver of Land Revenue for the Hawke's Bay Land District one-tenth of the price of the allotment. Such payment shall be deemed to be a discharge of the licensefee for the six months due on the first day of January, one thousand eight hundred and eighty-eight.

9. The purchaser of any lands described in the First Schedule, upon the full payment of the purchase-money, and the purchaser of any lands described in the Second Schedule, upon the like payment, and also the fulfilment of the terms and conditions prescribed by "The Land Act, 1885," relating to land on deferred payments, will be entitled to his Crown grant, to be issued in the usual way upon payment of the fees prescribed by law.

Regulations under "The Hospitals and Charitable Institutions Act, 1885," for the Election of Members of Boards by
Contributory Local Authorities where grouped.

WHEREAS by warrant under the hand of His Excellency the Governor, bearing date the twenty-fourth day of October last, and published in the New Zealand Gazette of the twenty-eighth day of October then instant, regulations were made under "The Hospitals and Charitable Institutions Act, 1885" (hereinafter termed "the said Act"), for the election of members of the Boards of such districts as are grouped together under the provisions of the said Act and "The Hospitals and Charitable Institutions Act 1885 Amendment Act, 1886:" And whereas the annual election of such members is about

to be held, and it is expedient to make provision therefor:

Now, therefore, His Excellency Sir William Francis Drummond Jervois, the Governor of the Colony of New Zealand, in exercise and pursuance of the powers vested in him by the said Act and its amendments, doth hereby order and declare that the election of the said members, to be held during the present month, shall be held subject to the regulations following, namely,-

REGULATIONS.

1. The local authorities named in the first column of the Schedule hereto shall have respectively the number of votes set opposite them in the second column of the said Schedule, and their representative or representatives shall meet at the time and place set opposite the names of such local authorities in the third and fourth columns of the said Schedule respectively to elect such member or members as have been apportioned to such local authorities by Order in Council of the nineteenth day of October, one thousand eight hundred and eighty-six.

2. The Presiding Officer to conduct the election in each case shall be the person named in the fifth column of the said Schedule, opposite the name of each local authority. Any local authority may, if it think fit, send only one representative to such election, and such representative shall then be entitled to exercise the full number of votes which such local authority is given by regulation one aforesaid.

3. Any local authority may appoint, by writing under the hand of the Chairman or Mayor, as the case may be, any person or persons residing at or near the place of meeting as aforesaid to be its representative or representatives at such meeting, and such representative or representatives shall be entitled to exercise the full number of votes which such local authority is given by regulation one.

4. In case any contributory local authority shall not send a representative to such election the representative or representatives of the local authority or authorities present at the meeting called for such election shall elect the member or members which such local authorities together are entitled to have, and that either at the meeting then held or at a subsequent meeting to be specially convened for the purpose by the Presiding Officer of such first-mentioned meeting.

REGULATIONS RESPECTING NAVAL CADETS.—(In Operation for the Examinations in November, 1887, and June, for th 1888.)

[For alterations to be made in November, 1888, see memorandum attached.]

1. APPOINTMENTS to naval cadetships will be made by limited competition, with the under-mentioned exceptions :

For cadetships given annually to sons of gentlemen in the colonies, on the recommendation of the Secretary of State for the Colonies.

of State for the Colonies.

Service cadetships, the total number of which is not to exceed five in any one year. Service cadets will be selected by the Board of Admiralty from (a) sons of officers of the army, navy, or marines who have been killed in action, or who have been lost at sea on active service, or killed on duty, or who have died of wounds received in action or injuries received on duty within six months from the date of such action or injury; (b) sons of officers of the navy who have performed long or distinguished service, and who hold or have held rank or relative rank on the Active List not lower than that of commander. Not more than two such latter service cadets will be nominated annually.

Applications for service cadetships should be addressed to the Military Secretary, Horse Guards, if the candi-

date is the son of an officer of the army; to the Secretary of the Admiralty, if the candidate is the son of an officer of the navy or marines; and to the Military Secretary, India Office, if the candidate is the son of an officer of the Indian army.

Colonial and service cadets will be entered on passing the test examination as specified in paragraphs 9 and 10, and will in all other respects be subject to these regulations.

The educational examination of all candidates will be conducted by the Civil Service Commissioners (address, Cannon ducted by the Civil Service Commissioners)

ducted by the Civil Service Commissioners (address, Cannon Row, Westminster), who will deal with all questions con-nected with such examination and will announce the results.

For all cadets entered under these regulations the payment will be at the rate of £70 per annum for the period in the "Britannia," to be paid half-yearly in advance to the Accountant-General of the Navy. But the Lords Commissioners of the Admiralty reserve the power of selecting, from among the cadets entered at each half-yearly examination, a number, not to exceed ten, being sons of officers of the navy, army, or marines, or of civil officers under the Board of Admiralty, with respect to whom the annual payment will be £40 only. (e.) Any cadet who shall at any time appear to their Lordwhatever, will be removed from the "Britannia;" and it must be understood that this rule will apply to those who are considered unfit from insufficient physical development or weakness of constitution, although no actual organic disease may have been developed.

16. It is to be distinctly understood that the period of training on board the "Britannia" is a time of probation, and the parent or guardian of every cadet will be required to sign a declaration (on the admission of the cadet to the "Britannia") to the effect that he shall be immediately withdrawn on the receipt of an official intimation of his being considered unit for the navy.

(Signed at San Salvador, 23rd June, 1886. Ratifications exchanged, 8th July,

WHEREAS in Article XXI. of the Treaty of Friendship, Commerce, and Navigation, between Her Majesty the Queen of the United Kingdom of Great Britain and Ireland and the

the United Kingdom of Great Britain and Ireland and the Republic of Salvador, signed on the 24th October, 1862, it is stipulated as follows:—

"The present treaty shall remain in force for the term of twenty years from the date of exchange of ratifications, and if neither party shall notify to the other its intention of terminating the same twelve months before the expiration of the twenty years stipulated above, the said treaty shall continue binding on both parties beyond the said twenty years until twelve months from the time that one of the parties may notify to the other its intention of terminating

And whereas the aforesaid high contracting parties are mutually desirous of prolonging the duration of the said treaty for a further term of years, the undersigned, duly authorised by their respective Governments, have agreed as follows: follows:

1. The Treaty of Friendship, Commerce, and Navigation

2. It is, nevertheless, agreed that any or all of the following colonies and foreign possessions of Her Britannic Majesty, that is to say, India, Canada, Newfoundland, the Cape of Good Hope, New South Wales, New Zealand, Queensland, South Australia, Tasmania, Victoria, Natal, Western Australia, may at any time within the period of two years from the date of the exchange of the ratifications of the present agreement give notice, through Her Majesty's representative accredited to the Republic of Salvador, of their desire to be excepted from the operation of the treaty aforesaid, and the said treaty shall not thenceforward apply to any of the said colonies or foreign possessions of Her Britannic Majesty which shall have given such notice. But, except as above provided, the said treaty shall apply to all the colonies and foreign possessions of Her Britannic Majesty until the treaty be terminated by notice given in pursuance of the terms of Article I. of the present agreement.

3. The present agreement shall be ratified, and the ratifications exchanged at Guatemala or San Salvador as soon as possible.

(1.) In respect of the first 200 tons avoirdupois of fish canned with or without oil, the sum of 1d. per pound, the weight of the cans not to be included in the

the weight of the cans not to be included in the tonnage upon which such bonus is paid;

(2.) In respect of every ton avoirdupois of fish canned as aforesaid beyond the first 200 tons, the sum of ½d. per pound, the weight of the cans not to be included in the tonnage upon which such bonus is paid;

(3.) In respect to cured fish the bonus to be paid shall be respectively ½d. and ½d. a pound under similar conditions, as far as the same are applicable to those contained in the two last subsections.

9. The total tonnage upon which the Treasurer may grant bonuses as aforesaid under this Act shall not exceed 6,000

tons.

10. Every person intending to apply for the grant of a bonus shall register a special trade-mark under the laws for the time being in force in New Zealand providing for the registration of trade-marks, such trade-mark to be used for all cured and canned fish to be prepared for export by such person, and shall, within six years after the passing of this Act, give notice to the Treasurer of his intention to export canned and cured fish with a view to applying for a bonus, and shall append to such notice a copy of such trade-mark; and all cases, barrels, or cans containing fish cured and canned for export by any such person shall, before exportation, be marked with the trade-mark so registered by him, and no part of any such bonus shall be payable except in respect of cases, barrels, or cans so marked.

The following remarks apply only to the four principal boroughs:—
The births in October were 321, against 225 in September, an increase of 96. The deaths in October; those from local diseases being 15, against 21 for previous month.

There were 17 deaths of persons of 65 years and upwards: 5 males of 81, 76, 74, 72, 66, and 3 females of 84, 69, and 66, died at Auckland; a male of 65, and 2 females of 75 and 72, at Wellington; a female of 74 at Christchurch; and a male of 68, and 4 females of 82, 70 (2), and 67, at Dunedin.

Specific Febrile or Zymotic Diseases.—Again the mortality from these causes is found to be small, 7 deaths altogether. Diphtheria, which was fatal at each town in September, caused only 1 death at Christchurch. There were 3 deaths from whooping-cough at Wellington. No deaths from typhoid or other fever occurred at the chief towns.

Constitutional Diseases.—Of 20 deaths, 12 were from phthisis and 3 from cancer.

Local Diseases.—Of 49 deaths, 21 were from bronchitis, pneumonia, and other diseases of the respiratory system, the number for the previous month being the same.

Violent Deaths.—These were 2 in number, 1 being that of a case of accidental scalding of a child.

The subjoined table shows the mortality for the last two months at each of these four boroughs from six principal specific febrile or zymotic diseases, and also the deaths from certain inflammatory diseases of the lungs. These causes of death have been distinguished from the others of the classes to which they belong, as being the most important special diseases which give rise to sudden increases in the death-rates of towns, and the prevalence of which is closely connected with sanitary condition and climatic influence of the season on health.
