Licensing Districts, defined.

WM. F. DRUMMOND JERVOIS, (L.S.) Governor.

A PROCLAMATION.

WHEREAS by "The Licensing Act, 1881," and "The Licensing Act Amendment Act, 1882," it is enacted that the Governor shall from time to time define districts to be licensing districts under the said Acts, and from time to time may alter and redefine the boundaries of the same, and

time may alter and redefine the boundaries of the same, and may abolish any district:

Now, therefore, I, William Francis Drummond Jervois, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority vested in me by the said Acts, do hereby abolish, from and after the twenty-fourth day of February instant, the Licensing Districts of Takapuna, Weiti, Ararimu, Waitakerei, Waikomiti, and Manukau; and do hereby proclaim and define the parts of the colony mentioned and described in the Schedule hereto to be, from and after the said twenty-fourth day of February instant, ordinary licensing districts for the purposes of the said Act.

WAITEMATA COUNTY.

Takapuna Licensing District.—Comprises the Lake Road District, as described in the New Zealand Gazette No 42,

Wainui Licensing District.—Comprising the Pukeatua, Wainui, and Whangaparoa Road Districts, as described in the New Zealand Gazette No. 42, 17th May, 1883.

Waikomiti Licensing District.—All that area in the Waitemata County bounded towards the north-west by the Parish of Waitakerei; towards the east by the Whau River and the County of Eden; towards the south-east by the Manukau Harbour; and towards the south-west by the Sea.

Waitakerei Licensing District.—All that area in the Waitemata County bounded towards the north by the Taupaki Block, the northern boundary of Section No. 1, Parish of Waipareira, by Brigham's Creek, and the Waitemata River; towards the east by the Waitemata Harbour; towards the south-east by Waikomiti Licensing District, hereinbefore described; and towards the west by the sea.

Helensville Licensing District.—All that area in the Waitemata County bounded towards the North by the Kaipara Harbour; towards the east generally by the Kaipara Harbour and the Kaipara River to the northern boundary of the Town District of Helensville; thence by the northern, eastern, and southern boundary-lines of that town district, again by the said Kaipara River and the Waiputukahu Stream to the south-eastern boundary-line of the Ongarahu Block; towards the south-east by the south-eastern boundary of the said Ongarahu Block and that boundary-line produced to the sea; and towards the west to the sea.

Kaukapakapa Licensing District.—All that area in the Waitemata County bounded towards the north by Rodney County; towards the east by the said Rodney County and the Wainui Licensing District, hereinbefore described; towards the south-east by the Waitakerei Licensing District, hereinbefore described; towards the west by the sea; towards the north-west by the Helensville Licensing District, hereinbefore described; and again towards the west by the said Helensville Licensing District, hereinbefore described; and again towards the west by the said Helensville Licensing District and the Kaipara Harbour.

A PROCLAMATION.

HEREAS by the sixth section of "The Licensing Act, 1881," it is enacted that the Governor shall, as soon as conveniently may be after the commencement of the said Act, by Proclamation in the Gazette, from time to time define districts to be licensing districts under the said Act, and from time to time may alter and redefine the boundaries of the same:

Now, therefore, I, William Francis Drummend Jervois, the Governor of the Colony of New Zealand, do hereby, in pursuance and exercise of the power and authority vested in me by the said Act, alter and redefine the boundaries of the Grey Licensing District, which shall, from and after the twenty-fourth day of February instant, be those described in the First Schedule hereto; and do hereby proclaim and define the part of the colony mentioned and described in the Second Schedule hereto to be, from and after the said twenty-fourth day of February instant, an ordinary licensing district for the purposes of he said Act.

It must be understood that the granting of a certificate depends only in part upon the result of an examination, and that candidates who have not had the experience required by the regulations, or who do not receive the necessary marks from a School Inspector, have no claim to a certificate.

The first list contains the names of the successful candidates at the examination for Classes C, D, and E. The second list gives the names of candidates who will be allowed to qualify for Classes C, D, and E, respectively, by passing at the next examination in those subjects only in which they have this year been unsuccessful. The names of candidates who were partially successful in former years, and have now passed in the additional subjects necessary for a certificate, are included in these lists. In the case of the candidates who relied partly upon work done at the matriculation examination, the results of that examination have been taken into consideration in preparing these lists.

Every candidate will receive a private intimation of his success or failure, and those whose names are in the third and fourth lists will be advised as to the subjects in which they will have to be examined again.

tons.

10.
