THE Commissioners appointed under "The Repre-sentation Act, 1887," hereby publish for general infor-mation, in terms of section 4 of the said Act, the following proposed alterations in the boundaries of electoral districts ;

proposed alterations in the boundaries of electoral districts; and, further, give notice that written objections to the same will be received at the office of the Commission, in Wel-lington, up to and including the 21st April, 1890. Maps of the proposed districts will be furnished to each local body in the colony, and large scale-plans of the pro-posed city and suburban electorates may be seen at the Chief Surveyors' offices at Auckland, Wellington, Christ-church, Dunedin, Invercargili, Napier, and Nelson. #### NORTH ISLAND ELECTORAL DISTRICTS.

Bay of Islands comprises the Counties of Mangonui, Whangaroa, Hokianga, Bay of Islands, and Hobson; together with that portion of Hikurangi Hiding, of the County of Whangarei, situate north-west of the Wairua and the Kai-mamaku Rivers.

mamaku Rivers. Marsden comprises the County of Otamatea; the Ridings of Ngunguru, Manaia, Maunu, Mangapai, and Waipu, of the County of Whangarei; and that portion of Hikurangi Riding, of the same county, situate east of the Wairua and the Kaimamaku Rivers; together with the Ridings of Albert, Omaha, and Matakana, of the County of Rodney; also that portion of Tauhoa Riding, of the last-named county. which is bounded on the east by the Hoteo River; and that part of Hoteo Riding, of the County of Rodney, which is bounded on the east and west respectively by the Hoteo and the Wai-whiu Rivers. This district includes the Island of Kawau and the islands adjacent thereto, and the Town Districts of Whangarei and Kamo. Waitemata comprises the Ridings of Mahurangi and Puhoi,

Whangarei and Kamo. *Waitemata* comprises the Ridings of Mahurangi and Puhoi, of the County of Rodney; and those portions of the Ridings of Tauhoa and Hoteo, of the same county, which are situate south of the Hoteo River; also the Ridings of Helensville, Wainui, Kaukapakapa, Birkenhead, Northcote, and Taka-puna, of the County of Waitemata; and so much of the Waitakerei Riding, of the latter county, as is situate to the north-east of the railway-line; together with the Boroughs of Devonport and Birkenhead. This electoral district in-cludes also the Islands of Great and Little Barrier and Tiri-tiri, and Helensville Town District. tiri, and Helensville Town District.

Eden comprises the Road Districts of Point Chevalier, Mount Albert, Avondale, Mount Roskill, and Mount Eden, all of the County of Eden; and that portion of the Epsom

Road District, in the same county, which is south of a line Road District, in the same county, which is south of a line commencing at the south-west corner of Allotment 40 of Section 6, Suburbs of Auckland, and proceeding northerly along the road fronting Sections 40, 41, 42, 23B, and 23A to Epsom-Onehunga Road; also a part of Eden Terrace Road District, bounded as follows: On the north-west and north-east respectively by the New North Road and the road along the south-west boundary of Allotment 2c of Section 5, Suburbs of Auckland; together with that portion of the County of Waitemata which is contained within Waikomiti Riding, and that part of Waitakerei Riding west of the railway-line. Riding, and railway-line.

Newton comprises the Borough of Newton; the Arch Hill Road District, in the County of Eden; and that portion of Ponsonby Ward, of the City of Auckland, which is situate south-west of Ponsonby Road and Curran Street; together with that portion of Eden Terrace Road District north of the New North Road and of the road forming the south-west boundary of Allotment 2c of Section 5, Suburbs of Auckland Auckland.

City of Auckland comprises the whole of the area included Within the city boundaries, excepting that piece of Ponsonby Ward to the south-west of Ponsonby Road and Curran Street from the junction of Franklin Street with Ponsonby Road, as far as Waitemata Harbour.

Parnell comprises the Boroughs of Parnell and New-market; the Remuera Road District, of the County of Eden; market; the Remuera Road District, of the County of Eden; and the portion of Epsom Road District, of the same county, which is north of a line commencing at the south-west corner of Allotment 40 of Section 6, Suburbs of Auckland, and continuing northerly along the road fronting Sections 40, 41, 42, 23B, and 23A to Epsom-Onehunga Road; also that part of One-Tree Hill Road District north of Green Lane and its continuation to the Epsom-Onehunga Road. The Auck-land Domain is included within this electoral district.

Manukau comprises the Road Districts of Mount Welling-ton, Tamaki West, and Panmure, of the County of Eden; and the portion of One-Tree Hill Road District, in the same county, which is situate south of Green Lane; together with the Ridings of Otahuhu and Howick, of the County of Manu-kau; and the Borough of Onehunga. This electoral district includes also the Islands of Rangitoto, Motutapu, Waiheke, Ponui, Tara-taroa, Brown's, Chamberlin's, Rakino, Bean Rock, and adjacent islands.

Franklin comprises the whole of the County of Manukau, excepting the Ridings of Otahuhu and Howick; together with the islands in the Waikato River. Papakura Town District is within this electoral district.

Thames comprises the County of Coromandel and the Borough of Thames; and a portion of Hastings Riding, of the

County of Thames, situate west of the Waiwawa River and the Taitoko Stream, and to the immediate north of the borough; together with the Waiotahi Riding of the County of Thames; and that part of Kauaeranga Riding west of Augustus Street, in the Township of Shortland.

Waikato comprises the Counties of Raglan, Kawhia, West Taupo, Waipa, and Waikato, excepting that portion of the last-named county which is situate west of the road running northerly from the north-west corner of the Borough of Cambridge (Victoria Road) to the Parish of Tamahere. The Borough of Hamilton is included within the boundaries of this electoral district, as also are the Town Districts of Ngaruawahia, Te Awamutu, and Kihikihi.

ruawahia, Te Awamutu, and Kihikihi. Te Aroha comprises the Counties of Piako and Ohinemuri; together with the Ridings of Totara and Parawai, of the County of Thames; and that portion of the Hastings Riding, of the last-named county, which is situate east of the Taitoko Stream and the Waiwawa River; also the portion of Kauaeranga Riding, of the County of Thames, to the east of Augustus Street, in the Township of Shortland; together with the Katikati and Te Puna Ridings, of the County of Tauranga; that part of Waimapu Riding west of the Tauranga-Rotorua Road and of the Waimapu River; and that part of Cambridge Riding, of the County of Waikato, east of Victoria Road. The Borough of Cambridge is included within the boundaries of this electoral district, also the Te Aroha Town District.

East Coast comprises the Counties of Rotorua, Whakatane, and East Taupo; and the Boroughs of Gisborne and Tauranga; also that part of the County of Tauranga contained within the boundaries of Maketu Riding; and that part of Waimapu Riding east of the Tauranga-Rotorua Road; together with the whole of the County of Cook, excepting the Arai Riding of that county. Motiti Island is within the boundaries of this electoral district, as is also the Opotiki Town District.

New Plymouth comprises the County of Clifton; the Waitara Riding, of the County of Taranaki; the Borough of New Plymouth; the Road Districts of Omata, Barrett, Elliot, Frankley, Carrington, Mangorei, and Waiwakaiho, of the County of Taranaki; and that portion of the Moa Road District which is situate west of the railway-line between Waitara Riding and Inglewood, and to the west and north of a line starting from Inglewood and proceeding along Windsor Road to Section 111, Tarurutangi, thence along the northern boundary-line of that section to the Waiongona, thence up that stream to the road at the northern boundary of Section 132, thence along that road to the Mangaoraka Stream, thence up that stream to the southern corner of Section 164 (E.R.), and thence along the southern boundary-line of that section to the Waiwakaiho; together with that portion of the Oakura Road District which is east of the Tapuae Stream. This electoral district includes the Waitara Town District.

Endes the Waltara Town District. Egniont comprises the Parihaka Riding, of the County of Taranaki; the Waimate Riding, of the County of Hawera; the Road Districts of Tataraimaka and Upper Hurford, and that portion of the Oakura Road District west of the Tapuae Stream, all in the County of Taranaki; together with that portion of Moa Riding, in the last-mentioned county, which is not absorbed by the New Plymouth Electoral District; also the portions of the Ridings of Eltham and Hawera, of the County of Hawera, which are situate west of the Mountain Road, the Ohangai Road, and the Whareora Road. This electoral district includes also the Borough of Hawera, and the Town Districts of Inglewood, Stratford, Opunake, and Manaia.

Opunake, and Manaia. Waitotara comprises the County of Patea; the Ngaire and Mokoia Ridings, of the County of Hawera; and the portions of the Ridings of Eltham and Hawera, in the same county, which are situate east of the Mountain Road, the Ohangai Road, and the Whareora Road; together with the Waitotara Riding, of the County of Waitotara; and that portion of Tokomaru Riding situate north of a line running along the southern boundary-lines of Sections 207, 208, and 125, and along the western boundary of the last-mentioned section and Section 126 to Kai-iwi Stream, and thence along that stream to the Kai-iwi Block; also the Ridings of Mangawhero and Upper Wangachu, of the County of Wanganui; the Ridings of Paraekaretu and Makohau, of the County of Rangitikei; and that portion of the Porewa Riding, of the last-mentioned county, which is situate north of the Borough of Marton. This district includes also the Borough of Patea and the Town Districts of Normanby and Waverley. Wanganui comprises the Ridings of Westmere and Bruns-

Wanganui comprises the Ridings of Westmere and Brunswick, in the County of Waitotara; the southern portion of Tokomaru Riding, in the same county, from Kai-iwi Stream southward; and the Ridings of Mateongaonga, Kaukatea, Purua, and Kaitoke, in the County of Wanganui; together with the Ridings of Wangaehu and Okakapu, of the County

of Rangitikei; and the Borough of Wanganui. The Lethbridge Town District is included in this electoral district.

bridge Town District is included in this electoral district. Rangitikei comprises the Boroughs of Marton and Feilding; the Ridings of Maungaraupi, Clifton, and Rangitoto, of the County of Rangitikei; and the lower portion of Porewa Riding, of the same county, which is not included within the boundaries of the Waitotara Electoral District; together with the whole of the County of Oroua, less the Ridings of Taonui and Fitzherbert, of that county. This district includes also Mount Stewart Riding, of the Same county, which is situate to the north of the road from Sanson to the Rangitikei River, viá the Pakapakatea Native Block. The Town Districts of Halcombe and Bulls are within this electoral district.

Palmerston comprises the whole of the County of Horowhenua; the Boroughs of Palmerston North and Foxton; the Ridings of Taonui and Fitzherbert, of the County of Oroua; the whole of the County of Manawatu, excepting the Riding of Mount Stewart, and that part of the Sandon Riding north of the road from Sanson to the Rangitikei River, viå the Pakapakatea Native Block; together with that portion of the Horokiwi Riding, of the County of Hutt, which is north of a line drawn due east from a point on the sea-coast about one mile south of Paikakariki. This electoral district includes also the Island of Kapiti.

Hawke's Bay comprises the County of Wairoa; the Arai Riding of the County of Cook; and the whole of the County of Hawke's Bay, excepting the Meanee Riding and that portion of Clive Riding north and west of a line starting at the south-east corner of Clive Township, and continuing along the road to West Clive, thence across the Ngaruroro River bridge, and on to Farndon Railway-station, and thence southerly along the railway-line to the old bed of the Ngaruroro River; also the Patangata and Oero Ridings, of the County of Patangata; and that part of Waipawa Riding, of the County of Waipawa, which is situate to the east of a line commencing at the north-east corner of Block 48, Waipukurau Survey District, and proceeding along the northeastern boundary-lines of Blocks 48, 72, 77, and 172, the eastern boundary-line of the last-mentioned block to Manga-o-muku River, and thence along that river to the county boundary. This electoral district includes also the Borough of Hastings, and has within its boundaries the Town Districts of Clyde and Kaikora North, and Portland Island.

Napier comprises the whole of the Borough of Napier; and Meanee Riding, of the County of Hawke's Bay; together with the north-western portion of Clive Riding, of the same county, which is situate east of the railway-line and north of the road leading from Farndon Railway-station to the southeastern corner of Clive Township, near the mouth of the Tukituki River. Taradale Town District is within the boundaries of this electoral district.

boundaries of this electoral district. Waipawa comprises the Ridings of Taumumu, Eparaima, and Porangahau, in the County of Patangata; and the whole of the County of Waipawa excepting (1) that portion of the Waipawa Riding, north of the Manga-o-muku River, which is absorbed by Hawke's Bay Electoral District, and (2) the portion of Woodville Riding which is situate on the southwest of a line commencing at the confluence of the Mangaatua River with the Manawatu River, and proceeding along the northern boundary of Block XIII., Woodville Survey District, thence along the north-western and northeastern boundaries of Block XII. to the road which forms the western boundary of Section 1 of Block XII., thence along that road and its continuation through Block VII., and past Sections 11 and 13, Block IX., and through the last-mentioned block to the Manawatu River at the southern corner of Section 22. This electoral district includes within its boundaries the Town Districts of Waipawa, Ormondville, and Danevirke.

Masterton comprises the County of Pahiatua; and the County of Wairarapa North, less the Wainuioru Riding of the latter county, and a portion of the Masterton Riding situate between the Taueru River and the Wangaehu River, and south of the road leading from the Wangaehu River to and across the Mangatopi Stream to the Taueru River; together with that portion of Woodville Riding, in the County of Waipawa, which is situate south of Block V., Woodville Survey District, and south of the road commencing between Sections 1 and 2, and proceeding easterly through Blocks VII. and IX. to the Manawatu River. This district includes also the Boroughs of Masterton and Woodville, and the Town District of Pahiatua.

Wairarapa comprises the whole of the County of Wairarapa South; the Wainuioru Riding, of the County of Wairarapa North; and that portion of Masterton Riding, in the same county, which is situate between the Taueru and the MAR. 21.]

Wangaehu Rivers, and south of the road from the Wangaehu River across the Mangatopi Stream to the Taueru River; together with the Boroughs of Greytown and Carterton, and the Town District of Featherston.

Hutt comprises the whole of the County of Hutt; excepting that portion of the Horokiwi Riding which is north of a line running due east from a point on the coast-line about one mile south of Paikakariki, to the eastern boundary of the riding; and excepting also that portion of Karori Riding which is situate to the east of a line commencing on the sea-coast at the mouth of the Karori Stream and proceeding up that stream to the south-western boundary-line of Karori District, thence to and along the summit of the watershed over Makara Peak to the northwestern boundary-line of Karori District, thence in a generally north-easterly direction along sectional boundaries to the Borough of Onslow at the Kaiwarra Stream, and thence along the western and northern boundaries of that borough to the waters of Port Nicholson; together with the Borough of Petone and the Islands of Mana and Somes. This electoral district includes within its boundaries the Town Districts of Lower Hutt, Johnsonville, and Kaiwarra.

City of Wellington comprises the whole of the area included within the boundaries of the City of Wellington; together with the Boroughs of Melrose and Onslow and the Seatoun Road District; and that portion of the Karori Riding, of the County of Hutt, which is situate east of a line starting from the sea-coast at the mouth of Karori Stream and proceeding up that stream to the south-western boundary-line of Karori District; thence to and along the summit of the watershed over Makara Peak to the north-western boundary-line of the Karori District; thence in a northeasterly direction by sectional boundaries to the Borough of Onslow at the Kaiwarra Stream.

#### MIDDLE ISLAND ELECTORAL DISTRICTS.

City of Nelson comprises the City of Nelson; together with the Stoke Riding, of the County of Waimea. This district includes the Town District of Richmond.

Waimea - Picton comprises the County of Sounds; the Borough of Picton; and the whole of the County of Waimea, excepting the Wangapeka Riding and that portion of the Motueka Riding west of the Motueka Road District, and excepting also the Stoke Riding, of the same county; together with the Pelorus Riding, of the County of Marlborough; and that portion of the Picton Riding, in the same county, situate west of the Blenheim-Picton Railway and north of Sections 97 and 117 and Forest Reserve. This district includes the Town District of Havelock.

Wairau comprises the whole of the County of Marlborough; excepting the Pelorus Riding, and that portion of the Picton Riding situate west of the Blenheim-Picton Railway and north of Sections 97 and 117 and Forest Reserve; together with the County of Kaikoura and the Borough of Blenheim.

Buller comprises the County of Collingwood; the Ridings of Karamea and Wareatea North of the County of Buller; and that portion of the Lyell Riding, of the same county, situate north of the Buller River; together with the Borough of Westport; the Wangapeka Riding, of the County of Waimea; and the whole of the Motueka Riding, of the same county, excepting the Motueka Road District.

Inangahua comprises the whole of the County of Inangahua; the Ridings of Waipuna, Red Jack's, and Nelson Creek, of the County of Grey; that portion of the Brunnerton Riding, of the same county, situate north of the Grey River, and that portion of the Cobden Riding, of the County of Grey, situate north of the Seven-mile Creek; together with the Ridings of Charleston and Wareatea South, of the County of Buller; and that portion of the Lyell Riding, of the same county, south of the Buller River. This district includes also that portion of the Borough of Brunner north of the Grey River.

Grey comprises the Ridings of Hohonu, Paroa, Marsden, and Maori Creek, of the County of Grey; that portion of Brunnerton Riding situate south of the Grey River; and that portion of Cobden Riding, of the same county, situate south of Seven-mile Creek; together with the Boroughs of Kumara and Greymouth; and that portion of the Arahura Riding, of the County of Westland, situate north of the Greenstone Junction and Christchurch Roads between Kumara Borough and Waimea Creek. This district includes also that portion of the Borough of Brunner situate south of the Grey River.

Westland comprises the Boroughs of Ross and Hokitika; together with the whole of the County of Westland excepting that portion of the Arahura Riding north of the Greenstone Junction and Christchurch Roads between Kumara Borough and Waimea Creek.

Ashley comprises the Counties of Amuri and Cheviot; together with the Ridings of Waipara, Kowai, Mount Thomas, and Oxford, all of the County of Ashley. This district includes the Amberley Town District.

Kaiapoi comprises the Ridings of Mandeville, Cust, and West Eyreton, of the County of Ashley; and the north-east portion of Eyreton Riding, of the same county, situate on Kaiapoi Island north of Cherry Road, and east of Kaikainni Creek and of the road passing Sections 738 and 560; together with the Boroughs of Kaiapoi and Rangiora.

the Boroughs of Kaiapoi and Rangiora. Avon comprises the Avon Road District, of the County of Selwyn; that part of the Riccarton Road District, of the same county, which is north of the Wairarapa Road; together with that part of the Borough of St. Albans which is north-west of Innes Road and Aikman's Road; and the whole of the Eyreton Riding, of the County of Ashley, excepting that portion of Kaiapoi Island south of Cherry Road, near Clarkville Post-office, east of the Kaikainui Creek and of the road passing Sections 738 and 560. This district includes also that part of the Heathcote Riding, of the County of Selwyn, which is situate north-east of the Canal and Road Reserve. City of Christchurch comprises the City of Christchurch:

City of Christchurch comprises the City of Christchurch; and the Boroughs of Sydenham and St. Albans, excepting that portion of the latter borough which is north-west of Innes Road and Aikman's Road.

Heathcote comprises the Town Districts of Linwood, Woolston, and Sumner; and that portion of the Heathcote Road District, of the County of Selwyn, which is situate to the south-west of the Canal and Road Reserve.

Halswell comprises the Road Districts of Halswell, Lincoln, Tai Tapu, and Spreydon, all of the County of Selvyn; together with that portion of the Templeton Road District, of the same county, situate east of Hampton's Road and north of the railway-line; and that portion of the Riccarton Road District situate south of the Wairarapa Road.

Banks comprises the County of Akaroa; together with the Boroughs of Lyttelton and Akaroa.

Selwyn comprises the Ridings of Upper Waimakariri, Malvern, and Courtenay, of the County of Selwyn; and that portion of Coleridge Riding, of the same county, which is situate west of Rakaia Road, north of Sharland's Road, and west of Two-chain Road; together with the Springs Road District, of the same county; and that portion of the Templeton Road District, of Selwyn County, which is west of Hampton's Road.

Ellesmere comprises the Mount Hutt and South Rakaia Ridings, of the County of Ashburton, with that portion of the Upper Ashburton Riding, in the same county, east of Winchmore Road and north of the road running through the Kaiapoi Borough Endowment; and that portion of the Wakanui Riding, of the County of Ashburton, which is east of a road running south from Dromore, and passing Newland and Seafield Post Offices, to the sea; together with that portion of the County of Selwyn contained within the Ellesmere Riding; and also that portion of the Coleridge Riding south-east of Rakaia Road and Sharland's Road and Twochain Road. This district includes the Southbridge Town District.

Ashburton comprises the Ridings of Mount Somers, Rangitata, and Ashburton, of the County of Ashburton; and that portion of the Upper Ashburton Riding, in the same county, which is west of Winchmore Road and south of the road running through the Kaiapoi Borough Endowment to Section 6,502; together with that portion of the Riding of Wakanui which is west of the road running south from the Town of Dromore, past the Newland and Seafield Post Offices, to the sea; and that portion of the Temuka Riding, of the County of Geraldine, between the Rangitata and Orari Rivers. This district includes also the Borough of Ashburton and the Town Districts of Tinwald and Hampstead.

Geraldine comprises the whole of the County of Geraldine; excepting that portion of the Levels Riding situate south of the Opihi River, east of Stonyer's Road, south of the road running westerly from Section 14449 to the northern boundary of Section 13782, and south of the road running westerly from that section past Sections 15095 and 15879 to Tycho Road, and south of the northern boundary of the present Waimate Electoral District from Tycho Road to near Cave Railway-station; and excepting also that portion of Temuka Riding which is situate between the Rangitata and the Orari Rivers and south of the railway-line. This district includes the Town Districts of Arowhenua, Temuka, and Geraldine.

Timaru comprises that portion of the Levels Riding, of the County of Geraldine, which is bounded as follows: On the north and north-west by the Ophi River and by Stonyer's Road to the railway-line, thence by the railwayline to the road forming the eastern boundary of Section 14449, thence by that road in a westerly direction to the road at the northern boundary of Section 13782, thence by the last-mentioned road and its continuation past Sections 15095 and 15879 to Tycho Road; and on the south-west and west by Tycho Road and the road passing Claremont and Fairview Post Offices to the Otipua Creek; and by the Otipua Creek to the sea. This district includes also the Borough of Timaru.

Waimate comprises the Counties of Waimate and Mackenzie; and that portion of the Levels Riding, of the County of Geraldine, which is situate south of Tycho Road, and of the road running south-easterly past Claremont and Fairview Post Offices to Otipua Creek, and south of the present Gladstone Electoral District. This district includes also the Borough of Waimate.

Borough of Waimate. Waitaki comprises the whole of the County of Waitaki; excepting the Riding of Papakaio and that portion of Waiareka Riding situate east of the Waiareka Creek and of the road proceeding through Block IX. to Section 21, Block V., Awamoko Survey District; and excepting also that portion of the Kakanui Riding east of the Waiareka Creek, and of the road forming the eastern boundaries of Sections 19, 21, and 23, Block VII., Oamaru District; together with the whole of the County of Waihemo; that portion of the Hawksbury Riding, of the County of Waikouaiti, west of the Pleasant River, the Main South Road, and the Borough of Hawksbury; and that part of the Deep Stream Riding, in the County of Taieri, situate east of the Taieri River and north of Three o'Clock Creek. This district includes also the Boroughs of Palmerston and Hampden.

Oamaru comprises the Papakaio Riding, of the County of Waitaki; and that portion of the Waiareka Riding, of the same county, situate east of the Waiareka Creek and of the road proceeding through Block IX. to Section 21, Block V., Awamoko Survey District; together with that portion of Kakanui Riding, of the County of Waitaki, east of the Waiareka Creek, and of the road which forms the eastern boundaries of Sections 19, 21, and 23, Block VII., Oamaru District. This district includes also the Borough of Oamaru.

Mount Ida comprises the Teviot Riding, of the County of Tuapeka; the Ridings of Dunstan, Manuherikia, and Matakanui, in the County of Vincent; together with the County of Maniototo, the Boroughs of Naseby, Alexandra, and Roxburgh; and that portion of the Deep Stream Riding, in the County of Taieri, west of the Taieri River.

Port Chalmers comprises the Ridings of North-east Valley, Blueskin, and Merton, of the County of Waikouaiti; and that part of the Hawksbury Riding, in the same county, south of the Pleasant River and the Main South Road; together with the Boroughs of Port Chalmers and Hawksbury; and that portion of the Borough of West Harbour contained within Sawyer's Bay Ward and St. Leonard's Ward; north of Section 24, Upper Harbour West District, near the "White Stone," and east of Block IX., North Harbour and Blueskin Survey District. This district contains also that portion of the Borough of Maori Hill situate in the present Electoral District of Dunedin West.

*Peninsula* comprises the County of Peninsula; and the Boroughs of St. Kilda and Dunedin South; together with that portion of the Borough of Caversham east of Forbury Road, and that other portion of the same borough situate east of Section 18, Town District, and south of the Main South Road and of the Town Belt of the City of Dunedin.

City of Dunedin comprises the whole of the area included within the boundaries of the City of Dunedin; together with that portion of the Borough of Roslyn situate south of the Helensburgh Road, east of the Dunedin and East Taieri Road, and south of Kaikorai Valley Road, and of Block V., Lower Kaikorai District; and that portion of the Borough of Mornington situate north of the Township of Williamsburgh and east of Elgin Road.

Dunedin Suburbs comprises the Borough of North-east Valley; that portion of the Borough of West Harbour which is contained in Ravensbourne and Rothesay Wards, and in that portion of St. Leonard's Ward to the west of Upper Harbour West Survey District, and south of Section 23 of the said survey district, near the "White Stone"; that portion of

the Borough of Maori Hill which is situate south of the Waikari Road, of the Balmacewan Road, and of the northern boundary of Block VIII., Upper Kaikorai District; together with that portion of the Borough of Roslyn which is situate to the north of Helensburgh Road, to the west of Dunedin and North Taieri Road, and to the north of Kaikorai Valley Road and of Block IX., Dunedin and East Taieri District; that portion of the Borough of Mornington which is situate west of Elgin Road and south of the Township of Fullwood; and that portion of the Borough of Caversham which is situate west of Section 17, Town District, and north of the Main South Road; and that other portion of the lastmentioned borough situate west of Forbury Road.

Taieri comprises the whole of the County of Taieri, excepting Deep Stream Riding. This district includes also the Boroughs of Mosgiel and Green Island, and the Town Districts of Grey and Outram.

Bruce comprises the whole of the County of Bruce and the Boroughs of Milton and Kaitangata; together with that portion of the Waitahuna Riding, of the County of Tuapeka, situate to the south of Waitahuna River.

*Clutha* comprises the whole of the County of Clutha, the Borough of Balclutha, and that part of the Mataura Riding, of the County of Southland, situate north of the Main South Road. This district includes the Town Districts of Clinton and Gordon.

Tuapeka comprises the whole of the County of Tuapeka, excepting the Teviot Riding and that part of the Waitahuna Riding situate south of the Waitahuna River; together with the Boroughs of Lawrence and Tapanui; and that part of the Riding of Waikaia, in the County of Southland, situate south of a line running due east from East Dome to Tuapeka County.

Mataura comprises the Ridings of Waihopai, Toetoes, and Hokonui, of the County of Southland; and that portion of the Mataura Riding of the same county south of the Main South Road. This district includes also the Borough of Gore, and the Town Districts of Mataura and Wyndham.

Wakatipu comprises the whole of the County of Lake, the Ridings of Hawea, Clutha, Carrick, Earnscleugh, and Lindis, of the County of Vincent, and the Boroughs of Queenstown, Arrowtown, and Cromwell; together with that part of the Oreti Riding, of the County of Southland, situate north of Tomogalak Creek and of the southern boundary of Run No. 207; and that part of the Waikaia Riding, of the same county, situate north of a line running due east from East Dome to Tuapeka County.

Wallace comprises the Counties of Wallace and Fiord; that part of the Oreti Riding, of the County of Southland, situate south of the Tomogalak Creek and of Run No. 207; and that portion of the Riding of Winton, of the County of Southland, situate north of the Oreti Hundred, west of the Wintom-Kingston Railway-line, and north-east of the road from Benmore to Gore vid Lora Station; also the Borough of Riverton; and the Otautau Town District.

of Riverton; and the Otautau Town District. Awarua comprises the Ridings of Awarua and Wallacetown, of the County of Southland; that part of the Riding of Winton, in the same county, south of the Taringatura District, east of the Winton-Kingston Railway, and south of the Benmore-Gore Road via Lora Station; together with the Boroughs of Winton and Campbelltown; and that part of the Borough of South Invercargill situate south of the northern boundary-lines of Sections 7, 39, 45, and 57, Invercargill Hundred, and of the Seaward Bush Railway-line. This district includes also Stewart Island, Centre Island, and Dog Island, and all adjacent islands.

Invercargill comprises the Boroughs of Invercargill, North Invercargill, East Invercargill, Avenal, and Gladstone; and that portion of the Borough of South Invercargill situate north of Section 7, Block III., and Sections 39, 45, and 57, Block XIX., Invercargill Hundred, and of the Seaward Bush Railway-line.
