

And I do further notify that licenses to take or kill such game within the said district shall be issued on payment of the sum of ten shillings each, and that licenses to sell game and native game shall be issued on payment of the sum of five pounds each; and the Postmasters at Marton and Bull's are hereby each; and the Postmasters at Marton and Bull's are hereby appointed to sign and issue the said licenses.
