WHEREAS by "The Resident Magistrates Act, 1867," it is enacted that it shall be lawful for the Governor from time to time, by Proclamation in the *New Zealand Gazette*, to declare that, from a day to be in such Proclamation fixed, sections one hundred and five to one hundred and fifteen, both inclusive, having special reference to persons of the Native race, or such of those sections as shall be in such Proclamation specified, shall come into operation in such districts of the colony as shall be in such Proclamation specified, and until so proclaimed, and in places not included in any such district, such sections shall not be in force:

Now, therefore, I, William Hillier, Earl of Onslow, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities so vested in me as aforesaid, do hereby proclaim and declare that, from and after the fourth day of September instant, sections one hundred and five to one hundred and fifteen, both inclusive, having special reference to persons of the Native race, shall come into operation within the following Resident Magistrate's district:—

Amended Regulation under "The Mining Act, 1886."

ONSLow, Governor.

WHEREAS by "The Mining Act, 1886" (hereinafter termed "the said Act"), it is enacted that it shall be lawful for the Governor, subject to the provisions of the said Act, from time to time to make, alter, amend, or revoke rules and regulations for all and any of the purposes therein-after enumerated: And whereas it is expedient to revoke the regulation hereinafter specified, and to make other provision in lieu thereof:

Now, therefore, I, William Hillier, Earl of Onslow, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities in that behalf conferred by the said Act, do hereby revoke regulation number twenty-three of the regulations issued on the twelfth day of May, one thousand eight hundred and eighty-seven, and published in the *New Zealand Gazette* of the sixteenth day of May then instant, which said regulation relates to forfeiture of licensed holdings and special claims, and in lieu thereof do hereby make and substitute the following, namely:—

Licensed Holdings and Special Claims may be forfeited.

23. If any licensee or special claimholder fails or neglects to perform any condition contained or implied in his license or special-claim grant, or makes default for the space of sixty days in the payment of the required license-fee, application may be made by any person for the forfeiture of such license or special claim in the form or to the effect set forth in Schedule 4 hereto.

A copy of such application shall be served personally on the licensee or special claimholder, or in such other manner as the Warden may direct, or, at the discretion of the Warden, may be posted on some conspicuous portion of the ground for such time as the Warden may direct, together with a notice in the form or to the effect set forth in Schedule 5 hereto.

At the inquiry in the notice mentioned, the Warden shall take evidence in relation to the application, and the licensee's or special claimholder's answer to the neglect complained of; and shall decide on the whole facts of the case as to whether the land included in such license or special claim shall be forfeited or not.

MORETON BAY.—FLOATING BEACON AT ENTRANCE TO NORTH OR HOWE CHANNEL REPLACED.

THE floating beacon has now been placed in the position of the fairway buoy which recently marked the entrance to the North or Howe Channel; and the fairway buoy, with staff and flag on it, has been moved to the position of the buoy which marked the western end of the East Bank; and the buoy which marked the latter has been taken away.

The floating beacon is provided with a mast and black circular cage, the centre of the cage being about 22ft. above the water.

The beacon is also provided with a bell.

Te Makarini Scholarships, held at Te Aute College, Hawke's Bay.

THREE scholarships of the yearly value of £35, tenable for two years, are offered for competition. One of these scholarships is open to all Maoris that have regularly and continuously attended a Native school during the previous year, and are under sixteen years of age at the end of the month preceding the date of the examination; the other two scholarships are open to all Maoris that are under fifteen years of age at the end of the month preceding the date of the examination, and that have attended a Native village school regularly and continuously during the previous twelve months. These scholarships are offered for competition among Maori boys, on the conditions laid down in the regulations of the Trustees of the Te Makarini Scholarships Fund, as printed in the Native Schools Code, 1886, and in

the supplementary regulations that have been sent out to all teachers. The examination will be held at convenient centres on the 15th and 16th December, 1890.

Candidates must, either directly or through their teachers, send notice to the Inspector of Native Schools, Education Department, Wellington, of their intention to present themselves for examination. Such notice must be posted not later than the 31st October next.

Copies of the regulations and forms of notice may be obtained from teachers of Native schools and boarding institutions, the Secretaries to Education Boards, or the Secretary for Education.

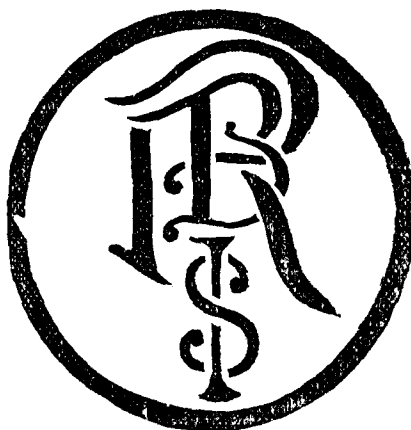

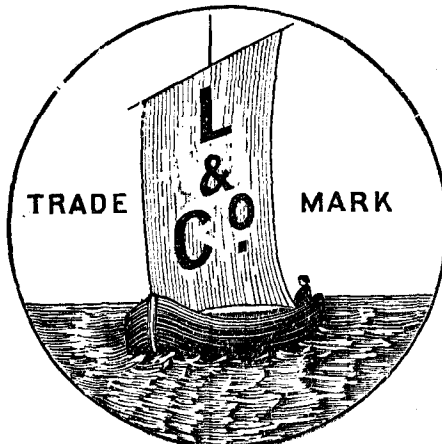
