*Proposed Alterations in Boundaries of Electoral Districts.*

Wellington, 14th October, 1891.

**T**HE Commissioners appointed under "The Representation Act, 1887," and amendments thereof, hereby publish for general information, in terms of section 4 of the said Act, the following proposed alterations in the boundaries of electoral districts; and, further, give notice that written objections to the same will be received at the office of the Commission, in Wellington, up to and including the 16th November, 1891.

Maps of the proposed districts will be furnished to each local body in the colony, and may be seen at the Chief Surveyor's offices at Auckland, Wellington, Christchurch, Dunedin, Invercargill, Napier, and Nelson.

**NORTH ISLAND ELECTORAL DISTRICTS.**

*Bay of Islands* comprises the Counties of Mangonui, Whangaroa, Hokianga, and Bay of Islands; together with the Ridings of Dargaville and Aratapu, of Hobson County; that portion of Ngunguru Riding, of Whangarei County, lying to the north of the Waitutu River and the road running through the Puhipuhi Blocks; and also that portion of Hikurangi Riding, of Whangarei County, which lies north-west of the Wairoa River, the Wairua River, and the Whakapara River. The boundary of this district where it runs through Whangarei County is unaltered.

*Marsden* comprises the whole of Whangarei County, excepting portions of the Ridings of Ngunguru and Hikurangi, situated in the existing Bay of Islands Electorate; together with the Ridings of Wairoa, Okahu, and Te Kopuru, in Hobson County; and the Ridings of Tokatoka, Mareretu, Paparoa, and Matakoho, in Otamatea County. This district includes the Town Districts of Whangarei and Kamo, and Mokohinau Lighthouse.

*Waitemata* comprises the whole of the County of Rodney; the Ridings of Wairau, Whakapirau, and Kaiwaka, in Otamatea County; the Ridings of Maireretu, Kaukapakapa, and Wainui, and Helensville Town District, all in Waitemata County; together with that portion of Waitakerei Riding, of the last-mentioned county, situated north of the railway-line: thus leaving the southern boundary of this district between Waitemata Harbour and the West Coast unaltered. The Islands of Great and Little Barrier, Kawau, Motuhora, Tiritiri, and others adjacent thereto, are included in this electorate.

*Eden* comprises the Ridings of Takapuna, Northcote, and Birkenhead, of Waitemata County; and that portion of the same county lying to the south of the present electoral boundary; together with that portion of Arch Hill Road District, of Eden County, situated south-west of Cracroft Street; and portions of the Mount Albert and Mount Roskill Road Districts, of the same county, being a narrow strip of country lying between Kingsland Road and Mount Eden Road District, and Mount Albert Road and Eden and Epsom Road Districts; and bounded on the north by the railway-line, on the west by Kingsland Road, and on the south by Mount Albert Road to the Borough of Onehunga, on the east by the Auckland and Onehunga Road, again on the north by Epsom and Mount Eden Road Districts, and again on the east by the last-mentioned road district. This district includes also the Boroughs of Birkenhead and Devonport.

*City of Auckland* comprises the City of Auckland and the Borough of Newton; that part of Arch Hill Road District situated to the north-east of Cracroft Street; and that part of Mount Eden Road District situated between the city boundary and the railway-line, and adjoining Shaddock Street, on the Eden Terrace Road District boundary.

*Manukau* comprises a narrow strip of Whau Riding, of the Eden County, lying on the north and east of a line commencing opposite the Royal Oak Hotel, on the Auckland-Onehunga Road, and proceeding westerly along Mount Albert Road to Kingsland Road, thence northerly along Kingsland Road to the railway-line, and thence easterly along the railway-line passing the Kingsland Railway-station to the Mount Eden Road District boundary; together with that portion of Mount Eden Road District lying to the south of Valley Road and Oakland's Road, and that portion of Epsom Road District lying south of Owen's Road, west of Gillies Avenue, south of the road fronting Lot 23, and west of Epsom Road to Kyber Pass opposite the railway-workshops. This district includes also the Road Districts of Remuera, Tamaki West, Panmure, and Mount Wellington, and the Borough of Onehunga.

*Parnell* comprises the Eden Terrace Road District; that portion of Mount Eden Road District which lies to the north of Valley Road and Oakland's Road, and south of the railway-line between the Eden Terrace Road District boundary and the City of Auckland boundary; and also that portion of Epsom Road District which lies north of Owen's Road, west of Gillies Avenue, and north of the Educational Endowment (Lot 23A), and west of Epsom Road; together with the Boroughs of Parnell and Newmarket, and the Auckland Domain.

*Thames* comprises the whole of Coromandel County; the Waitahi Riding, of Thames County; also that portion of Hastings Riding, of the same county, lying to the west of the Waiwara River and the Taitoko Stream; and that portion of Kaueranga Riding generally south-west of a line commencing at Hape Creek, in line with the middle of Sandes Street, Shortland Township, and proceeding northerly to and along the middle of the said street to Sealy Street, thence easterly along Sealy Street to the eastern boundary of Shortland Township, and thence northerly along that boundary to Karaka Creek. This district comprises also the Borough of Thames, and Great Mercury and Cuvier Islands.

*Franklin* comprises the Ridings of Pukekohe, Waiuku, Awahitu, Otahuhu, and Howick, of Manukau County; and that portion of Papakura Road District situated north-west of a road running easterly from the Great South Road, near Manurewa Railway-station, passing Sections 12 to 18, Papakura Parish, to the Pakuranga Parish boundary, and from thence north-west of a line along that boundary to the Wairoa Parish, and along the north-western boundary of the last-named parish to the Turanga Road District. This district includes also the Islands of Waiheke, Motutapu, Ponui, Rakino, Rangitoto, and adjacent islands.

*Waikato* comprises the whole of the Waikato County; the Maungatawhiri Riding, of the Manukau County; that portion of Papakura Riding lying south of Maraetai and Pakuranga Parishes, and of a road commencing in Section 65, Papakura Parish, and extending westerly to the Great South Road, near Manurewa Railway-station; together with all of Raglan County, excepting the Ridings of Pirongia and Karamu. Cambridge Borough is included with the boundaries of this district, and also Papakura Town District.

*Waipa* comprises the following counties: Waipa, West Taupo, East Taupo, and Piako; together with the Ridings of Pirongia and Karamu, of Raglan County; and the whole of Kawhia County, excepting that part lying south of the parallel of 38° 30' south latitude. This district includes also the Borough of Hamilton, and the Town Districts of Te Awamutu, Kihikihi, Ngaruawahia, and Te Aroha.

*Bay of Plenty* comprises the Counties of Ohinemuri, Tauranga, Whakatane, and Rotorua; and that portion of Thames County lying to the south-east of a line starting at the Coromandel County boundary, and proceeding along the Waiwara River and the Taitoko Stream, and along the eastern boundary of Hastings Riding, and the eastern and southern boundaries of Waitahi Riding, thence across the Karaka Creek, and along the north-eastern boundary of Shortland Township to Sealy Street, thence westerly along Sealy Street to Sandes Street, thence southerly along Sandes Street and its extension to Hape Creek, and thence along Hape Creek to Thames Borough. Included also in this electorate are the Borough of Tauranga, Opotiki Town District, and Motiti Island.

*East Coast* comprises the Counties of Cook, Waiapu, and Wairoa; together with the Petane Riding and the Puketapu Road District, both of Hawke's Bay County; and the Borough of Gisborne. Clyde Town District is in this electorate.

*Hawke's Bay* comprises the whole of Hawke's Bay County, excepting the Ridings of Petane and Puketapu, and that part of Meanee Riding situated south of the Tutakuri River and of the road fronting Sections 15, 16, 8, and 9, Papakura, and south of Waitangi River; together with the Road Districts of Waipawa and North Ruataniwha; the Waipawa Town District, of Waipawa County; and that part of Ruataniwha Riding, of the Waipawa County, lying north of the Mangatawai or Avoca River; also the Patangata and Oero Ridings, of Patangata County. This district includes the Borough of Hastings, and has within its boundaries the Kaikora North Town District.

*Napier* comprises the Borough of Napier; and that part of Meanee Riding, of Hawke's Bay County, lying north of the Tutakuri River, and of the road intersecting the Papakura Block, fronting Sections 15, 16, 8, and 9, Papakura, and north of Waitangi River. Taradale Town District is in this electorate.

*Waipawa* comprises the whole of Waipawa County, excepting the Road Districts of Waipawa and North Ruataniwha, the Waipawa Town District, and that portion of Ruataniwha Riding situated north of the Mangatawai or Avoca River; together with the whole of Patangata County, excepting the Ridings of Patangata and Oero. There are also included in this electorate the Makuri Riding, of Pahiatua County; and another portion of Pahiatua County, which is bounded on the east by the Mangaramarama Creek and the road of the same name, and by the eastern boundaries of the Wellington Corporation Endowment, on the south by lines so as to exclude Pahiatua Town District and the Woodville-Mangatainoko Special Settlement, by the Mangahao River and the Tararua Road (known as the road to Palmerston), and on the west by the Tararua Range; also that portion of Akiteo Riding, of Wairarapa North County, which extends northwards from the Aohanga River to the county boundary. The Borough of Woodville and the

Town Districts of Ormondville and Danevirke are within this electoral district.

*Masterton* comprises the whole of Pahiatua County, excepting Makuri Riding and an area situated north of a line extending along the Tararua Road (known as the road to Palmerston), along the northern boundary of the Woodville-Mangatainoko Special Settlement, and the northern boundary of Pahiatua Town District, and across the country to the Tiraumea River, near Ngaturi Township; together with the whole of Wairarapa North County, excepting the Wainuioru Riding and that part of Akiteo Riding stretching northward from the Aohanga River to the county boundary, as well as that portion of Masterton Riding in the existing electoral district. Masterton Borough forms part of this electorate, as also does Pahiatua Town District. The southern boundary of this district, extending from the East Coast to the Tararua Range, is unaltered.

*Wairarapa*.—This district is unaltered.

*New Plymouth* comprises Clifton County, and that part of Kawhia County lying south of parallel of south latitude 38° 30' (being generally a line east from Te Reinga Point, on the West Coast); together with the Road Districts of Waitara West, Egmont, Henui, Carrington, Frankley, Elliott, Barrett, Omata, Upper Hurford, Oakura, and Tataraimaka; Raleigh Town District; and that portion of Moa Riding within the boundaries of the present electoral district of New Plymouth. The Borough of New Plymouth is included in this district.

*Egmont* comprises the whole of Stratford County; the Road Districts of Okato and Parihaka; the Town District of Opunake, of Taranaki County; and that portion of Moa Riding, of the same county, which is included in the existing electorate of Egmont; together with the Waimate Road District, and Manaia Town District, of Hawera County. Inglewood and Stratford Town Districts are within the boundaries of this electorate.

*Waitotara* comprises the whole of Patea County; the Mokoia, Eltham, and Hawera Ridings, of Hawera County; together with the Ridings of Tokomaru and Waitotara, of Waitotara County; that portion of Westmere Riding, of the same county, which is situate to the north of the Kai Iwi Road-line and to the west of a line following the seaward boundaries of Sections 236, 233, 232, 231, and 230, Westmere Survey District, and proceeding thence to the northern corner of Castlecliff Township, and along its northern boundary to the sea; and that portion of Brunswick Riding, of Waitotara County, north of the Mission Line of road, and west of the eastern boundary of Section 60, and north of the northern boundaries of Sections 193, 229, and 134, Westmere Survey District. This district includes also the Boroughs of Hawera and Patea, and has within its boundaries the Town Districts of Normanby and Waverley.

*Wanganui* comprises the whole of Wanganui County, as well as that part of the Riding of Westmere, of Waitotara County, which lies to the south of the Kai Iwi line of road, and east of a line enclosing Sections 236, 233, 232, 231, and 230, Westmere Survey District, and proceeding thence to and along the northern boundary of Castlecliff Township to the sea; and also that part of Brunswick Riding lying south of the Mission Line of Road, east of Section 60, Westmere Survey District, and south of Sections 193, 229, and 134 of the same district; together with the Makohau and Wangaehu Ridings, of Rangitikei County; and that part of Okakapu Riding, of the last-named county, which lies west of the road which forms the western boundaries of Sections 24, 29, and 31, Block II., Rangitoto Survey District. This district includes also the Borough of Wanganui, and the Town District of Lethbridge.

*Rangitikei* comprises the whole of Rangitikei County, excepting the Ridings of Wangaehu and Makohau, and that part of Okakapu Riding lying to the west of the road which forms the western boundaries of Sections 24, 29, and 31, Block II., Rangitoto Survey District; together with the Riding of Waituna, of Oroua County; and that portion of Kiwitea Riding, of Oroua County, situated to the west of the Oroua River. This district includes also the Boroughs of Marton and Feilding; the Town Districts of Halcombe and Bulls are also within its boundaries.

*Palmerston* comprises the Ridings of Taonui, Ashurst, and Fitzherbert, of Oroua County; and that portion of Kiwitea Riding, of the same county, which lies east of the Oroua River; together with that part of Mount Stewart Riding, of Manawatu County, situated east of the road leading from Halcombe to Palmerston *via* Sections 93, 94, and 77, Block XIII., Oroua Survey District. This district includes also the Borough of Palmerston.

*Otaki* comprises Horowhenua County; the whole of Manawatu County, excepting the portion of Mount Stewart Riding which lies east of the road from Halcombe to Palmerston by way of Sections 93, 94, and 77, Block XIII., Oroua Survey District; together with the Ridings of Mungaroa, Wainui-omata, and Horokiwi, of Hutt County; and that portion of Epuni Riding situated to the north-east of the road leading northwards from the Borough of Lower Hutt, past Bel-

mont and up the valley of the Hutt, through Sections 51, 425, 203, 428, 431, 336, 435, 434, and 433, to Section 436, and *via* the last-mentioned section to Horokiwi Riding. This district comprises also the Borough of Foxton and Kapiti Island.

*Wellington Suburbs* comprise the Karori-Makara Road District, the Seatoun Road District, the Porirua Riding, of Hutt County; and that part of Epuni Riding, of Hutt County, which lies south-west of the road commencing at the northern boundary of Section 436, Hutt District, and proceeding southerly, passing Sections 436, 433, 434, to and along the valley of the western Hutt, and terminating at the boundary of the Borough of Lower Hutt below Belmont; together with the Boroughs of Melrose, Onslow, Karori, Lower Hutt, and Petone. Johnsonville Town District is in this electorate, and the islands of Mana and Somes.

*City of Wellington* comprises the City of Wellington.

#### MIDDLE ISLAND ELECTORAL DISTRICTS.

*City of Nelson* comprises the City of Nelson and the Borough of Richmond; together with the Wangamoa and Stoke Ridings, of Waimea County; and that part of Wai-iti Riding, of the same county, which lies between the Wairoa River and the Nelson and Foxhill Railway, east of the road forming the western boundaries of Sections 53, 54, 60, and 140, Waimea Survey District, and east of a line drawn along the eastern boundaries of Sections 2 and 3, Waimea.

*Waimea-Sounds* comprises Sounds County, and the whole of Waimea County, excepting (1) the Ridings of Stoke, Wangamoa, Wangapeka, and Motupiko; (2) that part of Wai-iti Riding which is situated between the Wairoa River and the Nelson and Foxhill Railway, and east of the road on the western boundaries of Sections 53, 54, 60, and 140, Waimea Survey District, and east of a line drawn so as to include Sections 2 and 3; and (3) that part of Motueka Riding lying north from Sandy Bay, and more particularly described as situated to the west of Sections 2 of 13, 4, 204, 5, and 82, and north of the road leading towards Takaka; together with the Riding of Pelorus and Havelock Town District, both of Marlborough County, and the Brothers and D'Urville and adjacent islands.

*Wairau* comprises the whole of Marlborough County, excepting Pelorus Riding and Havelock Town District; together with the Boroughs of Picton and Blenheim.

*Buller* comprises the Ridings of Wareatea North and Karamea, of Buller County; also that portion of Lyell Riding, of the same county, which lies north of the Buller River; and the whole of the Collingwood County; together with the Wangapeka Riding, of Waimea County; that part of Motueka Riding, of the last-named county, to the north of the road leading from Sandy Bay towards Takaka, and west of a line excluding Sections 2 of 13, 4, 204, 5, and 82; and the Borough of Westport. The southern and south-eastern boundaries of this district, extending from the mouth of the Buller River as far as the Baton River, remain unaltered.

*Inangahua* comprises the following: The whole of Inangahua County; the Ridings of Charleston and Wareatea South, of Buller County; and that part of Lyell Riding, of Buller County, situated south of the Buller River; together with the Waipuna Riding, of Grey County; and the part of Brunner Riding, of the same county, which lies north-east of the watershed between Moonlight Creek and Blackball Creek; and the Motupiko Riding, of Waimea County. The northern boundary of this district, from the Buller mouth to the Baton River, remains unaltered.

*Grey* comprises the Ridings of Hohonu, Marsden, Maori Creek, Paroa, Cobden, Nelson Creek, and Red Jack's, of Grey County; and that portion of Brunner Riding lying to the south-west of the watershed between Moonlight Creek and Blackball Creek; together with that portion of Westland County north of the road leading from Kumara *via* Chesterfield Township to the mouth of the Arahura River. This district includes also the Boroughs of Brunner and Greymouth.

*Westland* comprises almost the whole of Westland County; the portion omitted being that lying to the north of the road leading from the mouth of the Arahura River to Kumara *via* Chesterfield Township. The Boroughs of Kumara, Ross, and Hokitika are in this electorate.

*Ashley* comprises the Counties of Kaikoura, Amuri, and Cheviot; together with the Ridings of Waipara, Mount Thomas, and Kowai, of Ashley County; and that portion of Oxford Riding, of the last-mentioned county, which is situated west of the road leading from East Oxford northwards towards Glentui, and north of the Oxford-Sheffield Railway. Amberley Town District is in this electorate.

*Kaiapoi* comprises the Ridings of Cust and Mandeville, and the West Eyreton Road District, of Ashley County; together with that portion of Oxford Riding situated south of the Oxford-Sheffield Railway, and east of the road leading from East Oxford towards Glentui; and the east portion of Eyreton Road District, of Ashley County, situated on Kaiapoi Island, north of Cherry Road and east of Kaikainui Creek, and of the road passing Sections 738 and 560. Included also

in this electorate are the Boroughs of Rangiora and Kaiapoi. The northern, southern, and eastern boundaries of this district are unaltered.

*Avon* comprises that portion of the Heathcote Road District, of Selwyn County, which is situated north-east of the Canal and Road Reserve (or, in other words, the present electoral boundary); and the whole of Eyreton Road District, of Ashley County; excepting that portion of Kaiapoi Island south of Cherry Road, near Clarkville Post-office, east of the Kaikainui Creek and of the road passing Sections 738 and 560; together with that portion of the Avon Road District, of Selwyn County, which lies east of a line commencing at the northern boundary of the Borough of St. Albans, and proceeding northerly to and along Kelly's Road, Hill's Road, Hawkins Road, and the Canal and Road Reserve, to and across the railway-line at Chaney's Station, and along the road skirting the Waimakariri River to White's Bridge. Woolston and Linwood Town Districts are in this electoral district.

*Lyttelton* comprises the Port Levy Riding of Akaroa County; and that portion of Heathcote Road District which is situated to the south-west of the Canal and Road Reserve between Woolston and Linwood; together with the Borough of Lyttelton and Sumner Town District.

*Ellesmere* comprises the Ridings of Wainui, Little River, Le Bon's Bay, and Okain's Bay, of Akaroa County; that portion of Ellesmere Riding, of Selwyn County, lying to the south of the Southbridge Railway-line, and of the North Rakaia and Taumumu Junction Road; that portion of Lincoln Riding lying to the south of the Southbridge Railway-line, and west of Halswell River and Junction Road; and that portion of Halswell Road District lying to the south-east of the road leading from the Halswell River, at Section 1487, to and past the Halswell Road Board Office to the Plantation and Road Reserve, thence along that reserve to the Heathcote River near Cashmere, and to the north-east of the Heathcote River. This district includes also the Borough of Akaroa and Southbridge Town District.

*Riccarton* comprises that portion of Avon Riding, of Selwyn County, which is situated to the west of a line drawn from the northern boundary of the Borough of St. Albans to Kelly's Road, thence northerly along that road and Hill's Road and Hawkins Road to the Canal and Road Reserve, and along that reserve crossing the railway-line at Chaney's, and along the road skirting the Waimakariri River to White's Bridge; and the whole of Riccarton Riding of Selwyn County, excepting (1) Hagley Park and a block of land between the park boundary and the railway, and north of Riccarton Road and south of the Avon River, and (2) that portion of Riccarton Riding lying south of Newton and Coal Tramway Road and west of Prebbleton and Waimakariri Road; together with that portion of Halswell Riding lying to the north-west of the road leading from Halswell River, at Section 1487, to and past the Halswell Road Board Office to the Plantation and Road Reserve, and along that Road Reserve to the Heathcote River near Cashmere; and to the south-west of the Heathcote River; and that portion of Lincoln Riding, of Selwyn County, which lies to the east of Harewood and Hampton's Road, and of the Southbridge Railway-line, and north of Leadley's Road, of the road at the western boundaries of Sections 5772, 7626, 5784, and 5502, and of Halswell Road by Ladbroke's.

*City of Christchurch* comprises the City of Christchurch and the Boroughs of Sydenham and St. Albans, together with Hagley Park and the narrow strip of Riccarton Riding between the park boundary and the Northern Trunk Railway, bounded on the north by the Avon River, and on the south by Riccarton Road.

*Selwyn* comprises the Ridings of Courtenay, Malvern, and Coleridge; that portion of Riccarton Riding situated south of Newton and Coal Tramway Road, and west of Prebbleton and Waimakariri Road; and that portion of Lincoln Riding situated to the west of Harewood and Hampton's Road and the Southbridge Railway-line, and south of Halswell Road by Ladbroke's to the road forming the western boundaries of Sections 5502, 5784, 7626, and 5772, and east of that road and of Leadley's Road; and that portion of Ellesmere Riding situated east of Selwyn and Bealey's Road, north of Rakaia and Irwell Road, Buckley's Road, and Brookside and Irwell Road, and west of the Southbridge Branch Railway-line.

*Rakaia* comprises the Ridings of Mount Hutt and South Rakaia, of Ashburton County, and that portion of Wakanui Riding, of the same county, which lies east of the road leading from Ashburton to the beach *via* Wakanui Post-office; and that part of Upper Ashburton Riding which lies east of the Ashburton River; together with that portion of the Ellesmere Riding which lies to the north of the road leading westerly from Southbridge known as the North Rakaia and Taumumu Junction Road, and to the north-west of the Southbridge Railway-line as far as the Brookside and Irwell Road, and south of that road, of Buckley's Road, and of Rakaia and Irwell Road, and west of Selwyn and Bealey's

Road. This district includes also the Borough of Ashburton, and has within its boundaries the Town District of Hampstead.

*Rangitata* comprises the Ridings of Ashburton, Rangitata, and Mount Somers, of Ashburton County; that portion of Upper Ashburton Riding, of the same county, which lies to the west of the Ashburton River; and that part of Wakanui Riding, of Ashburton County, which lies to the west of the road leading from the Borough of Ashburton to the beach *via* Wakanui; together with that part of Raukapuka Riding, of Geraldine County, which is situated on the east side of the Haehaetemoana River and west of Campbell's Road, running past Woodbury and east of the Waihi River; that part of Mount Peel Riding, of Geraldine County, which lies east of the Waihi Gorge Road, and of a line drawn to the summit of Four Peaks Range, thence to the source of the south branch of the Orari River, then along that river and the Tripp's Pass Road down to the North Opuha River, and thence up that river to its source, thence over the Saddle and on to Forest Creek; and that part of Temuka Riding situated north-east of Ohapi Creek, and north of Barker's Road. Tinwald and Geraldine Town Districts are in this electorate.

*Pareora* comprises the whole of Mackenzie County; the Ridings of Lower Pareora, Upper Pareora, and that portion of Otaio Riding lying to the north of Woolshed Gully Road, and east of the road leading past Bluecliffs to the Otaio River; and the whole of the Levels Riding, of Geraldine County, excepting that portion in the present Timaru Electoral District; together with that portion of Mount Peel Riding lying to the west of a line running from the Waihi Gorge Road to the summit of Four Peaks Range, thence to the source of the south branch of the Orari River, thence along the Orari River and the Tripp's Pass Road down to the North Opuha River, and thence up that river to its source, and thence over the saddle and on to Forest Creek; and that portion of Temuka Riding lying to the west of Ohapi Creek and south of Barker's Road; and that portion of Raukapuka Riding lying to the west of the Haehaetemoana River, west of Campbell's Road, passing Woodbury, and south of the Waihi River. The Town Districts of Temuka and Arowhenua are in this electorate.

*Timaru*.—This district is unaltered.

*Waitaki* comprises the Ridings of Hakateramea, North Waihao, Deep Creek, and Makikihi, of Waimate County; and that portion of the Otaio Riding, of the same county, which is situated south of Woolshed Gully Road and west of the road leading past Bluecliffs to the Otaio River; together with the Ridings of Awamoko, Ahuriri, and Otakaika, of Waitaki County; and that portion of Waiareka Riding, of the last-named county, which lies to the north of the northern boundaries of Kuroo and Oamaru Survey Districts, in the locality of Elderslie Railway-station; and that portion of Papakaio Riding, of Waitaki County, which lies generally north of a line commencing at the western boundary of Block III., Papakaio Survey District, on the road from Peebles to Duntroon, and following the western, northern, and eastern boundaries of the said Block III., and the northern and eastern boundaries of Block IV., Papakaio, to the railway-line; and along the railway-line to Waitaki Bridge; and that portion of Incholme Riding, of Waitaki County, which lies north of the Kuroo River; and that part of Otepopo Riding, of Waitaki County, which lies west of the railway-line and of Herbert Township, and north of the north branch of the Waianakarua River. This district includes also the Borough of Waimate, and includes within its boundaries the Township of Maheno.

*Oamaru* comprises the Kakanui Riding, of Waitaki County; that portion of the Waiareka Riding, of the same county, which is situated south of the Awamoko and Papakaio Survey Districts; together with that portion of Papakaio Riding, of Waitaki County, which lies generally south of a line commencing at Waitaki Bridge, and proceeding along the railway-line to the eastern boundary of Block IV., Papakaio Survey District, and thence along the eastern and northern boundaries of that block, and the eastern, northern, and western boundaries of Block III., Papakaio, to the road leading from Peebles to Duntroon; and that portion of Incholme Riding which lies south-east of the Kuroo River. This district includes also the Borough of Oamaru.

*Waihemo* comprises the whole of Maniototo County; and the whole of Waihemo County, excepting Goodwood Riding and that portion of Macrae's Riding situated south-west of the road leading from Macrae's to Hyde *via* Deepdell; together with the Moeraki Riding, of Waitaki County; that portion of Otepopo Riding, of the same county, which is situated south of the north branch of the Waianakarua River, and east of the Southern Trunk Railway-line; and the Township of Maheno. This district includes also the Boroughs of Naseby, Palmerston, and Hampden. The Township of Herbert is within the boundaries of this electorate.

*Waikouaiti* comprises the whole of Peninsula County, and Goodwood Riding, of Waihemo County; together with the whole of Waikouaiti County, excepting that portion of

North-east Valley Riding between the Boroughs of Port Chalmers and West Harbour, and enclosed by a line starting at the north-eastern boundary-line of the latter borough, and proceeding north-westerly along the road which forms the south-western boundaries of Sections 11, 9, 7, 5, 3, 1, 36, 38, 40, and 42, Sawyer's Bay District; thence north-easterly and south-easterly generally along the boundaries of that district to the Borough of Port Chalmers. This district includes also the Borough of Hawksbury.

*Dunedin North* comprises the Boroughs of West Harbour, Maori Hill, Port Chalmers, and North-east Valley; and that portion of the Borough of Roslyn which is situated south-east of Helensburgh Road, east of West Taieri Road, north-west of Broughton Township, and north-east of a line commencing at the original south-western boundary of Section 20, Upper Kaikorai District (now closed road-line), and proceeding south-easterly along the south-west boundaries of original Sections 20, 18, 16, 14, 12, 10, 8, 6, 4, and 2, Block III., Upper Kaikorai District, and along the south-west boundary of original Section 1, Block II., Upper Kaikorai District, to the Town Belt of the City of Dunedin. This district comprises also that portion of North-east Valley Riding, of Waikouaiti County, which is situated between the Boroughs of Port Chalmers and West Harbour, and enclosed by the following: On the south-west by the Borough of West Harbour and the road fronting Sections 12, 10, 8, 6, 4, 2, 37, 39, 41, and 43, Sawyer's Bay District; on the north-west and north-east generally by the north-western and north-eastern boundaries of Sawyer's Bay District; towards the north by the northern boundary of Sawyer's Bay District; on the east by the Borough of Port Chalmers; and on the south by the Port Chalmers Railway-line.

*City of Dunedin* comprises the City of Dunedin, with that portion of the Borough of Caversham situated east of Section 18, Town District, and south of the Main South Road, and north of Cargill Road; and that other portion of the Borough of Caversham lying between the Boroughs of South Dunedin and St. Kilda, and east of Forbury Road; together with the whole of the Borough of South Dunedin and the whole of the Borough of St. Kilda; and that portion of the Borough of Mornington situated west of Argyle Street, north-east of Elgin Road and of Argyle Street, in Primrose Hill Township, and of the Glen Road.

*Caversham* comprises that portion of the Borough of Roslyn which is situated generally south-west of Helensburgh Road, West Taieri Road, south-west of Waikari Township, and of a line drawn along the south-western boundaries of original Sections 20, 18, 16, 14, 12, 10, 8, 6, 4, and 2, Block III., Upper Kaikorai, and along the south-western boundary of Section 1, Block II., Upper Kaikorai, to the Town Belt of the City of Dunedin; also that portion of the Borough of Mornington situated to the south-west of Glen Road, Argyle Street, and Elgin Road, and south-east of Hamthorn Road; together with that portion of the Borough of Caversham situated west of Section 17, Town District, and of Forbury Road. This district includes also the Borough of Green Island, and the Kaikorai Riding, of Taieri County.

*Taieri* comprises the whole of Taieri County, excepting the Kaikorai Riding; together with Clarendon Riding, of Bruce County; and Waipori Riding, of Tuapeka County; and that portion of Macrae's Riding, of Waihemo County, situated to the south-west of the road leading from Macrae's to Hyde by way of Deepdell; and also the Borough of Mosgiel. Greytown and Outram Town Districts are in this electorate.

*Bruce* comprises the whole of Bruce County, excepting Clarendon Riding; together with Clydevale Riding, of Clutha County; and Waitahuna Riding, of Tuapeka County; and the whole of Clark's Riding, of the same county, excepting that portion which is included within a line commencing at Lawrence and proceeding along the road starting between Sections 99 and 100, Block II., Tuapeka East, and continuing southerly through that block to the railway-line near Section 29, thence along the railway-line to Forsyth Railway-station, thence along the road continuing south-westerly, passing Sections 10, 24, 28, 39, 25, and 63, Block V., Tuapeka East, Sections 18, 46, and 47, Block VII., Waitahuna East, and Sections 25, 20, 19, 22, 24, 13, and 84, Block VI., Waitahuna West, to Breakneck Road, and thence along the riding boundary to Lawrence. This district includes also the Boroughs of Milton and Kaitangata.

*Clutha* comprises the whole of Clutha County, excepting Clydevale Riding; together with Tapanui Riding, of Tuapeka County; and that portion of Mataura Riding, of Southland County, which is situated north of the Southern Trunk Railway-line and of the Borough of Gore; and south-east of the Okapua Stream. This district includes also the Boroughs of Balclutha and Tapanui, and has within its boundaries Clinton Town District.

*Tuapeka* comprises the whole of Tuapeka County, excepting the Ridings of Waitahuna, Waipori, and Tapanui; and excepting also that portion of Clark's Riding excluded by a line commencing at the Borough of Lawrence and proceed-

ing along the road between Sections 99 and 100, Block II., Tuapeka East District, and continuing southerly through that block to the railway-line near Section 29, thence along the railway-line to Forsyth Railway-station, thence along the road continuing south-westerly, passing Sections 10, 24, 28, 39, 25, and 63, Block V., Tuapeka East, Sections 18, 46, and 47, Block VII., Waitahuna East, and Sections 25, 20, 19, 22, 24, 13, and 84, Block VI., Waitahuna West, to Breakneck Road, at the riding boundary. This district includes also the Ridings of Earnsclough, Dunstan, Manuhēria, and Matakānui, of Vincent County; and the Boroughs of Alexandra, Roxburgh, and Lawrence.

Wakatipu comprises the whole of Lake County; and the Ridings of Carrick, Clutha, Hawea, and Lindis, of Vincent County; together with the Waikaia Riding, of Southland County; and that portion of Matakāra Riding, of Southland County, which lies to the north-west of Okapua Stream, and of a line from the source of that stream to the Waikaka River, and thence on northwards to the riding boundary. This district includes also the Boroughs of Queenstown, Arrowtown, and Cromwell.

Matakāra comprises the Waihopai and Toetoes Ridings, of Southland County; and that portion of the Matakāra Riding, of the same county, which is situated to the south of the Southern Trunk Railway; together with that portion of Hokonui Riding, of Southland County, which is situated to the south of the Otamita Stream. This district includes also the Borough of Gore. That part of the western bound-

dary of this electoral district extending from Foveaux Strait to Otamita Stream is unaltered.

Awarua comprises the Ridings of Wallacetown and Winton, of Southland County; that portion of Awarua Riding which is situated to the north of the Waihopai River, south of the Seaward Bush Railway-line, and of the Borough of South Invercargill; and also that part of Oreti Riding, of Southland County, which lies south-west of the road leading southerly from Josephville Railway-station via Glenure to the Waimea. This district includes also the Boroughs of Campbelltown and Winton, and Stewart Island, Dog Island, Centre Island, and other adjacent islands.

Invercargill comprises the Boroughs of Invercargill, North Invercargill, East Invercargill, South Invercargill, Avenal, and Gladstone; and that portion of Awarua Riding, of Southland County, which lies between the Waihopai River and the Seaward Bush Railway, and of a line running west from the southern boundary of the Borough of South Invercargill to the New River Estuary.

Wallace comprises the whole of the Counties of Wallace and Fiord, and the whole of the Oreti Riding, of Southland County, excepting that portion which is situated to the south-west of the road leading southerly from Josephville Railway-station via Glenure to the Waimea; together with that portion of Hokonui Riding, of Southland County, which lies north of the Otamita Stream. The district includes also the Borough of Riverton.
