



Local Patent Offices for the reception of applications for Letters Patent have been established at the following places:-Auckland, Thames, New Plymouth, Wanganui, Gisborne, Napier, Blenheim, Westport, Greymouth, Hokitika, Christ-church, Ashburton, Timaru, Oamaru, Dunedin, Queenstown, Lawrence, and Invercargill. In every case the office is at the Courthource the Courthouse.

Specifications of all Patents and Letters of Registration applied for in the colony can be inspected at the Patent Office, and particulars of Patents, &c., granted in England, the United States, Canada, and the Australian Colonies can be seen at the Patent Office Library at the Museum, Wel-
