*Altering the Boundaries of the Land Districts of Nelson and Canterbury.*

GLASGOW, Governor.  
ORDER IN COUNCIL.

At the Government Buildings, at Wellington, this twenty-first day of February, 1893.

Present:  
THE HONOURABLE SIR P. A. BUCKLEY, K.C.M.G., PRESIDING IN COUNCIL.

WHEREAS by the twenty-second section of "The Land Act, 1892," certain land districts are defined, but it is provided that the Governor, by Order in Council, if he shall deem it necessary, may from time to time alter the boundaries of any land district as he shall think fit:

And whereas it is desirable to alter the boundaries of the Nelson and Canterbury Land Districts, so that the land described in the Schedule hereto may be taken from the Nelson Land District and added to the Canterbury Land District:

Now, therefore, I, David, Earl of Glasgow, the Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority conferred upon me by the hereinbefore in part recited Act, and by and with the advice and consent of the Executive Council of the said colony, do hereby direct and declare that, from and after the date hereof, the land described in the said Schedule shall cease to belong to the Nelson Land District, as defined under the said Act, and shall be added to the Canterbury Land District, as defined as aforesaid, and that the boundaries of the said land districts are hereby altered by excluding the said land from the Nelson Land District and including it within the Canterbury Land District.

ALL that area in the Colony of New Zealand, containing by admeasurement 85,361 acres, more or less, bounded towards the north generally by the Waiau-au River to a point in line with the eastern boundary-line of Section No. 1, Cheviot Survey District; thence to and by that section and by Sections Nos. 2 and 39, and again by the Waiau-au River; towards the east by the sea; towards the south by the Hurunui River; and towards the west generally by the Kaiwara River and Sections Nos. 75, 76, 77, 78, 79, 80, 81A, 82, 83, 84, 85, 86, 87, 88, 89, and 200, Lowry Peaks Survey District.

THE HONOURABLE SIR P. A. BUCKLEY, K.C.M.G., PRESIDING IN COUNCIL.

WHEREAS the lands mentioned in the Schedule hereto were reserved permanently as quarry reserves on the eleventh day of October, one thousand eight hundred and eighty-six, and the fourth day of April, one thousand eight hundred and eighty-nine:

And whereas, in the opinion of the Governor, it is expedient to vest the said lands in the inhabitants of the Opaheke North Road District:

*Land open for Selection under "The Naval and Military Settlers' and Volunteers' Land Act, 1891."*

IT is hereby notified that, in terms of section 8 of "The Naval and Military Settlers' and Volunteers' Land Act, 1891," the Land Boards of the under-mentioned districts have decided that the land specially set apart for the satisfaction of remission certificates shall be open as unsurveyed land on and after the 31st March, 1893, at the land offices of the respective districts.

Where more than one application for the same allotment is made on the same day, the priority of choice shall be decided by lot between the applicants.

A holder of a remission certificate may select any area the price whereof, according to the rates per acre specified against the block of land, does not exceed in amount the sum of money to be remitted under such certificate; and with his application for such area shall deposit his remission certificate.

If personal attendance is not possible, duly-authorized agents shall deposit the applications, together with the scrip, at the District Land Office, so as to make the selection, as otherwise the land will be allotted by the Commissioners according to the order of choice decided by the ballot.

Selectors must conform to a general scheme approved by the Commissioners of Crown Lands, and shall in every instance extend to the back line, unless otherwise approved.

## Teachers' Examination, 1893.

Education Department,  
Wellington, 23rd February, 1893.

THE following lists contain statements of the principal results of the examination held last month. It must be understood that the granting of a certificate depends only in part upon the result of an examination, and that candidates who have not had the experience required by the regulations, or who do not receive the necessary marks from a School Inspector, have no claim to a certificate.

The first list contains the names of the successful candidates for Classes C, D, and E. The names of candidates who, having been partially successful in former years, have now passed in the subjects in which they formerly failed, are included in this list. The second list gives the names of candidates who will be allowed to qualify for Classes C, D, and E respectively, by passing at the next examination in those subjects only in which they have this year been unsuccessful. In the case of the candidates who relied partly upon work done at the matriculation examination, the results of that examination have been taken into consideration in preparing these lists. The third list gives the names of the candidates to whom prizes for drawing and for elementary experimental science have been awarded. In a fourth list are given the names of the candidates whose work has been deemed worthy of special mention by the examiners.

Every candidate will receive a private intimation of his success or failure, and those whose names are in the second list will be advised as to the subjects in which they will have to be examined again.

The next examination will take place in January, 1894, beginning about the eighth of the month. Notices must be given so as to be in the office of the Department by the thirty-first of October. Candidates who have obtained "partial pass" must observe this rule equally with other candidates, and must not expect to receive any further intimation of the date at which the notices become due. Forms of application can be obtained at the office of the Department or of any Education Board.

Teachers who have gained promotion at this examination may send in their certificates for indorsement.
