At the Government House, at Christchurch, this thirtieth day of December, 1893.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS it has been made to appear to the satisfac-Which it has been made to appear to the satisfaction of the Governor in Council that disease is believed to exist in the countries and places hereinafter mentioned, and that the importation to New Zealand of the animals hereinafter specified from any of the said countries or places is likely to propagate disease: And whereas it is expedient to make the several regulations hereinafter set footh:

forth:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in exercise of the powers conferred by "The Stock Act, 1893," acting by and with the advice and consent of the Executive Council of the said colony, doth hereby absolutely prohibit the introduction of cattle, sheep, and swine into the Colony of New Zealand from any of the countries or places following—namely, the countries comprised within the Continents of Europe, Asia, Africa, and America, except Great Britain and Ireland—unless such stock have been fourteen days in Great Britain or Ireland, and have been forwarded direct to this colony; and doth also prohibit such importation from all colonies or places other than the Australasian Colonies:

And in exercise of the like powers, and with the like advice and consent, His Excellency doth hereby revoke all Orders

And in exercise of the like powers, and with the like advice and consent, His Excellency doth hereby revoke all Orders in Council and regulations made under "The Diseased Cattle Act, 1881," prior to the date hereof, and doth hereby make, for the purposes of "The Stock Act, 1893," the general regulations set forth in the Schedule hereto, and doth hereby declare that this Order in Council shall come into force on and after the first day of February, one thousand eight hundred and ninety-four.

PART A.—INTRODUCTORY.

I. GENERAL.

Stock to which these regulations shall apply.

1. The provisions of "The Stock Act, 1893," shall extend to all stock of the kinds mentioned in the Schedule I. hereto.

What are to be deemed infectious or contagious diseases, and what infected stock.

2. The diseases mentioned in the second column of Schedule I. hereto are hereby declared to be diseases to which the several animals mentioned in the first column of the said Schedule opposite the names of such diseases respectively are subject; and all stock infected with any one of such diseases are hereby declared to be infected stock.

Interpretation.

3. In these regulations, and in the several Schedules and forms thereto, the following words and terms shall, unless the context otherwise indicates, have the meanings set against

context otherwise indicates, have the meanings set against them respectively, namely:—
"Attendant:" Means any person in charge, or who may have been at any time during the three months next preceding date of arrival in charge of imported

stock:

stock:

"Australasian: "As regards places—any of the Colonies of Queensland, New South Wales, New Zealand, Victoria, South Australia, Western Australia, and Tasmania, and any port or place in any of such colonies; as regards stock or things—any stock or things from any of such colonies; and as regards vessels—any vessels trading solely, and which have traded solely for three months preceding date of shipment, between such colonies:

"Carcase:" The carcase of any stock, or the whole or any part of the flesh, wool, skin, hide, bones, hair, horns, hoofs, or other portion of the carcase:

"Cattle:" Any bull, cow, ox, steer, heifer, or calf, and the carcase or any portion of the carcase thereof respectively:

respectively:

"Chief Inspector:" The Chief Inspector of Stock, or any person for the time being performing the duties

of the Chief Inspector:
"Conveyance:" Any dray, cart, carriage, truck, horsebox, wagon, vehicle, or vessel which is or has been

box, wagon, venicle, or vessel which is or has been used for the conveyance of, or has come into contact with, any stock:

"Destroy:" To entirely consume by fire, or, if permitted by an Inspector, to bury at a depth of not less than 3ft. underground; or, in the case of sheep, if permitted by an Inspector, to consume the wool and skin by fire, and to boil down the remainder of the

carcase:
"Dip" or "dipped," in respect of ticks and lice in sheep, means plunged or immersed in some effective tick- or lice-destroying preparation:

"Disease:" Any of the diseases mentioned in the Schedule I. hereto, and any other disease affecting stock, which the Governor shall hereafter, by Order in Council, declare to be a disease for the purposes of the said Act:
"Diseased stock:" All stock actually suffering from or

"Diseased stock:" All stock actually suffering from or affected with disease as hereinbefore defined:
"Dog:" Any dog, slut, or whelp of any breed or age:
"Fittings:" Any stall, stable, sheep-pen, cow- or cattle-house, horse-box, or other premises for keeping or confining stock; and any halters, brushes, clothes, buckets, or other articles or things whatsoever which shall have been brought into contact with any shall have been brought into contact with any

stock:
"Fodder:" Any hay, straw, grass, green crop, root, vegetable, grain, corn, litter, manure, or any other thing used for the food or litter of stock, or found

with or about stock:
"Foreign:" As regards

"Foreign:" As regards places, stock, vessels, or things
—any place, port, stock, vessel, or thing, other than
any Australasian place, port, stock, vessel, or thing:
"Horse:" Any horse, mare, gelding, colt, filly, foal, ass,
or mule, or the carcase or any portion of the carcase thereof respectively:
"Imported stock:" Any stock arriving in the colony by

"Infected place:" Any place, land, or premises defined by Order in Council or by an Inspector to be an in-

"Infected stock:" All stock not actually diseased which forms, or during the preceding three months has formed, part of a lot containing any diseased stock, or which has during the preceding three months been in contact with diseased stock or with stock dressed, dipped, or otherwise treated for the cure of any disease; but no stock shall be considered "infected stock" by reason only of forming part of a lot affected or infected with a disease to which such stock are not liable:

"Infected vessels or things:" Any vessel or thing with which any infected stock shall have come in contact within the three months preceding the date of ar-

rival:

"Inspector:" The Chief Inspector, or any Inspector of

"Litter:" Any straw, or other bedding or litter, or any manure or other excreta with which stock shall have been in direct or indirect contact:

"Master:" The captain or other person in charge of any

"Notice" means a notice in writing or in print, or partly in writing and partly in print, delivered personally, or by leaving the same at, or posting the same addressed to, the office or address of an Inspector, or at or to the usual or last-known place of abode in New Zealand of the stockowner or other person to be affected by such notice, or by affixing such notice at the homestead or other conspicuous and frequented place on the land of such stockand frequented place on the land of such stock-

"Owner:" Any owner or joint owner (other than a

Introduction of infected stock, &c., prohibited.

4. The introduction into this colony of any stock, articles, or things infected or likely to be infected with any disease is hereby prohibited; and the introduction of any carcase, skins, hair, wool, horns, hoofs, or other portion of any carcase brought from any colony other than a clean colony, or other than by a clean vessel, except as hereinafter provided, is also prohibited.

Veterinary surgeons not to act under regulations and for the owner. 5. No veterinary surgeon shall perform any duties as such under these regulations with respect to any stock which are or have been under his professional treatment on behalf of the owner or consignee thereof.

Owner to give notice of arrival of stock.

6. If any stock are brought by sea to a port or place in this colony, the owner thereof shall, prior to or within twenty-four hours after their arrival, give the Inspector at or near such port or place notice to the effect of Schedule II. hereto: Provided that the notice hereby required may be dispensed with if the master of the reced by which such dispensed with if the master of the vessel by which such stock are brought make and deliver to the Customs officer first boarding his vessel a declaration to the effect of Schedule VI. or X. hereto, according as such stock are Australasian or foreign stock.

The whole expense re stock to be borne by owner.

The whole expense re stock to be borne by owner.

7. The owner of the stock shall pay all charges and expenses connected with the inspection, transporting, quarantining, housing, sustenance, disinfecting, dipping, dressing, veterinary, or other treatment of any stock from the time of their arrival in the waters of this colony until they are, as the case may be, released from detention or quarantine, transhipped, or otherwise disposed of; and the charges and expenses as set forth in Schedule XIII. hereto, together with all other expenses incurred, shall be payable on demand. all other expenses incurred, shall be payable on demand. The charges and expenses for transit, inspection, and dipping shall be calculated on the whole number of stock, and where there are more owners than one each owner shall pay on demand a proportionate share thereof.

All risks and loss to be borne by the owner.

8. All loss sustained with respect to any imported stock while being conveyed to or from or whilst in quarantine, whether by accident or by sickness arising from natural causes, or contracted from other stock, or by the destruction, or detention, or quarantine, or dipping, or dressing of such stock to prevent the spread of disease, shall be borne by the owner of such stock, and no Inspector shall be liable for any loss or damage occasioned to any owner of stock by any act of such Inspector, unless such damage shall be occasioned by his wilful neglect or default.

No stock to be landed but on Inspector's permit.

9. No person shall land or attempt to land, nor permit to be landed, any imported stock, nor any carcase, skin, to be landed, any imported stock, nor any carcase, skin, or any other portion of the carcase of any stock, nor any fodder, fittings, nor clothes, nor other articles or things with which such stock have been in contact, or likely to have been in contact—although their introduction may not be prohibited—without the written permission of an Inspector to the effect of Schedule III. hereto, except Australasian stock, as provided by Regulation No. 17 hereof; and any Inspector of Stock, officer of Customs, or member of the Police Force may prevent the landing of stock about to be introduced, or detain any such stock which may have been newly introduced, by sea into this colony until these regulations have been complied with. been complied with.

If Inspector is doubtful he may detain stock.

10. If the Inspector is doubtful ne may detain stock.

10. If the Inspector at the port of arrival is doubtful as to the freedom of any stock from infection he may temporarily detain them on board ship, or remove them to some other vessel for a period not exceeding forty-eight hours, at the owners' expense, where they may be dressed or disinfected as the Inspector may direct.

Owner to receive notice when stock are ailing or about to be destroyed.

11. When any stock are ailing or about to be destroyed under the above-named Act or regulations thereunder, notice thereof shall be given to the owner of such stock to the effect of Schedule IV. hereto.

How notices are to be given.

12. Notices under these regulations may be either served personally on the person to whom such notice is required to be given, or left at his residence or place of business, or sent to him by registered letter through the post, or by affixing such notice at the homestead or other conspicuous and frequented place on the land of such stockowner or

Inspector's directions to be carried out.

13. Any person receiving a requisition or direction from an Inspector under these regulations shall, with due despatch, give effect to and carry out the same; and if there be any information or document in the possession or power of any person which is required by an Inspector under these regulations, and asked for by him, the same shall be given by such person; and, if the requisition so made or directions so given be not complied with, they shall be carried out by an Inspector at the owner's cost and expense, and such cost and expense may be recovered in any competent Court by and in xpense may be recovered in any competent Court by and in the name of an Inspector.

PART B.—INTRODUCTION OF AUSTRALASIAN STOCK.

II. Introduction of Australasian Stock. 1. General Provisions.

What shall be deemed a clean colony.

14. Any Australasian Colony shall, as regards any particular kind of stock, be deemed a clean colony if the introduction of that kind of stock, or of stock of a different kind, but liable to be infected with the same disease, is not prohibited from such colony in terms of these regulations, or with respect to which there are no grounds for prohibiting the introduction of any such stock; and no stock shall be introduced into this colony but from a clean colony.

What shall be deemed a clean Australasian vessel.

15. When the question is raised, with respect to any particular kind of stock, whether or not the vessel by which such stock are intended to be conveyed, or have been conveyed, is a clean Australasian vessel, then it shall be held and deemed that such vessel is not a clean vessel,—

(1.) If any such vessel shall during the preceding three months have been in any port or place outside

months have been in any port or place outside
the Australasian Colonies;

(2.) If any of such stock have been put on board such
vessel at any port or place not being a port or
place in a clean Australasian Colony;

(3.) If within the then preceding three months such
vessel shall have had on board any infected stock
of the same kind, or stock of another kind but
liable to be infected with the same disease or
diseases as such first-mentioned stock;

diseases as such first-mentioned stock;
(4.) If such vessel shall within the then preceding three months have received on board any stock or skins, or any fodder or fittings, from a vessel which is not a clean Australasian vessel.

not a clean Australasian vessel.

And the exporter of stock shall, in every case, produce to the Inspector examining the same a declaration from the captain or agent of the vessel, in terms of Schedule V., that the vessel by which such stock are to be exported is a clean Australasian vessel in terms of this regulation. And no stock shall be introduced but by a clean vessel, and in accordance with the regulations relating to foreign stock.

Diseased Australasian stock, how to be disposed of.

Diseased Australasian stock, how to be disposed of.

16. If any Australasian stock shall be found on arrival, or on being landed, to be actually affected with any of the diseases mentioned in Schedule I. hereto, such stock shall be destroyed; and stock which have been in direct or indirect contact with or on the same land or vessel as such infected stock during the preceding three months shall be destroyed or otherwise disposed of as the Minister shall direct.

2. Miscellaneous Provisions.

Stock arriving from the undermentioned colonies are allowed to land (on complying with Regulation 17) as follows:

Dogs: All colonies, without quarantine.

Dogs: All colonies, without quarantine (see Regulation 17, last paragraph of subclause 4).

Sheep: Western Australia, prohibited; all other colonies,

Sheep: Western Australia, prohibited; all other colonies, without quarantine.
Cattle: Tasmania, without quarantine; all other colonies, ninety days.
Swine: All colonies, without quarantine.
Goats, deer, and other ruminants, if intended for zoological or acclimatisation society: Tasmania, without quarantine; Western Australia, prohibited; all other colonies, ninety days.

Conditions on which Australasian stock may be introduced

17. Australasian stock arriving by a clean Australasian vessel from a clean Australasian Colony, in terms of No. 14 of

vessel from a clean Australasian Colony, in terms of No. 14 of these regulations, may be admitted into this colony on the following conditions:—

(1.) Horses may be landed at the ports of Auckland, Gisborne, Napier, Wellington, Lyttelton, Dunedin, and Bluff on production of a declaration and certificate in terms of Schedule VI. if found, on inspection by a Customs officer or Inspector, to be free from disease; but, if the declaration and certificate in terms of Schedule VI. be not produced, such horse or horses shall not be landed until the master

or agent of the vessel and the owner of such horses shall have made a declaration as aforesaid, and shall have paid to the Inspector examining them a fee of 5s. per head for

inspection of such horses.
(2.) Swine, cattle, and other ruminants shall be landed at the ports of Wellington and Lyttelton only on production of a declaration and certificate in terms of Schedule VI. if found by an Inspector to be free from disease. No swine, cattle, or other ruminants will be allowed to land unless accompanied by a certificate from a veterinary surgeon in terms of Schedule VI.
(3.) Sheen may be landed at the ports of Arabida VI.

(3.) Sheep may be landed at the ports of Auckland, Wellington, Lyttelton, Dunedin, and Bluff on production of a declaration and certificate in terms of Schedule VI. if found declaration and certificate in terms of Schedule VI. If found on inspection by an Inspector to be free from disease; but, if the declaration and certificate in terms of Schedule VI. be not produced, such sheep shall not be landed until the master or agent of the vessel and the owner of such sheep shall have made a declaration as aforesaid, and shall have paid to the Inspector examining them a fee of 2s. 6d. per head, nor until they shall have been dressed as the Inspector shall direct.

(4.) Dogs may be landed at the ports of Auckland, Gisborne, Napier, Wellington, Lyttelton, Dunedin, and Bluff on production of a declaration and certificate in terms of Schedule VI. if found on inspection by a Customs officer or Inspector to be free from disease; but, if the declaration and certificate in terms of Schedule VI. be not produced, such dogs shall not be landed until the master or agent of the vessel and the owner of such dogs shall have made a declaration as aforesaid, and shall have paid the Inspector examining them a fee of 5s. per head.

Provided, however, that all dogs arriving from any Australasian Colony in which foreign dogs are quarantined at any other than a Government quarantine-ground shall be deemed and dealt with as foreign dogs, or as the Minister

shall direct.

Australasian stock arriving in vessel not a clean vessel.

18. Any Australasian stock arriving by a vessel which is not a clean Australasian vessel shall be deemed to be foreign stock, and shall be so treated.

Australasian stock not to be transhipped without the written permission of an Inspector.

19. No one shall within the waters of this colony transfer any Australasian stock from any vessel to any other vessel without the written authority of an Inspector, and in accordance with such authority; neither shall the master of any vessel allow any stock to stray from his vessel, nor to be removed therefrom, without the written authority of an In-

Australasian stock on a foreign vessel.

20. No Australasian stock shall be taken on board any 20. No Australasian stock shall be taken on board any foreign vessel except to be landed at a foreign port, and no person in charge of any foreign vessel shall allow any Australasian stock not intended to be taken to any foreign port to be taken or to go on board such foreign vessel, and all Australasian stock taken or being on board a foreign vessel shall be destroyed or treated and dealt with as foreign stock.

Foreign stock not to be put on board nor transhipped to an Australasian vessel.

21. No foreign stock, unless they shall have performed the quarantine hereby prescribed, and with respect to which all the other provisions of these regulations shall have been duly carried out, shall be put on board or transhipped to any Australasian vessel; and if any foreign stock shall be brought by sea by an Australasian vessel which shall not have performed the prescribed quarantine and been duly certified to be free from infection, then such stock shall, for the purpose of these regulations, he deemed to have been shipped at the of these regulations, be deemed to have been shipped place whence the same were originally brought, and such vessel shall for three months thereafter be held and deemed to be a foreign vessel.

PART C.—INTRODUCTION OF FOREIGN STOCK AND THINGS.

III. ANIMALS AND THINGS PROHIBITED.

22. The importation to the colony of the following foreign

- animals and things is hereby prohibited, viz.:—

 (1.) Cattle, sheep, and swine from all foreign countries and colonies other than Great Britain and Ireland, unless such have been fourteen days in Great Britain or Ireland.
 - (2.) All fodder and litter with which foreign animals have been in contact from any foreign colony or country, or from any foreign vessel.
 - IV. Introduction of Foreign Animals.

23. The following foreign stock may be admitted to the colony subject to the regulations hereby made (see Regulation 38)

Horses from any colony or country (1.)

(2.) Camels from any colony or country;

- (3.) Cattle, sheep, and swine from Great Britain or Ireland, or such as have been fourteen days therein;
- (4.) Goats, deer, and any other ruminants from any colony or country, if intended for a zoological or acclimatisation society;
- (5.) Dogs from any colony or country.

REGULATIONS.

Ports at which foreign stock can be landed.

24. Foreign stock shall only be landed at the ports of Wellington and Lyttelton: Provided that horses from San Francisco may be landed at Auckland.

V. Foreign Stock prior to starting and at Port of Shipment.

Notice to Inspector of intention to import foreign stock.

25. Any person intending to introduce foreign stock into this colony shall give the Inspector of Stock not less than fourteen days' notice in writing of his intention, to the effect of Schedule VII. hereto.

Declaration by owners, and certificate by district veterinary surgeon, prior to starting foreign stock for port of shipment.

26. The exporter of any foreign stock intended to be introduced into this colony shall take the following steps:—

(1.) He shall make a declaration before a Justice of the

Peace, solicitor, or notary public, to the effect of Schedule VIII. hereto:

(2.) He shall upon the declaration so made obtain the indorsement of a certificate by a veterinary surgeon in the district in which such stock are or from which they start for the port of shipment, to the effect of the certificate in the said Schedule VIII.

(3.) He shall deliver such declaration and certificate, as hereinafter provided, to the veterinary surgeon inspecting such stock (at the port of shipment).

If any foreign stock intended to be landed arrive unaccom-

panied by a declaration and certificate, or either of them, as required by this regulation, the owner shall pay a fine of 20s. per head, and the term of quarantine shall be extended for such further period as the Minister may direct.

Foreign cattle, sheep, and swine to be shipped from London or Glasgow.

27. All foreign cattle, sheep, and swine intended to be imported into this colony shall be shipped at the ports of London or Glasgow, and shall have been fourteen days at least in Great Britain or Ireland.

All stock to be examined at port of shipment by approved veterinary surgeon.

28. All stock, prior to their being put on board any vessel to be shipped for this colony, as well as all stock put or to be put on board the same vessel for the use of the passengers or crew, shall be carefully inspected at the owner's expense by a veterinary surgeon duly approved of in that behalf. Regulation 26 (3).)

The veterinary surgeon to obtain declaration, &c., and examine stock and certify to health or otherwise.

29. If the veterinary surgeon aforesaid shall have obtained the declaration and certificate hereinbefore mentioned, and shall be satisfied that the whole of the stock put on board or to be put on board such vessel are free from infection, and that all the other requirements of the regulations in force have up to that time been duly complied with, he shall, but not otherwise, makes and delivers declaration to the effect of not otherwise, make and deliver a declaration to the effect of Schedule IX. hereto to the master of the vessel, together with the declaration and certificate hereinbefore mentioned.

VI. Foreign Stock at Sea, and while in New Zealand Waters.

Skins of stock slaughtered or dying on board not to be landed. 30. The skins of all stock which have died or been slaughtered on board any foreign vessel during the voyage shall, if not thrown overboard while at sea, be salted and securely packed in cases or casks, and shall not be landed except for transhipment under the supervision of an Inspector.

Duty of master of vessel while in New Zealand waters re foreign stock and their treatment by Inspector.

31. It shall be the duty of the master of the vessel on board of which there are any foreign stock, as well as the actual owner thereof.-

(1.) To cause all such stock to be kept securely confined while such vessel is in the waters of this colony, and until such stock are removed to quarantine or otherwise disposed of:

(2.) To prevent any person except the attendant on such stock touching or handling the same without the

permission of an Inspector:
(3.) To see, while his vessel remains therein, that all such stock are cleansed, disinfected, and treated as the Inspector shall direct;

(4.) To see that no carcase nor any portion of a carcase of any stock, nor any fodder, fittings, nor litter, shall be allowed to fall or be thrown overboard without the permission of an Inspector, but shall be burned or otherwise disposed of as the In-spector in writing shall direct:

(5.) Not to allow any Australasian stock to be taken on board such vessel.

The master and attendant on the stock on arrival to make a joint declaration to Customs officer first boarding vessel.

32. The master of the vessel on which there are any foreign stock, and the attendant on such stock, shall on arrival in this colony make a statutory declaration to the effect of Schedule X. hereto, and the master shall forthwith deliver such declaration, together with the declaration and certificate to the effect of Schedule IX. hereto, at the office of the Inspector of Stock.

Stock on board a foreign vessel to be examined by the Inspector and veterinary surgeon,

33. All stock on board any foreign vessel shall on arrival in this colony be forthwith examined by an Inspector, and, if any of them are intended to be landed, then the whole of such stock shall be examined by a veterinary surgeon and an Inspector in company, who shall ascertain whether or not such stock are infected with any disease, whether mentioned in Schedule I. or not, and shall make their joint report to the effect of Schedule XI. hereto.

How ships' stock and ships' dogs are to be dealt with.

34. All stock intended for ship's use, and all dogs arriving by any foreign vessel, shall within forty-eight hours of their arrival in port be either removed to quarantine (see Regulation 24), killed, or otherwise disposed of as the Minister shall direct. The carcases of any cattle, sheep, or swine so killed may, by instructions from an Inspector and under his supervision, be sold and delivered ashore: Provided that ship's stock, after examination by a veterinary surgeon as required by Regulation 33, may be released from quarantine and returned to the vessel at any time by order of an Inspector without further examination on payment of inspection fees and charges as per Schedule XIII. Before removal to quarantine Regulation 36 must be complied with. removal to quarantine Regulation 36 must be complied with.

How foreign stock found to be infected are to be dealt with. 35. If any foreign stock on board ship, whether they are intended to be landed or not, are found to be infected, they shall be destroyed or otherwise disposed of as the Minister or Chief Inspector of Stock shall direct.

Payment of charges on foreign stock.

36. If foreign stock are not prohibited from being landed, and are reported by the Inspector to be free from infection, and if the Inspector is satisfied that all the requirements of these regulations have been fully complied with up to date, he shall take either of the following courses:—

(1.) He will either take a bond and guarantee to the effect of Schedule XII. hereto, duly executed by the owner or consignee of such stock, and two approved sureties, for insuring that such owner or con-

sureties, for insuring that such owner or consignee will, as regards such stock, faithfully carry out the conditions contained in these regulations, and pay all the charges and expenses specified in Schedule XIII. hereto, in so far as they may be incurred with respect to such stock, as well as any other charges and expenses payable by him under these regulations:

(2.) Or, if such a course be deemed necessary, the owner or consignee of such stock may be required by the Inspector to deposit with him such sum of money as he shall deem sufficient to defray all

such charges and expenses; And upon such bond and guarantee being obtained, or, as the case may be, such sum of money being deposited, such stock shall be removed to quarantine.

VII. QUARANTINE OF FOREIGN STOCK.

VII. QUARANTINE OF FOREIGN STOCK.

Stock to be taken by water to quarantine, and kept at owner's risk and expense.

37. All such foreign stock, including dogs, found on inspection to be free from infection shall, when necessary, before leaving the vessel, be washed and disinfected as the Inspector shall direct, and shall, within forty-eight hours after inspection, be conveyed by water at the owner's risk and expense to the quarantine-ground, and shall remain in quarantine for the terms respectively prescribed in the next succeeding regulation for the different kinds of such stock, during which they shall be kept at their owner's risk and expense, and shall be washed, dipped, and disinfected as prescribed by these regulations, and as the Inspector shall direct. direct.

Duration of quarantine for foreign stock.

38. The several kinds of foreign stock herein mentioned admitted to quarantine shall remain therein for the respective periods herein specified, dating from the day of removal from the vessel, namely :-

Horses, fourteen days. Cattle, sheep, goats, deer, antelopes, and other ruminants, sixty days. Pigs, sixty days. Camels, ninety days. Dogs, six months.

Foreign sheep to be dressed in quarantine.

39. All foreign sheep whilst in quarantine shall receive two or more dressings with tobacco and sulphur, or with lime and sulphur, as the Inspector shall direct.

ow foreign stock are to be released from quarantine.

40. After the expiration of the period of quarantine herein-before prescribed for the several kinds of foreign stock, they shall be examined by a veterinary surgeon and an Inspector, who shall ascertain whether all the requirements of these regulations in respect to such stock have been fully complied with, and whether such stock are free from infection; and if satisfied in these respects such examiners shall sign a certificate to the effect of Schedule XIV. hereto; and if such stock are free from infection, and the charges and expenses due have been paid, they may, but not otherwise, be released.

If owner refuse or fail to take delivery, stock may be sold.

41. In the event of any owner refusing or failing to release any stock from quarantine on the expiry thereof, or refusing or neglecting to pay any charges or expenses incurred with respect to such stock, they may be sold by order of the Minister, and the proceeds shall be paid into the Public Account, or proceedings may be taken against the owner for a penalty, or for the recovery of the amount of such charges and expenses. and expenses.

Restrictions on removal of stock or articles from quarantine.

42. No stock while alive or dead, nor any portion of the 42. No stock while alive or dead, nor any portion of the carcase thereof, nor any article of clothing used at any quarantine by any person in charge of, or attending on, any stock, and no covering of any such stock, nor any fodder, fittings, or other articles or things which may have come in contact with or been in use about such stock, shall be removed from the quarantine-ground without the written authority of an Inspector, and until, where necessary, such articles or things shall have been properly disinfected; and no person shall have in his possession or charge any stock, fodder, fittings, articles, or things which have been illegally removed from quarantine. removed from quarantine.

No person to enter quarantine-ground without permission, and persons entering to disinfect clothes, &c.

43. No person shall enter or leave the quarantine without the permission of an Inspector; and every person who shall enter a quarantine-ground shall clothe himself in such manner as shall be directed by an Inspector, and shall, before leaving the quarantine-ground, disinfect himself and his clothes in such manner as the Inspector shall direct.

Post mortem of stock dying in quarantine.

44. When any stock die or are slaughtered while in quarantine, a post mortem examination thereof shall be made by a veterinary surgeon, as the Inspector shall direct; and the remains shall be destroyed by fire at the expense of the owner

Australasian stock not to be taken or allowed to stray on to a foreign quarantine.

45. No stock shall be taken on to a quarantine-ground for foreign stock without the order in writing of an Inspector, nor shall any Australasian stock be allowed to stray on to such quarantine-ground; and all stock so taken or straying on to any such ground shall be kept, treated, and quarantined as if they were foreign stock, and their owner shall pay to the Inspector of Stock the charges and expenses of such first-mentioned stock fixed by these regulations for the inspection, keeping, quarantining, and treating of the inspection, keeping, quarantining, and treating of foreign stock.

VIII. MISCELLANEOUS PROVISIONS BE FOREIGN STOCK.

Foreign stock landed without passing through quarantine to be destroyed.

46. All foreign stock which have been landed without having passed through quarantine, and without having been released in accordance with these regulations, shall be destroyed or otherwise disposed of as the Minister shall direct.

Australasian stock coming into contact with foreign stock shall be held to be foreign.

47. Australasian stock coming into direct or indirect contact with foreign stock shall be destroyed, or held and deemed to be foreign stock, and shall be treated and dealt with as such.

No one but the attendant or person authorised to touch foreign stock.

48. No person except the attendant shall, without the permission of an Inspector, touch, handle, or come in contact with any foreign stock; and if any person touch, handle, or come in contact with any such stock contrary to these regulations, he shall disinfect himself and his clothes as an Inspector shall direct.

No foreign stock shall be transhipped without an Inspector's authority in writing.

49. No one shall, within the waters of this colony, transfer any foreign stock, whether alive or dead, nor any portion of such stock, nor any foreign fodder or fittings, from any one vessel to any other vessel, without the written authority of an Inspector and under the supervision of an Inspector or some one acting for him; and no foreign stock shall be transferred to an Australasian vessel unless such stock shall have been quarantined, disinfected, and dressed, and declared to be free from infection, as prescribed by these regulations

Foreign stock, fittings, &c., to be disinfected while in the waters of this colony.

this colony.

50. All foreign stock and all fittings used with or about any foreign stock, or on any foreign vessel, together with the clothes and other effects of their attendant, shall, when necessary, be disinfected as the Inspector may direct.

51. All foreign fodder, fittings, and litter shall either be burned on board ship or sent to quarantine and disinfected as the Inspector shall direct.

PART D.-PENALTIES, CONFISCATION, ETC.

IX. PENALTIES.

52. No person shall do or attempt to do, cause or permit to be done or to be attempted to be done, or assist in doing or attempting to do, any act forbidden by these regulations, or obtain or endeavour to obtain, or assist any one in obtaining or endeavouring to obtain, by fraud any certificate or authority under these regulations, or forge any certificate or authority, or make use of any such forged or fraudulently obtained certificate or authority, or fraudulently grant or issue any such certificate or authority, or obstruct or refuse to carry out the directions of any Inspector or other person acting under the authority of these regulations, under a penalty of not less than £5, and not exceeding £500.

X. DESTRUCTION OR CONFISCATION OF STOCK AND THINGS .-WHEN STOCK AND THINGS MAY BE DISPOSED OF BY MINISTER.

53. Stock may under all or any of the following circumstances be destroyed, sold, or otherwise disposed of, as the Minister shall direct:

(1.) If stock are infected with any infectious or contagious disease, whether they be on land or on board any vessel within the territorial limits of this colony:

(2.) If the owners of any stock shall have committed, or be concerned in committing, any breach of the above-named Acts or of any regulations there-

(3.) If foreign stock be found unconfined or unsecured on, or be removed or stray from, the vessel by which they arrive, or from any quarantine-ground:
(4.) If stray stock from shore be found on board a vessel or thick there are one foreign stock.

on which there are any foreign stock:

(5.) If stock other than those for which an Inspector shall have issued an order for quarantine are found within any quarantine-ground for foreign stock:

(6.) If the fees, charges, and expenses connected with any stock be not duly paid:
(7.) If any stock shall not be removed on the expiry of the term of quarantine, and after notice given:
(8.) If foreign stock, fodder, fittings, or effects are landed in contravention of these regulations:
(9.) If stock, fodder, fittings, or effects are removed to or from any guarantine ground without on order

or from any quarantine-ground without an order from an Inspector:

(10.) If any stock, articles, or things which are prohibited are landed.
