Sm.—I have the honour to state, for the information of your Government, that the Secretary of State for Foreign Affairs has received from the Chilean Minister at this Court a note, dated the 3rd September, 1895, denouncing the treaty of friendship, commerce, and navigation signed between Great Britain and Chile on the 4th October, 1854.
