IN exercise and pursuance of the powers and authorities vested in him by "The Public Domains Act, 1881," His Excellency the Administrator of the Government of the Colony of New Zealand, by and with the advice and consent of the Executive Council thereof, doth hereby revoke a certain Order in Council, dated the second day of April, one thousand eight hundred and eighty-three, making delegation of certain powers in manner as therein appears; and doth, with the like advice and consent, by this present Order, delegate, but only with respect to the parcel of land described in the Schedule hereto, all the powers conferred by the Act aforesaid, except the powers under or conferred by sections five and twelve thereof, to the under-mentioned persons, who shall be known as the Berwick Domain Board, namely, namely,-

IN COUNCIL. WHEREAS by the third section of "The Alcoholic Liquors Inspection Act, 1896," it is among other things enacted that the Governor may from time to time, by Order in Council, make regulations in order to define the powers and functions of special Inspectors, and to give full effect to the purposes of the said Act: Now, therefore, His Excellency the Administrator of the Government of the Colony of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the said Act, and by and with the advice and consent of the Executive Connoi of the said colony, doth hereby make the regulations Council of the said colony, doth hereby make the regulations set forth in the Schedule hereto, for the several purposes mentioned in the said Act.

SCHEDULE.

SCHEDULE. 1. THE duties of the special Inspectors are to prevent and detect violations of "The Licensing Act, 1881," and the sale of adulterated liquors; and for the purpose of enabling them the more effectually so to do, they shall have the powers and functions hereinafter set forth. 2. Every special Inspector shall be deemed to be an In-spector of Licensed Premises duly appointed under "The Licensing Act, 1881." 3. With respect to all licensed premises inspected by a special Inspector, he shall in each case satisfy himself that the same are properly kept and conducted as regards accom-modation, cleanliness, sanitary arrangements, food, attend-ance, fire-escapes, and otherwise; and also that all closets, urinals, cesspools, and drains attached to or connected with such licensed premises are clean and properly kept. 4. He shall report to the Minister of Justice any case that comes under his notice of any licensee being guilty of any

infringement of any Act in force relating to the registration of trade-marks

5. The standard strength to which spirituous liquors may be reduced by an admixture of pure water, without being deemed to be adulterated, is 25 degrees under proof for brandy, whiskey, or rum, and 35 degrees under proof for gin; but such spirituous liquor shall be deemed to be

gin; but such spirituous liquor shall be deemed to be adulterated if reduced below such standard strength.
6. In every case where a special Inspector obtains any samples of liquor from the licensee or other person in charge of any licensed premises for the purpose of analysis under section 180 of "The Licensing Act, 1881," and pays or tenders payment for such samples, the following provisions shall apply:—

(a.) He shall be deemed to have purchased such samples
within the meaning and for the purpose of sections

- (a.) He shall be deemed to have purchased such samples within the meaning and for the purpose of sections 17 and 18 of "The Adulteration Prevention Act 1880 Amendment Act, 1863."
 (b.) He shall make the notification and offer prescribed by the aforesaid section 17, and dispose of the samples in manner prescribed by the aforesaid sections 17 and 18: Provided that in every case he shall, in the presence of such licensee or person in charge, seal with his own seal, and also, if such licensee or person so desires, with the seal of such licensee. in charge, seal with his own seal, and also, it such licensee or person so desires, with the seal of such licensee or person, every part into which such samples are divided, as prescribed by the aforesaid sections 17 and 18.
 7. Every special Inspector shall report monthly to the Minister of Justice the result of his inspections, showing the names of the houses inspected and of the licensees thereof, and the two results of the solutions.

In such monthly report he shall also make such suggestions or recommendations as he deems expedient for the better administration of the Licensing Acts.

ninety-six:

And whereas by Order in Council dated the second day of June, one thousand eight hundred and ninety-six, the said close season for seals was further extended up to the thirtieth

day of June, one thousand eight hundred and ninety-seven: And whereas it is desirable to further extend such close

Every person who, during the close season prescribed as aforesaid, takes any seal is liable to a penalty of not less than £25 nor more than £500, and in addition thereto is liable to a further penalty of not less than £1 nor more than £20 in respect of every seal so taken. The taking of seals means and includes the killing, catching, dredging for, raising, or hunting of any seal, or any attempt so to do. 3. No person shall buy, sell, expose for sale, consign for sale, buy for sale, or have in possession any seal, or any skins, oil, or blubber from any seal, in any manner in con-travention of the said Act or of these regulations; and every person so doing is liable for every such offence to a penalty of not less than £1 nor more than £20. Shooting Season for Imported and Native Game, License-fee, &c., Waitaki District.

TN exercise of the powers vested in me by "The Animals Protection Act, 1880," and the Acts amending the same, I, James Prendergast, Administrator of the Government of the Colony of New Zealand, do hereby notify that cook pheasants, Californian quail, and hares may be taken or killed within the Waitaki District, consisting of the County of Waitaki, together with all the town districts and boroughs therein, from the first day of June, one thousand eight hundred and ninety-seven, to the thirty-first day of July, one thousand eight hundred and ninety-seven, both inclusive (subject, nevertheless, to the restrictions in the said Acts mentioned). And I do further notify that licenses to take or kill such game within the said district shall be issued on payment of the sum of twenty shillings each, and that licenses to sell game and native game shall be issued on pay-ment of the sum of five pounds each; and the four five said licenses. said licenses.

And I do further declare that native game, excepting tui, huia, white heron, and crested grebe, may be taken or killed within the above-mentioned district from the seventeenth day of April, one thousand eight hundred and ninety-seven, to the thirty-first day of July, one thousand eight hundred and ninety-seven, both days inclusive.

Wellington, 6th April, 1897. Wellington, 6th April, 1897. THE attention of sportsmen, game-dealers, and others is called to the provisions of "The Animals Protection Act Amendment Act, 1895," which are now in force. A digest of the chief of such provisions is subjoined, viz.:-

"THE ANIMALS PROTECTION ACT AMENDMENT ACT, 1889."

Section 4. No person shall kill, destroy, or shoot at any game or native game with anything but a shoulder-gun, and no such gun must exceed size No. 10 at muzzle, or be fitted with barrels exceeding 36 in. in length. No gun shall exceed 10 lb. in weight.

10 lb. in weight. Any person offending against this provision is liable to a penalty not exceeding £10. Section 5. No person shall sell any native game, or take or kill any native game for the purpose of sale, without previously taking out the required license. Penalty not exceeding £20. Section 6. No sale of native game shall take place prior to the 1st May and subsequent to the 1st August in any year. If any person hold a license to sell game—*i.e.*, imported game—he is not liable to pay a second fee on taking out a license to sell native game. But both licenses must be taken out if it is intended to sell both kinds of game.

Alterations to the Scale of Fares, Rates, and Charges in Force upon the New Zealand Government Railways.

A charge of 5s. per mile will be made for each special train required by the Postal Department for conveyance of mails, increased up of the number of values. irrespective of the number of vehicles.

A charge of 5s. per mile will be made for each special train required by the Defence Department for conveyance of passengers: provided that the charge made shall in no case be less than the value of the fares, for the total number of passengers carried, computed at the rates specified in

regulation 10 of Part I., or at ordinary fares where cheaper. Special trains for which two engines are required will be charged double rate.

The minimum charge for a special train required by any Government department will be $\pounds 3$. When engine is ordered and not used, half the minimum charge will be made.

Special trains will be permitted to wait five hours at the station of destination, after which period half special-train rates will be charged for the return journey until seven hours' detention from time of arrival; after which full special-train rates will be charged for the return journey.

place. The total births in the above boroughs amounted to 377, against 319 in February, an increase of 58. The deaths in March were 168, an increase of 11 on the number in February. Of the total deaths, males contributed 96, females 72. Fifty-five of the deaths were of children under 5 years of age, being 32.74 per cent. of the whole number; 49 of these were under 1 year of age. There were 31 deaths of persons of 65 years and upwards: five men, 67, 70, 73, 82 (two), and two women, 66, 74, died at Auckland; four men, 65 (two), 66, 70, and five women, 66 (two), 67, 86, 89, at Wellington; one man, 67, and four women, 71 (two), 73, 84, at Christehurch; and seven men, 70, 71, 73, 75, 77, 79, 86, and three women, 67, 70, 73, at Dunedin.

In the first table are given the deaths and death-rates for each of the four cities, for the suburban boroughs severally, and for each city with its suburban towns. As regards Auckland and Christchurch, the whole of the area usually recognised as suburban has not yet been brought under municipal government, and the vital statistics do not deal with such portions as still remain in road districts. But the omission is not very important, for there are in either case quite enough suburbs included within borough boundaries to give a fair idea of the death-rate of Greater Auckland and Greater Christchurch. As further boroughs are formed the vital statistics will be made to include them. The inclusion of the suburban boroughs tends to lower the death-rate at each of the four centres. The rates for March are-

The subjoined table shows the mortality for the last two months at each of the four centres from six principal specific febrile or zymotic diseases, and also the deaths from certain inflammatory diseases of the lungs. These causes of death have been distinguished from the others of the classes to which they belong as being the most important special diseases which give rise to sudden increases in the death-rates of towns, and the prevalence of which is closely connected with sanitary condition and climatic influence of the season on health.
