Now, therefore, His Excellency the Administrator of the Government of the Colony of New Zealand, in pursuance and exercise of all the powers enabling him in this behalf, and by and with the advice and consent of the Executive Council of the said colony, doth hereby extend the time for holding the election of members of the Kaikoura River Board to the twenty-sixth day of May, one thousand eight hundred and twenty-sixth day of May, one thousand eight hundred and ninety-seven, and doth hereby order and declare that such election shall take place at the Kaikoura Suburban Schoolhouse, that George Renner shall be the Returning Officer to conduct such election, and that the first meeting of the said conduct such election, and that the first meeting of the said Board shall take place at the residence of Mr. Benjamin Burland, Kaikoura, on the twenty-ninth day of May, one thousand eight hundred and ninety-seven, at the hour of seven o'clock in the evening; and, lastly, that the provisions of "The Regulation of Local Elections Act, 1876," so far as applicable, shall extend to the election to be held hereunder.

The cost of bringing the machines or appliances on to the ground, from within the colony, supplying the necessary shafting, motive-power, and buildings, to be defrayed by the Government. If any machine sent from beyond the colony is awarded the bonus or part thereof, then the cost of bringing such machine shall be borne by the Government.

(3.) Whether, in the event of no one machine or process
