"The evolution of gases by the heretofore-described ingredients acted on by the water would sometimes tend to force a muddy mixture into the pores of the cylinder, thereby closing them, instead of allowing the solution to pass outwards into the cistern. It is therefore preferable that a hole about the size of a knitting-needle should be left through the centre of the lid and through the sealing cement, whereby the said gases are emitted from the cylinder. In order to prevent the water of the cistern occupying this hole before the gas is generated a paper gummed label is stuck over the outside of the hole, and when the gas requires exit it lifts the said label."

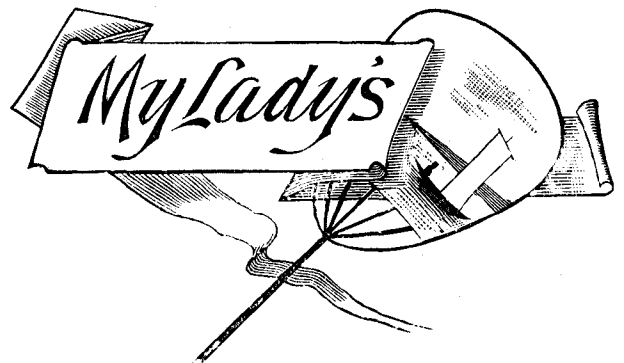

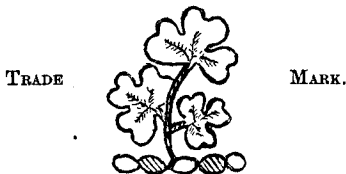
