SIR,—With reference to Lord Granville's circular despatch of the 1st March, 1886, I have the honour to transmit to you, for information in the colony under your government, copies of the Queen's Regulations respecting Foreign Orders and Medals, recently revised as regards foreign orders, and I have to request that they may be substituted for the copies of those previously in force.

It will be observed that the exceptions under Rule II. of the regulations of 1886 have been extended.

The Queen has been pleased to direct that the following regulations respecting foreign orders and medals shall be substituted for those now in force:—

Regulations respecting Foreign Orders.

Regulations respecting Foreign Orders.

1. No subject of Her Majesty shall accept a foreign order from the sovereign of any foreign country, or wear the insignia thereof, without having previously obtained Her Majesty's permission to that effect, signified by a warrant under her Royal Sign-manual.

2. "Unless the foreign decoration shall have been conferred in consequence of active and distinguished service, either at sea or in the field, such permission will not be given to any subject of Her Majesty, except in the following cases, if recommended specially by the Secretary of State for Foreign Affairs:—

cases, if recommended specially by the Secretary of State for Foreign Affairs:—
"(1.) The chief of a complimentary mission from Her Majesty.
"(2.) A military or naval attaché, on the termination of his appointment.
"(3.) Any person, not at the time in the service of Her Majesty, who has rendered valuable service to the sovereign bestowing the order outside Her Majesty's dominions, or in an embassy or legation of that sovereign in this country."

3. The intention of a foreign sovereign to confer upon a British subject the insignia of an order must be notified to Her Majesty's Principal Secretary of State for Foreign Affairs, either through the British Minister accredited to

All the court of such foreign sovereign, or through his Minister accredited at the Court of Her Majesty.

4. If the service for which it is proposed to confer the order has been performed during war, the notification required by the preceding clause must be made not later than two years after the exchange of the ratifications of a treaty of peace.

If the service has been performed in time of peace, the notification must be made within two years after the date of

such service.

5. After such notification shall have been received, Her Majesty's Principal Secretary of State for Foreign Affairs shall, if the case comes within the conditions prescribed by

the present regulations, and arises from naval or military services before the enemy, refer it to Her Majesty's Principal Secretary of State for the War Department, previously taking Her Majesty's pleasure thereupon, in order to ascertain whether there be any objection to Her Majesty's per-

mission being granted.

A similar reference shall also be made to the Commander-in-Chief if the application relates to an officer in the army, or to the Lords of the Admiralty if it relates to an officer in

or to the Lords of the Admiratty it it relates to an olincer in the navy.

6. When Her Majesty's Principal Secretary of State for Foreign Affairs shall have taken the Queen's pleasure on any such application, and shall have obtained Her Majesty's permission for the person in whose favour it has been made to accept the foreign order, and wear the insignia thereof, he shall signify the same to Her Majesty's Principal Secretary of State for the Home Department, in order that he may cause the warrant required by clause 1 to be prepared for the Royal Sign-manual.

When such warrant shall have been signed by the Queen,

When such warrant shall have been signed by the Queen, a notification thereof shall be inserted in the Gazette stating the service for which the foreign order has been conferred.

7. The warrant signifying Her Majesty's permission may, at the request and at the expense of the person who has obtained it, be registered in the College of Arms.

8. Every such warrant as aforesaid shall contain a clause providing that Her Majesty's license and permission does

providing that Her Majesty's license and permission does not authorise the assumption of any style, appellation, rank, precedence, or privilege appertaining to a Knight Bachelor of

Her Majesty's realms.

9. When a British subject has received the Royal permiss.

When a British subject has received the Royal permission to accept a foreign order, he will at any future time be allowed to accept the decoration of a higher class of the same order to which he may have become eligible by increase of rank in the foreign service, or in the service of his own country; or any other distinctive mark of honour strictly consequent upon the acceptance of the original order, and common to every person upon whom such order is conferred

common to every person upon whom such order is conferred.

10. The preceding clause shall not be taken to apply to decorations of the Guelphic Order, which were bestowed on British subjects by Her Majesty's predecessors, King George IV. and King William IV., on whose heads the crowns of Great Britain and of Hanover were united.

Decorations so bestowed cannot properly be considered as rewards granted by a foreign sovereign for services rendered according to the purport of clause 2 of these regulations: they must be rather considered as personal favours bestowed on British subjects by British sovereigns, and as having no reference to services rendered to the foreign Crown of Hanover.

Applications for permission to accept and wear medals which, not being the decoration of any foreign order, are conferred by a foreign sovereign on British subjects in the army or navy, should be addressed to the Commander-in-Chief or the Lords of the Admiralty, as the case may be, who, if they see fit, may submit the same for Her Majesty's sanction, upon obtaining which they may grant such permission without other formality.

2. Any other British subject, having obtained Her Ma-

jesty's permission, is at liberty to accept and wear a foreign medal not being the decoration of a foreign order.

3. No permission is necessary for accepting a foreign medal, if such medal is not to be worn.

EXAMINATIONS FOR THE CIVIL SERVICE OF INDIA.

An open competitive examination for admission to the Civil Service of India will be held in London, under the subjoined regulations, commencing on the 1st August, 1899.

The number of persons to be selected at this examination will be announced hereafter.

No example of the service will be admitted to compete from when the

No person will be admitted to compete from whom the Secretary, Civil Service Commission, has not received, on or before the 31st May, 1899, an application on the prescribed form, accompanied by a list of the subjects in which the candidate desires to be examined.

The order for admission to the examination will be posted on the 18th July, 1899, to the address given on the form of application. It will contain instructions as to the time and place at which candidates will be required to attend, and as to the manner in which the fee (£6) is to be paid.

Regulations.

. The following regulations, made by the Secretary of State for India in Council, are liable to alteration from year to year.

An examination for admission to the Civil Service of 1. An examination for admission to the Civil Service of India, open to all qualified persons, will be held in London in August of each year. The date of the examination and the number of appointments to be made for each province will be announced beforehand by the Civil Service Commis-

2. No person will be deemed qualified who shall not satisfy the Civil Service Commissioners—

(1.) That he is a natural born subject of Her Majesty.
(2.) That he had attained the age of twenty-one, and had not attained the age of twenty-three, on the

first day of the year in which the examination is held.

[N.B.—In the case of natives of India it will be necessary for a candidate to obtain a certifi-cate of age and nationality, signed, should he be a resident in British India, by the Secretary to Government of the province, or the Commissioner of the division, within which his family resides,

or, should he reside in a native State, by the highest political officer accredited to the State in which his family resides.]

(3.) That he has no disease, constitutional affection, or bodily infirmity unfitting him, or likely to unfit him, for the Civil Service of India.
(4.) That he is of good moral character.

(4.) That he is of good moral character.

3. Should the evidence upon the above points be primal facie satisfactory to the Civil Service Commissioners, the candidate, on payment of the prescribed fee, will be admitted to the examination. The Commissioners may, however, in their discretion, at any time prior to the grant of the certificate of qualification hereinafter referred to, institute such further inquiries as they may deem necessary; and, if the result of such inquiries, in the case of any candidate, should be unsatisfactory to them in any of the above respects, he will be ineligible for admission to the Civil Service of India, and, if already selected, will be removed from the position of a probationer.

5. The merit of the persons examined will be estimated by

5. The mert of the persons examined will be estimated by marks; and the number set opposite to each branch in the preceding regulation denotes the greatest number of marks that can be obtained in respect of it.

6. The marks assigned to candidates in each branch will be subject to such deduction as the Civil Service Commissioners may deem necessary(b) in order to secure that no credit be allowed for merely superficial knowledge.

7. The examination will be conducted on paper and viva voce, as may be deemed necessary.

voce, as may be deemed necessary.

8. The marks obtained by each candidate in respect of each of the branches in which he shall have been examined will be added up, and the names of the several candidates who shall have obtained, after the deduction above men-

(b) No deduction will be made from the marks assigned to candidates in mathematics or English composition.

tioned, a greater aggregate number of marks than any of the remaining candidates, will be set forth in order of merit, and such candidates shall be deemed to be selected candidates for the Civil Service of India, provided they appear to be in other respects duly qualified. Should any of the selected candidates become disqualified, the Secretary of State for India will determine whether the vacancy thus created shall be filled up or not. In the former case, the candidate next in order of merit, and in other respects duly qualified, shall be deemed to be a selected candidate. A candidate entitled to be deemed a selected candidate, but declining to accept the nomination as such which may be offered to him, will be disqualified for any subsequent competition.

9. Selected candidates, before proceeding to India, will be on probation for one year, at the end of which time they will be examined with the view of testing their progress in the following subjects(a):-

In this examination, as in the open competition, the merit of the candidates examined will be estimated by marks (which will be subject to deductions in the same way as the marks assigned at the open competition), and the number set opposite to each subject denotes the greatest number of marks that can be obtained in respect of it. The examination will be conducted on paper and vivâ voce, as may be deemed necessary. This examination will be held at the close of the year of probation, and will be called the "final examination."

10. The selected candidates will also be tested during their probation as to their proficiency in riding. The examinations in riding will be held as follows:—

 Shortly after the result of the open competitive examination has been declared, or at such time or times as the Commissioners may appoint during the course of the probationary year.
 Again, at the time of the final examination, candidates who may fully satisfy the Commissioners of their ability to ride well and to perform journeys on horseback shall receive a certificate which shall entitle them to be credited with 200 or 100 marks, according to the degree of proficiency marks, according to the degree of proficiency displayed, to be added to their marks in the final examination.

(3.) Candidates who fail to obtain this certificate, but who gain a certificate of minimum proficiency in riding, will be allowed to proceed to India, but will be subjected on their arrival to such further will be subjected on their arrival to such further tests in riding as may be prescribed by their Government, and shall receive no increase to their initial salary until they have passed such tests to the satisfaction of that Government. A candidate who fails at the end of the year of probation to gain at least the certificate of minimum proficiency in riding will be liable to have his name removed from the list of selected candidates.

11. The selected candidates who, at the final examination, shall be found to have a competent knowledge of the subjects specified in Regulation 9, and who shall have satisfied the Civil Service Commissioners of their eligibility in respect of nationality, age, health, character, and ability to ride, shall be certified by the said Commissioners to be entitled to be appointed to the Civil Service of India, provided they shall comply with the regulations in force at the time for that service.

12. Persons desirous to be admitted as candidates must apply on forms, which may be obtained from "The Secretary, Civil Service Commission, London, S.W.," at any time after the 1st December in the year previous to that in which the examination is to be held. The forms must be returned so as to be received at the office of the Civil Service Commissioners on or before the 31st May (or, if that date should fall upon a Sunday or public holiday, then on or before the first day thereafter on which their office is open) in the year in which the orangination is to be held. which the examination is to be held.

The Civil Service Commissioners are authorised by the Secretary of State for India in Council to make the following announcements:

(1.) Selected candidates will be allotted to the various pro-inces upon a consideration of all the circumstances, including their own wishes; but the requirements of the public service will rank before every other consideration.

cluding their own wishes; but the requirements of the public service will rank before every other consideration.

(2.) An allowance amounting to £100 will be given to all candidates who pass their probation at one of the universities or colleges which have been approved by the Secretary of State—viz., the Universities of Oxford, Cambridge, Dublin, Glasgow, Edinburgh, St. Andrew's, and Aberdeen; Victoria University, Manchester; University College, London; and King's College, London: provided such candidates shall have passed the final examination to the satisfaction of the Civil Service Commissioners, and shall have conducted themselves well, and complied with such rules as may be laid down for the guidance of selected candidates. The whole probation must ordinarily be passed at the same institution. Migration will not be permitted except for special reasons approved by the Secretary of State.

(3.) The allowance of £100 will not be paid to any selected candidate until he has been certified by the Civil Service Commissioners to be entitled to be appointed to the Civil Service of India; and every certificated candidate must, before receiving his allowance, give a written undertaking to refund the amount in the event of his failing to proceed to India.

(4.) All candidates obtaining certificates will be also required to enter into covenants by which, amongst other things, they will bind themselves to make such payments as under the rules and regulations for the time being in force they may be required to make towards their own pensions or for the pensions of their families. The stamps payable on

these covenants amount to £1.

(5.) The seniority in the Civil Service of India of the selected candidates will be determined according to the order in which they stand on the list resulting from the combined marks of the open competitive and final examinations.

(6.) Selected candidates will be required to report their arrival in India within such period after the grant of their certificate of qualification as the Secretary of State may in each case direct.

(7.) Candidates rejected at the final examination held in any year will in no case be allowed to present themselves

Syllabus showing the Extent of the Examination in certain Subjects.

English Composition.—An essay to be written on one of several subjects specified by the Civil Service Commissioners on their examination-paper.

English Language and Literature.—The examination will be in two parts. In the one the candidates will be expected to show a general acquaintance with the course of English literature as represented (mainly) by the following english to show a general acquaintance with the course of English literature as represented (mainly) by the following writers in verse and prose between the reign of Edward III. and the accession of Queen Victoria:—Verse: Chaucer, Langland, Spenser, Shakespeare, Milton, Dryden, Pope, Gray, Collins, Johnson, Goldsmith, Crabbe, Cowper, Campbell, Wordsworth, Scott, Byron, Coleridge, Shelley, Keats. Prose: Bacon, Sir Thomas Browne, Milton, Cowley, Bunyan, Dry-

den, Swift, Defoe, Addison, Johnson, Burke, Scott, Macaulay

(essays and biographies).

A minute knowledge of the works of these authors will not be looked for in this part of the examination, which will, however, test how far the candidates have studied the chief however, test how far the candidates have studied the chief productions of the greatest English writers in themselves, and are acquainted with the leading characteristics of their thought and style, and with the place which each of them occupies in the history of English literature. Candidates will also be expected to show that they have studied in these authors the history of the English language in respect of its vocabulary, syntax, and prosody.

The other part of the examination will relate to one of the periods named below, which will follow each other year by year in the order indicated.

1. (1899.) A.D. 1800 to A.D. 1832 (nineteenth-century writers to the death of Scott).
2. (1900.) A.D. 1360 to A.D. 1600 (Chaucer to Spenser).
3. (1901.) A.D. 1600 to A.D. 1700 (Shakespeare to Dryden).
4. (1902.) A.D. 1700 to A.D. 1800 (Pope to Cowper).

The examination in this part will require from candidates The examination in this part will require from candidates a more minute acquaintance with the history of the English language and literature, as illustrated in the chief works produced in each period, and will be based to a considerable extent, but by no means exclusively, on certain books specified each year by the Commissioners. The names placed under the dates are intended to suggest the general character of the literary development of the period, and, consequently, the natural limits of the examination. All the works of Shakespeare, for example, will be regarded as falling within the period 1600 to 1700; all the works of Swift within the period 1700 to 1800; all the works of Scott and Wordsworth, and all the works of Macaulay, within the period 1800 to 1832. the period 1800 to 1832.

French Language and Literature. — Translation from French into English, and from English into French. Critical questions on the French language and literature.

German Language and Literature. — Translation from German into English, and from English into German. Critical questions on the German language and literature.

Latin Language and Literature. — Translation from Latin into English, composition in prose and verse, or (as an alternative for verse-composition) a Latin essay or letter. Critical questions on the Latin language (including questions on philology) and literature. — Translation from Greek into English, composition in prose and verse, or (as an alternative for verse-composition) a Greek dialogue or oration. Critical questions on the Greek language (including questions on philology) and literature. — Translation from Sanskrit Language and Literature. — Translation from Sanskrit into English, and from English into Sanskrit. History of Sanskrit literature (including knowledge of such Indian history as bears upon the subject); Sanskrit grammar Vedic philology

Sanskrit into English, and from English into Sanskrit. History of Sanskrit literature (including knowledge of such Indian history as bears upon the subject); Sanskrit grammar; Vedic philology.

Arabic Language and Literature. — Translations as in Sanskrit. History of Arabic literature (including knowledge of such Arabic history as bears upon the subject); Arabic grammar; Arabic prosody.

English History.—General questions on English history from A.D. 800 to A.D. 1848; questions on the Constitutional History of England from A.D. 800 to A.D. 1848.

General Modern History.—Candidates may, at their choice, be examined in any one of the following periods: 1. From the accession of Charlemagne to the Third Crusade (A.D. 800 to A.D. 1193). 2. From the Third Crusade to the Diet of Worms (A.D. 1193 to A.D. 1521). 3. From the Diet of Worms to the death of Louis XIV. (A.D. 1521 to A.D. 1715). 4. From the accession of Louis XV. to the French Revolution of 1848 (A.D. 1715 to A.D. 1848). Periods 3 and 4 will include Indian history.

Greece to the death of Alexander; questions on the constitutional history.—Questions on the general history of Greece to the death of Vespasian; questions on the constitutional history of Rome during the same period.

In Greek and Roman history candidates will be expected to show a knowledge of the original authorities.

Mathematics.—Pure mathematics: Algebra, geometry (Euclid and geometrical conic sections), plane trigonometry, plane analytical geometry (less advanced portions), differential calculus (elementary), integral calculus (elementary). Applied mathematics: Statics, dynamics of a particle, hydrostatics, geometrical optics; all treated without the aid of the differential or integral calculus.

Advanced Mathematics. — Pure mathematics: Higher algebra, including theory of equations, plane and spherical trigonometry, differential calculus, integral calculus, differential equations, analytical geometry, plane and solid. Applied mathematics: Statics, including attractions, dynamics of a particle, rigid dynamics, hydrodynamics, the mathematical theory of electricity and magnetism.

Political Economy and Economic History.—Candidates will be expected to possess a knowledge of economic theory as treated in the larger text-books; also, a knowledge of the existing economic conditions, and of statistical methods as applied to economic inquiries, together with a general knowledge of the history of industry, land-tenure, and economic legislation in the United Kingdom.

Logic and Mental Philosophy (Ancient and Modern).—Logic will include both deductive and inductive logic. Mental philosophy will include psychology and metaphysics.

Political Science.—The examination will not be confined to analytical jurisprudence, early institutions, and theory of legislation, but may embrace comparative politics, the history of political theories, &c. Candidates will be expected to show a knowledge of original authorities.

EVIDENCE OF AGE TO BE REQUIRED FROM CANDIDATES FOR THE CIVIL SERVICE OF INDIA.

Every candidate born in the United Kingdom should be prepared to produce, when required, a certificate from the Registrar-General of Births, Marriages, and Deaths, or from one of his provincial officers. This certificate may be obtained from the Registrar-General in London, Dublin, or Edinburgh, or from the Superintendent Registrar of the district in which the birth took place.

2. A candidate born of European parents in India should be prepared to produce, when required, a certificate of baptism from the district in which he was baptized. If this baptism from the district in which he was baptized. If this does not also mention the date of birth it should be accompanied by a statutory declaration by one of the candidate's parents, stating the date and place of birth. When such certificates are not in the possession of the candidates an extract from the registers kept at the India Office will probably be obtainable.

3. A candidate who is a native of India must, before he can be admitted to the competition, have his age and nationality certified by the Government of India, or of the Presidency or Province in which he may have resided.

[No certificates except those issued under notification of the Government of India, No. 2252, dated 21st August, 1888, will be accepted for this competition.]

Except as noted in paragraphs 2 and 3, every candidate who proves to be successful is expected to produce a certificate of birth. The Civil Service Commissioners will not in ordinary cases accept a certificate of baptism, or other testimony, unless they are first satisfied that a certificate of birth cannot be procured.

Official certificates of birth may generally be obtained as

follows:

(a.) For persons born in England or Wales since 30th June, 1837: From the Registrar-General, Somer-set House, London, or from the Superintendent Registrar of the district in which the birth took

(c.) For persons born in Ireland since 31st December, 1863: From the General Register Office, Dublin; or from the Superintendent Registrar of the district in which the birth took place.

(d.) For persons of English, Scottish, or Irish parentage born on board British ships since the dates mentioned in (a), (b), and (c) respectively: From the General Register Office, London, Edinburgh, or Dublin, according to parentage.

(e.) For persons born in India of European parents: From the India Office, London.

GENERAL DESCRIPTION OF LAND.

Rangiwaea Block is situated between the Upper Wangaehu and Turakina Rivers, about seven miles south of Karioi. The area comprises generally hilly and undulating lands, intersected by valleys which merge into gorges in places, particularly on the Wangaehu side. The block is fairly well watered, but the destruction of the forest will doubtless affect the water-supply, and lead to the drying-up of the smaller streams in summer time. The whole area, except two or three small clearings, is covered with mixed bush, including maire, matai, kahikatea, rimu, rata, &c., with the usual undergrowth. On the western side of the block there is some birch in places. The formation is papa and sandstone, with shell-rock cropping up here and there. The only present legal access is from Wanganui and Fordell, viâ Mangamahu and Hale's Road, through the Maungakaretu Block, thence by the Mangatotara Road, which is formed for horse traffic to within one mile and a quarter of the block. It is proposed to survey and legalise the road-lines in continuation of those to the southward in the Wangaehu and Turakina Valleys, which will pass through the western and eastern sides respectively of the block, and to extend these two latter lines northward, through the Native lands, to a junction with the Main North Island Trunk Road from Hunterville to Waimarino. Karioi is distant from Hunterville by this road sixty-seven miles, and from Mangaonoho, the terminus of the North Island Main Trunk Railway sixty miles.

The country is from 1,300 ft. to 2,400 ft. above sea-level, and when brought into cultivation should prove well adapted to pastoral pursuits, though, owing to the elevation of the country and its inland position, the winters are colder than on the coast, and will consequently affect to some extent pasturage in the winter season.

DESCRIPTION OF SECTIONS.

Section 1, Block IV., Ngamatea District, is situated on the Wangaehu Road, which is laid out up the Maketu Creek. The present access is from Main Road near Karioi, which is about eight miles distant vià pack tracks through open tussock country. A dray-road is also constructed up the Wangaehu River for twenty miles from Mangamahu, and another ten miles would reach this section, most of which is only a surveyed road. The section comprises, generally speaking, hillocky forest country, with small flats in the different gullies; it is rough and broken for 10 to 20 chains back from the Wangaehu River. The soil ranges from poor to good, 4in. to 8 in. in depth, resting on papa-and-sandstone formation. The forest is heavy on the flats, and lighter on the hills, comprising chiefly rimu, kabikates, matai, maire, miro, &c., with a medium undergrowth of kotukutuku, mahoe, maku, rangiora, &c.
