A PROCLAMATION.

A PROCLAMATION. WHEREAS by the twenty-third section of "The Land Act, 1892," it is enacted that the Governor, by Pro-clamation in the *Gazette*, may from time to time establish and define, abolish, alter, or reconstitute local districts for the sale or disposal of land, and in like manner from time to time may appoint land offices and land officers or other persons for conducting sales of land in such local districts, and for receiving applications for the sale, letting, disposal, or occupation of Crown lands, and for generally carrying into effect the provisions of the said Act: Now, therefore, I, Uchter John Mark, Earl of Ranfurly, the Governor of the Colony of New Zealand, do hereby proclaim and declare that the district described in the Schedule hereto is hereby established, defined, and con-stituted a local district for the sale and disposal of land under the said Act, and that the Land Office the name of which is in the said Schedule set opposite the name of the said local district is appointed the Land Office for the said local district.
