Correcting Verbal Inaccuracies in Boundaries of Districts under "The Maori Lands Administration Act, 1900."

At the Government House, at Wellington, this seventeenth day of January, 1901.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

WHEREAS, by the fifth section of "The Maori Lands Administration Act, 1900" (hereinafter called "the said Act"), it is enacted that, for the purposes of the said Act, there shall be within the North Island of New Zealand not less than six Maori land districts, the boundaries and names of such districts to be defined by the Governor in Council, the same to be gazetted and published in the Kahiti, and on such publication the said Act shall be in full force in such district so proclaimed:

And whereas His Excellency the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities conferred by the said section, and by and with the advice and consent of the Executive Council of the said colony, did by Order in Council dated the twenty-sixth day of December, one thousand nine hundred (hereinafter referred to as "the said Order in Council"), define the boundaries and names of certain districts as in the Schedule to the said Order in Council set out:

And whereas certain verbal inaccuracies occur in the boundaries of districts in the said Order in Council named Waiariki, Actea, and Te Ikaroa:

Now, therefore, His Excellency the Governor of the Colony of New Zealand, for the purpose of rectifying such verbal inaccuracies, and in exercise and pursuance of the powers and authorities conferred upon him by the said Act, and by and with the advice and consent of the Executive Council of the Colony of New Zealand, doth hereby redefine the boundaries

of the said districts named Waiariki, Aotea, and Te Ikaro set out in the Schedule hereto, and doth hereby further direct and order that the boundaries as so redefined shall be substituted for those set out in respect of the said districts in the Schedule to the said Order in Council, and doth hereby amend the Schedule to the said Order in Council accordingly.

SCHEDULE.

WAIARIKI.

ALL that area in the Colony of New Zealand bounded towards the north by the Bay of Plenty from Wairakei to the northern boundary-line of the Whangaparaoa No. 2 Block at Potiki Rua: thence towards the north-east by the north-eastern boundary-lines of the said Whangaparaoa No. 2 Block to its easternmost corner: thence towards the No. 2 Block to its easternmost corner: thence towards the south-east generally by the south-eastern boundary-line of the Whangaparaoa No. 2 Block aforesaid to the Ahomatariki Block; thence by the said Ahomatariki Block, the Wairongomai Block, the Raparapaririki No. 3 Block, the Ahiparua Block, the Mangaparahi Block, and the Honokawa Blocks Nos. 2 and 3 to the southernmost corner of Te Kumi No. 1 Block; thence by the boundary-line between the Land Districts of Auckland and Hawke's Bay as described in Gazette No. 30, 28th April, 1898, to the northernmost corner of the Maungataniwha Block (No. 4708), Mangahopai Survey District: thence towards the south-west by a right line to the Rangitaiki River at the northernmost corner of the Runanga No. 18 Block; thence by a right line by a right line to the Rangitaiki River at the northernmost corner of the Runanga No. 1B Block; thence by a right line to the confluence of the Torepatutahi Stream with the Waikato River; thence by the right bank of the said Waikato River to the confluence of the Kopakorahi Stream with the said Waikato River: thence towards the northwest generally by that stream to the north-eastern corner of Block 5208 c.9 (Whakamaru Maungaiti); thence by a right line to the southernmost corner of the western portion of Tokoroa No. 2 Block; thence by the northern boundary of the Whakamaru Maungaiti Block (No. 5208), through Uraura and Pukerimu Trig. Stations, and by Tikorangi Block (No. 5220), to Horohoro Trig. Station; thence by the said Tikorangi Block, and by the north-western boundaries of Horohoro 1a Block and Horohoro 1c Block, to Wharaurangi; thence by the south-western boundaries of the following blocks: Kaitao 2B, Kaitao 2A, Rotohokahoka C2, Rotohokahoka C1, Rotohokahoka D, Okoheriki 1F, Okoheriki 1E, by the southern boundary-lines of Section 4, Block II., Horohoro Survey District, by the road forming the western boundaries of Sections 4 and 3 of said Block II.; thence by Blocks II. and I., Horohoro Survey District, and I., Horohoro West Survey District, to the south-western corner of Section 10, Block XIII., Rotorua Survey District; thence by a right line to the intersection of the northern side of the Oxford-Rotorua Road with the western boundary-line of Section 5a, Block IX., Rotorua Survey District; thence by a right line Block IX., Rotorua Survey District; thence by a right line to Puwhenua Trig. Station; thence by a right line to the southernmost corner of Wacku No. 2 Block near Otanewainuku Trig. Station; thence by a right line to Otawa Trig. Station; thence by a right line to the easternmost corner of Rikutawatawa Block (4864 in red), ard thence by a right line to Weinbeit Education. line to Wairakei, including Motiti Island.

AOTEA.

All that area in the Colony of New Zealand bounded towards the north generally from Parininihi by the confiscation line and the southern boundary-lines of the Rohepotae Block to the Wanganui River, by that river, by the Whakapapa River and the Mangahuia Stream, to the source of that stream; thence by a right line to Paratetaitanga; thence by a right line to Ruapehu; thence by a right line to the northernmost corner of Rawhitia Block, by the north-eastern boundaries of that block and the Rangituhia Block, by the Hautapu River to its confluence with the Pahekeheke Stream; thence by a right line to the confluence of the Hautapu River with the Oraukura Stream; thence by a right line to the confluence of the Hautapu River with the Stream; thence by a right line to the confluence of the Matawhero Stream with the Rangitikei River, by the said river and the Mangaohane Stream to the source of the last-named stream which is nearest to the Trig. Station 9a, Otupae; thence by a right line to said trig. station and by a line in the direction of the intersection of the 99th parallel of south latitude with the meridian of 176° 30' east longitude, to the Taruarau River; All that area in the Colony of New Zealand bounded

thence by the said Taruarau River and the Ngaruroro-River to the confluence of the latter river with the Omahiki Stream: thence towards the south-east by a right line over the highest peak at the northernmost source of the Makaroro Stream to the Ruabine Range; thence by the summit of the said Ruahine Range, the summit of the Tararua Range and the Rimutaka Range, and the summit of the water-shed east of the Orongorongo River to Cape Turakirae: thence towards the south by the sea to Cape Terawhiti: and thence towards the west generally by the sea to Parininihi aforesaid, the place of commencement.

TE IKAROA.

TE IKAROA.

All that area in the Colony of New Zea'and bounded towards the north-east by the Waiariki District hereinbefore described from the northern corner of Runanga No. 1B Block to the northernmost corner of Maungataniwha Block; thence by the Tai-Rawhiti District as described in the Schedule to the said Order in Council (published in New Zealand Gazette No. 1, of 7th January, 1901) to the mouth of the Waikare River in Hawke's Bay: thence towards the southeast by the sea to Cape Palliser: thence towards the southwest by the sea to Cape Turakirae: and thence towards the north-west by the Aotea District hereinbefore described to a right line bearing north-easterly from Trig. Station 94, Otupae, to the intersection of the 39th parallel of south latitude with the meridian of 176° 30′ east longitude; thence by that right line, by the southern, western, and northern boundary-lines of Owhaoko C Block, again by the said north-easterly line from Trig. Station 9A, by the Te Matei Block, and again by the said north-easterly line from Trig. Station 9A, by the Te Matei Block, and again by the said north-easterly line from Trig.
