To George Thomas Wilkinson, Esquire, Returning Officer for the Hikairo-Maniapoto-Tuwbaretoa Maori Land Dis-triot, under "The Maori Lands Administration Act, 1900": Greeting.

Greeting. WHEREAS it is necessary that an election of members, under the provisions of "The Maori Lands Administration Act, 1900," for the Hikairo-Maniapoto-Tuwbaretoa Maori Land District shall take place: Now, therefore, we do hereby require and command you to cause to be elected by the voters duly qualified for that purpose, freely and indifferently, and in manner and form by law and regulations in this be-half prescribed, three legally qualified persons to serve as members of the Council for the Hikairo-Maniapoto-Tuwhare-toa Maori Land District: And we do hereby further require and command that you cause the nomination of the said members to be at Mr. Hete's Hall, Otorohanga, on the eleventh day of February, one thousand nine hundred and two, and the polling, in case it shall be required, to be at the several polling-places on the fourth day of March, one thousand nine hundred and two; and that this our writ, with the names of the persons so elected indorsed thereon by you, shall be returned to us here on or before the first day of April, one thousand nine hundred and two.
