*Proposed Alterations in Boundaries of Electoral Districts,
North Island.*

Wellington, 25th June, 1902.

THE Commissioners for the North Island appointed under "The Representation Act Amendment Act, 1896," and in accordance with the provisions of "The Representation Act, 1887," and the amendments thereof, hereby publish for general information, in terms of section 4 of the last-named Act, the following proposed alterations in the boundaries of electoral districts; and, further, give notice that written objections to the same will be received at the office of the North Island Commission, care of the Surveyor-General, Wellington, up to and including Thursday, the 7th August, 1902.

Maps of the proposed districts will be furnished to each local body in the colony, and may also be seen at the Chief Surveyors' Offices at Auckland, New Plymouth, Napier, and Wellington.

NORTH ISLAND ELECTORAL DISTRICTS.

BAY OF ISLANDS.

Bay of Islands District comprises the Counties of Manganui, Whangaroa, and Bay of Islands, and the whole of Hokianga County less the Waipoua Riding thereof; together with Otonga Riding of Whangarei County, that portion of Hikurangi Riding of Whangarei County lying west of the Whakapara and Wairua Rivers, that portion of Wairua Riding situated to the north of the Moengawahine River and Aponga Post-office, and the north-west corner of Maunu Riding of Whangarei County situated north of the Mangakahia River and west of the Hikurangi River.

KAIPARA.

Kaipara District comprises the whole of the County of Hobson; the Waipoua Riding of Hokianga County; the Tokatoka, Matakobe, Papanoa, and Whakapirau Ridings of Otamatea County; that portion of Kaiwaka Riding of Otamatea County situated west of the Main North Road; that portion of Albert Riding of Rodney County situated south-west of Te

Hana River known as Albertland South and Wharehine Road Districts; and the whole of Tauhoa Riding of Rodney County excepting that portion situated east of Sections 69, 70, 145, 75, 77, 78, 79, 80, 128, and 111, Parish of Tauhoa; also that portion of Upper Mahurangi Riding of Rodney County lying west of the Onehunga Stream and the Kaitoto Stream, near Kaipara Flat Post-office; the whole of Mairatahi Riding of Waitemata County; and that portion of Kaukapakapa Riding of Waitemata County situated north-west of a line commencing where the Helensville Railway-line crosses the Waipatukahu Stream, near Reweti Railway-station, and proceeding thence easterly along the railway-line to the Ahukuramu Stream, thence northerly along that stream to the Kumeu River, thence along the Kumeu River to the Waikoukou River, and thence along the Waikoukou River to the eastern boundary of Kaukapakapa Riding. Helensville Town District is in this district.

MARSDEN.

Marsden District comprises the Borough of Whangarei; the whole of Whangarei County less Otonga Riding, and those portions of Hikurangi, Wairua, and Maunu Ridings absorbed by the Bay of Islands District, hereinbefore described; the Mareretu and Wairau Ridings of Otamatea County; that portion of Kaiwaka Riding of Otamatea County lying east of the Main North Road; that portion of Albert Riding of Rodney County situated north of Te Hana River known as Albertland North and Mainene Road Districts; the Omaha, Hoteo, and Matakana Ridings of Rodney County; that portion of Tauhoa Riding of Rodney County situated east of Sections Nos. 69, 70, 145, 75, 77, 78, 79, 80, 128, and 111, Parish of Tauhoa; the whole of Upper Mahurangi Riding of Rodney County excepting that portion situated west of the Onehunga Stream and Kaitoto Stream which is included in the Kaipara District, hereinbefore described, and excepting also that further portion of the Upper Mahurangi bounded towards the north by the road leading from Warkworth towards Kaipara Flats; towards the east by the Main North Road; towards the south by Puhoi Riding; and towards the west by the road intersecting Section No. 13, Parish of Kourawhero, and by that road continued intersecting Sections Nos. 12 and 11 to Kaipara Flats; together with Mokohinau Lighthouse and adjacent islands. Kamo Town District is in this district.

WAITEMATA.

Waitemata District comprises the Boroughs of Devonport and Birkenhead; the Puhoi Riding of Rodney County; and a small portion of Upper Mahurangi Riding of Rodney County bounded towards the north by the road leading from Warkworth towards Kaipara Flats; towards the east by the main North Road; towards the south by Puhoi Riding of Rodney County; and towards the west by the road intersecting Section No. 13, Parish of Kourawhero, and by that road continued intersecting Sections Nos. 12 and 11 to Kaipara Flats: together with the whole of Waitemata County excepting Waikomiti Riding, which lies along north side of Manukau Harbour, and that portion of the county absorbed by the Kaipara District, hereinbefore described. This district includes also the following islands—viz., Tiritiri, Bean Rock, Great and Little Barrier, Kawau, Motuhora, Pine, and adjacent islands.

EDEN.

Eden District comprises the Point Chevalier, Avondale, Mount Roskill, and Epsom Road Districts of Eden County: that portion of One-Tree Hill Road District situated north-west of the road leading westerly from the Great South Road near the Harp of Erin Inn to Mount Smart Road near the Royal Oak Hotel, passing *en route* Sections Nos. 7, 17A, 16, 15, and 14, and intersecting Section No. 13: the whole of Mount Eden Road District of Eden County less that portion bounded on the north-west by Mount Albert and Eden Terrace Road Districts; on the north by the City of Auckland to the Kaipara Railway-line; towards the south by the railway-line to Mount Eden Road; and thence towards the east by the Mount Eden Road; on the south by The Terrace and the View Road to Mount Roskill Road; again towards the east by Mount Roskill Road for about 13 chains south of View Road to the road forming the south-western boundary of Subdivision No. 8; and towards the south-west by the last-mentioned road to Mount Albert Road District boundary; and towards the west by Mount Albert Road District: also the whole of Mount Albert Road District of Eden County excepting that portion lying north of a line commencing at the eastern boundary of Point Chevalier Road District, and proceeding thence easterly along the Western Springs Road to the New North Road, and thence along the New North Road to the first road running south-east after passing Kingsland Railway-station, and thence south-easterly along the last-mentioned road, crossing George Street West, to Mount Roskill Road at the south-eastern boundary of Subdivision No. 7: together with the Waikomiti Riding of Waitemata County.

CITY OF AUCKLAND.

City of Auckland District comprises the whole of the City of Auckland, together with that portion of the Borough of Grey Lynn lying eastward of a line commencing at the junction of a street in the Borough of Grey Lynn with the Great North Road, about 10 chains south-west of the eastern-most corner of the Borough of Grey Lynn, and proceeding thence north-westerly along the north side of the said street, crossing successively Crumer Road and Williamson Avenue to Rose Road, thence westerly along the north side of Rose Road to the first street running northerly from Rose Road, and thence along the eastern side of the last-mentioned street to Ponsonby Road.

GREY LYNN.

Grey Lynn District comprises the whole of the Borough of Grey Lynn less that portion absorbed by the City of Auckland District, hereinbefore described, and the whole of the Arch Hill and Eden Terrace Road Districts of Eden County, together with those portions of Mount Albert and Mount Eden Road Districts of Eden County not absorbed by the Eden District, hereinbefore described.

PARNELL.

Parnell District comprises the Boroughs of Parnell and Newmarket, and the Remuera, Orakei, Tamaki West, and Panmure Township Road Districts of Eden County, together with that portion of Mount Wellington Road District situated north of the road which starts at the Tamaki River, about 16 chains south of Tamaki Bridge, and runs westerly, passing the small lots near Panmure and striking the Great South Road about 10 chains below Penrose Junction Railway-station. This district includes also the Auckland Domain.

MANUKAU.

Manukau comprises the Borough of Onehunga; that portion of One-Tree Hill Road District of Eden County lying south-east of the road leading westerly from the Great South Road near the Harp of Erin Inn to Mount Smart Road near the Royal Oak Hotel, passing intermediately Sections Nos. 7, 17A, 16, 15, and 14, and intersecting Section No. 13; also that portion of Mount Wellington Road District situated south of the road which starts at the Tamaki River, about

16 chains south of Tamaki Bridge, and runs westerly, passing *en route* the small lots near Panmure, and striking the Great South Road about 10 chains below Penrose Junction Railway-station; together with Otahuhu, Howick, and Papakura Ridings of Manukau County; the Opaheke Road District of Manukau County; and the outlying district of Maungatawhiri Riding of Manukau County facing the Firth of Thames. This district includes also Ponui Island, Waiheke Island, Rotorua, Pakatoa, Paheki, Rakino, Motutapa, Rangitoto, Motuibi, Brown's, and adjacent islands. Papakura Town District is in this district.

FRANKLIN.

Franklin District comprises Awitu, Waiuku, and Pukekohe Ridings of Manukau County; the Papanata, Pokeno, Mercer, and Maungatawhiri Road Districts of Manukau County; the Onewhero and Whangape Ridings of Raglan County; that portion of Te Akau Riding of Raglan County lying north of Rangikahu Stream; that portion of the Waingaro Riding of Raglan County lying north of the Te Pahi Stream, Te Hue Stream, and Mangakara Stream, together with the whole of Waikato County less that portion situated south-east of the Hamilton-Morrinsville Railway, and less that further portion lying south of Komakorau Parish and between the Waikato River and the road leading northerly from the railway about a mile and a half on the Hamilton side of Ruakura Junction, passing Sections Nos. 238, 192, 191, 190, 189, 188, 187, 185, and 184, and that road continued northerly to Section No. 136; thence along the road fronting Sections Nos. 136A and 137 to the road forming the western boundary of Section No. 86; thence along the last-mentioned road and its continuation, passing Sections Nos. 85, 84, 80, 79, 77, 74, and 73, to the southern boundary of Komakorau Parish: also that portion of Waitoa Riding of Piako County situated within the following boundaries—viz., commencing where the road which runs through the Manga-o-tupua Native block intersects the western boundary of Piako County, and proceeding thence northerly along that road to the Hamilton-Te Aroha Railway; thence north-easterly along that railway to Morrinsville; thence along lines so as to include Morrinsville to the railway-line, and thence easterly along the railway-line to the crossing at the Waitoa River, and thence up that river to the boundary of Waitoa Riding; thence south-easterly along the boundary of Waitoa Riding to the Thames River near Stanley; thence down the Thames River to the road forming the northern boundary of Section No. 64, Block XII., Aroha Survey District; thence westerly along that road and its continuation to Waibou Township; thence along the eastern, southern, and western boundaries of Waihou Township to Rangiatea Settlement; thence along the north-eastern boundary of Rangiatea Settlement to the Waitoa River, and thence northerly along that river to the northern boundary of Piako County; thence westerly along the northern boundary of Piako County and southerly along the western boundary of Piako County to the place of commencement; also that portion of Te Aroha Riding of Piako County situated south of line which extends easterly from the Thames River along the southern boundary of the Thames High School endowment, and thence due east to Tauranga County boundary; and that portion of Newcastle Riding of Waipa County situated in the fork of the Waikato and Waipa Rivers north-west of a line commencing at the north-western corner of Hamilton Riding at the road forming the northern boundary of Section No. 146, Pukete Parish, and proceeding along that road continued, passing Sections Nos. 136, 135, 134, 133, 132, and 210A, to Ohote Stream, and thence along that stream to the Waipa River. Ngaruawahia Town District is in this district.

THAMES.

Thames District comprises Coromandel County; the Parawai, Kauaeranga, and Waitohi Ridings of Thames County; and that portion of Hastings Riding of the same county lying west of the Waiwaha River and the Waiwhakaurunga Timber Leasehold; together with the Borough of Thames, and Great Mercury and Cuvier Islands.

OHINEMURI.

Ohinemuri District comprises the whole of Thames County less that portion thereof absorbed by the Thames District hereinbefore described; the whole of Ohinemuri County less the Waihi Riding thereof, together with the Borough of Te Aroha; and those portions of Te Aroha and Waitoa Ridings of Piako County lying east and west respectively of the Borough of Te Aroha, and north of a line commencing at a point on the boundary between Piako and Tauranga Counties due east of the south-eastern corner of the Thames High School endowment, and proceeding thence due west to the said endowment; thence westerly along the southern boundary of the Thames High School endowment to the Thames River; thence northerly along the Thames River to the road forming the northern boundary of

Section No. 64, Block XII., Aroha Survey District; thence westerly along that road and its continuation to the Township of Waihou; thence by lines so as to include the Township of Waihou to Rangiatea Settlement; thence northerly along the eastern boundary of Rangiatea Settlement to the Waitoa River; and thence northerly along that river to the northern boundary of Piako County. This district includes also Slipper Island.

WAIKATO.

Waikato District comprises the whole of Waipa County less the area lying in the fork of the Waikato and Waipa Rivers north-west of a line commencing at the north-western corner of Hamilton Riding, at the road forming the northern boundary of Section No. 146, Puketē Parish, and proceeding thence southerly along that road and its continuation, passing Sections Nos. 136, 135, 134, 133, 132, and 210A, to Ohote Stream, and thence along that stream to the Waipa River; the Cambridge and Tamahere Ridings of Waikato County: with that portion of Kirikiriroa Riding of Waikato County situated south-east of the Hamilton-Morrinsville Railway, and that further portion of Kirikiriroa Riding situated east of the Waikato River and south of Komakorau Parish, and west of the road commencing at the railway about a mile and a half on the Hamilton side of Ruakura Junction and running north from Section No. 238, Kirikiriroa Parish, passing Sections Nos. 192, 191, 190, 189, 188, 187, 185, 184, and that road continued northerly to Section No. 136, and thence along the road fronting Sections Nos. 136A and 137 to the road forming the western boundary of Section No. 86, thence along the last-mentioned road and its continuation, passing Sections Nos. 85, 84, 80, 79, 78, 77, 74, and 73, to the southern boundary of Komakorau Parish; the Matamata and Taotaora Ridings of Piako County: and that portion of the Waitoa Riding of Piako County south-east of a line commencing where the road which intersects the Maunga-o-tupua Native Block crosses the western boundary of Piako County, and proceeding thence northerly along that road to the Hamilton-Te Aroha Railway; thence north-easterly along that railway to Morrinsville; thence along lines so as to exclude Morrinsville, and again to the railway-line; thence along the railway-line easterly to the crossing at the Waitoa River; and thence up that river to the boundary of Waitoa Riding: that portion of Patetere Riding of Piako County situated west of a line commencing on the south-western boundary of Piako County at the road intersecting the Tokoroa No. 1 Block, and proceeding thence northerly along that road through Te Whetu No. 1 Block and Pakuranga No. 1 Block, and round the eastern boundaries of the Township of Lichfield to the old railway-line; thence along that line northerly for about a mile and a half to the nearest road branching off to the right; thence northerly along that road across the Oraka Stream, and on to the Thames River at the Mangapouri No. 1 Block, in Block VII., Patetere North Survey District; thence northerly along the Thames River to the road intersecting the Tuarapararaha No. 2 Block; thence easterly along that road and its continuation, and along the road leading to Tauranga which crosses the Piako County boundary in the Whaiti Kuranui No. 6B Block: the Karioi, Karamu, and Pirongia Ridings of Raglan County: and that portion of Te Akau Riding of Raglan County situated south of the Rangikahu Stream; that portion of Waingarō Riding of Raglan County situated south of Te Puke Stream, Te Hui Stream, and Mangakara Stream; the whole of Kawhia County less that portion situated west of Mangaotaki River, and south of a line drawn from the source of that river to Tirua Point; and that portion of Clifton County not absorbed by the Egmont District hereinafter described; together with the whole of the County of West Taupo, and the Boroughs of Hamilton and Cambridge. The Town Districts of Kihikihī and Te Awamutu are in this district.

BAY OF PLENTY.

Bay of Plenty District comprises the whole of the Counties of Tauranga, Rotorua, East Taupo, Whakatane, and Opotiki, and the Boroughs of Waihi and Tauranga, together with the Waihi Riding of Ohinemuri County, and that portion of Patetere Riding of Piako County not included in the Waikato District hereinbefore described, and Motiti Island. The Town District of Opotiki is in this district.

WAIAPU.

Waiapu District comprises the whole of the Counties of Cook and Waiapu and the Borough of Gisborne.

HAWKE'S BAY.

Hawke's Bay District comprises the whole of Wairoa County, the whole of Hawke's Bay County excepting—(1) Meanee Riding: (2) portion of Erewhon Riding situated west of a line commencing at the county boundary on the summit of the Ruahine Range, and proceeding northerly along the summit

of that range over Otupae Trig. to the Taruarua River, and thence along the Taruarua River to the northern boundary of Hawke's Bay County: (3) that portion of Clive Riding situated north of the Ngaruroro River, and north-east of a line commencing at the north-eastern corner of Section No. 35, and proceeding thence southerly along the eastern boundary of Section No. 35 and the eastern boundary of Section No. 9, thence along the northern boundary of Sections Nos. 22 and 8, West Clive Suburban, thence southerly along the road leading to the Township of Clive, and thence along the south-western boundary of the Township of Clive, and thence to the Tuki Tuki River: and (4) that portion of Petane Riding at the Spit included in the existing Electoral District of Napier; also the Oero Riding of Patangata County; also the whole of Patangata Riding of Patangata County excepting that portion lying south of the Waipawa-Taumumu Road; also that portion of Waipawa Riding of Waipawa County situated north of a line commencing at the road leading westerly from the Township of Kaikora, intersecting Blocks 51, 49, 18, 180, 15, 142, 131, 17, 21, 23, to the Manga-o-nuku River, thence northerly along the right bank of the Manga-o-nuku River to its confluence with the Mangamouku River, and thence along the right bank of the Mangamouku River to the western boundary of Waipawa Riding. This district comprises also the Boroughs of Napier and Hastings. Portland Island and the Town Districts of Kaikora North and Clyde are in this district.

NAPIER.

Napier District comprises the whole of the existing Electoral District of Napier, together with that portion of Clive Riding of Hawke's Bay County situated north of the Ngaruroro River, and north-east of a line commencing at the north-eastern corner of Section No. 35, and proceeding southerly along the eastern boundary of Section No. 35 and the eastern boundary of Section No. 9, thence along the northern boundary of Sections 22 and 8, West Clive Suburban, thence southerly along the road leading to the Township of Clive, and thence along the south-western boundary of the Township of Clive, and thence to the Tuki Tuki River; also that portion of the Meanee Riding of Hawke's Bay County situated south of and adjoining the existing Napier Electoral District. Taradale Town District is in this district.

WAIPAWA.

Waipawa District comprises the whole of Waipawa County, less the northern portion of Waipawa Riding, situated north of a line commencing at the road leading westerly from the Township of Kaikora, intersecting Blocks 51, 49, 18, 180, 15, 142, 131, 17, 21, and 23, to the Manga-o-nuku River; thence northerly along the right bank of the Manga-o-nuku River to its confluence with the Mangamouku River; and thence along the right bank of the Mangamouku River to the western boundary of Waipawa Riding; and less that portion of Dannevirke Riding of Waipawa County situated south-west of a line commencing where the Tahoraite-Wainui Road crosses the south-eastern boundary of Waipawa County, and proceeding north-westerly along the Tahoraite-Wainui Road to the Manga-a-toro Stream, and thence along that stream to the Manawatu River, and thence along the right bank of the Manawatu River to the south-western boundary of Waipawa County: together with the Ridings of Taumumu and Eparaima of Patangata County; the northern portion of Porangahau Riding of Patangata County, situated north of the boundary-line between the existing Waipawa and Pahiatua Electoral Districts; and a small portion of Patangata Riding of Patangata County, situated south of the Waipawa-Taumumu Road; together with the Borough of Dannevirke. The Town Districts of Ormondville and Waipawa are in this district.

PAHIATUA.

Pahiatua District comprises the whole of the Counties of Pahiatua, Woodville, and Akitio, the Boroughs of Pahiatua and Woodville, together with those portions of Porangahau Riding of Patangata County, Dannevirke Riding of Waipawa County, and Alfredton Riding of Masterton County, situated within the existing Pahiatua Electoral District.

MASTERTON.

Masterton District has the same boundaries as the existing Masterton Electoral District.

WAIRARAPA.

Wairarapa District has the same boundaries as the existing Wairarapa Electoral District.

EGMONT.

Egmont District comprises the whole of Clifton County, less that portion situated north-east of a line commencing at the confluence of the Taringamutu River with the Ongarue River, about two miles and a half north of Taumarunui, and proceeding thence westerly along the northern boundaries of

the Pongahuru, Iriwhata, and Ohura South Native Blocks to the Ohura River; thence across the Ohura River and along the summit of the western watershed of the Waikaka River to Rangipuanono; thence along the eastern boundaries of the Waikaukau and Pukeuha Blocks to the Mokau-iti River, and along that river to the Mokau River: together with that portion of Kawhia County lying south-west of the Mangatangi River, and south of a line drawn from the source of that river westerly to the sea-coast at Tirua Point; the Waitara West Road District of Taranaki County: that portion of Moa Riding of Taranaki County situated in the existing Egmont Electoral District, and North and West Ridings of Stratford County, and Waitara Town District. The Town District of Inglewood is in this district.

TARANAKI.

Taranaki District comprises the Borough of New Plymouth: and that portion of Taranaki County situated within the existing Taranaki Electoral District, less the area covered by Waitara West Road District: together with that portion of Egmont County situated north-west of a line commencing at the Manihi Road near the sea-coast, and proceeding easterly along that road to the Main South Road; thence northerly along the Main South Road to the Kahui Road; thence easterly along the Kahui Road to Section No. 18, Block XIV., Cape Survey District; thence northerly along the western boundaries of Sections 18, 13, 8, and 7 to Newall Road; and thence across Newall Road and along the western boundaries of Section No. 7, Block X., Cape Survey District, to Waiweranui Stream; and thence across that stream and along the western boundary of Section No. 6 to the northern boundary of Egmont County.

HAWERA.

Hawera District comprises that portion of Egmont County situated south-east of a line commencing at the Manihi Road near the coast and proceeding easterly along that road to the Main South Road; thence northerly along the Main South Road to the Kahui Road; thence easterly along the Kahui Road to Section No. 18, Block XIV., Cape Survey District; thence northerly along the western boundaries of Sections 18, 13, 8, and 7 to Newall Road, and thence across Newall Road and along the western boundaries of Section No. 7, Block X., Cape Survey District, to Waiweranui Stream; thence across that stream and along the western boundary of Section No. 6 to the northern boundary of Egmont County: also the Waimate, Mangatangi, and Okaiawa Ridings of Hawera County: that part of Eltham Riding of Hawera County lying to the south-west of a line commencing where the Mountain Road crosses the Eltham Borough boundary, and proceeding southerly along that road to Rotokare Road; thence easterly along Rotokare Road to Tiromoana Road; and thence along Tiromoana Road to the southern boundary of Eltham Riding: also that portion of Hawera Riding of Hawera County situated south-west of a line commencing at the junction of Makino Road with Whareroa Road, and proceeding southerly along Whareroa Road to Morea Road; thence north-easterly along Morea Road to Mataimaroke Road, and thence along that road to the road forming the western boundary of Section No. 6, Block IV., Hawera Survey District; thence southerly along the last-mentioned road to the south-eastern boundary of Hawera Riding: also that portion of Mokoia Riding of Hawera County situated south and west of a line commencing at Kaitoke Road on the north-western boundary of Mokoia Riding, and proceeding easterly along Kaitoke Road to Meremere Road; thence southerly and westerly along Meremere Road to Noonan Road; thence westerly along Noonan Road to the Township of Mokoia; and thence along the eastern boundaries of the Township of Mokoia to the railway-line; and thence along the railway-line to the south-eastern boundary of Hawera County: together with the Borough of Hawera. The Town Districts of Opunake, Normanby, and Manaia are in this district.

PATEA.

Patea District comprises the whole of Stratford County excepting North Riding and West Riding thereof, the whole of Patea County, and that portion of Eltham Riding of Hawera County situated north-east of a line commencing where the Mountain Road crosses the Eltham Borough boundary, and proceeding southerly along that road to Rotokare Road; thence easterly along Rotokare Road to Tiromoana Road; and thence along Tiromoana Road to the southern boundary of Eltham Riding: also that portion of Hawera Riding of Hawera County situated north-east of a line commencing at the junction of Makino Road with Whareroa Road, and proceeding southerly along Whareroa Road to Morea Road; thence north-easterly along Morea Road to Mataimaroke Road, and thence along that road to the road forming the western boundary of Section No. 6, Block IV., Hawera Survey District; thence southerly along the last-mentioned road to the south-eastern boundary of Hawera Riding: also that

portion of Mokoia Riding of Hawera County situated north and east of a line commencing at Kaitoke Road on the north-western boundary of Mokoia Riding, and proceeding easterly along Kaitoke Road to Meremere Road; thence southerly and westerly along Meremere Road to Noonan Road; thence westerly along Noonan Road to the Township of Mokoia; thence along the eastern boundaries of the Township of Mokoia to the railway-line; and thence along the railway-line to the south-eastern boundary of Hawera County: together with the Boroughs of Stratford, Eltham, and Patea. The Town District of Waverley is in this district.

WANGAEHU.

Wangaehu District comprises the Maungahoe, Ohingaiti, Otairi, and Paraekaretu Ridings of Rangitikei County; and the whole of Wanganui County excepting the western portions of Kaitoke, Purua, and Mataongaonga Ridings, situated west of a line commencing at the southernmost corner of Run No. 15, near Wilson's Bluff, and proceeding thence along the south-eastern and eastern boundaries of Run No. 15 to Section No. 258; thence northerly along the eastern boundaries of Sections Nos. 258, 257, 263, and 7 to No. 1 Line; thence easterly along No. 1 Line to the road forming the western boundary of Section No. 104, Block VI., Ikitara Survey District; thence northerly along that road and its continuation, passing Sections Nos. 104, 105, 106, 107, 40, and intersecting Section No. 55; thence along the southern boundary of Section No. 74, and the western boundaries of Sections Nos. 74, 75, and 73, to No. 3 Line; thence easterly along the north side of No. 3 Line to the western boundary of Section No. 272, Block II., Ikitara Survey District; thence along the western and northern boundaries of Section No. 272 to Section No. 206; thence along the western boundary of Section No. 206 to Section No. 293; thence along the southern and western boundaries of Section No. 293, and the southern, western, and northern boundaries of Section No. 359, and the western boundary of Section 354, to Kukuta Stream; and thence westerly along that stream to the Wanganui River: together with the whole of Waitotara County excepting the eastern portions of the Westmere and Brunswick Ridings, situated south and east of a line commencing at a point on the coast about a mile and a quarter north of the mouth of the Wanganui River, and proceeding thence along a right line to the southernmost corner of Section No. 232, Block V., Westmere Survey District; thence northerly along the eastern boundaries of Sections Nos. 232, 233, 235, and 85, to the Great North-western Road; thence along that road to the Great Western Line, and thence along the Great Western Line to the Brunswick Line; thence easterly along the Brunswick Line to the New Missionary Line; thence along the New Missionary Line to the Mission Line; and thence along the Mission Line to the Wanganui River: and that portion of Erewhon Riding of Hawke's Bay County not included in the Hawke's Bay District hereinbefore described.

WANGANUI.

Wanganui District comprises the Borough of Wanganui; that portion of the Kaitoke Riding of Wanganui County situated west of a line commencing at the southernmost corner of Run No. 15, near Wilson's Bluff on the sea-coast, and proceeding along the south-eastern and eastern boundaries of Run No. 15 to Section No. 258; thence northerly along the eastern boundaries of Sections Nos. 258, 257, 263, and 7 to No. 1 Line; thence easterly along No. 1 Line to the road forming the western boundary of Section No. 104, Block VI., Ikitara Survey District; thence northerly along that road and its continuation to the northern boundary of Kaitoke Riding; also that portion of Purua Riding situated west of a line commencing at the road between Sections 39 and 40, Block VI., Ikitara Survey District, and proceeding northerly along that road and its continuation to the northern boundary of Purua Riding: also that portion of Mataongaonga Riding situated west of Sections Nos. 293, 359, and 354, Block III., Ikitara Survey District: also that portion of Westmere Riding of Waitotara County situated east of a line drawn from the sea-coast about a mile and a quarter north of the mouth of the Wanganui River to the southernmost corner of Section No. 232, Block V., Westmere Survey District, and proceeding thence northerly along the eastern boundaries of Sections 232 and 233, 235 and 85, to the north-eastern boundary of Westmere Riding: also that portion of Brunswick Riding of Waitotara County situated east of the Great Western Line, and south of the Brunswick Line, the New Missionary Line, and the Mission Line.

OROUA.

Oroua District comprises the whole of the Counties of KIWITEA and Pohangina; the Borough of Fellding; the Town District of Halcombe; and the whole of the Manchester Road District of Oroua County excepting that portion situated

south of a line commencing at the junction of Nannestad's Road with the Bunnythorpe-Feilding Railway, and proceeding north-easterly along the south side of Nannestad's Road to Reid's Line; thence south-easterly along Reid's Line to Section No. 15, Block IV., Kairanga Survey District; thence along the northern boundary of that section and the western boundary of Section No. 19 to Feilding Road; thence westerly along the Feilding Road to Penelope Road, and northerly along Penelope Road to Spur Road; thence easterly along Spur Road to the road fronting Section No. 7, Block I., Gorge Survey District; thence southerly along that road and its continuation, passing Sections Nos. 6, 5, 4, 3, 2, and 1 of the said Block I., to the Township of Ashhurst; thence along lines so as to include the Township of Ashhurst to the Pohangina River at the easternmost corner of Section No. 464; thence southerly along the right bank of the Pohangina River to the Manawatu River; and thence along the right bank of the Manawatu River to the south-eastern boundary of the Manchester Road District.

PALMERSTON.

Palmerston District comprises the whole of Kairanga County; the whole of the Borough of Palmerston North; together with that portion of Manchester Road District of Oroua County situated south of a line commencing at the junction of Nannestad's Road with the Bunnythorpe-Feilding Railway, and proceeding north-easterly along the south side of Nannestad's Road to Reid's Line; thence south-easterly along Reid's Line to Section No. 15, Block IV., Kairanga Survey District; thence along the northern boundary of that section and the western boundary of Section No. 19 to Feilding Road; thence westerly along the Feilding Road to Penelope Road, and northerly along Penelope Road to Spur Road; thence easterly along Spur Road to the road fronting Section No. 7, Block I., Gorge Survey District; thence southerly along that road and its continuation, passing Sections Nos. 6, 5, 4, 3, 2, and 1 of the said Block I., to the Township of Ashhurst; thence along lines so as to exclude the Township of Ashhurst to the Pohangina River at the easternmost corner of Section No. 464; thence southerly along the right bank of the Pohangina River to the Manawatu River, and easterly along the right bank of the Manawatu River to the south-eastern boundary of the Manchester Road District.

MANAWATU.

Manawatu District comprises the whole of Manawatu County; the whole of the Ridings of Rangitoto, Porewa, Otakapu, Maungarauipi, and Wangaeahu, of Rangitikei County; and the whole of Tokomaru Riding of Horowhenua County; together with the Boroughs of Marton and Foxton. The Town Districts of Lethbridge and Bull's are in this district.

OTAKI.

Otaki District comprises the whole of Horowhenua County excepting the Tokomaru Riding; the whole of the Ridings of Whareroa and Horokiwi of Hutt County; the whole of Porirua Riding of Hutt County excepting that portion situated between the Boroughs of Petone and Onslow south-eastward of a line commencing at the north-western corner of the Borough of Petone, and proceeding westerly to the Johnsonville-Horokiwi Road, thence southerly along that road to the Town District of Johnsonville, and thence along the eastern and southern boundaries of the Town District of Johnsonville to the Borough of Onslow; together with that portion of the Borough of Karori situated north of a line commencing at the western boundary of the Borough of Karori where it is intersected by the Karori-Makara Road in Section No. 42, and proceeding thence along the western side of the Karori-Makara Road to the Karori Road; thence along the south side of the Karori Road to the western boundary of Section No. 38, Block VI., Port Nicholson Survey District; thence along the western and part of the southern boundaries of the said Section No. 38 to Section No. 9 of the said Block VI.; thence along the north-eastern boundary of the said Section No. 9 to the Kaiwarra Stream; thence along the left bank of the Kaiwarra Stream to main road Karori to Wellington, and thence along that road to the road leading to Mitchelltown; and thence along the south side of the last-mentioned road to the eastern boundary of the Borough of Karori: the whole of the Makara Road District of Hutt County excepting that portion which is situated east of a line commencing at the mouth of the Karori Stream, and proceeding along the left bank of that stream to its confluence with the stream which intersects Section No. 1, Block IX., Port Nicholson Survey District, and thence along the left bank of the last-mentioned stream to the eastern boundary of the Makara Road District. Johnsonville Town District and Kapiti Island are in this district.

HUTT.

Hutt District comprises the whole of the Boroughs of Petone, Onslow, and Lower Hutt; the whole of the Ridings of Mungaroa, Epuni, and Wainuiomata, of Hutt County; together with that portion of the Porirua Riding of the Hutt County which is situated between the Boroughs of Petone and Onslow, south-east of a line commencing at a point where the southern boundary touches the Johnsonville Town District, touches the Borough of Onslow, and proceeding thence along the southern and eastern boundaries of Johnsonville Town District, and along the Johnsonville-Horokiwi Road towards Petone to a point nearly due west of the north-western corner of the Borough of Petone, and thence along the northern boundaries of Sections Nos. 7 and 78, Block VIII., Belmont Survey District, to the Borough of Petone.

CITY OF WELLINGTON.

City of Wellington District comprises the whole of the City of Wellington excepting that portion situated south of a line commencing at the city boundary at the north-west corner of Town Acre No. 37, and proceeding thence easterly along the northern boundary-line of the said Town Acre No. 37 to Town Acre No. 685; thence northerly along the western boundary-line of the said Town Acre No. 685 to the eastern side of Bidwell Street; thence along the eastern side of Bidwell Street to Wallace Street; thence northerly along the western side of Wallace Street to Hankey Street; thence easterly along the southern side of Hankey Street and the southern boundary-line of the Mount Cook Reserve to Town Acre No. 717; thence southerly along the western boundary-line of the said Town Acre No. 717 and along the western boundary-lines of Town Acres Nos. 718 and 719, 720 and 721 to Town Acre No. 722, Oxford Road; thence easterly along the northern boundary of Town Acre No. 722 and along the south side of Oxford Road to Tasman Street; thence southerly along the east side of Tasman Street and the east side of Crawford Street to the southern boundary of Reserve No. 11; thence easterly along that boundary to Oliver Street, and thence along the north side of Oliver Street to the junction of Adelaide Road with Revans Street; thence along the east side of Revans Street to the northern boundary-line of Town Acre No. 762; thence along the northern boundary-line of the said Town Acre No. 762; and southerly along the north-eastern boundaries of Town Acres Nos. 763, 764, 765, and 766 to the northern boundary-line of Town Acre No. 769; thence easterly along the northern boundary-line of Town Acre No. 769 (Hospital Reserve boundary), across Daniell Street, along the northern boundary-line of Town Acre No. 770, near the Old Men's Home, across Owen Street, to the western boundary-line of Town Acre No. 771; thence along the western and north-western boundary-lines of Town Acre No. 771 and along the north-western boundary-lines of Town Acres Nos. 772 and 773 to Coromandel Street; thence across Coromandel Street to the western boundary-line of Town Acre No. 774; thence along the western and north-western boundary-lines of Town Acre No. 774 to the northernmost corner of the last-mentioned acre; thence along the north-eastern boundary-lines of Town Acres Nos. 774 and 775 to Mein Street; and thence along the northern side of Mein Street to the eastern boundary of the City of Wellington: together with Somes Island.

NEWTOWN.

Newtown District comprises all that portion of the City of Wellington not included in the City of Wellington District hereinbefore described; the whole of the Borough of Melrose, and the whole of the Seatoun Road District; together with that portion of the Borough of Karori situated south of a line commencing at the north-western boundary of the Borough of Karori where it is intersected by the Karori-Makara Road in Section No. 42, Block V., Port Nicholson Survey District, and proceeding thence along the western side of the Karori-Makara Road to the Karori Road; thence easterly generally along the south side of the Karori Road to the western boundary of Section No. 38, Block VI., Port Nicholson Survey District; thence southerly along the western and part of the southern boundaries of the said Section No. 38 to the north-eastern corner of Section No. 9 of the said Block VI.; thence along the north-eastern boundary of the said Section No. 9 to the Kaiwarra Stream; thence northerly along the left bank of the Kaiwarra Stream to main road Karori to Wellington, and thence south-easterly along that road to the Cemetery Road leading to Mitchelltown; and thence along the south side of the last-mentioned road to the eastern boundary of the Borough of Karori: and that portion of the Makara Road District situated east of a line commencing at the mouth of the Karori Stream, and proceeding along the left bank of that stream to its confluence with the stream which intersects Section No. 1, Block IX., Port Nicholson Survey District, and thence along the left bank of the last-mentioned stream to the eastern boundary of the Makara Road District.

MIDDLE ISLAND ELECTORAL DISTRICTS.

CITY OF NELSON.

City of Nelson District comprises the area covered by the existing City of Nelson Electoral District, together with D'Urville Island and Stephens Island, and the Bulwer Peninsula extending from Hallam Cove to Harding Point. The City of Nelson, the Borough of Richmond, and Town District of Havelock are in this district.

MOTUEKA.

Motueka District comprises the area covered by the existing Motueka Electoral District; together with that portion of Hampden Riding of Inangahua County situated to the north-east of a line commencing at the Buller River where that river is crossed by the western boundary of Inangahua County, and proceeding thence easterly along the left bank of the said Buller River to a point about 30 chains westward of Doughboy Creek, thence along the leading spur to Mount Mantell, and thence along the summit of the Mantell Range and the summit of Cann Range to the Spenser Mountains near Faerie Queen. The Borough of Motueka is in this district.

BULLER.

Buller District comprises the Borough of Westport; the Boatman's, Murray, Crushington, and Reefton Ridings of Inangahua County; and the south-western portion of Hampden Riding of Inangahua County, which is bounded towards the north by the Buller River from the Buller County boundary to a point about 30 chains westward of Doughboy Creek, and thence by the summit of the leading spur to Mount Mantell, and thence by the summits of the Mantell and Cann Ranges to the Spenser Mountains near Faerie Queen; together with the Lyell, Wareatea North, Wareatea South, and Charleston Ridings of Buller County.

GREY.

Grey District comprises the area covered by the existing Grey Electoral District, less Charleston Riding of Buller County, which has been added to Buller District hereinbefore described; together with Marsden Riding of Grey County, and a small portion of Maori Creek Riding of Grey County situated between Maori Creek Road and Marsden Riding. The Boroughs of Greymouth and Brunner are in this district.

WESTLAND.

Westland District comprises the area covered by the existing Westland Electoral District, less the whole of Marsden Riding of Grey County and that portion of Maori Creek Riding of Grey County, which have been included in the Grey District hereinbefore described. The Boroughs of Hokitika, Kumara, and Ross are in this district.

WAIRAU.

Wairau District comprises the area covered by the existing Wairau Electoral District, excepting that stretch of country extending from Cook Strait to Barefell Pass, known as that portion of Awatere Riding of Marlborough County situated south-east of a line commencing at Cook Strait at Lake Grasmere, and proceeding south-westerly along the northern shore of that lake to the Main Road, thence along the Main Road to Blind River Creek, thence along Blind River Creek to its source, thence along a right line to Mount Peter, thence along the summit of the Kaikoura Range over Monument Hill, Big Cregan, Tapuaenuku, and Mount Monro, to Barefell Pass; and excepting also D'Urville Island, Stephens Island, and the Bulwer Peninsula extending easterly from Hallam Cove to Harding Point. The Boroughs of Blenheim and Picton are in this district.

HURUNUI.

Hurunui comprises the Counties of Kaikoura, Amuri, and Cheviot, and that portion of Awatere Riding of Marlborough County not absorbed by the Wairau District hereinbefore described; together with the Waipara, Kowai, and Mount Thomas Ridings of Ashley County. Amberley Town District is in this district.

KAIAPOI.

Kaipoi District comprises the Boroughs of Rangiora and Kaiapoi, together with the Mandeville, Cust, Eyreton, and West Eyreton Ridings of Ashley County.

AVON.

Avon District comprises the Boroughs of New Brighton and Linwood; that portion of Heathcote Riding of Selwyn County situated north of the Boroughs of Woolston and Linwood; the New Brighton Subdivision of Avon Road District; that portion of Richmond Subdivision of Avon Road District lying eastward of the road forming the western boundaries of Sections Nos. 713 and 1135, Block XI., Christchurch Survey District; and the whole of Styx Subdivision of Avon Road District excepting that portion extending about two miles and three-quarters south from the mouth of the Waimakariri River, and lying north of Rural Sections Nos. 2638, 2637, 2340, 31684, 20428, and 19571.

CITY OF CHRISTCHURCH.

City of Christchurch comprises the City of Christchurch, the Borough of St. Albans, the Borough of Sydenham, and Hagley Park.

RICCARTON.

Riccarton comprises the Riccarton Road District; the Papanui and Belfast Subdivisions of Avon Road District; that portion of Richmond Subdivision of Avon Road District situated westward of Sections Nos. 713 and 1135, Block XI., Christchurch Survey District; and that portion of Styx Subdivision of Avon Road District which extends about two miles and three-quarters south from the mouth of the Waimakariri River, and is situated north of Sections Nos. 2638, 2637, 2340, 31684, 20428, and 19571, Block IV., Christchurch Survey District; together with that portion of Templeton Road District lying east of a line commencing at the junction of Springs Road with Junction Road, and proceeding thence northerly along Springs Road to the South Road, thence westerly along the South Road to the Southbridge Railway-line, thence northerly along the Southbridge Railway-line to Hornby Junction Road, and thence along Hornby Junction Road to the north-eastern boundary of Templeton Road District.

ELLESMERE.

Ellesmere District comprises that portion of Ellesmere Riding of Selwyn County within the boundaries of the existing Ellesmere Electoral District: that portion of Lincoln Riding of Selwyn County situated south of a line commencing at the Selwyn Railway-bridge, and proceeding easterly along the Southbridge Branch Railway from the River Selwyn to the Little River Railway; thence southerly along the Little River Railway to the road forming the southern boundaries of Rural Sections Nos. 10211 and 9499; thence easterly along that road to the western boundary of Rural Sections Nos. 4727 and 4754; and thence southerly along the western boundary of the last-mentioned sections to the Halswell River: the Taitapu Road District of Selwyn County; together with the Borough of Akaroa, and the whole of Akaroa County less that portion of Port Victoria Road District lying to the west of Gebbie's Pass Road, leading from the head of the Bay to the road district boundary and Lyttelton harbour. Southbridge Town District is in this district.

LYTTELTON.

Lyttelton District comprises the Boroughs of Lyttelton, Woolston, and Sumner; that portion of the Heathcote Riding of Selwyn County within the boundaries of the existing Lyttelton Electoral District; that portion of the Victoria Road District of Akaroa County situated within the boundaries of the existing Lyttelton Electoral District; that portion of Halswell Road District of Selwyn County situated east of a line starting from the road at the southern corner of Spreydon Road District near Cashmere, and proceeding southerly along the road intersecting Section No. 383, and passing Sections Nos. 502, 1324, 4682, 2599, 4620, 2063, 31362, intersecting Sections Nos. 10210 and 493, to Section No. 452, and thence along the north-western and south-western boundaries of the last-mentioned section to the eastern boundary of Halswell Road District; and that portion of Spreydon Road District of Selwyn County situated south of Stark's Road and east of Barrington Road.

COURTENAY.

Courtenay District comprises the whole of the Templeton Road District of Selwyn County less that portion absorbed by Riccarton District hereinbefore described; the whole of the Halswell and Spreydon Road Districts of Selwyn County less those two portions absorbed by Lyttelton District hereinbefore described; that portion of Springs Road District of Selwyn County situated north-west of the Southbridge Branch Railway, east of Little River Railway, and north of the road forming the southern boundary of Sections Nos. 10211 and 9449, Block V., Halswell Survey District; and the whole of Courtenay and Lincoln Road Districts of Selwyn County.

SELWYN.

Selwyn District comprises Malvern and Coleridge Ridings of Selwyn County, and that portion of Ellesmere Riding of Selwyn County situated in the existing Selwyn Electoral District, together with Oxford Riding of Ashley County, Mount Hutt and South Rakaia Ridings of Ashburton County, and that portion of Upper Ashburton Riding of Ashburton County situated east of Winchmore Road and north of Black's Road.

ASHBURTON.

Ashburton District comprises the existing Ashburton Electoral District less that portion of Upper Ashburton Riding of Ashburton County situated north of Black's Road and east of Winchmore Road, which has been added to Selwyn District hereinbefore described. The Borough of Ashburton and the Town Districts of Tinwald and Hampstead are in this district.

GERALDINE.

Geraldine comprises the existing Geraldine Electoral District, minus Albury Riding of Mackenzie County, and plus that portion of Point Riding of Levels County within the boundaries of the existing Timaru Electoral District. The Borough of Temuka and the Geraldine Town District are in this district.

TIMARU.

Timaru District comprises the existing Timaru Electoral District less the portion of Point Riding of Levels County included therein, which has been added to Geraldine District hereinbefore described.

WAITAKI.

Waitaki District comprises the existing Waitaki Electoral District and Albury Riding of Mackenzie County, less all the country lying south of the Waitaki River and west of the Ohau and Hopkins Rivers. The Borough of Waimate is in this district.

OAMARU.

Oamaru District comprises the Borough of Oamaru; the Papakaio, Waiareka, Incholme, and Kakanui Ridings of Waitaki County; that portion of Otepopo Riding of Waitaki County situated north of a line commencing where the north branch of the Waianakarua River crosses the north-western boundary of Otepopo Riding, and proceeding easterly to the confluence of the said north branch with the south branch of the Waianakarua River, and thence along the Waianakarua River to the sea-coast; together with that portion of Otakaika Riding of Waitaki County lying between the north and south branches of the Kakanui River, and extending to Kakanui Peak.

MOUNT IDA.

Mount Ida District comprises that portion of Waitaki County within the boundaries of the existing Waitaki Electoral District, and the whole of Maniototo County; together with the Manuherikia, Matakani, and Hawea Ridings of Vincent County; and that portion of Lindis Riding of Vincent County north-east of a line commencing at the confluence of the Bannockburn with the Clutha River, and proceeding thence easterly to the track leading from Bendigo to the watershed between Devil's Creek and Bannockburn, and thence southerly along that track to the south-eastern boundary of Lindis Riding. The Borough of Naseby is in this district.

WAIKOUAITI.

Waikouaiti District comprises the whole of Waihemo and Waikouaiti Counties, and that portion of Waitaki County situated south of a line commencing at the south-western boundary of Waitaki County, near the source of the north branch of the Waianakarua River, and proceeding easterly along the said branch to its confluence with the south branch of the Waianakarua River, and thence along the Waianakarua River to the sea-coast; together with the Boroughs of Hampden, Palmerston South, and Hawksbury.

CHALMERS.

Chalmers District comprises the Boroughs of Port Chalmers, and North-east Valley, and West Harbour; Peninsula County; and that portion of the Borough of St. Kilda situated east of Hillside Road. Quarantine Island, in Otago Harbour, is in this district.

CITY OF DUNEDIN.

City of Dunedin District comprises the City of Dunedin; together with the Boroughs of Roslyn, Mornington, and Maori Hill.

CAVERSHAM.

Caversham District comprises the Boroughs of Caversham and South Dunedin, and that portion of the Borough of St. Kilda situated west of Hillside Road.

TAIERI.

Taieri District comprises the whole of Taieri County less that portion lying between Lee's Creek and the Taieri River, west of the road fronting Sections Nos. 41, 40, 23, 22, and 5, Block IV., Maungatua Survey District; together with the Boroughs of Mosgiel and Green Island. The Town Districts of Outram and Allanton are in this district.

BRUCE.

Bruce District comprises the existing Bruce Electoral District, with the addition of that portion of Maungatua Riding of Taieri County situated between Lee's Creek and the Taieri River west of the road fronting Sections Nos. 41, 40, 23, 22, and 5, Block IV., Maungatua Survey District, and less Clydesdale Riding of Otago County. The Boroughs of Kaitangata and Milton are in this district.

CLUTHA.

Clutha District comprises the whole of Clutha County; Tapanui Riding of Tuapeka County; the Borough of Balclutha; and that portion of Mataura Riding of Southland County east of a line commencing at the south-eastern corner of Tuturau Road District and proceeding thence northerly along the eastern boundary of the said Tuturau Road District to the source of the north branch of the Otakaramu Stream; thence along a right line to the south-western corner of Block IX., Waikaka Survey District; thence along the western boundary-lines of Blocks IX. and VI. and III., Waikaka Survey District, to the northern boundary-line of the last-mentioned block; thence easterly along the northern boundary of the said Block III. to the eastern boundary of Southland County; thence northerly along the eastern boundary of Southland County to the road leading to Chatton Village; thence westerly along that road, passing Maitland Village, to Chatton Village; thence north-easterly along the road forming the south-eastern boundary of Section No. 9, Block V., Chatton Survey District, and along the continuation of that road, passing Waikaka Township, to the northern boundary of Mataura Riding. The Borough of Tapanui and Clinton Town District are in this district.

TUAPEKA.

Tuapeka District comprises the existing Tuapeka Electoral District, less the Matakani and Manuherikia Ridings of Vincent County, which are included in Mount Ida District, hereinbefore described. The Boroughs of Lawrence, Roxburgh, and Alexandra are in this district.

WAKATIPU.

Wakatipu District comprises the existing Wakatipu Electoral District, with the addition of that portion of Oreti Riding of Southland County lying north of the Waimea Plains Railway from Lumsden to Balfour, east of the road leading westerly from Balfour, passing Sections Nos. 353, 351, and 266, to and across Waimea Stream, and north of the road intersecting Section No. 91, to Cowan's Creek; less the Hawea Riding of Vincent County, and less that portion of Lindis Riding of Vincent County included in the Mount Ida District hereinbefore described. The Boroughs of Queenstown, Cromwell, and Arrowtown are in this district.

MATAURA.

Mataura District comprises the existing Mataura Electoral District, with the addition of that portion of Mataura Riding of Southland County not included in the Clutha District hereinbefore described, and less that portion of Waihopai Riding of Southland County lying to the north of the Seaward Bush Railway and west of Blocks I. and VI., Oteramika Survey District. The Boroughs of Gore and Mataura and Wyndham Town District are in this district.

AWARUA.

Awarua District comprises the existing Awarua Electoral District, with the addition of that portion of Waihopai Riding of Southland County situated north of the Seaward Bush Railway and west of Blocks I. and VI., Oteramika Survey District, and that portion of Awarua Riding of Southland County bounded towards the north by the Waihopai River; towards the east by Blocks VII. and XXIII., Invercargill Hundred; towards the south by the Seaward Bush Railway; and towards the west by the Borough of South Invercargill and the road known as Oteramika Road, fronting Sections Nos. 38, 2 of 21, and 13; towards the north-west by the road known as Dunedin-Invercargill Road, fronting Sections Nos. 8, 13, 14, 15, and 16, Block II., Invercargill Hundred; and again towards the west by the road known as Mill Road, fronting Sections Nos. 16, 17, and 12 of the said Block II., to the Waihopai River; and less that portion of Winton Riding of Southland County north of the northern boundaries of Winton, Forest Hill, and Oreti Hundreds. The Boroughs of Winton and Campbelltown are in this district.

INVERCARGILL.

Invercargill District comprises the existing Invercargill Electoral District, less that portion of the Waihopai Riding

of Southland County included within the boundaries of the Awarua District hereinbefore described, and bounded towards the north by the Waihopai River; towards the east by Blocks VII. and XXIII., Invercargill Hundred; towards the south by the Seaward Bush Railway; towards the west by the Borough of South Invercargill and Oteramika Road, to the Main Road, Invercargill to Dunedin; thence towards the north-west by the last-mentioned road to Mill Road; and thence again towards the west by Mill Road to the Waihopai River. The Boroughs of Invercargill, North Invercargill, South Invercargill, East Invercargill, Avenal, and Gladstone are in this district.

WALLACE.

Wallace District comprises the existing Wallace Electoral District, with the addition of that portion of Winton Riding of Southland County lying north of the northern boundaries of Oreti, Winton, and Forest Hill Hundreds which is included within the boundaries of the existing Awarua Electoral District, and less that portion of Oreti Riding of Southland County included within the boundaries of Wakatipu District hereinbefore described. The Borough of Riverton and Otautau Town District are in this district.
