HIS EXCELLENCY THE GOVERNOB IN COUNCIL. WHEREAS by the one-hundred-and-sixty-ninth section of "The Land Act, 1892," it is enacted that the Governor in Council may fix the terms and conditions upon which the lands in any village settlement shall be disposed of, subject as in the said section is provided: And whereas by a Proclamation made under the said Act on the twenty-fith day of February, one thousand nine hundred and three, and published in the New Zealand Gazette on the fifth day of March, one thousand nine hundred and three, the lands described in the First Schedule hereto have been set apart under the said Act and declared open for lease as village settlements, and it is expedient to fix the terms and con-ditions upon which the said lands shall be disposed of: Now, therefore, His Excellency the Governor of the Colony of New Zealand, in pursuance and exercise of the powers and authorities conferred by the said Act, and by and with the advice and consent of the Executive Council of the said

colony, doth hereby fix the terms and conditions on which the lands mentioned in the First Schedule hereto shall be disposed of by way of lease in perpetuity, and which said terms and conditions are set forth in the Second Schedule hereto, and also doth direct that the lands shall be leased as village-homestead allotments only.

These sections are situated south of Taihape Township, the access being by metalled dray-road for distances varying from three-quarters of a mile to a mile and a quarter, and by surveyed road for remaining distances of about a quarter of a mile. They comprise flat, sloping, and hilly lands, having soil of a good quality on a papa formation. With the exception of Section 85 and a small area of Section 89, which are in grass, all the sections are covered by forest, which comprises kahikatea, matai, maire, &c., with the usual undergrowth. With the exception of a small stream on Sections 89 and 92 there is no water. The owners of improvements will be given one month from date of sale in which to remove those they have effected.

 Each applicant shall state his or her residence, occupation, and condition in life (namely, whether married or single), and will be required to make the declaration prescribed in Schedule C of the said Act.
 The successful applicants shall pay the first half-year's rent, together with the lease and registration fee, and the valuation of the improvements (if any), immediately the application has been approved or declared successful at the ballot.
 All rents must be paid half-yearly, in advance, on the

7. All rents must be paid half-yearly, in advance, on the 1st days of January and July in each year, as provided in section 157 of the said Act; and the first half-year's rent is payable as before provided.

The provisions of section 144, and all other provisions of the said Act with respect to substantial improvements, shall apply accordingly to lessees under these regulations. The provisions of section 141, and all other provisions of the said Act in respect of compulsory residence, shall apply accord-ingly to lessees under these regulations. 9. No lessee shall subdivide, sublet, or transfer the land held by him under these regulations, except under and sub-ject to the provisions of Part I. of the said Act. 10. No lessee shall hold more than one allotment, and such allotments shall be held for his or her sole use and benefit, and not for the use or benefit of any other person whomsoever. No married woman shall be eligible as a selector; but this provision shall not apply to any married woman who may become a transferee under a will or by virtue of an intestacy. virtue of an intestacy.

All the provisions of the said Act, so far as applicable, shall extend and apply to the lands affected by these regula-tions, and to the applications and leases to be made and issued thereunder, and generally to the interests created, and the persons whose rights, liabilities, or interests are thereby affected; and the mention of any particular pro-vision of the said Act shall not be deemed to exclude any other provision of the said Act applicable to the particular case. case.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.  $\mathbf{W}^{\mathrm{HEREAS}}$ , there being no Harbour Board empowered to grant the license hereinafter mentioned under "The Harbours Act Amendment Act, 1883" (hereinafter called "the said Act"), the Puponga Coal- and Gold-mining Company (Limited), (hereinafter called "the company"), has applied to the Governor in Council for a license under the said Act to occupy a part of the foreshore at Puponga, in Golden Bay, in the Provincial District of Nelson, in order to construct a wharf thereon, and, in accordance with the one-hundred-and-fifty-sixth section of "The Harbours Act, 1878," has deposited plans in the office of the Marine Department at Wellington, marked M.D. 2603 (two sheets), showing the area of foreshore and land below low-water mark intended to be occupied, and the manner in which it is proposed to construct the wharf: And whereas the is proposed to construct the wharf: And whereas the Governor in Council has approved of the purpose for which the said foreshore is to be occupied: And whereas it is expedient that a license should be granted and issued to the company under the said Act for the purpose aforesaid, on the torms and conditions the main for a margade.

All persons shall at all reasonable times, upon payment of the proper dues, have free and full liberty to use the said wharf, and all rights of ingress and egress thereon and

6. The company shall maintain the abovementioned wharn in good order and repair, and shall at all times exhibit therefrom and maintain at its own cost suitable and neces-sary lights for the guidance of vessels: Provided that no light shall be exhibited until after it has been approved of

light shall be exhibited until after it has been approved of by the Minister. 7. Any person authorised by the Minister may at all reasonable times enter upon the said wharf and view the state of repair thereof; and, upon such Minister leaving at or posting to the last known address of the company in New Zealand a notice in writing of any defect or want of repair in such wharf, requiring it within a reasonable time, to be therein prescribed, to repair the same, it shall with all convenient speed cause such defect to be removed or to be therein prescribed, to repair the same, 10 SHAH with all convenient speed cause such defect to be removed or such repairs to be made.

Nothing herein contained shall authorise the company to do or cause to be done anything repugnant to or incon-sistent with any law relating to the Customs, or any regu-lation of the Commissioner of Trade and Customs, or with any provisions of "The Harbours Act, 1878," or its amend-ments, or any regulations made thereunder, and that are now or may hereafter be in force. 9. The ballast of all vessels loading at the said wharf shall be taken away by the company, and deposited above high-water mark, or at such place as may be approved of by the Minister, or by any person appointed by the Minister for that purpose.

10. The rights, powers, and privileges conferred by or under this Order in Council shall continue to be in force for fourteen years from the date hereof, unless in the mean-

time such rights, powers, and privileges shall be altered, modified, or revoked by competent authority; and the company shall not assign, charge, or part with any such right, power, or privilege without the previous written con-sent of the Minister first obtained.

The said rights, powers, and privileges may be at any time resumed by the Governor, without payment of any com-pensation whatever, on giving to the company three calendar months' previous notice in writing. Any such notice shall be sufficient if given by the Minister, and delivered at or posted to the last known address of the company in New Zealand.

12. The company shall be liable for any injury which the said wharf may cause any vessel or boat to sustain through any default or neglect on its part. (13) In case the company shall-(1.) Commit or suffer a breach of the conditions herein-

- (2.) Cease to use or occupy the said wharf for a period of thirty days; or
- (3.) Be in any manner wound up or dissolved; or
  (4.) Fail to pay the sums specified in clause three of these conditions—

these conditions— then and in either of the said cases this Order in Council, and every right, power, or privilege, may be revoked and determined by the Governor in Council without any notice to the company or other proceeding whatsoever; and publi-cation in the New Zealand Gazette of an Order in Council containing such revocation shall be sufficient notice to the company, and to all persons concerned or interested, that this Order in Council, and the license, rights, and privileges thereby granted and conferred, have been revoked and determined. 14. 



# LOCALITIES AND DESCRIPTIONS OF RUNS.

Run No. 424: Occupies the greater part of Mount Te Kinga, on southern shores of Lake Brunner. Very steep bush-clad spurs and gullies; suitable for cattle, with a small area of open tussock on top fit for sheep.

Run No. 425: Cattle-feed country on forest-clad slopes of Mount Alexander, opposite Jackson Railway-station. Access from Taramakau River bed.

Run No. 426: Consists of lower northern faces of Mount Alexander. Very rugged country; cattle-feed only. Access from Bell Hill Road.

Run No. 427: Rough bush-clad sidelings, with a little open grassed mountain-tops of the northern watershed of Deception River. Suited for cattle-grazing, and for a few sheep during summer months. Access from Christchurch Road, Otira Valley.

Run No. 428: Situated in Arahura and Taipo Valleys, occupying the ranges between these rivers. Very wild, rough country; lower flanks covered with cattle-feed bush; upper portions bare and snow-clad with a fringe of grass; summer feed for sheep. Access by both valleys, but mainly from Arahura horse-track.

Run No. 429: Principally table-lands and hollows covered with dense forest and patches of scrub; cattle-feed only. Access  $vi\hat{a}$  Marsden and Greenstone Roads.

Run No. 430: Very rough hill-sides; all cattle country. Comprises bulk of Tuki River watershed. Access from Upper Mikonui River bed.

The total population of Auckland and its suburbs was 67,326 persons, and that of Christchurch with its complete suburbs amounted to 57,041 persons, at the Census of March, 1901.

Deaths occurring at hospitals, of persons not residents of the borough wherein the hospital is situated, have been allotted in each case to the borough where the disease was contracted, and not to that in which the death actually took place.

The total births in the above boroughs amounted to 438, against 473 in January—a decrease of 35. The deaths in February were 211, a decrease of 40 on the number in January. Of the total deaths, males contributed 103, females 108. Seventy-seven of the deaths were of children under five years of age, being 36 49 per cent. of the whole number; 58 of these were under one year of age.

There were thirty-six deaths of persons of 65 years and upwards: Six men, 65, 66, 71, 77, 81, 83, and five women, 71, 72, 82, 83, 84, died at Auckland; six men, 66 (two), 67, 68, 71, 83, and three women, 65, 74, 77, at Wellington; four men, 68, 69, 75, 76, and two women, 68, 84, at Christchurch; and six men, 67, 68 (two), 74, 82, 84, and four women, 71, 74, 79, 82, at Dunedin.

In the first table are given the deaths and death-rates for each of the four cities, for the suburban boroughs severally, and for each city with its suburban towns. As regards Auckland and Christchurch, the whole of the area usually recognised as suburban has not yet been brought under municipal government, and the vital statistics do not deal with such portions as still remain in road districts. But the omission is not very important, for there are in either case quite enough suburbs included within borough boundaries to give a fair idea of the death-rate of Greater Auckland and Greater Christchurch. As further boroughs are formed the vital statistics will be made to include them.

The inclusion of the suburban boroughs tends to lower the rate at Wellington, Christchurch, and Dunedin, but raises it at Auckland.

Specific Febrile or Zymotic Diseases.—Thirty-one deaths from diseases of this class were registered in February last as occurring at the four chief cities and their suburban boroughs—viz., 12 at Auckland, 7 at Wellington, 5 at Christohurch, and 7 at Dunedin. Of this total, 21 were under five years of age. Diarrhœa, dysentery, and infantile cholera were the causes of 13 deaths, scarlet fever of 6, whooping-cough of 4, measles of 3, septic diseases of 3, and influenza and stricture of the urethra of 1 each.

Dietetic Diseases.—There were 5 deaths in this class, 2 children dying from malnutrition or want of nourishment, and 3 adults from alcoholism.

Constitutional Diseases.—These numbered 38, or 2 more than in the preceding month, and of the total 21 were due to phthisis and other tubercular diseases, 14 to cancer, 2 to diabetes, and 1 to rachitis.

Developmental Diseases .-- In this class there were 17 deaths-8 from premature birth, and 9 from old age.

Local Diseases.—The total number of deaths recorded as from diseases of this class was 107—29 under and 78 over five years of age—and of these 19 were due to diseases of the nervous system, 25 to diseases of the circulatory system, 16 to diseases of the respiratory system, 32 to diseases of the digestive system, 1 to disease of the lymphatic system, 9 to diseases of the reproductive system, and 1 (arthritis) to disease of the organs of locomotion.

Violence.—All the 10 deaths in this class registered in February at the four chief centres were accidental—4 in Auckland, 1 in Wellington, 2 in Christchurch, and 3 in Dunedin. Three of the deaths were tram accidents, 1 from a fractured pelvis, 1 from burns, 1 from poison, a labourer was sufficient at a drain at Auckland and an infant accidentally sufficient in Wellington, also an infant at Dunedin died from an accident at birth, and a child of two years from the effects of a fall.

Ill-defined and Not-specified Causes .- Only 3 deaths in this class were reported, all from infantile atrophy, and at Auckland.

The subjoined table shows the mortality for the last two months at each of the four centres from six principal specific febrile or zymotic diseases, and also the deaths from certain inflammatory diseases of the lungs. These causes of death have been distinguished from the others of the classes to which they belong as being the most important special diseases which give rise to sudden increases in the death-rates of towns, and the prevalence of which is closely connected with sanitary condition and climatic influence of the season on health.
