#### A PROCLAMATION.

THEREAS by section eight of "The Native and Maori V Land Laws Amendment Act, 1902," it is enacted that the Governor may from time to time, by Proclamation published in the Gazette and Kahiti, declare that any parcel or parcels of Maori land, whether or not such parcels form portions of several blocks, and whether or not such parcels are held by the owners under separate titles, shall be vested in the Maori Land Council of the district within which such land is situated as a site for a Native township, and shall by

the same Proclamation assign a name to such township:
And whereas by section twelve of the said Act it is further enacted that any Proclamation under the said Act may from time to time be amended, varied, or revoked by the Governor as he thinks fit, and thereupon all amendments or cancellations in the Land Transfer Register as may be necessary shall be made by the District Land Registra, but without prejudice to any valid dealings that may in the

And whereas by Proclamation bearing date the twenty-second day of January, one thousand nine hundred and two, the Governor, in exercise of the aforesaid powers, proclaimed and declared that the parcel of land described in the Schedule thereto should be vested in the Maniapoto-Tuwharetoa District Maori Land Council as a site for a Native township, and did thereby assign the name of "Te Kuiti" to such township:

Now, therefore, I, Uchter John Mark, Earl of Ranfurly, the Governor of the Colony of New Zealand, in exercise and pursuance of the powers conferred upon me as aforesaid, do hereby amend the description of the said Native township, as set out in the Schedule to the Proclamation aforesaid, by substituting in lieu thereof the description set out in the Schedule hereto.

#### SCHEDULE.

ALL that parcel of land in the Auckland Land District, situated in Blocks III. and IV., Otanake Survey District, being portion of Pukenui No. 2n, portion of Pukenui No. 2o, Pukenui No. 5, portion of Pukenui No. 2r, Pukenui No. 2q, Pukenui 2n No. 1, Pukenui 2n No. 2, and Pukenui No. 2a, Nos. 1 to 20 inclusive; and 5 acres 2 roods 34 perches of roads laid off by the Court giving access to Pukenui No. 2a Subdivisions; containing by admeasurement 262 acres 2 roods 14 perches, more or less. Bounded towards the north-east generally by the Mangaokewa Stream to a point in line with the southcontaining by admeasurement 262 acres 2 roods 14 perches, more or less. Bounded towards the north-east generally by the Mangaokewa Stream to a point in line with the southeast boundary of Te Kuiti Railway-station, bearing 51° 11′; thence towards the south-east by a right line, 760 links, bearing 231° 11′; towards the east by the Te Kuiti-Awakino Main Road. 1689 links, to a point in line with the north-east boundary of Pukenui No. 25 No. 6; thence again towards the south-east by a right line, 2850 links, bearing 252° 9′; and towards the south-west by a right line, 4645 links, bearing 324°; and towards the north-west by a right line, 4000 links, bearing 50°, and by its production across the railway-line, 100 links, and the crossing of a road, and by Pukenui No. 24 North, 1500 links: save and excepting Main Trunk Railway and the Te Kuiti Railway-station, which is excluded from the above area: be all the aforesaid linkages more or less. more or less.

were appointed Commissioners to hear and determine disputes respecting ownership and boundaries of the Awanui-Haparapara Block, containing one thousand eight hundred and eighty-seven acres; the Marachako Block, containing one thousand eight hundred and ninety-four acres; the Tunapahore Block, containing five thousand four hundred and forty-nine acres; and the subdivisions of the Kapuarangi Block known as Kapuarangi West, containing nine thousand acres, Kapuarangi No. 1a, containing five hundred acres. Kapuarangi No. 1b, containing two thousand nine hundred acres, and Kapuarangi No. 3, containing ten thousand five hundred and forty-nine acres—be all the aforesaid acreages more or less:

And whereas by the said Commission you were required to transmit to me, under your hands and seals, your decisions, orders, and opinions resulting from such investigations and inquiries not later than the thirtieth day of June, one thousand nine hundred and two, or such extended date as may be appointed in that behalf:

And whereas by a Commission bearing date the sixteenth day of June, one thousand nine hundred and two, the time at or before which you were to present to me your report as aforesaid was extended to the thirtieth day of June, one thousand nine hundred and three:

And whereas it has been represented that, in order to enable you the more properly to fulfil the duties intrusted to you, it is expedient to further extend the period within which you are required to report your proceedings touching the said premises:

Know ye, therefore, that I, Uchter John Mark, Earl of Ranfurly, the Governor of the Colony of New Zealand, in pursuance and exercise of the powers conferred upon me by the said Act, and of all other powers and authorities enabling me in this behalf, and acting by and with the advice and consent of the Executive Council of the said colony, do hereby further extend the period within which you shall (using all diligence) transmit to me, as by the said Commission provided, your decisions, orders, and opinions as aforesaid to the thirty-first day of December, one thousand nine hundred and three. And with the like advice and consent, and in further pursuance and exercise of the said powers and authorities, I do hereby confirm the said Commission except as altered by these presents to be issued under the seal of
