ORDER IN COUNCIL.

At the Government Buildings, at Wellington, this fifteenth day of December, 1904

Present:

THE HONOURABLE J. MCGOWAN PRESIDING IN COUNCIL.

IN pursuance and exercise of the powers conferred upon him by "The Orchard and Garden Pests Act. 1903," His Excellency the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, doth hereby declare that on and after the date of the gazetting hereof,

Early blight (Alternaria solani) and Potato-rot, or Irish potato - blight (Phytophthora infestans),

shall be diseases within the meaning of the said Act; and with the like advice and consent doth hereby extend the First Schedule to the said Act by including the aforesaid diseases therein.

Regulations under "The Stock Act, 1893," for the Pre-vention of Blackleg among Cattle.—Nolice No. 924.

At the Government Buildings, at Wellington, this fifteenth day of December, 1904. Present:

THE HONOURABLE J. MCGOWAN PRESIDING IN COUNCIL.

W HEREAS by section twenty-three of "The Stock Act, 1893" (hereinafter termed "the said Act"), it is pro-vided that the Governor may from time to time, by Order in Council, make regulations for, *inter alia*, eradicating and preventing the spread of any disease; for declaring land or premises an infected place, and for prohibiting or regu-lating the movements of stock out of such infected place; for declaring infected areas from which no stock, or no one or more kinds of stock, shall be removed excent in accord. or more kinds of stock, shall be removed except in accord-

ance with the regulations; for probibiting or regulating the manner in which stock shall be driven or allowed to pass manner in which stock shall be driven or allowed to pass from one district to another within the colony; for prescrib-ing certain brands or marks to be used on diseased, infected, or inoculated stock; and generally for all or any such pur-pose as he may deem necess ary for preventing the spread of disease: And whereas it is expedient to revoke the regu-lations made on the seventh day of September last for the prevention of blackleg among cattle, and to make others in lieu thereof: Now therefore. His Excellence the Governor of the Colony

Now, therefore, His Excellency the Governor of the Colony of New Zealand, in pursuance and exercise of the powers conferred by the said Act, and acting by and with the advice and consent of the Executive Council of the said colony, doth hereby revoke the said regulations made on the seventh day of September last, and make the following amended regulations in lieu thereof, and doth hereby declare that such amended regulations shall come into force on the day of the gazetting hereof.

# REGULATIONS.

Interpretation.

- 1. For the purposes of these regulations,— "Affected" means actually suffering from or affected
  - with blackleg: "Blackleg "means the disease known as blackleg, blackquarter, quarter evil, or symptomatic anthrax : "Young cattle " means cattle under eighteen months
  - old
  - old: "Cattle," "Chief Inspector," "disease," "infected area," "infected pluce," "Inspector," "land," "Minister," and "owner" have the meanings re-spectively assigned to them in section three of "The Stock Act, 1893 " (hereinafter referred to as "the said Act ").

#### Infected Area declared.

2. The land described in the First Schedule hereto is hereby declared an infected area from which no young cattle shall be removed unless they have within the preceding twenty-one days been vaccinated and branded as provided in clause four hereof, and unless their removal has been authorised as provided in clause five hereof.

# Removal of Cattle from the Infected Area.

At least fourteen clear days before removing any young cattle from the infected area as aforesaid, the owner of such cattle shall deliver or post to the Inspector of Stock for the district a written application in the form in the Second

Schedule hereto for a permit to so remove the said cattle. Forms of application will be obtainable free of cost from any Inspector.

4. Within seven days after the receipt of an application as aforesaid the Inspector shall proceed to the farm or place specified, and may vaccinate, in such manner as he thinks fit, in order to prevent the spread of blackleg, the young cattle described in the application, and brand them with the letter S on the neck.

on the neck. 5. If at the end of seven days after being vaccinated and branded such young cattle are, in the opinion of the Inspec-tor, not affected and not liable to convey blackleg, he shall give the owner a permit in the form in the Third Schedule hereto, authorising him to remove the said cattle from the said infected area at any time within fourteen days from the

said infected area at any time within fourteen days from the date of the said permit. 6. At any time between the issue of the permit and the removal of such young cattle from the said infected area the owner shall, on demand by any Inspector or other officer appointed in that behalf, produce the permit for perusal, and immediately before the said cattle are so removed shall give the permit up to the person indicated therein. In the case of such removal being by rail the permit shall be handed with the consignment note to the railway officer appointed to receive the latter. to receive the latter.

# Vaccination of Cattle on certain Lands.

7. With respect to cattle depasturing on the land described in the Fourth Schedule hereto, and in any case where an Inspector is satisfied that blackleg exists on any land wherever situate, or that any land is likely to become infected with blackleg, the following provisions shall apply:—

(a.) Upon being notified in writing by the Inspector to do so, the owner shall muster all his cattle, or such provide the provide

- portion thereof as is specified in the notice, in order that the same may be inspected.

  (b.) The cattle shall be mustered at such time and place as the Inspector directs.
  (c.) The Inspector may cause the cattle or any of them to be vaccinated in such manner as he thinks fit in order to prevent the spread of blackleg.
  (d.) All cattle so vaccinated shall at the same time be branded by the Inspector with the letter S on the neck.

#### General.

8. If any young cattle that have not, at least seven days previously, been vaccinated and branded as provided in clauses four or seven hereof are found in any yard, or on any land or other place, at which stock are offered for sale within the area described in the Fourth Schedule hereto, or if such young cattle are taken or allowed to pass out of the said area, the owner of such cattle shall be deemed to have

said area, the owner of such cattle shall be deemed to have committed a breach of these regulations. 9. Upon receipt of a notification in pursuance of sec-tion twenty-four of the said Act, to the effect that any In-spector is satisfied that affected stock exist, or have during the preceding twelve months existed, upon any land outside the said infected area, the Chief Inspector shall forthwith report the matter to the Minister; and if the Minister is satisfied that such stock are affected, or have during the preceding twelve months been affected, or that blackleg exists, or has during the preceding twelve months existed, upon such land, the Minister may, by notice in the Gazette, declare such land an infected place from which no young cattle shall be removed. cattle shall be removed.

10. In every case where any stock has died within the said infected area, or within any such infected place as aforesaid, the owner shall, unless otherwise directed by an Inspector, at once cause the carcase of such stock to be destroyed by burning; or, in cases where burning would be unreasonably costly, or fire would be likely to cause damage by spreading, the proof of which shall in either case be upon the owner, the latter may cause the carcase to be buried to a depth of not less than three feet under ground. Such burning or burying shall be done at, or as near as is practicable to, the spot where the stock died. 11. Every person who commits any breach of these rest

11. Every person who commits any breach of these regu-lations, or who neglects to faithfully comply with these regulations, commits an offence, and shall be liable for each such offence to a fine of not less than two nor more than two hundred pounds.

# Compulsory Vaccination Area.

ALL that area of land in the Auckland and Taranaki ALL that area of land in the Auckland and Taranaki Land Districts, and bounded towards the north by the left bank of the Mokau River from the sea to where the said river is intersected by the western side of the North Island Main Trunk Railway; thence towards the east by the said western side of the said railway to the Wanganui River, and by the right bank of the said Wanganui River to the point where it meets the south-eastern boundary-line of the Taranaki Land District; thence towards the south by a right line to the intersection of the Patea River with the south-eastern boundary-line of the Hawera County; thence towards the south-east by the said south-eastern boundary-line of the Hawera County to the sea; and thence towards the south-west, west, and north-west by the sea to the Mokau River aforesaid.
