ORDER IN COUNCIL.

At the Government House, at Wellington, this twenty-seventh day of January, 1905.

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

W HEREAS it is provided by "The Lyttelton Harbour Board Act, 1882," that one member of the Lyttelton Harbour Board shall be elected by the ratepayers of the Borough of Sydenham, and one member of the said Board shall be elected by the ratepayers of the Borough of St.

And whereas the Boroughs of Sydenham and St. Albans have ceased to exist, and have been united to and now form part of the City of Christchurch, and have become wards of

And whereas it is expedient to make provision for the election of two members of the said Board in manner

hereinafter set forth:

Now, therefore, I, William Lee, Baron Plunket, the
Governor of the Colony of New Zealand, in pursuance and exercise of the power and authority conferred upon me by "The Harbours Act. 1878," and of all other powers and authorities enabling me in this behalf, and acting by and with the advice and consent of the Executive Council of the with the advice and consent of the Executive Council of the said colony, do hereby declare that the ratepayers of the Sydenham Ward of the City of Christchurch shall elect a member of the Lyttelton Harbour Board in lieu of the ratepayers of the late Borough of Sydenham, and that the ratepayers of the St. Albans Ward of the said City of Christchurch shall elect a member of the said Board in lieu of the ratepayers of the late Borough of St. Albans, such boroughs having ceased to exist as aforesaid.
