A PROCLAMATION.

WHEREAS by section two hundred and fifty of "The Land Act, 1892" (hereinafter termed "the said Act"), it is enacted that whenever the Governor is satisfied that any Native lands acquired by the Crown in any way, or purchased out of any sums authorised or to be authorised to be issued and expended in the purchase of lands in the North Island of New Zealand, are free from Native claims and all difficulties in connection therewith he shall, by Proclamation, declare such lands to be Crown lands, subject to be sold and dealt with as in the said Act is more particularly mentioned : And whereas the lands hereinafter mentioned have been purchased out of sums so authorised to be issued and expended as aforesaid:

Now, therefore, I, William Lee, Baron Plunket, the Governor of the Colony of New Zealand, being satisfied that the lands enumerated in the Schedule hereto are free from Native claims and all difficulties in connection therewith, do hereby, in pursuance and exercise of the power and authority vested in me by the said Act, proclaim and declare the lands so enumerated as aforesaid to be Crown lands, subject to be sold and dealt with according to the provisions of the laws regulating the sale and disposal of Crown lands in force in the land districts in which they are respectively situated.

WHEREAS the duplicate railway-line of a portion of the Waitaki - Bluff Railway — namely, from Dunedin to Mosgiel (hereinafter termed "the said railway") —is a railway the construction of which is authorised by "The Railways Authorisation Act, 1900": And whereas it has been determined to construct and maintain the same: Now, therefore, I, William Lee, Baron Plunket, the Governor of the Colony of New Zealand, in exercise and pursuance of the powers and authorities conferred by "The Public Works Act, 1905," and in exercise of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the middle line of the said railway shall be that defined and set forth in the Schedule hereto. In addition to the marking on the outer package required by an order of the Secretary of State in England, made under "The (Imperial) Explosives Act, 1875" (and in force for the time being), such outer package shall bear the words "As defined in the List of Permitted Explosives"; and, further, that each inner package shall be clearly marked words "As defined in the list of Fernited Explosives"; and, further, that each inner package shall be clearly marked with the words "Permitted Explosive, to be used only with not less than No. 6 detonator," and also with the name of the explosive, the name of the manufacturer, the date and place of manufacture, and the nature and proportion of the ingredients.


