

Additional Regulations under "The New Zealand International Exhibition Empowering Act, 1905.

#### PLUNKET, Governor.

ORDER IN COUNCIL.

At the Government House, at Wellington, this twentysixth day of October, 1906.

Present :

#### HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

N pursuance and exercise of the powers conferred upon I him by "The New Zealand International Exhibition Empowering Act, 1905," His Excellency the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, doth here-by make the following additional regulations for the purposes mattioned in contractions in of the derived dat : mentioned in section six of the aforesaid Act :

1. In these regulations, if not inconsistent with the context.-

- "Exhibition "includes grounds and buildings : "Exhibition grounds " or "grounds " means the land described in "The New Zealand International
- Exhibition Empowering Act, 1905": "Executive" means the Executive Commissioners, and, as to any specified act or function, includes any officer authorised by the Commissioners to perform
- such act or function:
  "Side shows" or "side show" means such portions of the Exhibition as are set apart for shows or other entertainments which are open to the public on payment of special admission fees other than the ordinary admission fee to the Exhibition.

#### ADMISSION.

2. Subject to these regulations the Exhibition shall be open to the public daily (except on Sundays) during such hours as, with the approval of the Colonial Secretary, are fixed by the Executive.

3. With the like approval the Executive may from time to time close the Exhibition or any part thereof to the public for such time as it thinks fit.

4. Except in accordance with these regulations, or by authority of the Executive, it shall not be lawful for any

person to enter the Exhibition or any part thereof, or,

An ordinary admission ticket (single or season) to the Exhibition shall be produced by the holder thereof to the attendant at the gate of entry, and (if a single ticket) shall there be given ap to him. Subject to these regulations it shall entitle the holder to admission to any part of the Exhibition (other than side shows or reserved places) whilst the same is open to the public. 7. Subject to these regulations, an admission ticket to a side show shall entitle the holder (being then lawfully in the Exhibition) to admission to that show whilst the same is open to the public, and shall be given up by him to the attendant at the door or gate of entry of the show. 8. Except as hereinafter provided in the case of exhibitors and others, no person shall enter the Exhibition or any side-show unless he is the lawful holder of an appropriate admis-sion ticket entitling him so to do.

- They shall not be transferable, and each ticket shall have thereon the name of the holder (being in every case the person to whom the ticket was originally issued).
   If any season ticket is transferred, then, irrespective
- of the penalty thereby incurred for breach of these regulations, the ticket and the rights thereby con-ferred shall be and be deemed to be cancelled, and no person shall thereafter be entitled to use it for the purposes of admission or otherwise,

- (3.) The holder of any season ticket which has been used or attempted to be used by any other person for the purpose of obtaining admission to the Exhibition shall, unless he proves to the satisfaction of the Executive his non-complicity in such act or attempt, be liable to have all his privileges and rights under such ticket forfeited and the ticket cancelled at the discretion of the Executive.
- (4.) Any person who may have gained entrance to the Exhibition by a season ticket may be called upon by any duly accredited Exhibition official to produce such season ticket for examination, and to make and sign a statutory declaration of his identity with the holder whose name appears on such ticket, and if he refuses or neglects to do so, such person shall be deemed a trespasser upon the Exhibition grounds and not the holder of such ticket.
- (5.) Any person producing a season ticket at any entrance gate to the Exhibition or its grounds, or, when demanded, to any gate-keeper or other official, may be called upon by such gate-keeper or other official to make and sign a statutory declaration of his identity with the holder whose proceeperson such ticket and on his refugal name appears on such ticket, and on his refusal or neglect to do so he shall be deemed to be not the holder whose name appears on such ticket, and not entitled to admission.

10. No person unless duly authorised by the Executive shall enter any room, apartment, or place reserved by the Executive for official or such other persons as the Executive may determine, or, having entered, shall remain therein.

#### EXHIBITORS AND OTHERS.

11. Exhibitors and others who are authorised by the 11. Exhibitors and others who are authorised by the Executive to sell goods shall be permitted to have attendants, and such attendants may take orders, but shall not be permitted to importune, canvass, or annoy the public or other exhibitors by solicitations; and any exhibitor or assistant breaking this rule may be expelled by the Executive, and not allowed to re-enter the Exhibition without the written permission of the Executive. Concessionnaires shall not be the aremitted to canves, importung or anot the multiple of the executive. not be permitted to canvass, importune, or annoy the public by any solicitations. 12. Exhibitors occupying stands with two or more frontages

must arrange their exhibits on each frontage. Any bare woodwork and backs of signboards, &c., must be covered. 13. Exhibitors will not be allowed to exhibit advertise-ments in any part of the Exhibition, or to give away or cause to be given away any handbills or printed matter, except at their own respective stands, and such handbills and printed matter must before distribution receive the approval of the Executive, which may be withdrawn at any time.

time. 14. Exhibitors must keep their exhibits and stands in good order and well displayed from 10 a.m. to 10 p.m. on all the days the Exhibition is open to the public; and in the event of any exhibitor failing to comply with this rule the Executive may remove any covering and expose the exhibit at the risk and cost of the exhibitor, who shall in addition be liable to £10 per day as liquidated damages.

15. Exhibitors, concessionnaires, and their employees will be admitted to the Exhibition by special ticket at 7 a.m. on

all days on which the Exhibition is open to the public. 16. Passes (not transferable) to admit exhibitors, their attendants and workmen, will be supplied free of cost to attendants and workmen, will be supplied free of cost to the exhibitors; and no exhibitor, attendant, or workman will be admitted without such pass being produced to the Exhibition official or gate-keeper at the entrance to the grounds. In the event of such pass being transferred or otherwise disposed of, the same will be immediately can-celled, and no further pass will be issued to the person trans-ferring or otherwise disposing thereof. The number of passes issued to the workmen and attendants of exhibitors will be limited at the discretion of the Executive.

17. Exhibitors, concession of the Executive. 17. Exhibitors, concessionnaires, or other persons must keep their allotted spaces, stands, and exhibits properly cleansed and in good order, and such space free from shav-ings, paper, or litter of any description, during the whole period of the Exhibition, and are also required to provide all necessary attendants for such purpose

necessary attendants for such purpose. 18. Exhibitors, concessionnaires, and other persons hiring space must have the spaces allowed to them cleansed within one hour after the close of the Exhibition buildings at night. All litter and rubbish must be swept daily into the aisles at the appointed time and in such manner as to facilitate the removal thereof by the Exhibition assistants.

19. No cleansing, amending, repairing, carpentering-work, or any operation of such character, will be permitted during the hours the Exhibition is open to the public, and all exhibits must be in complete order for exhibition each day

at least thirty minutes before the Exhibition buildings are opened to the public.

20. The Executive will maintain a corps of assistants whose duties will be to properly care for and cleanse the aisles within the Exhibition buildings, but their duties and responsibility will not extend to spaces allotted to exhibitors,

responsibility will not extend to spaces allotted to exhibitors, concessionnaires, or other persons. 21. It is absolutely prohibited to place rubbish or litter of any description in the aisles except during the period of general cleansing above mentioned. If any exhibitor, con-cessionnoiare, or other person hiring space neglects or makes default in cleansing and keeping in proper order his allotted space, such space will be cleansed and kept in order by the Exhibition assistants, and the cost thereof shall be recover-able forthwith from the person so neglecting or defaulting. 22. All persons producing or having garbage, refuse, or waste shall, at their own cost, deposit the same at such time and in such location in or about the Exhibition buildings or grounds as may be appointed by the Executive or the Director of exhibits. 23. All garbage, refuse, or waste shall be collected daily

23. All garbage, refuse, or waste shall be collected daily between the closing of the Exhibition at night and 7 a.m. the following morning. Any person requiring this service will be charged 6d. per sack, box, or bundle for collecting the same. Partially filled sacks, boxes, or bundles shall be counted the same as if entirely filled. Payment for this service shall be by means of tickets, which must be obtained to the training office and at the point where the conbern at the Exhibition Office, and at the point where the garbage, refuse, or waste is collected, the persons requiring such service shall pay the Exhibition assistants sufficient tickets therefor.

24. Exhibitors, concessionnaires, or other persons hiring space, may appoint and employ watchmen to protect their exhibits and goods, but such appointments must be approved by the Executive or the Director of Exhibits, and such approval may be withdrawn and appointment cancelled at any time by the Executive at its discretion. All watchmen so appointed by exhibitors and approved as aforesaid shall be subject to the Exhibition official in charge of the Exhibition watchmen.

25. All goods and articles must be brought into the Exhi-bition buildings and taken out of the same only at the times, in the manner, and at the entrances and exits appointed by the Executive, and no other.

the Executive, and no other. 26. Signboards, name - boards, show - cards, tablets, or similar devices must be placed to the satisfaction of the Executive, and must not in any case be of greater length than the frontage of the space allotted to the Exhibitor, con-cessionnaire, or other person hiring the same, nor be placed at a greater height than 2 ft. from the top of the stall of such arbitic concessionnaire, or other person (unless otherwise exhibitor, concessionnaire, or other person (unless otherwise authorised in writing by the Executive).

The decision of the Executive in this matter shall be final. 27. Corridors and passageways must at all times be kept clear and free and fully available for passage, and no person shall cause any obstruction therein.

28. All articles exhibited will be at the sole risk and responsibility of the exhibitor, but every precaution and care will be taken by the Executive for the prevention of loss or damage to any exhibit. Exhibitors are recommended to in-sure their exhibits against fire. In the event of the buildings being unavailable in consequence of fire or other agencies over which the Executive has no control all contracts are null and void from the date of such occurrence.

29. No exhibitor will be permitted to remove his exhibit or any part thereof until the close of the Exhibition, and not then without the consent in writing of the Executive being previously obtained, and until all charges due are paid. The Executive shall have a lien upon all goods exhibited for any moneys due by exhibitors or concessionnaires, and shall be entitled to realise such lien by sale, public or private, or by forfeiture at its absolute discretion.

by forfeiture at its absolute discretion. 30. If any damage or injury is occasioned during the pro-gress of the Exhibition by any exhibited machinery, im-plement, or article to any visitor or other person (or to any officer, servant, or other person there and then employed by the Executive), then the exhibitor to whom such machinery, implement, or article may belong shall be responsible for such damage or injury, and shall besides indemnify and hold harmless the Executive and the Government from and against all actions, suits, expenses, and claims on account and in

harmless the Executive and the Government from and against all actions, suits, expenses, and claims on account and in respect of any such damages or injury. 31. All concessionnaites, exhibitors, proprietors of side-shows, and persons hiring or using any space, building, enclosure, or place in the Exhibition, its buildings or grounds, or exercising any right or privilege therein, shall abide by and fulfil any order given by the Executive with regard to the manner in which they shall carry on their business and exercise their rights and privileges. The person in charge and exercising control over exhibits.

The person in charge and exercising control over exhibits, side shows, and other places as aforesaid shall be deemed the agent of the exhibitor thereof or of the proprietor of such side-show or other place.

32. The Executive reserves to itself the sole right of compiling and printing a catalogue of exhibits.

33. No person shall offer, or  $\epsilon$  xpose for sale, or offer to sell, or sell, or negotiate for the sale, or make any part of a contract for sale of any article, or shall carry on any trade or business, or portion of a trade or business, within the Exhibition unless authorised so to do in writing by the Executive.

34. Any person offending against the last-named regulation 34. Any person offending against the last-named regulation may be ordered by the Executive at its discretion to remove his exhibit and goods from the Exhibition, and if he refuses or fails to do so, then immediately on his refusal or failure he may be ejected therefrom as a trespasser, and his goods may be removed from the Exhibition at his cost, and all his rights and privileges of exhibition and otherwise shall be absolutely forfeited, and he shall not be entitled to the return of any moneys paid therefor. 35 Exhibitors may erect railings around their stands

35. Exhibitors may erect railings around their stands, subject to the approval of the Director of Exhibits. In every instance these railings must be within the area of the space allotted. In the case of machinery in motion, it is im-perative that it be efficiently protected to the satisfaction of the Erecutive the Executive.

36. No exhibitor or concessionnaire will be permitted to display exhibits, or to erect or maintain sideboards, similar devices, and things, in such a manner as to obstruct the light or impede the view along the open spaces, or to occasion injury or inconvenience to other exhibitors.

37. The Executive reserves the right to remove at his cost the exhibits of any person who does not conform to these regulations.

38. No canvas or calico linings shall be allowed in any part of the Exhibition buildings, either as screens, ceilings, or for any other purpose: Provided always that in special cases the Executive may grant permission; but in such cases the lining shall be previously saturated with tungstate of soda or such other non-inflammable preparations as the Executive may energy. Executive may approve.

39. No movable gas-brackets, or other portable appliance for lighting, shall be used in the Exhibition buildings.

#### PUBLIC ORDER AND SAFETY.

40. No person visiting or walking through the grounds shall walk elsewhere than on the paths. 41. No person shall remove or damage any of the seats,

lamps, trees, shrubs, grass, flowers, statuary, lakes, foun-tains, aquaria, fish, or birds, or any other material or pro-perty in the Exhibition, its buildings or grounds; and no person shall throw stones or other missiles, or smoke, or light fires therein, or leave therein any bottles, orange-peel,

light fires therein, or leave therein any bottles, orange-peel, paper, cast-off clothing, or litter or refuse or any kind. 42. No person shall enter the Exhibition or any part thereof otherwise than by the Public Gates or other proper entrance, or climb or jump over the seats or fences in and around the Exhibition, its buildings or grounds, or lie on the seats, or stick bills on the buildings, fences, or gates, or cut names, letters, or marks on the buildings, trees, seats, gates, posts, or fences, or otherwise deface the same, or write, print, stick or distribute or scatter bills therein. 43. No person shall bring into the Exhibition, its buildings or grounds, any horse, dog, or other animal, or any vehicle

or grounds, any horse, dog, or other animal, or any vehicle except by special permission of the Executive.

44. No child under seven years of age shall be allowed in-side the Exhibition, unless in charge of an adult.

45. (1.) No person shall, while in the Exhibition, do or aid and abet the doing of any of the following things .---

- (a.) Assault or beat any person;
  (b.) Be drunk or incapable;
  (c.) Behave in a riotous or disorderly manner;
  (d.) Create or take part in any disturbance or breach of
- the peace
- (e.) Use any protane, indecent, obscene, threatening, or insulting language;

- insulting language;
  (f.) Commit any nuisance or act of indecency;
  (g.) Destroy, deface, or injure any tree, shrub, plant, building, structure, article, or thing in the Exhibition, its buildings or grounds;
  (h.) Pass or endeavour to pass any gate-keeper, money-taker, or ticket-collector without payment of admission fee, or without producing his pass or ticket, as the case may be, or by otherwise satisfying such gate-keeper, money-taker, or ticket-collector as to his right to obtain admission;
- ticket-collector as to his figur to exclude the mission;
  (i.) Pass or endeavour to pass into any side-show for which special admission fees are payable, unless by payment of the prescribed fee;
  (j.) Obtain admission to or be upon or in any part of the Exhibition, its buildings or grounds, unless duly entitled under these regulations.

(k.) Interfere with or obstruct any Executive Commissioner or official, or servant appointed or employed by the Executive, in the execution of his duty.

(2.) Any person who offends against this regulation may be expelled from the Exhibition by the Executive or any officer or servant of the Executive, or by a constable, and shall also be liable as for a breach of these regulations.

46. No persons, except artisans, labourers, or workmen employed in the gardens or grounds, shall enter any plots which may be enclosed within the Exhibition grounds, and then only such plot as they may be employed in.

47. Any person who gains admission to the Exhibition, or any part thereof, otherwise than as herein provided, or, being lawfully in, does not observe these regulations, shall be liable to be forthwith removed from the Exhibition, and also be liable as for a breach of these regulations.

48. Every Executive Commissioner and Exhibition officer upon presenting his pass or badge shall be deemed to be authorised by the Executive to enter and visit any part of the Exhibition, its buildings and grounds.

49. All artificial light, except that supplied by the Exhibition contractors, is absolutely prohibited, except in cases where it may be permitted by the Executive, under such restrictions as it may in each case adopt.

50. No exhibitor, concessionnaire, employee, or other person visiting or being in the Exhibition shall light or in-troduce any fire into any part of the Exhibition, its build-ings or grounds, unless authorised in writing by the Executive.

51. No shavings, straw, paper, packing, &c., or any in-flammable material shall be allowed to remain in the Exhibition, its buildings or grounds. 52. No person shall light, or assist in lighting, any match,

paper, wood, straw, or any other combustible material in the Exhibition, its buildings or grounds, and any person who is found smoking or using any lighted paper, cigar, or cigarette, or open light in or near any of the Exhibition buildings, or any side-show or other buildings, may be ordered to leave the Exhibition, and in addition thereto shall be liable as for a breach of these regulations

breach of these regulations. 53. No person shall sketch, photograph, or take any copy or reproduction by any method or process, or mode of representation whatever, of any person, photograph, picture, drawings, designs, models, or exhibit, or any other article or thing in the Exhibition, its buildings or grounds, or use any camera therein without the written authority of the Execu-tive. tive

54. No person shall sketch, photograph, or take any copy or reproduction, by any method or process or mode of repre-sentation whatever, of any painting, picture, or other work of art in the Exhibition Art Gallery, without the written

55. No person shall take into the Exhibition Art Gallery, or shall have in his possession in the Art Gallery, any sketching, drawing, photographic, or printing materials or apparatus, or materials or apparatus connected or used with apparatus, or materials or apparatus connected or used with any mode of reproducing representations, without the written authority of the Executive. Any sketch, drawing, photo-graph, painting, or any sketching, drawing, painting, photo-graphic or printing material or apparatus found in the Art Gallery or in the possession of any person therein may be seized by any Exhibition official or servant of the Executive, or by any constable, and shall be forfeited to the Executive, and may be destroyed, sold, or otherwise disposed of as the Executive may direct.

Executive may direct. 56. No person shall take any parcel, stick, umbrella, or parasol or other similar articles whatever into the Exhibition Art Gallery.

57. No person shall touch, handle, or disfigure, write on, or otherwise damage in any way any picture or work of art in the Exhibition Art Gallery.

58. Every person entering or being in the Art Gallery shall conform strictly to and obey all orders or directions of any Exhibition official in charge thereof or being therein.

59. Every exhibitor and every proprietor of side-shows and concessionnaire must take every precaution necessary to prevent fire, theft, or a breach of these regulations within his

court or allotted space. 60. Suitable places will be provided in certain parts of the Exhibition for the purpose of public convenience, and every person who uses any other place for such purpose shall be liable to be permanently excluded from the Exhibition, and, in addition, to be prosecuted for a breach of these "excluded" regulations.

61. It shall be a condition upon which each person shall be permitted to have access to the Exhibition that such per-son shall faithfully observe and conform to these regulations in all things, and any person committing a breach of these regulations may be ordered to leave the Exhibition grounds, and failing compliance with such order such person may be ejected therefrom and prosecuted as a trespasser.

enter therein during the Executive. 63. Every person who commits a breach of these regu-lations shall thereby forfeit all right to enter or be in the Exhibition, its buildings or grounds, or to remain thereon by reason of his having paid any admission fee or obtained any ticket of admission, and his ejectment from the Exhi-bition shall give him no right to the return of his admission-money or ticket. 64. It shall be the duty of the Executive and its officers and servants, and they and all constables are hereby autho-

and servants, and they and all constables are hereby authorised, to enforce the due observance and performance of these regulations. The Executive may appoint any person or persons on its behalf to require and enforce the due observance and performance of these regulations.

65. Any person who offends against any of the foregoing regulations shall be liable for any such offence to a fine not exceeding ten pounds.

Modification of Acts and Customs Duties under "The New Zealand International Exhibition Act, 1906."

# ORDER IN COUNCIL.

At the Government House, at Wellington, this twenty-ninth day of October, 1906.

#### **Present**:

## HIS EXCELLENCY THE GOVERNOB IN COUNCIL.

IN exercise of the powers in this behalf conferred upon him by "The New Zealand International Exhibition Act, 1906," His Excellency the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of the said colony, doth hereby order and declare as follows :-

#### MODIFICATION OF LABOUR ACTS.

1. In the cases and for the purposes specified in para-graph (a) of section 2 of the aforesaid Act the following provisions of the therein mentioned Acts are hereby sus-pended, subject to the conditions mentioned in this Order, that is to say,--

- "The Shops and Offices Act, 1904": Section 4 (hours of employment) is hereby suspended. except so far as it relates to the weekly limit of hours of employment in paragraph (a), the interval for meals in paragraph (c), and the weekly half-holiday under paragraph (d), which half-holiday may, how-ever, be given on any working-day of the week. Section 9 (shops to close on statutory closing-day) is hereby anomoded
  - hereby suspended. Section 21 (hours of closing by requisition) is hereby
  - suspended.
- suspended.
  Section 23 (office hours) is hereby suspended, provided that a weekly half-holiday is given to office-assistants on some working-day in the week.
  "The Shops and Offices Act Amendment Act, 1905":

Section 3 (limit of employment of shop-assistants) is hereby suspended. "The Factories Act, 1901":

- Paragraph (3) of section 6 (as to production of certifi-cate of registration) is hereby suspended.
- Sections 10 to 16 (registration of factories) are hereby suspended.
- Section 17 (records and notices) is hereby suspended Sections 18, 19, and 20 (as to hours of work) are hereby suspended, except so far as the same relate to the weekly limit of hours of employment and the interval to be allowed for meals.
- Section 33 (holidays) is hereby suspended, except as to the weekly half-holiday, which, however, may be given on any working-day of the week.
  "The Industrial Conciliation and Arbitration Act, 1905": The Act shall not be deemed to authorise the making of
- - The Act shall not be deemed to authorise the making of industrial agreements or awards fixing the hours of employment, except with respect to the weekly limit of such hours and the granting of a weekly half-holiday on some working-day of the week. All industrial agreements and awards now in force under the Act are hereby suspended so far as they fix the hours of employment, except with respect to the weekly limit of such hours and the weekly half-holiday, which, however, may be given on any working-day of the week : Provided that where the weekly limit is not fixed it shall be deemed to be six weekly limit is not fixed it shall be deemed to be six times the daily limit as fixed.

MODIFICATION OF CHINESE IMMIGRANTS ACT AND IMMIGRATION RESTRICTION ACT.

2. The provisions of "The Chinese Immigrants Act, 1881," and of "The Immigration Restriction Act, 1899," are hereby suspended in the case of persons who desire to enter New Zealand as visitors or exhibitors in connection with the Exhibition, and who comply with the following conditions :-

- (a.) The person claiming to enter New Zealand under this Order shall, on or before landing, make and deliver to the Collector at the port of landing a declaration in such one of the forms in the
- Schedule hereto as is applicable:
  (b.) He shall also register with the Collector at Christ-church his address whilst in New Zealand, and duly notify that Collector of any change in such address
- (c.) He shall leave New Zealand within twenty one days after the final closing of the Exhibition :
- (d.) Two weeks at least before leaving New Zealand he shall notify the Collector at Christchurch of the vessel by which he intends to leave, and the port of departure.

3. If any person who enters New Zealand under the last preceding clause of this Order makes default in faithfully complying with any of the aforesaid conditions, he may, if the Minister of Customs so directs, be dealt with as a person who has landed in New Zealand in breach of the Act which has been suspended as to him, and if that Act is "The Chinese Immigrants Act, 1881," he shall also be liable to

Conness Immigrants Act, 1881," he shall also be hable to pay the poll-tax thereby imposed. 4. No person shall be entitled to enter New Zealand under this Order after the 31st day of March, 1907. 5. Nothing hereinbefore contained shall be construed to authorise the admission into New Zealand of any person who is a prohibited immigrant under paragraph (2), (3), or (4) of section 3 of "The Immigration Restriction Act, 1899."

#### DUTIES OF CUSTOMS.

6. The Collector at Christchurch may allow goods to be cleared without payment of duty in any of the following cases, that is to say :-

- (a.) Pictures, statuary, and works of art exhibited at the Exhibition and subsequently purchased by any public institution (meaning thereby any public institution or art association registered as a corporate body, or any public school, college, or university) for display in the buildings of such institution, and not to be sold or otherwise dis-metered of hermship institutions. posed of by such institution: (b.) Samples of small value distributed free of charge
- within the Exhibition buildings or grounds by exhibitors :
- exhibitors:
  (c.) Handbills, circulars, posters, and show-cards relating to exhibits and distributed or displayed free of charge within the Exhibition buildings or grounds by exhibitors:
  (d.) Stationery bona fide used in the Exhibition buildings or grounds by exhibitors in connection with their exhibits.

7. Where any picture, statuary, or work of art exhibited at the Exhibiton is subsequently purchased by any person and duty is payable thereon, the Collector may assess the value for duty at one-half the price paid by the purchaser, and in such case the duty shall be payable accordingly. 8. Where an exhibitor's goods are destroyed or injured in the process of judging by juries of awards, the Collector may remit the whole or any part of the duty payable thereon:

thereon :

Provided that where the whole of the duty on any such goods is remitted the goods shall be abandoned to the Crown under the next succeeding clause hereof.

9. (1.) In lieu of paying duty on any article (whether an exhibit, or any stand, fitting, show-case, or material used by him for the purposes of his exhibits) the exhibitor may abandon the article to the Grown on giving the Collector three days' previous notice of abandonment and delivering

three days' previous notice of abandonment and delivering the article to such person as the Collector appoints. (2.) All articles so abandoned shall be sold by auction at such times and in such manner as the Collector directs, and the net proceeds of the sale (less expenses of and incidental to the sale) shall be paid into the Public Account as part of the Consolidated Fund. (3.) If in the opinion of the Collector the abandoned article is not worth selling as aforesaid it shall be destroyed, or otherwise disposed of as the Minister of Customs directs.

10. If by any fraud, misrepresentation, or deceit any person obtains or attempts to obtain in respect of any goods any concession of duty under this Order to which he is not properly entitled, he shall be liable to the

11. Before granting any concessions of duty under any of the foregoing provisions in that behalf, the Collector must be satisfied by declaration of some responsible and reputable person, and by such other evidence as he thinks fit to re-quire, that the case comes properly within such provision and that the concession should be made.

12. All declarations and certificates required by the Collector shall be in such form as he prescribes, and shall be deemed to be made under "The Customs Laws Consoli-dation Act, 1882," and the Acts incorporated therewith.

#### CONSTRUCTION OF ACTS.

13. All references in this Order to any Act shall be deemed to include every Act amending the same.
