ORDER IN COUNCIL.

At the Government House, at Wellington, this seventh day of January, 1907.

Present:

HIS EXCELLENCY THE GOVERNOR IN COUNCIL.

IN exercise of the powers conferred by "The New Zealand and South African Customs Duties Reciprocity Act, 1906," and in order to give full effect to the reciprocal Customs treaty made between New Zealand and the South African colonies and territories following—that is to say, the Colony of the Cape of Good Hope, the Colony of Natal, the Orange River Colony, the Transvaal, and Southern Rhodesia—His Excellency the Governor of the Colony of New Zealand, acting by and with the advice and consent of the Executive Council of that colony, doth hereby declare that, on and after the first day of January, one thousand nine hundred and seven, the goods specified in the Schedule hereto, being the produce or manufacture of the aforesaid South African colonies or territories, shall, on importation from those colonies or territories into New Zealand, be chargeable with the duties and be entitled to the exemptions as specified in that Schedule, and the existing New Zealand tariff is hereby altered accordingly, in so far, but so far only, as is necessary for the purpose of giving effect to this Order in Council.

Notification of Reciprocal Customs Treaty between New Zealand and South Africa.

Department of Trade and Customs,
Wellington, 7th January, 1907.

PURSUANT to section two of "The New Zealand and South African Customs Duties Reciprocity Act, 1906," His Excellency the Governor hereby notifies for public information that a reciprocal Customs treaty has been arranged between New Zealand and the following South African colonies and territories—viz., the Colony of the Cape of Good Hope, the Colony of Natal, the Orange River Colony, the Transvaal, and Southern Rhodesia—under which the goods named in the First Schedule hereto, being the produce or manufacture of New Zealand, will be admitted into the South African colonies and territories named on payment of the duties as specified therein, and the goods named in the Second Schedule hereto, being the produce or manufacture of the South African colonies and territories named, will be admitted into New Zealand on payment of the duties and with the benefit of the exemptions as specified therein.

It is further agreed that if a fiscal difference is made by either of the contracting parties between locally manufactured spirits and imported spirits, the manufactured spirits of the other contracting party shall be admitted at the same rate of duty as is payable on the locally manufactured spirits.

The treaty takes effect on and from the first day of January, one thousand nine hundred and seven, and (pursuant to section 4 of the aforesaid Act) will continue in operation until the close of the twenty-first day after the commencement of the next session of the New Zealand Parliament.

Proposed Boundaries of the Electoral Districts in the North Island of New Zealand.

THE North Island Representation Commission, appointed under "The Electoral Act, 1905" in pursuance of section 10 of the said Act hereby publishes for general information the following proposed boundaries of the electoral districts in the North Island; and further gives notice that written objections to the same will be received by the undersigned, the Chairman of the said Commission, at the office of the Surveyor-General, Wellington, not later than noon of Wednesday, the 16th day of January, 1907.

Maps of the proposed districts may be seen at the offices of the several local bodies in the said North Island; of the Chief Surveyors at Auckland, New Plymouth, Napier, and Wellington; of the Chief Electoral Officer at Wellington; and of the several Registrars of Electors throughout the North Island aforesaid.

Such objections as may be lodged will be considered by the Commission on Thursday, the 17th day of January, 1907, at 2.30 p.m. o'clock, at the Parliamentary Buildings, Wellington.

NORTH ISLAND ELECTORAL DISTRICTS.

BAY OF ISLANDS.

Bay of Islands District comprises the Counties of Mangonui, Whangaroa, Hokianga, and Bay of Islands, together with the Otonga Riding of Whangarei County, the northern portion of Hikurangi Riding lying north-westward of the Whakapara River, that portion of the Wairua Riding lying northwards of the Wairua River, and also that portion of the Maunu Riding lying northward of the Wairua River.

MARSDEN.

Marsden District comprises the existing Marsden Electoral District, less those portions of the Wairua and Maunu Ridings of Whangarei County lying to the north of the Wairua River, and less the Mahurangi Riding of Rodney County, and those parts of Warkworth and Kaipara Ridings included in the said existing Marsden District, and also excluding the Mahurangi East Road District of Rodney County. This district includes Moko Hinou Island.

KAIPARA.

Kaipara District comprises the existing Kaipara Electoral District, less the Waipoua Riding of Hokianga County, and including that portion of the Kumeu Riding of Waitemata County lying westward of the railway-line from the Kaipara River to the Kumeu River, and north of the Mokoroa River.

WAITEMATA.

Waitemata District comprises the existing Waitemata Electoral District, together with the Mahurangi Riding of Rodney County, the whole of Warkworth Riding, and also the Mahurangi East Road District of the said Rodney County, and excluding that part of Kumeu Riding of Waitemata County lying to the westward of the railway-line from the Kaipara River to the Kumeu River, and north of the Mokoroa River, and also excluding that portion of Waitakere Riding lying southward and westward of the road running westward from the Waitemata Harbour near Lawson's Creek and fronting Sections Nos. 37, 38, 45, 44, 58,

and 60, Parish of Waipareira. This district includes the following islands: Great and Little Barrier, Kawau, Motuhora, Tiritiri, Bean Rock, Rangiahua.

AUCKLAND EAST.

Auckland East District comprises that part of the City of Auckland lying east of Queen Street, Karangahape Road, and the Great North Road, together with that portion of the Epsom Road District of Eden County, west of Almorah Road, and that portion of the Borough of Mount Eden north of the road forming the northern boundary of Mount Eden Reserve, and thence along the northern part of Mount Eden Road and the railway-line to the city boundary.

AUCKLAND CENTRAL.

Auckland Central District comprises that part of the City of Auckland bounded on the north by Waitemata Harbour, on the east by Queen Street, Karangahape Road, and the Great North Road to Pollen Street; on the south by Pollen Street to Williamson Avenue; on the west by Williamson Avenue, Hepburn Street, Napier Street, across Franklin Road, along Middle Street, Cascade Street, and College Road to Patteson Street; thence along Patteson Street to the eastern boundary of Section No. 16, in Victoria Park; thence by the eastern boundary of that section and its production across Victoria Park to Waitemata Harbour.

AUCKLAND WEST.

Auckland West District comprises the western part of the City of Auckland lying west of Hepburn Street, Napier Street, across Franklin Road, along Middle Street, Cascade Street, and College Road to Patteson Street; thence along Patteson Street to the eastern boundary of Section No. 16, in Victoria Park; thence along the eastern boundary of that section and its production across Victoria Park to Waitemata Harbour.

GREY LYNN.

Grey Lynn comprises the Borough of Grey Lynn, less the portion lying east of Williamson Avenue and north of Pollen Street, and includes the whole of the Arch Hill and Eden Terrace Road Districts of Eden County, together with that portion of Mount Albert Road District of Eden County lying north of the Western Springs Road, New North Road, and Onslow Road, and that portion of the Borough of Mount Eden bounded by a line along the railway-line from Eden Terrace Road District to Mount Eden Road; thence by Mount Eden Road to the Terrace east of View Road; thence by the Terrace to Sherburn Road, by Sherburn Road to Valley Road, by Valley Road to Mount Roskill Road, by Mount Roskill Road to Onslow Road, by Onslow Road to the western boundary of the Borough of Mount Eden; and thence along the western and north-western boundaries of the Borough of Mount Eden to the railway-line.

EDEN.

Eden District comprises the Waikomiti Riding of Waitemata County, and that part of the Waitakere Riding not included in the Waitemata District hereinbefore described, together with the Avondale and Point Chevalier Road Districts of Eden County, and Mount Albert Road District, less that portion lying north of the Western Springs Road, New North Road, and Onslow Road; and includes that portion of Mount Roskill Road District lying north of Mount Albert Road and west of Buckland Road; the Epsom Road District, less the part lying west of Almorah Road; the northern portion of One-tree Hill Road District lying north of Market Road; and also the Borough of Mount Eden, less the northern portion included in the Auckland East and Grey Lynn Districts hereinbefore described.

PARNELL.

Parnell District comprises the existing Parnell Electoral District, together with that portion of One-tree Hill Road District of Eden County which lies between Market Road and the road which runs south-westerly from the Great South Road at the Harp of Erin Hotel to the Royal Oak Hotel.

MANUKAU.

Manukau District comprises the Mount Roskill Road District of Eden County, less the portion lying north of Albert Road, and west of Buckland Road; and includes those portions of One-tree Hill and Mount Wellington Road Districts in the existing Manukau Electoral District; also the Borough of Onehunga; together with the Otahuhu and Howick Ridings of Manukau County, the Drury and Papakura Road Districts, and the Papakura Town District in the Papakura Riding, and that part of the Wairoa

Road District lying westward of the Wairoa River. This district includes the following islands: Rangitoto, Motutapu, Rakino, Motuihi, Brown's, Waiheke, Pakatoa, Ruth's, Ponui, Pahiki.

FRANKLIN.

Franklin District comprises the Awhitu, Waiuku, Pukekohe, and Maungatawhiri Ridings of Manukau County; together with the Hunua Road District of Papakura Riding and that part of the Wairoa Road District east of the Wairoa River, the Whangamarino Riding of Waikato County, and the Huntly Riding less the south-western portion lying south of the road running east from the Waikato River immediately north of the Hakanoa Lake to Section 9A, Taupiri Parish; thence along the northern boundary of that section and through the Auckland University College endowment to the Manga-wara River; and also the Te Akau, Onewhero, and Whangape Ridings of Raglan County; and that part of the Waingaro Riding included in the existing Franklin Electoral District.

THAMES.

Thames District comprises the Coromandel and Thames Counties, together with the Borough of Thames.

OHINEMURI.

Ohinemuri District comprises the Ohinemuri County and the Borough of Waihi.

WAIKATO.

Waikato District comprises Waipa County, less that part of the Town of Cambridge south of the Waikato River, and includes the Karioi, Whangaroa, Pirongia, and Karamu Ridings of Raglan County, and that part of Waingaro Riding in the existing Waikato Electoral District; and also Kirikiriroa and Tamahere Ridings of Waikato County, the southern portion of Huntly Riding excluded from the Franklin District hereinbefore described; and the western portion of Cambridge Riding lying west of the road running south from Fencourt to the Waikato River west of Cambridge Borough and lying west of the railway-line from Fencourt to the northern boundary of the riding. This district includes the Borough of Hamilton.

TAURANGA.

Tauranga District comprises the Counties of Tauranga and Piako, together with that portion of the County of West Taupo lying north of a right line from the source of the Ongarue River to Lake Taupo at the mouth of the Waihora Stream, and also that portion of Cambridge Riding of Waikato County excluded from the Waikato District hereinbefore described; and also the Boroughs of Tauranga, Te Aroha, and Cambridge, and that part of the Town of Cambridge south of the Waikato River.

BAY OF PLENTY.

Bay of Plenty District comprises the Counties of Rotorua, Whakatane, Opotiki, and Waiapu, together with that portion of East Taupo County lying north of the Taupo-Napier Road, and also the Tolago Bay, Waimata, and Waikohu Ridings of Cook County, and that portion of Gisborne Riding lying north of Sections 17, 16, 30, and 71, Block VIII, Waimata Survey District. East Island is also included in this district.

GISBORNE.

Gisborne District comprises the Wairoa County, together with the Hangaroa, Patutahi, Arai, and Whataupoko Ridings of Cook County, and also the Gisborne Riding less that portion north of Sections 17, 16, 30, and 71, Block VIII, Waimata Survey District, included in the Bay of Plenty District hereinbefore described: the Borough of Gisborne is also included in this district. Portland Island is also included in this district.

NAPIER.

Napier District comprises the existing Napier Electoral District, together with the eastern portion of the Puketapu Riding of Hawke's Bay County lying east of the Mangaone River from the Tutaekuri River to Rissington and south of the road running easterly from Rissington; and also the eastern portion of the Okawa Riding, bounded by the road from Fernhill to Okawa Station, and thence by the road running northerly to the Tutaekuri River.

HAWKE'S BAY.

Hawke's Bay District comprises that portion of the East Taupo County lying south of the Taupo-Napier Road and east of the Tokaanu-Waiouru Road; together with the Hawke's Bay County, less the Napier District hereinbefore described: this district also includes the Waipawa Riding of

Waipawa County, that part of the Hampden Riding of Waipawa County lying north of the Mangamouku and Mangaonuku Rivers, and also the Patangata and Oero Ridings of Patangata County, the Erewhon Riding of Rangitikei County, and that part of the Karioi Riding of Waimarino County lying east of the Tokaanu-Waiouru Road. This district includes the Borough of Hastings.

TAUMARUNUI.

Taumarunui District comprises the Counties of Kawhia, Waitomo, and Awakino, together with that part of West Taupo County lying south of a right line from the source of the Ongarue River to Lake Taupo at the mouth of the Waihora Stream, that part of East Taupo County lying west of the Tokaanu-Waiouru Road, that part of Waimarino County lying west of the Tokaanu-Waiouru Road, and also the Mokau, Urenui, Tikerangi, and Waihi Ridings of Clifton County, that part of Ngatimaru Riding lying north of the Waitara River and the Mangaone Stream, and that part of Waitara West Road District of Taranaki County lying east of Richmond Road and the road from Mataitawa to Lepperton, and the continuation of that road northward and westward to the railway-line and along the railway-line to the boundary of the road district, excluding the Townships of Mataitawa and Lepperton; and includes that portion of the Ohura Riding of Stratford County lying east of the Tangarakau River. This district also includes the Borough of Waitara.

STRATFORD.

Stratford District comprises the North and East Ridings of Stratford County, and the Ohura Riding less that portion lying east of the Tangarakau River; together with that portion of South Riding lying east of a line along Cheal Road from the southern boundary of the county to Skinner Road, and along Skinner Road to Bird Road and lying north of Bird Road and Brookes Road, and also that part of Ngatimaru Riding of Clifton County lying south of the Waitara River and the Mangaone Stream, and the Moa Riding of Taranaki County less that portion included in the existing Taranaki Electoral District. The Boroughs of Stratford and Inglewood are also included in this district.

TARANAKI.

Taranaki District comprises the Omata Riding of Taranaki County; together with that part of Moa Riding in the existing Taranaki Electoral District, the Henui and Egmont Road Districts of Taranaki County, and that part of the Waitara West Road District not included in the Taumarunui District hereinbefore described, and that part of the Rahotu Riding of Egmont County lying north of Newall Road, and also the Borough of New Plymouth.

EGMONT.

Egmont District comprises the Oeo and Opunake Ridings of Egmont County, and that part of the Rahotu Riding lying south of the Newall Road; together with the west riding of Stratford County and that part of South Riding lying west of a line along Cheal Road from the southern boundary of the county to Skinner Road and along Skinner Road to Bird Road and lying south of Bird Road and Brookes Road, also the whole of Eltham County, that part of Mokoia Riding of Hawera County lying north of Tareere Road to Meremere Road, along Meremere Road to Tihi Road, and that road continued westerly to the boundary of the riding, that part of Hawera Riding lying north-east of the Mangimangi Stream and Austin Road, that part of Okaiawa Riding lying north of Normanby Road excluding the Township of Okaiawa, and the Waimate Riding less the south-eastern portion lying south of Normanby Road and west of Manaia Road and Sutherland Road, excluding the Township of Manaia from this district. The Borough of Eltham is also included in this district.

PATEA.

Patea District comprises the County of Patea; together with the County of Waitotara less those portions of Brunswick and Westmere Ridings included in the existing Wanganui Electoral District, and also those parts of Mokoia, Hawera, Okaiawa, and Waimate Ridings of Hawera County not included in the Egmont District hereinbefore described. The Boroughs of Hawera and Patea are also included in this district.

WANGANUI.

Wanganui District comprises the southern part of Matakanga Riding of Wanganui County lying south of the railway-line, the western part of Purua Riding lying west of the road intersecting Section No. 55, Block VI, Ikitara District, and forming the eastern boundary of Section No. 39, and that portion of Kaitoke Riding lying west of the road fronting Sections Nos. 104, 105, 106, and 107, and north

of the road known as No. 1 Line; together with the south-eastern portion of Brunswick Riding of Waitotara County bounded by the Mission Line from the Wanganui River to the New Missionary Line, thence by the New Missionary Line to the Brunswick Line, by the Brunswick Line to the Great Western Line, and thence by the Great Western Line to the southern boundary of the riding; and also the eastern portion of Westmere Riding included in the existing Wanganui Electoral District, and the Borough of Wanganui.

RANGITIKEI.

Rangitikei District comprises the Wanganui County, less the southern part of Mataongaonga Riding lying south of the railway-line, less the western part of Purua Riding lying west of the road intersecting Section No. 55, Block VI, Ikitara District, and forming the eastern boundary of Section No. 39, and less that portion of Kaitoke Riding lying west of the road fronting Sections Nos. 104, 105, 106, and 107, and north of the road known as No. 1 Line; together with the Awarua, Te Kapua, Otairi, and Rangatira Ridings of Rangitikei County, and that part of Wangaehu Riding lying to the north-west of the proposed Manawatu Electorate; also that part of the Hautapu Riding of KIWITEA County lying north of the Mangaharariki Stream.

OROUA.

Oroua District comprises the Pohangina County, the whole of the Oroua County except those portions of the Hiwinui, Taonui, and Otangaki Ridings lying south of the main road from Bunnythorpe to Ashhurst, and includes the Pakihikura, Peep-o'-day, Kimbolton, Waituna, Kiwitea, Ongo, Cheltenham, and Rangiwahia Ridings of Kiwitea County, and that part of Hautapu Riding lying south of the Mangaharariki Stream; including the Township of Rangiwahia; together with the Borough of Feilding.

MANAWATU.

Manawatu District comprises the Porewa, Otakapu, and Rangitoto Ridings of Rangitikei County, that part of Wangaehu Riding within the existing Manawatu Electoral District, together with the Manawatu County less that part of Awahou Riding south of the Borough of Foxton and the Foxton-Moutoa Road, that portion of Mangaone Riding lying north-westward of the Bunnythorpe-Kairanga Road, and that portion of the Taonui Riding of Kairanga County lying north-west of the Bunnythorpe-Kairanga Road and Jackytown Road. This district includes the Boroughs of Marton and Foxton.

PALMERSTON.

Palmerston District comprises that portion of the Fitzherbert Riding of Kairanga County bounded towards the south generally by the Manawatu Bridge Road, Sections Nos. 226 and 290, and Palmerston-Pahiatua Road; and includes the eastern portion of Taonui Riding bounded by the Manawatu River, the Wellington and Manawatu Railway line, Jackytown Road, and the Bunnythorpe-Kairanga Road, and that portion of Mangaone Riding lying to the south-east of the Bunnythorpe-Kairanga Road, and those parts of the Ridings of Taonui, Hiwinui, and Otangaki in Oroua County lying south of the main road from Bunnythorpe to Ashhurst. This district includes the Borough of Palmerston North.

WAIPAWA.

Waipawa District comprises Ruataniwha, Takapau, Waipukurau, Norsewood, and Ormondville Ridings of Waipawa County; together with that portion of Hampden Riding lying south of the Mangamouku and Mangaonuku Rivers, the portion of Mangatoro Riding north and west of the Manawatu River, that portion of Dannevirke Riding north of the Tahoraite-Wainui Road to the Tahoraite-Woodville Road, by that road to the road running north-westward between the Tamaki River and the Otamaraho Stream, along that road to Tamaki No. 2 Block and along the boundary between Tamaki Nos. 2 and 3 Blocks to the western boundary of the riding; and also the Taumumu Riding and Wanstead Road District of Patangata County; and the Borough of Dannevirke.

PAHIATUA.

Pahiatua District comprises the Counties of Woodville, Weber, and Akitio, together with the southern portion of Dannevirke Riding of Waipawa County not included in the Waipawa District hereinbefore described, and Mangatoro Riding less that portion north of the Manawatu River, and includes the Porangahau Riding, and the Wallingford Road District of Patangata County, the Pukemiku and Makuri Ridings of Pahiatua County, the northern portion of Mangahao Riding lying northward of Bridge Road from the Makakahi River to the railway-line, thence southward along the railway-line to Section 43, Mangahao, by Sections 43 and 40 to

the Mangahao River, by that river to Section 8, by Section 8 to the Tainui Valley Road, and by that road continued westerly to the county boundary, the northern portion of Mangaone Riding lying north of Rock Road, the Mangarama Road and the road fronting Sections 26, 21, 22, and 3, the northern portion of Puketoi Riding lying north of the Makuri River and the Makuri-Rakaunui Road; and also the Boroughs of Woodville and Pahiatua and the Township of Makuri.

MASTERTON.

Masterton District comprises the Eketahuna and Mauriceville Counties, together with the southern portions of Mangahao, Mangaone, and Puketoi Ridings of Pahiatua County not included in the Pahiatua District hereinbefore described, the whole of the Alfredton Riding of Masterton County, the Rangitumau Riding less that portion included in the existing Wairarapa Electoral District, that portion of the Te Whiti Riding west of the Ruamahanga and Wangaehu Rivers, and the eastern part of the Opaki Riding lying east of the road running between the Ruamahanga and Waipoua Rivers and east of the latter river to the Matahiwi Road, thence by a line south-westerly to the Upper Plain Road, and by that road to the Borough of Masterton, including the Borough of Masterton.

WAIRARAPA.

Wairarapa District comprises the Counties of Castlepoint, Wairarapa South, and Featherston, the Wainuioru and Upper Taueru Ridings of Masterton County, together with those portions of Rangitumau, Te Whiti, and Opaki Ridings not included in the Masterton District hereinbefore described, and also the Boroughs of Carterton and Greytown.

OTAKI.

Otaki District comprises the County of Horowhenua, together with the portion of Awahou Riding of Manawatu County south of the Borough of Foxton and the Foxton-Moutoa Road, the southern portion of the Taonui Riding of Kairanga County lying to the south-east of the Palmerston North-Oroua Bridge Road and south of the Wellington-Palmerston North Railway, also the southern portion of the Fitzherbert Riding bounded on the north generally by the Manawatu Bridge Road, Sections 215, 216, 217, 220, 221, 223, 224, and the Palmerston-Pahiatua Road, also that portion of the Hutt County bounded towards the south-east generally by the Mungaroa Riding of the said county to Section No. 196, Block IV, Belmont District, thence by Sections Nos. 196, 196A, 265, 264, 263, 437, 436, 431, 336, 341, 338, 340, 339, 331, 330, 529, 27, 7, 6, and 50 to the Wellington-Porirua Road, by that road to the Porirua Asylum Reserve, by the southern and western boundaries of that reserve and the southern boundaries of Wairere Nos. 2 and 1 Blocks to the sea. The Borough of Levin is included in this district, and Kapiti and Mana Islands.

HUTT.

Hutt District comprises the portion of the Hutt County bounded towards the north-west generally by the Otaki District hereinbefore described to Section No. 6, Block VII, Port Nicholson Survey District, thence by Sections Nos. 6, 4, 3, 2, 1, 38, 19, 18, 17, 13, 10, 8, 7, and 78 to the Korokoro Stream, by that stream to the western boundary of the Borough of Petone, and by the said western boundary to Port Nicholson; together with the Boroughs of Petone, Lower Hutt, and Eastbourne.

WELLINGTON NORTH.

Wellington North District comprises that portion of the City of Wellington situated north-west of a line which commences at the south-western corner of that part of the City of Wellington known as Kelburne (formerly Upland Farm), and proceeds easterly and northerly along the southern and eastern boundaries of Kelburne to the northern boundary of Native Reserve; thence easterly along the northern boundary of Native Reserve and through Plantation Reserve to Town Acre 436; thence southerly along the western boundaries of Town Acres 436, 435, 434, 433, 432, and 431; thence easterly along the southern boundary of Town Acre 431 to Woolcombe Street; thence northerly along Woolcombe Street to Dixon Street; thence easterly along Dixon Street to Cuba Street; and thence northerly along Cuba Street to Lambton Harbour. This district also includes Somes Island.

WELLINGTON CENTRAL.

Wellington Central District comprises that portion of the City of Wellington bounded towards the north-west by the Wellington North District hereinbefore described; towards the north-east by Lambton Harbour to a point opposite the Te Aro Railway-station; towards the east by a line

along Tory Street to Buckle Street; thence towards the south by a line along Buckle Street and Arthur Street to Cuba Street; along Cuba Street to Webb Street; thence along Webb Street to Upper Willis Street; along Upper Willis Street to Wordsworth Street; thence along Wordsworth Street to Happy Valley Road; thence along Happy Valley Road about 35 chains to a point in line with the southern boundary-line of Native Reserve; thence by a right line to and along the southern boundary of Native Reserve and that boundary produced to the western boundary of the City of Wellington; and thence towards the west by the western boundary of the City of Wellington to the Wellington North District, the place of commencement.

WELLINGTON EAST.

Wellington East District comprises that portion of the City of Wellington bounded towards the north-west by Lambton Harbour from a point opposite the Te Aro Railway-station to Point Jerningham; thence towards the east by Evans Bay to the northern boundary of that part of the City of Wellington known as Kilbirnie; thence by the northern and western boundaries of Kilbirnie to a point in line with Mein Street; thence towards the south-east by a line to and along Mein Street to Revans Street; thence towards the west along Revans Street to John Street; thence along John Street and Oliver Street to Crawford Street; and thence along Crawford Street, Tasman Street, Banks Terrace, and Tory Street to Lambton Harbour.

WELLINGTON SOUTH.

Wellington South District comprises that portion of the City of Wellington bounded towards the north by the Wellington Central and Wellington East Districts hereinbefore described, from the western boundary of the City of Wellington to a point on the western boundary of that portion of the City of Wellington known as Kilbirnie in line with the middle of Mein Street; thence towards the east by the said Kilbirnie to the north-eastern corner of Allotment 10, Town Belt; thence towards the south by the said Allotment 10 to Coromandel Street; thence by a line across Coromandel Street, and along Lawrence Street to Daniell Street; thence along Daniell Street to Rhodes Street; thence along Rhodes Street and across Mansfield Street to Russell Terrace; thence along Russell Terrace to Waripouri Street; thence along Waripouri Street to Allotment 28; thence by the said Allotment 28, the abutment of Stanley Street, and Allotment 26 to Section 18, Ohiro District; thence by the said Section 18 to Ohiro Road; thence northerly along the Ohiro Road to the northern boundary of Section 14 in Block X, Port Nicholson Survey District; thence by the said Section 14 to the western boundary of the City of Wellington; and thence towards the west by the western boundary of the City of Wellington to the Wellington Central District, the place of commencement. This district includes Vogeltown, Brooklyn, and Fitchett-town.

WELLINGTON SUBURBS.

Wellington Suburbs District is bounded towards the north by Wairere Nos. 1 and 2 Blocks from the sea to the Porirua Asylum Reserve, thence by the said Porirua Asylum Reserve to the Wellington-Porirua Road, thence by that road to the southern corner of Section No. 51, Block II, Belmont Survey District; thence by Sections 51 and 8, Block II; thence towards the east generally by Sections 7, 5, 36, 37, 23, 20, 16, 15, 14, 12, 11, and 9, and the Korokoro Stream to the Borough of Petone; thence by the Borough of Petone to Port Nicholson; thence by Port Nicholson to the City of Wellington; thence by the City of Wellington to the southern boundary of Wellington South District hereinbefore described; thence by the Wellington South and Wellington East Districts to Evans Bay, thence by Evans Bay and Port Nicholson; and towards the south and west by the sea to the place of commencement. This district includes the Boroughs of Karori, Onslow, and Miramar, and Johnsonville Town District.

Proposed Boundaries of the Electoral Districts in the South Island (including Stewart Island) of New Zealand.

THE South Island Representation Commission, appointed under "The Electoral Act, 1905," in pursuance of section 10 of the said Act hereby publishes for general information the following proposed boundaries of the electoral

districts in the South Island (including Stewart Island); and further gives notice that written objections to the same, addressed to the undersigned, the Chairman of the said Commission, will be received at the office of the Chief Surveyor, Lands and Survey Department, Christchurch, up to noon of Wednesday, the 16th day of January, 1907.

Maps of the proposed districts may be seen at the offices of the several local bodies in the said South Island (including Stewart Island); of the Chief Surveyors at Dunedin, Christchurch, Nelson, Blenheim, Hokitika, and Invercargill; of the Chief Electoral Officer at Wellington; and of the several Registrars of Electors throughout the South Island aforesaid (including Stewart Island).

Such objections as may be lodged will be considered by the Commission on Thursday, the 17th day of January, 1907, at 10 o'clock, at the Provincial Council Chamber, Christchurch.

SOUTH ISLAND ELECTORAL DISTRICTS.

NELSON.

Nelson District comprises the existing City of Nelson Electoral District, less that portion of the Pelorus Riding lying between the Town of Havelock and the western boundaries of Sections Nos. 8, 178, and 6, and a continuation of such boundaries to the nearest tidal water of the Pelorus River, and less that portion of the said City of Nelson Electoral District lying west of the Waimea River. This district also includes the western portion of the Sounds County, bounded by the watershed between the Kenepuru and Queen Charlotte Sounds and northward over Mount Stokes to Forsyth Bay; including also the City of Nelson and the Borough of Richmond.

MOTUEKA.

Motueka District comprises Collingwood and Takaka Counties, together with the Waimea County, less the Stoke and Wangamoa Ridings. The Borough of Motueka is also included in this district, together with the whole of the Buller County, excepting the south-western portion of Karamea Riding lying south of the Mokihini River to its confluence with Chasm Creek and thence along Chasm Creek to the eastern boundary of the Buller Coalfield Reserve, and thence by that boundary to the Ngakawhau River.

BULLER.

Buller District comprises the Inangahua County, less Antonio's Riding and less that portion of Reefton Riding lying south-westward of the Inangahua River, excluding the Town of Reefton, together with Charleston, Wareatea North, Wareatea South, and Lyell Ridings of Buller County, and that portion of the Karamea Riding which is excluded from the Motueka District. This district also includes the Borough of Westport.

GREY.

Grey District comprises the Paroa, Cobden, and Brunner Counties, together with that portion of Maori Creek Riding lying northward of the Maori Creek Road to the Township of Dunganville, thence north-easterly by the Dunganville Road and the Arnold Road to the Arnold River; and also Antonio's Riding of Inangahua County and that portion of Reefton Riding lying south-westward of the Inangahua River; and also the whole of the Township of Reefton and the Boroughs of Greymouth and Brunner.

WESTLAND.

Westland District comprises the whole of the County of Westland, together with the Hohou, Marsden, Red Jack's, Nelson Creek, and Waipuna Ridings of Grey County, and that portion of Maori Creek Riding lying southward of the Maori Creek Road, to the Township of Dunganville, thence north-easterly by the Dunganville Road and the Arnold Road to the Arnold River. This district also includes the whole of the Township of Dunganville, together with the Boroughs of Hokitika, Ross, and Kumara.

WAIRAU.

Wairau District comprises the existing Wairau Electoral District, together with the southern portion of Marlborough County lying between the Kaikoura Range and the Clarence and Acheron Rivers, and that portion of the Pelorus Riding lying between the Town of Havelock and the western boundaries of Sections Nos. 8, 178, and 6, and by a continuation of such boundary to the nearest tidal water of the Pelorus River, and that portion of Sounds County not included in Nelson District.

HURUNUI.

Hurunui District comprises the Counties of Amuri, Kai-koura, Cheviot, and Ashley, less the Mandeville, Eyréton, and West Eyreton Ridings, and less that portion of the Oxford Riding lying south of the Rangiora-Oxford Railway line to the Old Mill Road; thence by that road to its junction with the Main Bush Road; by the said Main Bush Road to Cooper's Road; thence by Cooper's Road to Perhams Road; thence by Perhams Road to Washpen Road, by the said Washpen Road to Gorge Road; thence by Gorge Road to Woodstock Road, and by Woodstock Road to the Ashley County boundary; excluding the Townships of East Oxford and West Oxford.

KAIAPOI.

Kaiapoi District is bounded towards the north by the Ashley River; towards the east by the sea; towards the south by the road from the sea to the Styx River, forming the northern boundaries of Reserves 2638 and 2637, and Rural Sections Nos. 2340, 31648, and 20428; thence by the Styx River to Rural Section No. 294, by that section to Hawkins Road; thence by Hawkins Road to Hill's Road, by Hill's Road to Kelly's Road; thence by Kelly's Road to Shirley's Road and by Shirley's Road to the City of Christchurch; thence by the City of Christchurch to Wairarapa Road, by Wairarapa Road to Fendalton and Sawyer's Arms Junction Road; thence by that road to Fendalton Road, by Fendalton Road to Kaiapoi Junction Road; thence by Kaiapoi Junction Road to Coringa Road; thence by Coringa Road and the road intersecting Section No. 6113 and its continuation north-easterly to Fleshorn Road; thence by that road to the Waimakariri River, across to Baile's Island, around the west end of that island to a point in line with Harr's Road; thence by a line to and by Harr's Road and along Waimakariri Road to the Rangiora and Waimakariri Road, and by the continuation of that road to the Oxford and Kaiapoi Road; thence north-westerly by the last-mentioned road to a point in line with the road forming the western boundaries of Sections Nos. 11210 and 11446; thence to and by that road to the Oxford-Rangiora Railway, by that railway to the western boundary of the Mandeville Riding of the Ashley County; and thence northward by the said western boundary to the Ashley River. This district includes the Boroughs of Kaiapoi and Rangiora.

CHRISTCHURCH NORTH.

Christchurch North District comprises that portion of the City of Christchurch lying north-west of a line along Fowke Street from its junction with Hills Road to a street in continuation of Fitzgerald Avenue; thence to Bealey Avenue; thence along the said Bealey Avenue to Churchill Street, and thence southerly along the said street to the Avon River; thence along the Avon River to Salisbury Street, along Salisbury Street to Colombo Street; thence southerly along Colombo Street to Cathedral Square; thence westerly along Worcester Street to Antigua Street; together with that portion of Hagley Park lying north of a line in continuation of the north side of Worcester Street to the western boundary of Hagley Park.

CHRISTCHURCH EAST.

Christchurch East District comprises that portion of the City of Christchurch bounded towards the north by the Christchurch North District hereinbefore described from Colombo Street to Fitzgerald Avenue; thence by a line along London Street to Perth Street; thence towards the east generally by a line along Perth Street to Victoria Street; thence easterly along Victoria Street and southerly along the western boundaries of Allotments 11 and 10 to Heywood Terrace; thence along the street which runs from Heywood Terrace to Windsor Terrace; thence westerly along the latter terrace about 5 chains to a street which runs southerly to the Avon River, along that street to the Avon River; and thence by the Linwood Ward of the City of Christchurch and Wilson's Road to Shakespeare Road; thence towards the south along Shakespeare Road to Thackeray Street, by Thackeray Street to Darwin Street; thence westerly along Darwin Street to Waltham Road; thence along Waltham Road to Brougham Street, and westerly along Brougham Street to Colombo Street; thence towards the west by a line along Colombo Street to the Christchurch North District, the place of commencement.

CHRISTCHURCH SOUTH.

Christchurch South District is bounded towards the north by the Christchurch North District hereinbefore described from the western boundary of Hagley Park to Cathedral Square; thence towards the east by a line along Colombo Street to Brougham Street; thence again towards the north by a line along Brougham Street to Waltham Road; thence along Waltham Road to Darwin Street; thence along Darwin

Street and Thackeray Street to Shakespeare Road; thence along Shakespeare Road to Wilson's Road; thence towards the east by Wilson's Road to the Heathcote River, and along the Heathcote River to Tennyson Street; thence towards the south by Tennyson Street to Colombo Road, along Colombo Road to Strickland Street; thence by Strickland Street to Jackson's Creek, along Jackson's Creek to Jerrold Street, and along Jerrold Street to Lincoln Road; thence towards the west generally by Lincoln Road to Moorhouse Avenue, along Moorhouse Avenue to the western boundary of Hagley Park; and thence by the western boundary of Hagley Park to the place of commencement.

AVON.

Avon District is bounded towards the east by the sea; towards the south by the estuary of the Heathcote and Avon Rivers, and by the Borough of Woolston to Ferry Road, by Ferry Road to Grafton Road, by Grafton Road to Charles Street, thence by Charles Street to the eastern boundary of Christchurch East District; thence towards the east by Christchurch East and Christchurch North Districts to the north-eastern corner of the City of Christchurch; and thence towards the north-west by the Kaiapoi District to the sea.

RICCARTON.

Riccarton District comprises West Eyreton Riding of Ashley County, together with the south-eastern portion of Oxford Riding bounded on the west by the western boundary of Rural Section No. 27754 and the road west of Burnt Hill from the northern corner of the said section to the Main Race Road; thence by Main Race Road to Burnt Hill Road, by Burnt Hill Road to South Eyre Road, by South Eyre Road to its junction with Domain Road; thence by the road running north to the Town of Oxford, by the eastern boundary of the said Town of Oxford to the Oxford-Rangiora Railway, and by the said railway to the boundary of the Oxford Riding; and also the western portion of Eyreton Riding not included in the Kaiapoi District, also that portion of Courtenay Riding of Selwyn County lying to the west of the Selwyn-Waimakariri Road to Bealey's Road, by Bealey's Road to Strange's Road, by Strange's Road to Hawkins and Burnham Road, by Hawkins and Burnham Road to the road forming the western boundaries of Sections 27988 and 30432, and by that road to the Wakaepa River, the western portion of Riccarton Riding bounded towards the east by Hagley Park and the City of Christchurch to Wairarapa Road, by Wairarapa Road to Fendalton and Sawyer's Arms Junction Road; thence by that road to Fendalton Road, by the said Fendalton Road to Kaiapoi Junction Road, by the said Kaiapoi Junction Road to Coringa Road; thence by the said Coringa Road and the road intersecting Section No. 6113 and its continuation north-easterly to Fleshorn Road, and thence by that road to the Waimakariri River, less that portion lying south-west of the Harewood-Hampton Road and the railway-line, together with that portion of Halswell Riding bounded towards the north by Burke's Bush North Road from the western boundary of the said riding to the Mount Herbert County; thence by the said county boundary to the southern corner of Rural Section No. 452; thence by the road running north to Cashmere; thence by the south-eastern boundary of Spreydon Road District to Barrington Road; thence by the said Barrington Road to Stark's Road; thence by Stark's Road to the City of Christchurch; thence by that city and the northern and western boundaries of the Halswell Riding, and also the northern portion of the Lincoln Road District of Selwyn County bounded on the south by Leadley's Road from the Halswell Road to the railway-line; thence northward by the railway-line to Hampton's Road, by Hampton's Road to the boundary of the said Lincoln Road District.

LYTTELTON.

Lyttelton District comprises the existing Lyttelton Electorate, less that portion of the Spreydon Road District lying north-west of Stark's Road; also the southern portion of the Linwood Ward of the City of Christchurch, bounded by Wilson's Road from the railway-line to Charles Street, thence by Charles Street to Grafton Street, thence by Grafton Street to Ferry Road, and thence by Ferry Road to Ensor's Road, and also the whole of Mount Herbert County.

ELLESMERE.

Ellesmere District comprises the Akaroa County, together with the southern portions of the Lincoln and Halswell Ridings not included in Riccarton District, together with the whole of Ellesmere Riding of Selwyn County, and also the Borough of Akaroa.

SELWYN.

Selwyn District comprises the Coleridge and Māveru Ridings of Selwyn County, and that portion of Courtenay

Riding not included in Riccarton District, together with the south-western portion of Oxford Riding of Ashley County bounded towards the north by Hurunui District and towards the east by Riccarton District, including the Towns of East Oxford and West Oxford, and also the Mount Somers, Mount Hutt, and South Rakaia Ridings of Ashburton County; and also Wakanui Riding less the Town District of Hampstead and less that portion lying west of Wakanui Road; also the north-western portion of Upper Ashburton Riding lying north of Sections Nos. 24665 and 21039 and the eastern portion of the said Upper Ashburton Riding lying eastward of the Dromore Road.

ASHBURTON.

Ashburton District comprises the Ashburton Riding of Ashburton County and the Upper Ashburton Riding less those portions included in the Selwyn District, together with the Town District of Hampstead and that portion of the Wakanui Riding lying west of Wakanui Road, and also the eastern portions of the Temuka and Raukapuka Ridings bounded towards the north-east by Rangitata River, towards the south-east by the sea, towards the west by the Orari River from the sea to Section No. 8825; thence by the south-eastern boundaries of Sections Nos. 8825, 7211, 3606, 7181, and 8847 to the railway-line; thence by the railway-line to the southern boundary of the Raukapuka Riding; thence by the said southern boundary to the Hae Hae te Moana River; thence by the Hae Hae te Moana River to Macdonald's Road, by Macdonald's Road to Turton's Road, by Turton's Road to Kempster's Road, by Kempster's Road to Pithie's Road; thence by Pithie's Road to the northern boundary of the Raukapuka Riding, and thence by the said northern boundary to the Rangitata River; and also the Boroughs of Ashburton and Geraldine.

TIMARU.

Timaru District comprises the Ridings of Seadown, Waimataiti, Gleniti, and Otipua of Levels County, together with the eastern part of Claremont Riding lying eastward of Brockley Road, and also the Borough of Timaru.

TEMUKA.

Temuka District comprises the Mackenzie County, that portion of Geraldine County not included in the Selwyn District, and that part of Levels County not included in Timaru District, together with the Upper Pareora, Lower Pareora, Otaia, and Makikihi Ridings of Waimate County, and also the northern portion of the North Waihao Riding lying northward of the northern boundary of Rural Section No. 29778, and the road running westward from the north-western corner of that section to the Hakataramea River, and also the northern portion of Hakataramea Riding lying north of a line along the stream intersecting Section No. 29450 from the Hakataramea River to the Main Road; thence along the Main Road to the northern boundary of Section No. 29359; thence by the northern boundaries of Sections Nos. 29359, 29356, and 33019, by the southern boundary of Section No. 33199 and a right line to Trig. Station N; thence westward by the main watershed to the Waitaki River at the confluence of that river with the Ahuriri River; also including the Borough of Temuka.

OAMARU.

Oamaru District comprises the Dunback, Blue Mountain, Meadowbank, and Bushy Ridings of Waihemo County, together with the Moeraki, Otepopo, and Kakanui Ridings of Waitaki County, the south-eastern portion of Waireka Riding bounded by the western boundaries of Western Park and the Ardgowan Settlement and part of the northern boundary of the said Ardgowan Settlement, and also the southern portion of Papakaio Riding bounded on the north by the northern boundary of Blocks I and II, Oamaru Survey District, to London Creek, by London Creek to Section 125, and thence by Sections 125, 126, to the road forming the north-eastern boundary of the last-mentioned section and Section 156 to the Main Road, by the Main Road to the road north of Section 141, and thence by that road running easterly to the sea. The Borough of Palmerston is included in this district.

WAITAKI.

Waitaki District comprises that portion of Waimate County not included in the Temuka District, together with the Ahuriri, Otekaike, Awamoko, and Incholme Ridings of Waitaki County, and also those portions of Waireka and Papakaio Ridings not included in the Oamaru District. The Borough of Waimate is also included in this district.

MOUNT IDA.

Mount Ida District comprises the Boroughs of Naseby, Roxburgh, and Alexandra, the whole of the Maniototo County

less that part of the Hyde Riding south of the Cap Burn, together with the Green Valley and Macrae's Ridings of Waihemo County, the Matakau, Manuherikia, Dunstan, and Earnscliffe Ridings of Vincent County, the Teviot, Beaumont, and James Ridings of Tuapeka County, the portion of Tapanui Riding of Tuapeka County lying north of the road running south-easterly from the southern boundary of the Township of Kelso and thence easterly to the boundary of the said Tapanui Riding, and also the northern portion of Glenkenich Riding of Clutha County lying north of Blocks I and II, Glenkenich Survey District, and along the road running north-easterly from Block II to the Pomahaka River; also including the Township of Kelso, and also that part of Gabriel's Riding of Tuapeka County lying north of Gardener's Track.

CHALMERS.

Chalmers District comprises the whole of the Waikouaiti and Peninsula Counties, together with the Goodwood Riding of Waihemo County, the Boroughs of Hawksbury, Port Chalmers, and West Harbour, and the northern portion of the Borough of North-east Valley lying north-east of the Pine Hill Road intersecting Sections Nos. 58, 57, 55, and 53 to Watts Road, by the said Watts Road to the Main North Road, and by the Main North Road to the south-western corner of the Township of Dalkeith, thence by the south-western boundary of the said township and Sections Nos. 46 and 2 of 29 to the boundary of the Borough of West Harbour.

DUNEDIN NORTH.

This district is bounded towards the north and towards the south-east generally by the northern and south-eastern boundaries of the Borough of Maori Hill from Swampy Hill to the road fronting Section No. 66, Block XI, North Harbour and Blueskin Survey District; thence towards the north-west by the road fronting Sections Nos. 66, 64, 62, and 60; thence towards the north-east generally by the Chalmers District hereinbefore described and the Borough of West Harbour to Dunedin Harbour; thence towards the south generally by Dunedin Harbour to a point in line with Frederick Street; thence by a line to and along Frederick Street to Leith Street; thence by Leith Street to Albany Street, along Albany Street to Queen Street; thence along Queen Street to Pitt Street, along Pitt Street and Royal Terrace to the right-of-way between Sections Nos. 46 and 47 on the north side of Royal Terrace; thence along that right-of-way and by a right line to the easternmost corner of the Borough of Roslyn; thence by the Borough of Roslyn, and the western boundary of the Borough of Maori Hill to Swampy Hill, the place of commencement.

DUNEDIN WEST.

Dunedin West District comprises the Borough of Roslyn and that part of the City of Dunedin bounded by a line from the easternmost corner of the Borough of Roslyn to the right-of-way between Sections No. 46 and 47, situated north of Royal Terrace; thence along that right-of-way to Royal Terrace, along Royal Terrace, to Pitt Street, and along Pitt Street, Queen Street, Albany Street, and Leith Street to Frederick Street; thence along Frederick Street and its continuation to Dunedin Harbour; thence by Dunedin Harbour to a point in line with Stuart Street; thence by a line to and along Stuart Street across the Octagon to Smith Street, along Smith Street, Rattray Street, and the Roslyn Cable Tramway to the Borough of Roslyn.

DUNEDIN CENTRAL.

Dunedin Central District comprises the Borough of Mornington, together with that part of the City of Dunedin bounded towards the north by the Roslyn Cable Tramway along Rattray Street to Smith Street, by Smith Street to Stuart Street; thence by Stuart Street across the Octagon and a line in continuation of Stuart Street across the Railway Reserve and continued to Dunedin Harbour; thence towards the east by Dunedin Harbour; towards the south by the Caversham Ward of the City of Dunedin; and towards the west by the Borough of Mornington, and also that part of the Caversham Ward of the City of Dunedin lying east of Goodall Street and north of the railway-line and the Main South Road.

DUNEDIN SOUTH.

Dunedin South District comprises the Borough of St. Kilda, together with the Caversham and South Dunedin Wards of the City of Dunedin less that portion of the Caversham Ward lying east of Goodall Street and north of the railway-line and the Main South Road, which is included in the Dunedin Central District.

TAIERI.

Taieri District comprises the whole of the Taieri County, together with that portion of Hyde Riding of Maniototo

County lying south of the Cap Burn, the Waipori Riding of Tuapeka County, and the Clarendon and Waihola Ridings of Bruce County.

BRUCE.

Bruce District includes the whole of the Bruce County less Clarendon and Waihola Ridings, together with the Waitahuna, Clark's, and Brown's Ridings of Tuapeka County, and that part of Gabriel's Riding not included in Mount Ida District, and also the Boroughs of Milton, Lawrence, and Kaitangata.

CLUTHA.

Clutha District comprises the existing Clutha Electoral District with the addition of the Toetoes Riding of the Southland County, excepting the north-western portion of the said riding lying to the westward of the road running south-westerly from the Mimiha Stream at Section No. 89, Block VII, Tuturau Survey District, to the Oware Stream, thence along the Oware Stream and Mokoreta River to the Mataura River; excluding the northern portion of the Mataura Riding, which is included in the existing Clutha Electoral District; excluding also the northern portion of the Glenkenich Riding of Clutha County lying north of Blocks I and II, Glenkenich Survey District, and a line along the road running north-easterly from the north-eastern corner of Block II to the Pomahaka River, about a mile north of the Township of Kelso; also excluding the northern portion of Tapanui Riding of Tuapeka County lying north of the road running south-easterly from the southern boundary of the Township of Kelso, and thence easterly to the boundary of the said Tapanui Riding. The Township of Kelso is excluded from this district.

WAKATIPU.

Wakatipu District comprises the existing Wakatipu Electoral District, including the whole of the Hawera and Lindis Ridings of Vincent County, together with the north-eastern portion of the Mataura Riding of Southland County lying

north of the Knapdale-Kelso Road, and that portion of the Oreti Riding of Southland County lying west of the Township of Balfour, between the Waimea Plains Railway and the road running south-easterly from the Josephville Railway-station to the junction of Balfour-Carolins Road.

MATAURA.

Mataura District comprises the existing Mataura Electoral District, excluding that part of the Toetoes Riding of the Southland County which is included in the Clutha District hereinbefore described, and including the whole of the Waihopai Riding and the eastern portion of the Awarua Riding lying north of the Waihopai Riding as far as the Mabel Bush Road.

AWARUA.

Awarua District comprises the existing Awarua Electoral District less that portion lying to the eastward of the Invercargill Road District, and the eastern boundary of that road district produced northwards to the Mabel Bush Road, and thence in a north-easterly direction to the boundary of the Awarua Riding, and including those portions of the Invercargill Road District adjoining the Boroughs of Invercargill, Gladstone, North Invercargill, East Invercargill, and South Invercargill, which were excluded from the existing Awarua Electoral District.

INVERCARGILL.

Invercargill District comprises the Boroughs of Invercargill, Avenal, Gladstone, North Invercargill, East Invercargill, and South Invercargill.

WALLACE.

Wallace District comprises the existing Wallace Electoral District, less that portion of Oreti Riding of Southland County included in the Wakatipu District. This district also includes Centre Island.
