**ORDER IN COUNCIL.**

At the Government Buildings, at Wellington, this twenty-ninth day of February, 1908.

WHEREAS by section five of the Fire Brigades Act, 1907 (hereinafter termed "the said Act"), it is provided that the Governor may by Order in Council, on the application of any Borough Council, declare the district within the jurisdiction of such Borough Council to be a fire district under the said Act: And whereas an application has been made by the Greymouth Borough Council in accordance with the provisions of the said Act, and it appears expedient to grant the said application:

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred upon him by the said Act, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare the Borough of Greymouth to be a fire district under the said Act.

**W**HEREAS by "The Court of Appeal Act, 1882," it is enacted that the Court shall hold its sittings at such times and places as shall from time to time be fixed by the Governor in Council and proclaimed in the *Government Gazette* twenty-one days at least before the times so fixed respectively :

Now, therefore, His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby fix that sittings of the Court of Appeal of New Zealand shall be held within the Supreme Court House, in the City of Wellington, upon the following days, at eleven o'clock in the forenoon :—

Monday, the sixth day of July, one thousand nine hundred and eight.

Monday, the fifth day of October, one thousand nine hundred and eight.
