Amended Description of Hauraki Mining District.

PLUNKET, Governor. (L.S.) A PROCLAMATION.

A PROCLAMATION. IN pursuance and exercise of the powers and authorities vested in me by "The Mining Act, 1908" (hereinafter termed "the said Act"), and of all other powers enabling me in this behalf. I, William Lee, Baron Plunket, the Governor of the Dominion of New Zealand, do hereby re-voke so much of the Proclamation constituting the Hauraki Mining District, published in the New Zealand Gazette No. 68, of the tenth day of August, one thousand eight hundred and ninety-nine, as defines the boundaries of that district, and in lieu thereof do hereby proclaim and declare that the boundaries of the said district shall be those mentioned in the Schedule hereto. And I do hereby further proclaim and declare that this Proclamation shall take effect as from the date of gazetting hereof. the date of gazetting hereof.

SCHEDULE

NORTH ISLAND .- HAURAKI MINING DISTRICT.

NORTH ISLAND.—HAURAKI MINING DISTRICT. ALL that area in the Auckland Land District bounded towards the north-east generally by the sea and Tauranga Harbour, from Cape Colville to the Kaituna River; thence by the estuary of that river towards the south-east, by the road from Maketu to Rotorua to a point where a line drawn from Trig. Station No. 27 (Puwhenua) over the trig. station on Te Taheke intersects the said road; thence towards the south-west by a right line over the said Te Taheke Trig. Station to the said Trig. Station No. 27 (Puwhenua); thence by a right line to Weraiti Trig. Station; thence towards the south and south-west by Okauia No. 1B Block; and again towards the south-west generally by the left bank of the Waihou or Thames River, the Firth of Thames, and the Hauraki Gulf to Cape Colville, to place of commence-ment: save and excepting Sections Nos. 1, 2, 3, 4, 5, 7, 8, 9, 20, and 26, Block XI; Sections Nos. 12, 13, 15, 16, and 22, Block 15, Hastings Survey District : comprising an area of 3,295 acres. 3,295 acre

the source of the Waikoukou River to the northermost corner of Section No. 97, Paremoremo Parish; thence by Pukeatua and Okura Parishes to the sea; thence towards the east generally by the sea to the mouth of the Wairau Stream; thence towards the south generally by the said Wairau Stream and its northern branch through Sections Nos. 105, 113, and 112, Parish of Takapuna, to its source; thence by a right line to the source of Hellyer's Creek; thence by the said Hellyer's Creek to Waitemata Harbour; thence by the waters of the said Waitemata Harbour, by Brigham's Creek and Waipareira Parish to the Kumeu River; and thence towards the west generally by that river and the Waikoukou River to the source of the latter river, the place of commencement. the place of commencement. Bringing the Urewera District Native Reserve under the Operation of "The Mining Act, 1908," and making Special Regulations relating thereto.

PLUNKET, Governor.

BLUNKET, Governor. BY virtue and in exercise of the powers and authorities vested in me by section twenty-four of "The Mining Act, 1908" (hereinafter termed "the said Act"), and by section seven of "The Maori Land Claims Adjustment and Laws Amendment Act, 1907," and of all other powers enabling me in this behalf, I, William Lee, Baron Plunket, the Governor of the Dominion of New Zealand, do hereby bring the Urewera District Native Reserve, as constituted by section seven of the last-mentioned Act, being the land described in the First Schedule hereto, within the operation of the said Act, subject, however, to the conditions, modifi-cations, and restrictions contained in the regulations set forth in the Second Schedule hereto, which regulations are forth in the Second Schedule hereto, which regulations are hereby made by me under the aforesaid powers and authorities.

FIRST SCHEDULE.

FIRST SCHEDULE. ALL that area in the Auckland and Hawke's Bay Land Districts, containing by admeasurement 656,000 acres, more or less. Bounded towards the north by the confiscation-boundary line; towards the north by the Waimana and Tahora No. 2 Block; towards the south-east by the Waipaoa Block, the Waikaremoana Lake, by forest re-serve, educational reserve, Block V, Waiau Survey Dis-trict, and Section No. 1, Block VIII, Mangahopai Survey District; towards the south-west by the Waiau River to the northernmost corner of Maungataniwha Block, thence by a right line to the trig. station on Maungataniwha, and thence by Heruiwi No. 4 Block; and towards the west generally by Whirinaki, Kuhawaea No. 1, Waiohau Nos. 1B, 1A, and 2, and Tuararangaia Blocks to the confiscation-boundary line at Tapapa-kiekie.

SECOND SCHEDULE.

REGULATIONS FOR MINING ON UREWERA DISTRICT NATIVE RESERVE.

1. In these regulations, if not inconsistent with the con-In these regulations, if not inconsistent with the context, words and expressions shall have the same meaning as in "The Mining Act, 1908" (hereinafter called "the Mining Act"). "Reserve" means the Urewera District Native Reserve, as defined by the First Schedule to "The Urewera District Native Reserve Act, 1896."
 Miners' rights shall be insued on payment of a fee of 10s. each, and shall be in force for twelve months. Such miners' rights shall apply only to the reserve, and shall be in the Form 1 of the Third Schedule hereto.
 No person unless he is the holder of such a miner's

 No person, unless he is the holder of such a miner's right, shall prospect or mine for gold, silver, or any other metal or minerals within the boundaries of the reserve, and every person working in or about any mining privilege within the reserve shall be the holder of such a miner's

right. 4. No person shall shoot, snare, or in any other method capture or kill any native or imported game within the ervé

reserve. 5. Timber within the reserve shall be cut for domestic and mining purposes only, and within such areas as are specially set apart for that purpose, as Warden's timber areas under section 147 of the Mining Act. 6. No person shall mine, occupy, cut timber or flax within the reserve on any land used or set apart for cultivation, unidence or burgle grounds

residence, or burial-grounds.

7. Every person who commits any breach, whether of omission or commission, of any of these regulation is liable to a penalty not exceeding for the first offence ten pounds and for every subsequent offence of the same nature twenty pounds.

8. Any person discovering gold shall report such discovery

8. Any person discovering gold shall report such discovery to the Warden with full particulars.
9. A royalty of sixpence for every ounce of gold won within the reserve by the holder of any mining privilege shall be paid to the Native owners in manner set out in section 23, (c), of the Mining Act.
10. Subject to these regulations, the Mining Act and the regulations thereunder shall apply to the reserve.
