

ORDER IN COUNCIL.

At the Government Buildings, at Wellington, this twenty-ninth day of November, 1909.

THE RIGHT HONOURABLE SIR J. G. WARD, K.C.M.G., PRESIDING IN COUNCIL.

IN pursuance and exercise of the powers and authorities vested in him by "The Valuation of Land Act, 1908," His Excellency the Governor of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby appoint

JOSEPHUS HARGREAVES RICHARDSON

to be the Deputy of the Valuer-General under and for the purposes of the said "Valuation of Land Act, 1908," as from the twenty-ninth day of November, one thousand nine hundred and nine.

Lands tempororily reserved in the Canterbury Land District.

PLUNKET, Governor.

WHEREAS by the three-hundred-and-twenty-first sec-tion of "The Land Act, 1908," it is enacted that the Governor may from time to time, either by general or particular description, and whether the same has been surveyed or not, reserve from sale temporarily, notwith-standing that the same may be then held under pastoral

license, any Crown lands which in his opinion are required for any of the purposes in the said section mentioned : Now, therefore, I, William Lee, Baron Plunket, the Governor of the Dominion of New Zealand, in exercise and pursuance of the powers and authorities vested in me by the said Act, do hereby temporarily reserve from sale the land in the Canterbury Land District described in the Schedule hereunder written, for the purposes in the said Schedule specified at the end of the respective descriptions of the lands so intended to be temporarily reserved.

SCHEDULE. ALL that area in the Canterbury Land District, containing by admeasurement 25 acres and 14 perches, more or less, being Reserve No. 3661 (in red), Block II, Lyndon Survey District. Bounded towards the west by a line in continua-tion of the eastern boundary of Lot 22. Hanmer Plains Reserve, and running northerly, 100 links; thence by a line at right angles, bearing 84° 11', 1728'1 links; thence by a line, bearing 17° 41', 1391 links; thence by a line, bearing 84° 11', 1700 links; thence by a line, bearing 197° 41', 1500 links; and thence by a line, bearing 264° 11', along the northern boundary of Sections 23 and 24 of the Hanmer Plains Reserve, 3384'6 links, to the starting-point: be all the aforesaid bearings and linkages more or less: as the same is delineated on the plan marked L. 53102/27n, de-posited in the Head Office, Department of Lands, Welling-ton, and thereon bordered pink.
