A PROCLAMATION.

In pursuance and exercise of the powers and authorities vested in me by the Counties Act, 1908, and the Selwyn County Subdivision Act, 1910, I, John Poynder Dickson-Poynder, Baron Islington, Governor of the Dominion of New Zealand, do hereby divide the new County of Malvern, as constituted by the said Acts, into four ridings, to be called the West Melton Riding, the Courtenay Riding, the Homebush Riding, and the Sheffield Riding, and declare that the boundaries thereof shall be those set forth in the Schedule hereto.

And I do hereby declare that one member shall be elected for the West Melton Riding, five members for the Courtenay Riding, one member for the Homebush Riding, and two members for the Sheffield Riding. And I do further declare that Tuesday, the fourth day of April, one thousand nine hundred and eleven, shall be the day upon which the election of the first Council of the said County of Malvern shall take place; and that Thursday, the sixth day of April, one thousand nine hundred and eleven, at half past two o'clock in the afternoon, shall be the time, and the East Malvern Road Board Office, at Sheffield, shall be the place, at which the first meeting of the said Council shall be held.
