Proposed Boundaries of the Electoral Districts in the North Island of New Zealand.

THE North Island Representation Commission appointed under the Legislature Act, 1908, in pursuance of section 21 of the said Act, hereby publish for general information the following proposed boundaries of the electoral districts in the North Island; and further give notice that written objections to the same will be received by the undersigned, the Chairman of the said Commission, at the office of the Surveyor-General, Wellington, not later than noon of Wednesday, the 13th day of September, 1911. Maps of the proposed districts may be seen at the offices of the several local bodies in the said North Island; of the Chief Surveyors at Auckland, New Plymouth, Napier, and Wellington; of the Chief Electoral Officer at Wellington; and of the several Registrars of Electors throughout the North Island aforesaid. Such objections as may be lodged will be considered by the Commission on Thursday, the 14th day of September, 1911, at 2.30 p.m. o'clock, at the office of the Surveyor General, Government Buildings, Wellington. ### NORTH ISLAND ELECTORAL DISTRICTS. BAY OF ISLANDS.

Bay of Islands District comprises the Counties of Mango-nui, Whangaroa, Bay of Islands, the whole of Hokianga County with the exception of the Waipoua Riding, and includes also those portions of the Maunu, Wairua, and Hikurangi Ridings of Whangarei County lying to the north of the Wairua River; also the whole of the Otonga Riding, the Hikurangi and Marua Road Districts, and Hikurangi Town District Town District.

### KAIPARA.

Kaipara District comprises the existing Kaipara Electoral District, also the Waipoua Riding of Hokianga County,

and that portion of Kumeu Riding lying to the east of the Waikoukou River and north of the Auckland-Helensville Railway.

### MARSDEN.

Marsden District comprises the existing Marsden Elec-toral District less the portions now taken in by the Bay of Islands Electorate, and includes also Mahurangi, Puhoi, and Warkworth Ridings, the Mahurangi East Road Dis-trict, and Warkworth Town District. This district also includes Moko Hinau Island.

### WAITEMATA.

Waitemata District comprises the existing Waitemata Electoral District less the portions now included in the Marsden and Kaipara Electoral Districts hereinbefore described, and includes that portion of the Waitakerei Riding lying to the north of the Auckland-Helensville Railway. This district includes the following islands: Kawau, Great Barrier, Little Barrier, Motuketekete, Mou-terekareka, Tiri Tiri, and Bean Rock.

### Eden.

EDEN. Eden District comprises the existing Eden Electoral District less the portion of Waitakerei Riding included in the Waitemata Electoral District already described, less that portion of the Mount Eden Borough bounded on the east by the Mount Eden Road, on the south by Valley Road, on the west by Sherburn Road, and on the north by View Road; also less that portion of Mount Eden Borough lying to the east of Mount Eden Road; less also that por-tion of the Epson Road District bounded towards the north generally by Almorah Road, Secombe's Road, and Bucktion of the Epsom Road District bounded towards the north generally by Almorah Road, Seccombe's Road, and Buck-land Road, towards the east by Epsom Road, towards the south by the southern boundary of the said road district, and towards the west by the Mount Eden Borough; less also that portion of One Tree Hill Road District bounded on the north-east by the Great South Road, on the south-east by Market Road, and on the west by Epsom Road.

### AUCKLAND WEST.

Auckland West District boundaries remain unchanged.

### AUCKLAND CENTRAL.

Auckland Central District comprises the existing Auck-land Central Electoral District, and also includes that por-tion of the City of Auckland bounded towards the east by Queen Street, towards the south generally by West Street, Pitt Street, Edwin Street, Montague Street, and Gundry Street, and towards the north-west generally by the Ka-rengenera Board rangahape Road.

### AUCKLAND EAST.

Auckland East District comprises the existing Auckland East Electoral District less that portion of the City of Auckland now included in the Auckland Central Electoral District as hereinbefore described, and includes that por-tion of the Grafton Riding lying to the north of Alexander Street, New North Road, and Brown Street.

### GREY LYNN.

Grey Lynn District comprises the existing Grey Lynn Electoral District less that portion of Grafton Riding now included in the Auckland East Electoral District as here-inbefore described, and includes that portion of Mount Eden Borough bounded towards the north by View Road, on the east by the Mount Eden Road, on the south by Valley Road on the west by Sharburn Road Valley Road, and on the west by Sherburn Road.

### PARNELL.

Parnell District comprises the whole of the Parnell Rid-ing, the Boroughs of Parnell and Newmarket; also that portion of Mount Eden Borough bounded on the west by Mount Eden Road and on the south by Owens Road; also that portion of the Epsom Road District lying to the west generally of Seccombe's Road, Buckland Road, and Epsom Road, and north of Owens Road; also that portion of One Tree Hill Road District lying to the north of Fountain Street. Street.

### MANUKAU.

Manukau District comprises the whole of the Tamaki Riding; the Ellerslie Town District; the Borough of One-hunga; that portion of the One Tree Hill Road District less the portion now included in the Parnell Electoral District hereinbefore described; includes that portion of Epsom Road District bounded towards the north by Owens Dead towards the act the arth the arth the court Epsom Road District bounded towards the north by Owens Road, towards the east by Epsom Road, towards the south by Whau Riding, and towards the west by Mount Eden Borough; also that portion of Mount Eden Borough lying to the east of Mount Eden Road and south of Owens Road; also includes Mount Roskill Road District less that portion lying to the north of Mount Albert Road and now included in Eden Electoral District hereinbefore described; and also includes that portion of Otahuhu Road District lying between the Great South Road and the Tamaki River. This district also includes the following islands : Rakino, Motutapu, Waiheke, Brown's, Motuihi, Pakatoa, Rotoroa, Ponui, and Pahiki.

### FRANKLIN.

FRANKLIN. Franklin District comprises the whole of the Otahuhu Riding of Manukau County less that portion of the Ota-hubu Road District now included in the Manukau Elec-toral District hereinbefore described; includes also the following ridings in Manukau County—Howick, Papakura, Awitu, Waiuku, and the outlying portion of Maungata-whiri; the following road districts of Manukau County— Mauku, Karaka, Opaheke, Paparata, Pokeno, and Mercer; also that portion of the Pukekohe East Road District lying to the west of the Great South Road and north of the road running through Sections 26, 30, 15, and 12, Blocks XV and XVI, Drury Survey District.

#### RAGLAN.

RAGLAN. Raglan District comprises the Road Districts in Manukau County of Pukekohe West, Maungatawhiri, and that por-tion of Pukekohe East Road District lying to the south of the road running through Sections 26, 30, 15, and 12, Blocks XV and XVI, Drury Survey District; the whole of Raglan County with the exception of the Pirongia Riding of that county; the Kirikiriroa, Tamahere, and Cambridge Ridings of Waikato County; that portion of Newcastle Riding lying to the north of the coach-road from Whata-whata to Hamilton. The Town Districts of Huntly, Nga-ruawahia, Pukekohe, and Raglan are included in this district.

#### THAMES.

Thames District comprises the Counties of Coromandel and Thames, the Whangamarino Riding of Waikato County, the Huntly Riding less the Huntly Town District, and includes that portion of the Ohinemuri County lying to the west of the Thames (or Waihou) River. This district also

includes the Thames Borough and the Islands of Great Mercury, Cuvier, and Slipper.

### OHINEMURI.

Ohinemuri District comprises that portion of Ohinemuri County lying to the east of the Thames (or Waihou) River; that portion of Katikati Riding of Tauranga County lying to the north of the county road from Te Aroha to the mouth of the Terereatukahia Stream, and running through Blocks I and II, Aongatete Survey District; and that por-tion of Te Aroha Riding of Piako County lying to the north of Blocks II and III, Wairere Survey District. The Te Aroha Borough is included in this district. Te Aroha Borough is included in this district.

### WAIKATO.

WAIKATO. Waikato District comprises the whole of the Waipa County less that portion of Newcastle Riding north of the coach-road from Whatawhata to Hamilton hereinbefore described, now included in the Raglan Electoral District; includes the Maungatautari and Putaruru Ridings of Matamata County; that portion of West Taupo County within the existing Tauranga Electoral District; the Mata-kowhai and Kawhia Ridings of Kawhia County; Pirongia Riding of Raglan County; and includes part of the Te Rau-a-moa Riding of Waitomo County lying to the north generally of Otorohanga Riding and the Ngutunui Road leading to the Village of Te Rau-a-moa. The Town Dis-tricts of Kihikihi, Te Awamutu, Leamington, Kawhia, Frankton, and the Boroughs of Hamilton and Cambridge are included in this district.

### TAURANGA.

Tauranga District comprises the whole of the Piako County less that portion of Te Aroha Riding now included in the Ohinemuri Electoral District hereinbefore described; in the Ohinemuri Electoral District hereinbefore described; includes the Ridings of Matamata, Taotaoroa, and Pate-tere of Matamata County; the Ridings of Te Puke, Wai-mapu, Te Puna, and that part of Katikati Riding not included in the Ohinemuri Electoral District hereinbefore described; that portion of Rotorua County lying to the west of Block XIV, Maketu Survey District; Blocks II and VI, Rotoiti Survey District; thence skirting the eastern shore of Lake Rotorua to the north-eastern boundary of the said block to the old road; thence by that road to the Town of Rotorua as defined by the Rotorua Town Act, 1907; thence south-easterly and south-westerly by the south-eastern and south-western boundaries of the said town to Tangatarua; thence by a right line due west to the western boundary of Rotorua County. This district includes the Borough of Tauranga, the Town of Rotorua, and Motiti Island.

### BAY OF PLENTY.

Bay of Plenty District comprises the existing Electoral District of Bay of Plenty less that portion of Rotorua County now included in the Tauranga Electoral District hereinbefore described, and also less that portion of Patu-tahi Riding lying to the west of the Waipaoa River and north of the Waikakariki Stream and the Okahuatiu No. 2 Block, and includes the Maketu Riding of Tauranga County. This district includes Opotiki Town District.

### TAUMARUNUI.

TAUMARUNUI. Taumarunui District comprises the Ridings of Taharoa, Awaroa, Te Kuri, and Waiharakeke, of Kawhia County; the whole of the Awakino and Ohura Counties; the whole of the Waitomo County less that portion of Te Rau-a-moa Riding now included in the Electoral District of Waikato hereinbefore described; that portion of the West Taupo County lying south-west of a right line drawn from Pureora to the mouth of the Waihora Stream; the Waihi, Tiko-rangi, Urenui, and Mokau Ridings of Clifton County; and that part of the Ngatimaru Riding already in the existing Electoral District of Taumarunui; that portion of the Wai-tara West Road District lying to the west of the Wai-tara West Road District lying to the west of the Wai-tara West Road to the Mataitawa Road; thence by the exist-ing Taranaki Electoral District to the Mahoetahi Road, and thence by that road to the sea. This district includes the Boroughs of Te Kuiti, Taumarunui, and Waitara.

### GISBORNE.

Gisborne District comprises part of the Waikaremoana Riding of Wairoa County lying between the Wairoa River and the western boundary of the Mahia Riding; the whole of the Mahia Riding of Wairoa County, and the Hangaroa, Arai, Patutahi, and Whataupoko Ridings of Cook County; the whole of the Gisborne Riding less that portion already included in the Bay of Plenty Electoral District. This district includes the Borough of Gisborne and Portland Island. Island.

### HAWKE'S BAY.

Hawke's Bay District comprises the whole of the Mohaka Riding of Wairoa County, and that portion of the Wai-karemoana Riding lying to the west of the Wairoa River; the whole of the Okawa and Puketapu West Ridings of Hawke's Bay County; the whole of Petane Riding at present in the existing Hawke's Bay Electoral District; that part of Puketapu East Riding bounded by the road forming the southern boundary of Section 3, intersecting Sections 57, 27, 28, and 26, the Wharerangi Native Reserve, forming the southern boundaries of Sections 32, 25, the Sections 57, 27, 28, and 26, the Wharerangi Native Reserve, forming the southern boundaries of Sections 32, 25, the eastern boundary of Sections 35 and 36, all in Block III, Heretaunga Survey District, to the Tutaekuri River; also that portion of Clive Riding bounded towards the north by the existing Napier Electoral District, and towards the south by the northern boundary of the Kidnapper Survey District; also that portion of the Heretaunga Riding bounded towards the south by the Hastings-Maraekakaho Road and the road intersecting Kakiraawa Block to the Wellington-Napier Railway; also that portion of the Have-lock Riding bounded on the west by Block III, Tamata Survey District, and Block IV, Kidnappers Survey District. This district includes the Boroughs of Hastings and Wairoa.

### NAPIER.

Napier District comprises the whole of Meeanee Riding; those portions of Petane and Clive Ridings already in the existing Electoral District of Napier; that portion of Puke-tapu East Riding bounded by the road forming the southern boundary of Section 3, intersecting Sections 57, 27, 28, and 26, the Wharerangi Native Reserve forming the southern boundary of Sections 32 and 25, the eastern boundary of Sections 35 and 36, all in Block III, Heretaunga Survey District, to the Tutaekuri River. This district includes the Borough of Napier and the Town District of Taradale.

### WAIPAWA.

Waipawa District comprises the whole of the Waipawa County; the whole of the Erehwon and Maraekakaho Ridings of Hawke's Bay County; parts of Heretaunga and Havelock Ridings not already included in Hawke's Bay Electoral District hereinbefore described; and that Bay Electoral District hereinbefore described; and that portion of Clive Riding lying to the south of the northern boundary of the Kidnapper Survey District; the whole of the Patangata Riding of Patangata County; the whole of Norsewood Riding of Dannevirke County; the whole of Norsewood Riding of Dannevirke County; that por-tion of the Mangatoro Riding lying to the north of the Manawatu River; that portion of the Ormond-ville Riding lying to the north-west of the Mana-watu River; that portion of the Dannevirke, on the east by the Mangatoro Riding, on the south by the Manawatu River, and on the west by the main road. This district includes the Boroughs of Dannevirke and Waipawa, and the Town Districts of Otane, Waipukurau, Norsewood, and Ormondville. and Ormondville.

### PAHIATUA.

PAHIATUA. Pahiatua District comprises the whole of Weber and Woodville Counties; the Waihi and Akitio Ridings of Akitio County; and that portion of the Pahiatua County already included in the existing Pahiatua Electoral Dis-trict; the whole of Dannevirke Riding of Dannevirke County with the exception of that portion included in the Waipawa Electoral District hereinbefore described; also those portions of Mangatoro and Ormondville Ridings gene-rally lying to the south-east of the Manawatu River; the whole of the Waipukurau County less the Waipukurau Town District included in the Waipawa Electoral District hereinbefore described; the whole of Porongahau, Epa-raima, Tamumu, and Oero Ridings. This district includes the Boroughs of Woodville and Pahiatua.

#### MASTERTON.

Masterton District comprises the existing Electoral District of Masterton, together with the Rakaunui, Pongaroa, and Mataikona Ridings of Akitio County. This district includes the Boroughs of Masterton and Eketahuna.

### WAIRARAPA.

Wairarapa District comprises the existing electoral dis-trict, the boundaries remaining unaltered. This district includes the Boroughs of Greytown and Carterton, and the Town Districts of Featherston and Martinborough.

### TARANAKI.

Taranaki District comprises the existing Electoral Dis-trict of Taranaki, together with that portion of the Wai-tara West Road District lying to the west of the Manoetahi Road and north of the New Plymouth-Waitara Railway

line, and that portion of the Moa Road District lying be-tween Wortley Road and the existing electoral boundary, and less that portion of the Rahotu Riding lying to the north of Newall Road. This district contains the Boroughs of New Plymouth and Inglewood, and the Town Districts of Fitzroy and St. Aubyn.

### STRATFORD.

STRATFORD. Stratford District comprises part of Waitara West Road District south of Cross Road, Huirangi Village, and Wai-tara River, formerly included in the Taumarunui Electoral District, and the remaining portion of Moa Riding of Taranaki County not included in the Taranaki Electoral District hereinbefore described; the whole of Whanga-momona County; the whole of North, East, and Mangaehu Ridings of Stratford County ; and that portion of the South Riding of Stratford County lying to the east of the Wellington – New Plymouth Railway; the whole of the Omoana Riding of Eltham County ; that portion of Eltham Riding of Eltham County lying to the east of a road inter-secting Sections 41, 42, forming the eastern boundary of Section 44, intersecting Section 53, by Sangster Road, Maata Road, Mangawhero Road, and the Mangimangi Stream; the whole of the Meremere Riding, Hawera County, and that portion of the Ararata Riding included in the existing Electoral District of Egmont; also that por-tion of Kapara Riding of Patea County lying to the north of the boundary between the Land Districts of Wellington and Taranaki and the Waitotara River. This district in-cludes the Borough of Stratford. **EGMONT.** 

### EGMONT.

Egmont District comprises the whole of the Egmont Egmont District comprises the whole of the Egmont County; Kaponga, Mangatoki, and South Ridings of Eltham County; the whole of Waimate West County; the West Riding of Stratford County, and that portion of the South Riding of Stratford County lying to the south of Stratford Borough and west of the New Plymouth-Wellington Railway, and that portion of the Eltham Rid-ing not included in the Stratford Electorate hereinbefore described; also that portion of the Hawera Riding lying to the west of the Waingongoro River. This district in-cludes the Borough of Eltham, and the Town Districts of Opunake, Manaia, and Kaponga.

### PATEA

Patea District comprises the whole of the Waitotara. County less the Gonville Town District; the whole of Patea County less that portion of Kapara Riding now in-cluded in the proposed Stratford Electoral District herein-before described; the whole of the Mokoia Riding, those before described; the whole of the Mokola Riding, those portions of Meremere and Ararata Ridings already included in the existing Patea Electoral District; also that portion of Hawera Riding lying to the east of the Waingongoro River. This district includes the Boroughs of Hawera and Patea, and the Town Districts of Waverley, Castlecliff, and Normanby.

### RANGITIKEI.

Rangitikei District comprises the whole of the Kaitieke, Waimarino, and Wanganui Counties; the whole of the Te Kapua Riding of Rangitikei County; that portion of Erehwon Riding at present included in the existing Hawko's Bay Electoral District; that portion of East Taupo County lying to the south of the Taupo-Napier main coach-road and Lake Taupo. This district includes the Borough of Taihape and the Town District of Ohakune.

### WANGANUI.

Wanganui District comprises the Wanganui and Wanganui East Boroughs and the Gonville Town District.

#### OROUA.

Oroua District comprises the whole of Kiwitea and Oroua District comprises the whole of Kiwitea and Pohangina Counties; that portion of the Awarua Riding lying to the north of the Kawhatau River and the Mako-hine-Mangaweka Road; that portion of Erehwon Riding at present included in the existing Rangitikei Electoral District; all that portion of the Oroua County included in the existing Oroua Electoral District; also that portion of the Manawatu County at present included in the Oroua Electoral District. The southern boundary of this dis-trict is unchanged. This district includes the Borough of Feilding.

### MANAWATU.

Manawatu District comprises the whole of the Ridings of Rangitoto, Otakapu, Porewa, Wangaehu, Rangatira, and Otairi, of Rangitikei County, and that portion of Awarua Riding lying to the south of the Makohine-Mangaweka Road; the whole of the Ridings of Sandon, Waitohi, and Rongotea, of Manawatu County, and that portion of Mount Stewart Riding at present in the existing Manawatu Elec-

toral District; that part of Carnarvon Riding lying to the north of Sections 305 and 306, Block IX, Te Kawau Sur-vey District, and the southern boundary of Run No. 24, Block II, Sandy Survey District; also those portions of the Mangaone and Taonui Ridings of Kairanga County at present included in the existing Manawatu Electoral Dis-trict. This district includes the Borough of Marton, and the Town Districts of Mangaweka, Hunterville, Leth-bridge, Bulls, and Rongotea.

### PALMERSTON.

Palmerston District comprises the whole of the Kairanga County less those portions of the Mangaone and Taonui Ridings at present in the existing Electoral District of Manawatu, and includes that portion of Oroua County at present in the existing Electoral District of Palmerston. This district includes the Borough of Palmerston North.

### OTAKI.

Otaki District includes the whole of the Horowhenua Otaki District includes the whole of the Horowhenua County; the whole of the Awahou and Kawakawa Ridings of Manawatu County; that portion of the Carnarvon Rid-ing lying to the south of the northern boundaries of Sec-tions 305 and 306, Block IX, Te Kawau Survey District, and the southern boundary of Run No. 24, Block II, Sandy Survey District; the whole of the Whareroa Riding of the Hutt County, and that part of the Mungaroa Riding of Hutt County lying to the north of the main road over the Rimutaka, the Pakuratahi River, and west of the Hutt River. This district includes the Boroughs of Foxton and Levin. and also Kaniti Island. Levin, and also Kapiti Island.

### HUTT.

Hutt District comprises the whole of the Wainuiomata Riding; that portion of the Mungaroa Riding lying to the south of the main road over the Rimutaka, the Pakuratahi River, and east of the Hutt River and the Wellington-Napier Railway from the Upper Hutt Town District; also that portion of the Epuni Riding lying to the east of the Wellington-Napier Railway. This district includes the Boroughs of Lower Hutt, Petone, and Eastbourne, the Upper Hutt Town District, and Somes Island.

### WELLINGTON NORTH.

WELLINGTON NORTH. Wellington North District comprises the existing Wel-lington North Electoral District, and also that portion of the City of Wellington lying to the west of Elizabeth Street (Wadestown) to its intersection with the main road, thence lying south of the main road to the Kaiwarra Stream, thence by that stream to the Cemetery Road, and by the said road to the existing northern boundary of the Wellington Central Electoral District, less that portion of the existing electoral district lying to the west of Wool-combe Street and north of Abel Smith Street.

### WELLINGTON CENTRAL.

Wellington Central District comprises the existing elec-Wellington Central District comprises the existing elec-toral district less that portion of the existing Wellington North Electoral District lying to the west of Woolcombe Street and north of Abel Smith Street. To this district has been added that portion of Wellington City lying to the east of the existing Wellington Central Electoral Dis-trict and bounded on the north by Lambton Harbour, on the east by Clyde Quay and Kent Terrace, and on the south by Buckle Street ; also that portion lying to the south of the present Wellington Central Electoral District bounded towards the east by Tasman Street, on the South by Tainui Street, and Sections 712, 711, and 710, Hankey Street, and Sections 40 and 42. Sections 40 and 42.

### Wellington East.

WELLINGTON EAST. Wellington East District comprises the existing Electoral District of Wellington East less that portion of Wellington City bounded towards the north by Lambton Harbour, to-wards the east by Clyde Quay and Kent Terrace, on the south by Buckle Street, and on the west by the existing Wellington Central Electoral District : and includes that portion of Wellington City bounded on the north by the existing Wellington East Electoral District; on the east and north by Evans Bay to the Wellington City boundary; towards the east by the said city boundary; towards the south by a road running parallel to the outfall sewer to Tainui Terrace in Maranui Township, and by the northern boundary of the said township to Newtown Park; towards the west by the said Newtown Park and Suburban Sec-tions II and 10 to the existing Electoral District of Wel-lington South; thence by the said electoral district and the existing Electoral District of Wellington East.

### WELLINGTON SOUTH

Wellington South District comprises the existing Elec-toral District of Wellington South less that portion of the

City of Wellington lying south of the existing Wellington Central Electoral District bounded towards the east by Tasman Street, towards the south by Tainui Terrace, Sec-tions 712, 711, and 710, Hankey Street, and Sections 40 and 42; and includes that portion of the City of Welling-ton in the existing Wellington Suburbs Electoral District bounded towards the east by the Township of Kilbirnie, towards the south generally by Newtown Park, Russell Terrace, Leraud Street, Adelaide Road, Chilka Street, Stanley Street, Brittomart Street, the northern boundary of Section 25, and the western boundary of Section 26, to the existing Wellington South Electoral District.

WELLINGTON SUBURBS AND COUNTRY DISTRICT.

This district comprises the whole of the Makara County ; This district comprises the whole of the Makara County; the whole of the Horokiwi Riding of Hutt County; that portion of the Epuni Riding lying to the west of the Wellington-Napier Railway from the Upper Hutt Town District and lying west of the Boroughs of Lower Hutt and Petone; and all that portion of the City of Wellington ton not absorbed by the Electoral Districts of Wellington North, Central, South; and East. This district includes the Boroughs of Onslow, Karori, and Miramar, and the Johnsonville Town District.

### roposed Boundaries of the Electoral Districts in the South Island (including Stewart Island) of New Zealand.

Such objections as may be lodged will be considered by the Commission on Thursday, the 14th day of September, 1911, at 10 o'clock, at the Provincial Council Chambers, Christchurch.

### SOUTH ISLAND ELECTORAL DISTRICTS.

### NELSON.

NELSON. NELSON District comprises the existing Nelson Electoral District, less that portion of Sounds County lying east of Pelorus Sound. This district also includes that portion of the Wai-iti Riding of Waimea County bounded towards the north-west by the Wai-iti River; towards the east by the Waimea River from its junction with the Wai-iti River to Section No. 3 in Block X, Waimea Survey District; thence by that section to the junction of roads at the northernmost corner of Section No. 8; thence by the road forming the north-western boundary of that section, of Sections Nos. 9 and 141 in Block IX, and of Sections Nos. 140, 137, 136, 134, 1 of 133, 131, and 129 in Block XIII, Waimea Survey District; and thence towards the south-west by Section No. 1 of 42, said Block XIII, Sections Nos. 19 and 40, Block XVI, Wai-iti Survey Dis-trict, and the road forming the north-eastern boundaries of Sections Nos. 2 of 2 and 19A; and continuing thence morth-westerly through Sections Nos. 79 and 85 to the Wai-iti River. MOTUEKA.

### MOTUEKA.

Motueka District comprises the existing Motueka Electoral District comprises the existing Motueka Elec-toral District, excepting that portion of the Wai-iti Riding of Waimea County included in the Nelson Electoral Dis-trict hereinbefore described. This district also includes that portion of Mokihinui Riding of Buller County lying between the boundary of the existing Motueka Electoral District and the Ngakawhau River.

### BULLER

Buller District comprises the Murchison County, the Charleston, Wareatea, Wareatea South, Waimangaroa,

Ngakawau, Millerton, and Lyell Ridings of Buller County, the Borough of Westport, Boatman's Riding of Inangahua County, and Crushington Riding, except the western por-tion lying to the south-west of the road which runs gene-rally south-easterly from Reefton to the saddle near Trig. Station B in Block II, Waitahu Survey District.

### GREY.

GREY. Grey District comprises Reefton Riding of Inangahua County; that portion of Crushington Riding lying to the south-west of the road which runs generally south-easterly from Reefton to the saddle near Trig. Station B in Block II, Waitahu Survey District; the northern portion of Antonio's Riding lying to the north-west of a right line running from Trig. Station P in Block X, Waitahu Survey District, to the north-eastern corner of Section No. 86, school reserve, Blackwater Township; thence along the eastern boundary of Blackwater Township and a right line to the easternmost corner of Section No. 11, Block IV, Ahaura Survey District, and along the south-eastern bound-ary of that section to the Grey River : together with that portion of Grey County lying to the north of the Grey River and west of Otututu River, and that portion of the Borough of Brunner lying to the north of the Grey River. This district also includes the Borough of Greymouth.

### WESTLAND.

WESTLAND. Westland District comprises the whole of Westland County, together with Grey County, except that portion which lies north of the Grey River and west of the Otututu River, and also that portion of Antonio's Riding of In-angahua County lying to the south-east of a right line run-ning from Trig. Station P in Block X, Waitahu Survey District, to the north-eastern corner of Section No. 86, school reserve, Blackwater Township; thence along the south-eastern boundary of that township, a right line to the easternmost corner of Section No. 11, Block IV, Ahaura Survey District, and along the south-eastern boundary of that section to the Grey River. This district also includes that portion of the Borough of Brunner lying to the south of the Grey River, and the Boroughs of Hokitika, Ross, and Kumara.

### WAIRAU.

Wairau District comprises the existing Wairau Elec-torate, together with that portion of Sounds County lying to the east of Pelorus Sound.

### HURUNUI.

HURUNUI. Hurunui District comprises the Counties of Amuri, Kai-koura, Cheviot, and Waipara, together with the Cass Riding of Tawera County, Kowai and Mount Thomas Ridings of Ashley County, and Oxford Riding, less that portion lying to the east of the railway-line from the Waimakariri River at Bexley to East Oxford, thence along Bay Road, Sales Road, and Ashley Gorge Road to the Ashley River.

#### KAIAPOI.

Kalapoi District comprises Manderville, Eyreton, West Eyreton, and Cust Ridings of Ashley County, and that part of Oxford Riding lying to the east of the railway-line from the Waimakariri River at Bexley to East Oxford; thence along Bay Road, Sales Road, and Ashley Gorge Road to the Ashley River: together with the Styx, Belfast, and Marshland Ridings of Waimairi County.

### CHRISTCHURCH NORTH.

Christchurch North District comprises the existing Christchurch North Electorate unaltered.

### CHRISTCHURCH EAST.

Christchurch East District is bounded towards the north by Salisbury Street from Colombo Street to the River Avon; thence by the River Avon to Fitzgerald Avenue; thence towards the east by Fitzgerald Avenue to Lower High Street; thence by Lower High Street to Wilson's Road; thence by Wilson's Road to Charles Street; thence by Charles Street to Grafton Street; thence by Grafton Street to Lower High Street; thence by Lower High Street to Ensor's Road; thence by the said railway-line to Wilson's Road; thence by the said railway-line to Wilson's Road; thence by Wilson's Road to Lang-down Street; thence by Langdown Street to Rogers Street; thence by that street to Huxley Street; thence by Huxley Street to Croydon Street; thence by Huxley Street to South-ampton Street; thence by that street to Mont-rose Street; thence by that street to Colombo Street; and thence to-wards the west by Colombo Street to Salisbury Street. Christchurch East District is bounded towards the north

### CHRISTCHURCH SOUTH.

CHRISTCHURCH SOUTH. Christchurch South District is bounded towards the north by Christchurch North Electoral District; towards the east by Christchurch East Electoral District, herein-before described, to the Heathcote River; thence towards the south by that river to Barrington Road; thence by that road to Conway Street; thence by that street to Lyttelton Street; thence towards the west by Lyttelton Street and Hellewell Street to Lincoln Road; thence by that road to Moorhouse Avenue; thence by the western extension of Moorhouse Avenue to the West Belt; and thence by the West Belt to the boundary of Christchurch North Electorate. Avon.

#### Avon.

Avon. Avon District comprises the Avon Riding of Waimairi County, the Avonside and Bromley Ridings of Heathcote County, and the Borough of New Brighton, together with that part of the City of Christchurch bounded towards the south-east by the Borough of Woolston; towards the south-west and west by Christchurch East District and Christchurch North District.

#### SELWYN.

SELWYN. Selwyn District comprises the whole of Selwyn County, together with Kowai Bush and Springfield Ridings of Tawera County, Homebush Riding of Malvern County, Sheffield Riding less that portion lying eastward of the Oxford – Sheffield and Sheffield – Darfield Railway lines, and that portion of Courtenay Riding of Malvern County lying west of the Hawkins River from the Selwyn River to the Whitecliffs Railway line, the railway-line to Dar-field, and the Darfield–Springfield Railway line to the western boundary of Courtenay Riding. This district also includes the Mount Somers, Mount Hutt, South Rakaia, Wakanui, and Upper Ashburton Ridings of Ash-burton County, and that portion of Rangitata Riding lying to the west of the Rangitata Bridge to Meyfield and Mount Somers Road : excluding the Town Districts of Hampstead and Tinwald.

### RICCARTON.

RICCARTON. Riccarton District comprises all that portion of Malvern County not included in Selwyn Electorate, together with the West Melton and Yaldhurst Ridings of Paparua County, that part of Templeton Riding lying north of the main South Road, Islington Riding less that portion lying south of the main South Road and south-west of Hals-well Junction Road and Sockburn Riding, excepting Rural Sections Nos. 1581 and 2642. This district also includes the Harewood, Papanui, Middleton, Fendalton, and that part of Riccarton Riding not included in Christ-church North and Christchurch South Electorates.

### LYTTELTON.

LYTTELTON. Lyttelton District comprises Mount Herbert County; Port Levy, Okain's Bay, and Le Bon's Bay Ridings of Akaroa County; the Boroughs of Lyttelton, Sumner, and Woolston; Opawa, Hillsborough, Heathcote Valley, Mar-tins, and Cashmere Ridings of Heathcote County; to-gether with that part of Halswell County lying east of the following boundary: Hoon Hay Road from plantation and road reserve at Cashmere to the northernmost corner of Rural Section No. 1325; thence along the road forming the western boundaries of Rural Sections Nos. 1325, 2063, 31362, 31363, 2231, intersecting Rural Sections Nos. 10210 and 493; thence to the northernmost corner of Rural Sec-tion No. 338, along the road forming the north-eastern and south-eastern boundaries of that section, and to the easternmost corner of Rural Section No. 491. This dis-trict also includes that part of the Borough of Spreydon lying south-west of Barrington Road and south-east of Conway Street to Lyttelton Street, along Lyttelton Street to Rose Street, and along that street to the borough boundary. boundary.

### ELLESMERE.

Ellesmere District comprises the Counties of Ellesmere, Springs, and Wairewa; the Wainui Riding of Akaroa County; the Borough of Akaroa; and that part of the Borough of Spreydon not included in the Christchurch South and Lyttelton Electorates, and that portion of Pa-parua County not included in the Riccarton Electoral District; together with the Halswell County, excepting that portion included in the Lyttelton Electorate.

### ASHBURTON.

Ashburton District comprises that portion of the Ash-burton County not included in the Selwyn Electoral Dis-trict; the whole of Geraldine County, less that portion lying to the east of Hae-Hae-te-Moana River from its confluence with the Opihi to the southern boundary of the

Raukapuka Riding; by the southern boundary of that riding to the Southern Trunk Railway-line; by Allot-ments Nos. 2, 3, 4, 5, Block X, and 6 of Reserve No. 2645, Block XI, Geraldine Survey District, to the Orari River; and by that river to the ocean. This district includes the Boroughs of Ashburton and Geraldine, and Town Dis-tricts of Tinwald and Hampstead.

### TIMARU.

TIMARU. Timaru District comprises that portion of the Seadown Riding of Levels County lying to the south of the road forming the southern boundaries of Rural Sections Nos. 19856, 12846, 12167, 3963, 3903, 23225, 14574, 21370, 20966, 20817, and 22161 to Levels Plains, Middle Road, and to the west of that road; and that part of the Waimataiti Riding lying south of the road forming the northern boundaries of Rural Sections Nos. 5476, 13965, 14834, 14197, 14305, and 11195, the road forming the north-eastern boundaries of Sections Nos. 7 and 6 of Papaka Settlement, Reserve 3533, and Rural Sections Nos. 13782, 13781, 14665, and that road continued to the western boundary of the said Waimataiti Riding; also that por-tion of the Claremont Riding lying to the east of Brockley Road. This district also includes the Gleniti and Otipua Ridings of the said Levels County, and the Borough of Timaru. Timaru.

### GERALDINE.

GERALDINE. Geraldine District comprises the whole of Mackenzie County; the Tengawai and Point Ridings of Levels County; that portion of Claremont Riding included in the existing Geraldine Electorate; and those parts of Wai-mataiti and Seadown Ridings not included in the Timaru District hereinbefore described; together with those parts of Hakataramea and North Waihao Ridings of Waimate County included in the existing Geraldine Electorate, the whole of the Upper Pareora, Lower Pareora, Otaio, and Makikhi Ridings of Waimate County, and that part of Deep Creek Riding lying to the north of the Waihao Forks Railway line, and that portion of Geraldine County not included in the Ashburton Electorate.

### WAITAKI.

WAITAKI. Waitaki District comprises those portions of Hakata-ramea and North Waihao Ridings of Waimate County included in the existing Waitaki Electorate; that portion of Deep Creek Riding lying to the south-east of the Wai-hao Forks Railway line and east of the Main Trunk Rail-way line; together with the Borough of Waimate, the Ahuriri, Otekaike, Awamoko, Papakaio, Waiareka, and Incholme Ridings of Waitaki County, that portion of Kakanui Riding lying to the west of the Main Trunk Railway line, and that portion of Otepopo Riding lying to the west of the Hampden-Maheno main road : ex-cluding the Towns of Herbert and Maheno.

### OAMARU.

OAMARU. Oamaru District comprises the Borough of Oamaru; that portion of Kakanui Riding of Waitaki County lying east of the Main Trunk Railway line; that portion of Otepopo Riding lying to the east of the main South Road, including the whole of the Towns of Maheno and Herbert; the whole of Moeraki Riding of the said Waikaki County; and the Borough of Hampden; together with Waihemo County, the Borough of Palmerston, the Hawksbury and Merton Ridings of Waikouaiti County, the whole of Blueskin Riding except that portion lying to the east of a line along the road forming the eastern bound-aries of Sections Nos. 1, 2, 3, 10, 13, 15, 17, 18, 19, 51, 53, 56, 57, and 66, Block I, North Harbour and Blueskin Survey District, intersecting Section No. 1, Block VI, forming the eastern boundary of Sections Nos. 90 and 72, Block VII, and along the eastern boundary of Section No. 73, Block VII aforesaid. This district also includes the Borough of Waikouaiti.

### OTAGO CENTRAL.

OTAGO CENTRAL. Otago Central District comprises Maniototo County and the Borough of Naseby; Strath Taieri, Maungatua and Outram Ridings of Taieri County; and the whole of Deep Stream Riding except that portion lying east of Silverstream; Matakanui and Manuherikia Ridings of Vincent County; the whole of Dunstan Riding except the Town of Clyde; together with the Borough of Alex-andra and the eastern portion of Earnscleugh Riding lying east of the eastern watersheds of the Fraser River and Omeo Creek, and the extension of the track along the said watersheds to the eastern boundary of Section No. 2, Block III, Fraser Survey District, and lying south of Sec-tions Nos. 2 and 1, said Block III, and Sections Nos. 2, **3, and 4**, Block I, Fraser Survey District. This district also includes Teviot, Benger, and Crookston Ridings of

Tuapeka County, that portion of Tapanui Riding in the existing Tuapeka Electorate, that portion of Gabriel's Riding west of the Beaumont River, and that portion of Beaumont Riding lying north of Blocks I, XVI, and XIV, Crookston Survey District; together with the Glenkenich Riding of Clutha County, and the Borough of Roxburgh.

### DUNEDIN NORTH.

DUNEDIN NORTH. Dunedin North District comprises the Borough of Maori Hill and that part of the City of Dunedin lying north of a line along Argyle Street to Elder Street, along Elder Street to Pitt Street, along Pitt Street to Frederick Street, along Frederick Street to King Street, along King Street to Albany Street, along Albany Street to the railway-line, along the railway-line southwards to the southern bound-ary of the existing Dunedin North Electorate, and along that boundary to Otago Harbour.

### DUNEDIN WEST

Dunedin West District comprises the Borough of Roslyn Dunedin West District comprises the Borough of Roslyn and that portion of the City of Dunedin bounded towards the north by Dunedin North District hereinbefore de-scribed; towards the east by Otago Harbour to a point in line with the middle of Stuart Street; thence towards the south generally by a right line to and along the middle of Stuart Street to High Street, and by High Street to Dowling Street, by Dowling Street to Canongate Street, by Canongate Street to Duncan Street, by Duncan Street to York Place, and by York Place to a point in line with the southern boundary of the Borough of Roslyn, and by a right line to the Borough of Roslyn.

### DUNEDIN CENTRAL.

This district comprises the Boroughs of Green Island and Mornington, and that portion of Dunedin City bounded towards the north by the Dunedin West Electoral District towards the north by the Dunedin West Electoral District hereinbefore déscribed; towards the south-east by the Otago Harbour to a point in line with the middle of Park Street; thence towards the south by a right line to and along the middle of Park Street to the railway-line; thence by the railway-line to Ferguson Street; by Fer-guson Street to Caversham Valley Road; by Caversham Valley Road to the Green Island Borough boundary.

### DUNEDIN SOUTH.

DUNEDIN SOUTH. This district is bounded towards the north generally by the main South Road from a point where it crosses the Kaikorai River to the Green Island Borough; thence by the Dunedin Central Electoral District, hereinbefore described, to the Otago Harbour; thence towards the east by the Otago Harbour and the City of Dunedin boundary to the Borough of St. Kilda; thence by the eastern and southern boundaries of the last-named borough to the ocean; thence towards the south by the ocean to a point in line with the road forming the north-western boundary of Section No. 155, Green Island Bush Survey District; thence by a right line to the middle of the last-mentioned road, and by that road to a point in line with the south-western corner of the last-mentioned section, and by the south-western boundary-line of the said Section No. 125 to the south-eastern corner of Section No. 120; again towards the south generally by the south-eastern boundaries of the last-mentioned sections Nos. 121, 122, and 123 to the south-western corner of the last-mentioned section; by the south-western boundary of the said Sec-tion No. 123 and Section No. 124 to the road forming the north western boundary of the last-mentioned section; across that road; again towards the south-east generally by the road forming the south-eastern boundaries of Section No. 64; by the south-western boundary-line of Section No. 124 to the road forming the south south road; again towards the south-east generally by the road forming the south-eastern boundary-line of Section No. 64; by the south-western boundary-line of Section Section No. 64; by the south-western boundary-line of Section No. 64; by the south-western boundary-line of Section No. 84; by the south-western boundary-line of by the road forming the south-eastern boundaries of Sec-tions Nos. 74, 36, and 43 to the south-western corner of Section No. 64; by the south-western boundary-line of the last-mentioned section to the road forming the north-eastern boundary of Section No. 55; thence towards the south-east by the last-mentioned road to the Kaikorai River, and by the said Kaikorai River to the place of commencement commencement

### CHALMERS.

Chalmers District is bounded towards the south-west by the Taieri River to the Otago Central Electoral District, hereinbefore described; towards the north generally by the last-mentioned electoral district and the Oamaru Elec-toral District, hereinbefore described, to the ocean; to-wards the east and south generally by the ocean to the said Taieri River, the place of commencement : excluding the Dunedin North, Dunedin West, Dunedin Central, and Dunedin South Electoral Districts, hereinbefore described.

### BRITCE

Bruce District comprises the Waipori, Waitahuna, and also includes Teviot, Benger, and Crookston Ridings of Brown's Ridings of the Tuapeka County, also those portions of Gabriel's and Beaumont Ridings not included in the Otago Central Electoral District hereinbefore de-scribed; the County of Bruce, and the Clydevale Riding of the Clutha County. The Boroughs of Lawrence, Milton, and Kaitangata are included in this district.

### CLUTHA.

ULUTHA. Clutha District comprises the Clutha County, less the Glenkenich Riding included in the Otago Central Elec-toral District hereinbefore described, and the Clyde-vale Riding included in the Bruce Electoral District hereinbefore described; also that portion of the South-land County included in the existing Clutha Electoral District. This district also includes the Borough of Bal-District. This district also includes the Borough of Bal-District. This district also includes the Borough of Bal-clutha and Tapanui, and that portion of Tapanui Riding included in the existing Clutha Electorate.

### WAKATIPU.

WAKATIPU. Wakatipu District comprises the Lake County, and that portion of Vincent County not included in the Otago Central District hereinbefore described; the Waikaia Riding of Southland County; that portion of Oreti Riding included in the existing Wakatipu Electoral District; and that portion of the Mataura Riding lying north of the road forming the southern boundaries of Sections Nos. 2, 3, and 4, Block VIII, Chatton Survey District, and Sections Nos. 1, 3, 4, and 5, Block III, and lying west of the road forming the western boundaries of Sections Nos. 29, 18, 16, 14, 12, 10, 8, 6, 4, 2, and 1, Block I, of the said Chatton Survey District, and Sections Nos. 12, 11, 18, 10, and 9, Block I, of the said Waikaka Survey District; and that portion of the Hokonui Riding lying north of the Waimum Hundred and the road intersecting Section No. 493, Hokonui Survey District, and forming the northern boundaries of Sections Nos. 492, 491, 490, 489, 488, 282, 122, 456, and intersecting Sections Nos. 135 and 306 of the said Hokonui Survey District; and those portions of Winton Riding included in the existing Waka-tipu and Mataura Electoral Districts. This district also includes the Boroughs of Queenstown and Arrowtown.

### MATAURA.

Mataura District comprises the existing Mataura Elec-Matabra District comprises the existing matabra inte-toral District, excluding those portions of Mataura, Hokonui, and Winton Ridings included in the Wakatipu District hereinbefore described, and also excluding that portion of Winton Riding lying east of the Makarewa River.

### INVERCARGILL.

Invercargill District comprises the existing Invercargill Electoral District, and that portion of the Waihopai Sub-division of the Invercargill Road District lying west of Mill Road, together with Section No. 3, Block I, Inver-cargill Hundred.

#### AWARUA.

AWARUA. Awarua District comprises the existing Awarua Elec-toral District, together with that portion of the Winton Riding of Southland County bounded towards the west by the Invercargill-Kingston Railway line from Limehills to Section No. 181, Hokonui Survey District; thence to-wards the north by the road forming the northern bound-aries of Sections Nos. 180 and 162, and intersecting Sections Nos. 341, 363, 432, 709, and 659, to the northern-most corner of the last-mentioned section; thence by Sec-tions Nos. 430, 788, and 366 to the Otapiri Stream, by that stream to the road intersecting Section No. 215; thence by that road and the road forming the northern boundary of Section No. 257 to Laura Stream; thence towards the east by Laura Stream, and towards the south by Forest Hill and Winton Hundreds and the Township of Limehills. This district also includes that portion of Winton Riding lying east of the Makarewa Stream : excluding that part of Waihopai Subdivision of the Invercargill Road District included in Invercargill Elec-torate, and Section No. 3, Block I, Invercargill Hundred.

### WALLACE.

Wallace District comprises the Counties of Fiord and Wallace, the Borough of Riverton, and that portion of Winton Riding of Southland County not included in the Awarua, Mataura, and Wakatipu Districts hereinbefore described. This district also includes Centre Island.
