Union of Boroughs of City of Auckland and Parnell.

LIVERPOOL, Governor. A PROCLAMATION.

HEREAS the respective Councils of the City of Auckland and of the Borough of Parnell, by petitions under the respective common seals of the Corporations of such city and borough, as provided by the Municipal Corporations Act, 1908, have prayed the Governor that such city and borough (forming one continuous area) be constituted one united because. united borough:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance of the powers vested in me by the said Municipal Corporations Act, 1908, do hereby proclaim that the said City of Auckland and the said Borough of Parnell are hereby constituted one united borough, and also that the said borough so constituted is a city by the name of the City of Auckland, and also that the boundaries of the said city so constituted and named shall be those set forth in the Schedule hereto:

And I do also proclaim and declare that the said borough
shall be an undivided borough, and that the number of
Councillors to be elected to the Council thereof shall be
fifteen, exclusive of the Mayor:
And I do hereby appoint, Henry William Wilson (the Town
Clerk to the existing City of Auckland) to be the Town Clerk,
and George Robert Hogan, Returning Officer, temporarily of
the said united borough: the said united borough:

And I do also proclaim and declare that this Proclamation shall take effect on and from the fifteenth day of February, one thousand nine hundred and thirteen.

## SCHEDULE.

BOUNDARIES OF THE CITY OF AUCKLAND.

ALL that area in the Auckland Land District bounded towards the west and north generally by high-water mark of Waitemata Harbour in the year 1886 from Cox's Greek to a point on the north-eastern boundary of Allotment No. 15 of Section No. 8, Suburbs of Auckland, as defined in the Schedule of the Proclamation extending the boundaries of the City of Auckland in the New Zealand Gazette No. 85, of the

27th October, 1904; thence by right lines 2930, 2274, 3000, 3092, 945, 182, 163, 196, 410, 563, 364, 155, 76, 316, 76, 1490, 758, 184, 577, 241, 802, 913, 1168, 1064, and 1767 links respectively, and thence by the high-water mark of the said Waitemata Harbour to Resolution Point; thence towards the east by the shore of Hobson Bay, in Waitemata Harbour, to the widdle of Slaughterhouse Creek: thence towards the south middle of Slaughterhouse Creek; thence towards the south and south-west generally by the southern and south-western boundaries of the Borough of Parnell as it existed at the time when described in the New Zealand Gazette No. 35, of the 19th April, 1877, page 415, to the southern corner of Section No. 11, City of Auckland, and thence by the southwest boundary of that section to Stapley Street: thence again Section No. 11, City of Auckland, and thence by the southwest boundary of that section to Stanley Street; thence again towards the east generally by the east side of said Stanley Street, by the Government Domain, and by the Hospital Reserve to the road known as Park Road; thence by the northern side of the said road to a point in line with the eastern boundary-line of Allotment No. 22 of Section No. 3, Suburbs of Auckland, now the middle of Park Avenue; thence by a right line to and by the said boundary-line, and by its production to the south side of Carlton Gore Road; thence by the south side of that road to the western boundary-line of subdivisional Lot No. 37 of Original Allotment No. 4 of Section No. 3, Suburbs of Auckland; thence by the said Lot No. 37 and Lots Nos. 55, 56, 65, 66, 75, 76, 85, 86, 95, 96, 105, 106, 115, 116, and 13 of Allotment 4 aforesaid, and by the production of the western boundary-line of the lastmentioned lot to the southern side of Kyber Pass Road; thence by the southern side of that road to the eastern side of Boston Road; thence towards the south-east and south thence by the southern side of that road to the eastern side of Boston Road; thence towards the south-east and south generally by the south-eastern side of the said Boston Road to its junction with Mount Eden Road; thence by the western side of Mount Eden Road to Symonds Street; thence by a right line across Symonds Street to and by the north side of Basque Road to Allotment No. 1 of Section No. 5, Suburbs of Auckland; thence by Allotment No. 1 aforesaid and Allotment No. 2 and 4 of Section No. 5 aforesaid and Allotment of Auckland; thence by Allotment No. I aforesaid and Alotments Nos. 3 and 4 of Section No. 5 aforesaid, and Allotment No. 13 of Section No. 7, Suburbs of Auckland, to the Great North Road; thence by the eastern side of that road to its junction with Ponsonby Road; thence across the Great North Road and by the southern side of Ponsonby Road to Richmond Road; thence by the southern side of Richmond Road to Cox's Creek; and thence by Cox's Creek to the

Waitemata Harbour, the place of commencement: as the same is delineated on the plans in the District Survey Office at Auckland.

Copy of the Declaration of Union signed in the Town Hall, Wellington, on the 6th Day of February, 1913, between the Methodist Church of New Zealand and the Primitive Methodist Connexion in New Zealand.

HEREAS at the Annual Conference of the Methodist Church of New Zealand held in the City of Wellington, in the Dominion of New Zealand, this sixth day of February, one thousand nine hundred and thirteen, it has been resolved and agreed that the Methodist Church of New Zealand unite with the Primitive Methodist Connexion (commonly known as the Primitive Methodist Church) in New Zealand known as the Primitive Methodist Church) in New Zealand upon the terms and conditions set forth and embodied in and incorporated with the Basis of Union prepared by a Joint and incorporated with the Basis of Union prepared by a Joint Committee representing the said Churches, and approved by the Annual Conferences and circuit quarterly meetings thereof, and by the members of the said Primitive Methodist Connexion in New Zealand, and duly consented to by the British Conference of the Primitive Methodist Connexion, a printed copy whereof is attached hereto, and also published in the printed minutes of the Annual Conference of the Methodist Church of Australasia in New Zealand held in the City of Auckland, in the said Dominion, in the months of February and March, one thousand nine hundred and twelve: And whereas at the Annual Conference of the Primitive Methodist Connexion in New Zealand also held in the City of Wellington aforesaid this sixth day of February, one thousand nine hundred and thirteen, it has also been resolved and agreed that the Primitive Methodist Connexion in New Zealand unite with the Methodist Church of New Zealand upon the terms and the Methodist Church of New Zealand upon the terms and conditions set forth and embodied in and incorporated with the said Basis of Union: And whereas it has been agreed by and between the said Churches that such union as aforesaid shall take effect on and from the said sixth day of February, one thousand nine hundred and thirteen: And whereas it is advisable that these presents should be executed for the purpose of evidencing the fact of such union as afore-

said:

Now, therefore, it is hereby agreed and declared that the Methodist Church of New Zealand and the Primitive Methodist Connexion in New Zealand shall enter into an organic union as one Church, under the name of "The Methodist Church of New Zealand," with common laws, common funds, and equal rights, upon the terms and conditions set forth and embodied in and incorporated with the Basis of Union aforesaid; and, further, that the said union shall take effect on and from the said sixth day of February, one thousand nine hundred and thirteen.

IN THE SUPREME COURT OF NEW ZEALAND. WELLINGTON DISTRICT.

I, DANIEL GEORGE ARTHUR COOPER, of the City of Wellington, in the Dominion of New Zealand, Registrar at Wellington of the Supreme Court of New Zealand, hereby certify that on this seventeenth day of February, one thousand certify that on this seventeenth day of February, one thousand nine hundred and thirteen, a declaration in writing made by Charles Manley Luke, of the City of Wellington, in the Dominion of New Zealand, gentleman, President of the Conference of the Primitive Methodist Connexion in New Zealand, and Thomas Moor, of the City of Auckland, in the said Dominion, builder, Secretary of the said Conference, was filed in the office of the Registrar at Wellington of the Supreme Court of New Zealand, and that the following is a true copy of such declaration: of such declaration :-

In the matter of the Methodist Church of New Zealand Act, 1911, and the various Acts incorporated therewith.

"WE, Charles Manley Luke, of the City of Wellington, in the Dominion of New Zealand, gentleman, President of the Con-ference of the Primitive Methodist Connexion in New Zealand, and Thomas Moor, of the City of Auckland, in the said Dominion, builder, Secretary of the said Conference, hereby

jointly and severally declare:

"1. That at the Conference of the Primitive Methodist Connexion in New Zealand held at Wellington, in the said Dominion, on the sixth day of February, one thousand nine hundred and thirteen, the following resolution was passed,

"A basis having been prepared for the union of the Methodist Church of New Zealand (formerly, designated the Methodist Church of Australasia in New Zealand) with the Primitive Methodist Connexion (commonly known as the Primitive Methodist Church) in New Zealand by a Joint Committee representing such Churches and approved by the Annual Conferences and circuit quarterly meetings thereof, and the members of the said Primitive Methodist Connexion in New Zealand and the British Conference of the Primitive Methodist Connexion having given its consent to such union. "2. That seventy-five (75) members were entitled to be

resent at the said conference, of whom seventy-two (72) were present at the time the said resolution was passed, all of whom voted in favour thereof."

"And we make this solemn declaration conscientiously believing the same to be true, and by virtue of an Act of the General Assembly of New Zealand intituled the Justices of the Peace Act, 1908.
