#### EASTBOURNE BOROUGH COUNCIL.

RESOLUTION MAKING SPECIAL RATE.

L meeting of the Council held on 1st September, 1913 :--"That, in pursuance and exercise of the powers vested in it in that behalf by the Municipal Corporations Act, 1908, and the Local Bodies' Loans Act, 1908, and their amending Acts, the Eastbourne Borough Council hereby resolves that, for the purpose of providing security for principal and interest of the No. 3 Loan of £15,000, authorized to be raised under the chargementioned Acts for the purpose of purchasing the the above-mentioned Acts, for the purpose of purchasing the ferry steamers "Duchess" and "Cobar," and for establish-ing a municipal ferry service, a rate of  $2\frac{1}{2}d$ . in the pound on the unimproved value of all rateable property in the Borough of Eastbourne is hereby made as an annual-recurring rate for a period of twenty-one years, or during the currency of the loan; and such special rate shall be payable half-yearly on the 1st day of March and 1st day of September in each and every year during the currency of such loan."
