VANCOUVER ISLAND.—VICTORIA HARBOUR.—SHOAL POINT LIGHT TO BE MOVED.—On 1st November, 1913, the light-beacon maintained off Shoal Point, Victoria Harbour, British Columbia, will be moved, without further notice, 300 ft. 245° and re-established about 300 ft. from the shore to mark the edge of the shoal making off from Shoal Point.

The fog-alarm building is a white, square, wooden building with a gable roof, standing in front of the lighthouse. The horn is elevated 100 ft. above high water and points 329°.

A white, rectangular, wooden, double dwelling, with a hip roof, stands 400 ft. eastward of the lighthouse.

EAST COAST.—DURIAN STRAIT.—PELANGKAT ISLAND.—INTENDED LIGHT.—The Netherlands Government has given notice that a *flashing white* light, visible 10 miles, will be established on the reef on the southern side of Pelangkat Island, Durian Strait, east coast of Sumatra.

TONGA ISLANDS.—NIUAFU (GOOD HOPE) ISLAND REPORTED DISAPPEARED.—Capt. J. H. Trask, of the steamer "Sonoma," reports under date of 12th September, 1913, having been informed by Captain Allen, of the schooner "Dawn," that Niuafo (Good Hope) Island, Tonga Islands, South Pacific Ocean, had disappeared.

Approx. position: Lat. 15° 35' S., long. 175° 42' W.

NOTE.—Just prior to the discovery that Niuafo (Good Hope) Island and Falcon Island had disappeared, the instruments at the Sydney Naval Station indicated that several violent earthquake shocks had occurred about 2,000 miles north-eastward.

There seems to be some doubt as to whether the island which has disappeared is the one above referred to or Honga Hapai Island, just southward of Falcon Island. Further information will be published when received.

NORTH PACIFIC OCEAN.

CAROLINE ISLANDS.—NGARUANGL REEF.—CORRECTED POSITION.—The master of the steamship "Sumatra" reports that Ngaruangel Reef, Caroline Islands, North Pacific Ocean, is located about 7 miles eastward of its charted position in (approximately) latitude $8^{\circ} 11' N.$, longitude $134^{\circ} 37' E.$

An extensive sandbank was observed on the southern side and four large rocks on the northern side of the reef.

Subsidies to Public Libraries.

NOTICE is hereby given that the sum of £4,000 has been voted by Parliament for distribution to public libraries.

The distribution will take place on the 9th February, 1914, and no claim will be entitled to consideration that shall not have been sent in due form and received by the Secretary for Education, Wellington, on or before the 26th January, 1914.

1. A library to be entitled to a subsidy must be public in the sense of belonging to the public, and of not being under the control of an association, society, or club whose membership is composed of a section of the community only, and if within a borough it must be open to the public free of charge. The receipts for the year from subscriptions and donations must not have been less than £2, exclusive of moneys received from endowments, or from Government, or from Borough or County Councils, or for special building purposes, or as rent, hire, or consideration for the use of any room, or building, or land belonging to the institution, in respect of none of which will subsidy be allowed. The net proceeds of concerts, lectures, or other entertainments on behalf of the current expenses of the library will be regarded as voluntary contributions. A subsidy will not be given to more than one library in the same town.

2. In the division of the vote a nominal addition of £25 will be made to the amount of the income of each library derived from subscriptions, donations, and rates, and the vote will be divided according to the amounts thus

augmented; but no library will receive credit for a larger income than £75—that is, in no case will the augmented amount on which distribution is based exceed £100.

3. The whole of the subsidy must be expended without delay in the purchase of books for the library.

4. It is particularly enjoined upon the authorities in charge of the public libraries concerned that a due proportion of the books purchased shall be books having a permanent value; that is on books of more than merely passing interest.

5. Application to share in the distribution must be by means of a statutory declaration by the Chairman, or Secretary, or Treasurer of the institution on behalf of which it is made, and must be accompanied by a statement of the receipts and expenditure of the institution for the year ending on the 31st day of December, 1913; and such declaration must be on the form provided for the purpose, which form shall be as follows:—

DECLARATION.

I, [Name], of [Place of abode], [Occupation], do solemnly and sincerely declare that I am Chairman [or Secretary, or Treasurer] of the [Name of institution]; that during the year ending on the 31st day of December, 1913, the receipts of the aforesaid institution for the maintenance of the library only were as follows: From rates levied by a local governing body under Part I of the Libraries and Mechanics' Institutes Act, 1908, or the Municipal Corporations Act, 1908, pounds shillings and pence; from the subscriptions of members, pounds shillings and pence; and from voluntary contributions other than members' subscriptions, pounds shillings and pence; that the library is public in the sense of belonging to the public, and is not under the control of an association, society, or club whose membership is composed of a section of the community only; that the information hereinafter furnished by me in the appendix hereto is correct in every particular; that the abstract of accounts is a true statement of the receipts and expenditure of the institution for the year herein specified; that the whole of the subsidy received during the year was expended in the purchase of books for the library; [and that by the rules of the library it is open to the public free of charge].

And I make this solemn declaration conscientiously believing the same to be true, and by virtue of the Justices of the Peace Act, 1908.

FOR Deaf Children of sound intellect. The pupils are taught to understand and use ordinary speech. The full charge for board and education is £40 a year, but less is accepted from parents who cannot afford to pay this amount. In case of necessity admission is free.

By the Education Act it is compulsory for deaf children to come under instruction at the age of six, and to continue until the age of twenty-one unless the Education Department previously grants exemption. Though a child is, as a rule, best fitted to begin the school course at the age of six, advice should be obtained as soon as any sign of deafness is observed.

The following classes of deaf children are admitted to the School for the Deaf (sound intellect being always a necessity):—

1. Children born deaf, or who have lost their hearing before learning to speak.
2. Children who can hear a little, but are too deaf to be taught in a public school.
3. Children who have lost their hearing after having learned to speak.

The Act imposes upon every parent, teacher of a school (either public or private), constable, or officer of a charitable or kindred institution who is aware of the place of residence (either temporary or permanent) of a deaf child, and the householder in whose house any such child resides, an obligation to send notification of the fact to the Minister of Education, giving the name, age, and address of the child; and any neglect or failure to comply with this provision involves liability to a fine.
