A PROCLAMATION.

WHEREAS it is enacted by the Town Boards Act, 1908, that the Governor may declare that any locality outside a borough wherein there are not less than fifty householders shall be a town district:

And whereas a petition has been presented to the Governor by the inhabitants within the area mentioned and described in the Schedule hereto, praying that such area may be constituted a town district under the Town Boards Act, 1908:

Now, therefore, I, Arthur William de Brito Savile, Earl of Liverpool, the Governor of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in me by the Town Boards Act, 1908, and of all other powers enabling me in this behalf, do hereby proclaim and declare that the said area shall be a town district, and the same is hereby constituted a town district, under the Town Boards Act, 1908, by the name of the Waiuku Town District: And, in further pursuance and exercise of the said powers, I do hereby proclaim, declare, and appoint that the Board of Commissioners for the said district shall consist of five members.

SCHEDULE.

WAIUKU TOWN DISTRICT.

ALL that area in the Auckland Land District bounded by a line commencing at the easternmost corner of Allotment No. 159, Waiuku East Parish; thence along the south-eastern boundary of that allotment for a distance of 800 links; thence along a right line to a point on the north-western side of the road forming the south-eastern boundary of Allotment No. 47, distant 775 links from the southernmost corner of that allotment; thence along a right line to the westernmost corner of Allotment No. 39, Waiuku East Parish; thence along the south-western boundary of that allotment to a point distant 900 links from the road forming the north-western boundary of Allotment No. 43; thence along lines parallel to and 900 links distant from the north-western boundaries at Allotments Nos. 43, 42, and 41 to the

south-western boundary of the last-mentioned allotment; thence along that boundary, the western boundary of Allotment No. 40, and the road forming the south-western boundary of Allotment No. 9 to the westernmost corner of that allotment; thence along a right line to the north-eastern corner of Allotment No. 11, Waiuku East Parish; thence along the northern boundary of that allotment, and that boundary produced across a public road, and along the western side of that road to the south-eastern corner of Lot 3 of Allotment No. 155, Waiuku West Parish, and along the southern and western boundaries of that lot and the production of its northern boundary westward for a distance of 14 chains; thence along a right line to the easternmost corner of Lot 4 of Allotment No. 313, Waipipi Parish; thence along the north-eastern boundary of the said Lot 4 for a distance of 7 chains; thence along a line parallel to the road forming the south-eastern boundary of Lot 3 of Allotment No. 313 aforesaid for a distance of 13 chains; thence by a right line to a point in line with the south-eastern side of Sandspit Wharf Road, and distant 10 chains from the southern side of the road forming the northern boundary of Lot 3 aforesaid; thence along a right line to the south-eastern side of the said Sandspit Wharf Road, and along the south-eastern side of that road for a distance of 17 chains; thence along a right line at right angles to the said Sandspit Wharf Road to high-water mark of Waiuku River; and thence along the high-water mark of that river to the easternmost corner of Allotment No. 159, Waiuku East Parish, the place of commencement.

The number of articles for delivery by one messenger must not exceed ten. Rules made by the Court of Arbitration under Section 104 of the Industrial Conciliation and Arbitration Act, 1908, in respect of Applications for Interpretation of Awards, &c.

RULES for the guidance of Clerks of Awards, Inspectors of Awards, and parties to awards and industrial agreements, in respect of applications for interpretation of awards and industrial agreements, have been made from time to time. The first rules on the subject are dated the 16th day of November, 1903.

In view of the Court's settled practice with regard to such applications, it is thought desirable to amend and consolidate the rules on the subject.

RULES.

MATTERS WHICH MAY BE THE SUBJECT OF AN APPLICATION.

1. AN Inspector of Awards, or any industrial union or association of workers or of employers, or any person, firm, or company who is a party to an award or industrial agreement, may, upon application being made to the Clerk of Awards in manner hereinafter provided, obtain the opinion of the Court upon any question connected with the construction of such award or industrial agreement, or upon any particular determination or direction of the Court, or upon the construction of any statute relating to matters within the jurisdiction of the Court, subject to the following conditions:—

- (a.) The Court will not consider any such application if any of the facts are in dispute.
- (b.) The Court will not consider any such application when the same is based upon a hypothetical case or set of facts.
- (c.) The Court will, without considering itself obliged to give reasons, decline to give such advice or opinion where, in the opinion of the Court, it is inadvisable to do so.
- (d.) Parties who are unwilling to seek or concur in seeking an opinion under these rules may resort to a test case in the ordinary way.
- (e.) The Court may refuse to consider itself bound by any opinion so given, even in the matter so submitted, if the Court is satisfied that it has not been fully informed, or that the matter affects parties other than those immediately interested, or where the asking for and obtaining of such opinion has a tendency to defeat or avoid penalties which ought not to be avoided, or to protect parties from the consequences of wilful breaches.

PROCEDURE.

2. An Inspector of Awards desiring to obtain an interpretation of an award or industrial agreement shall file with the Clerk of Awards for the industrial district in which the award or industrial agreement in question has been filed four (4) copies of the application for interpretation, which shall be in the form prescribed in the Schedule hereto (Form I.C.—G 2), and shall be headed "Inspector's Application for Interpretation." To each such copy the Inspector shall attach a typewritten copy of the views and contentions (if any) of the parties concerned, and also a typewritten copy of his own views and contentions (if any). The Clerk of Awards shall thereupon immediately forward to the Court three (3) copies of such application, and shall file the remaining copy. No filing fee shall be payable in respect of any such application by an Inspector of Awards.

3. Parties to an award or industrial agreement, as the case may be, who desire to obtain an interpretation thereof shall file four (4) copies of their application in the manner prescribed by Rule 2 hereof, and the party filing the same shall pay to the Clerk of Awards a filing fee of 3s. in respect of each application so filed. Such application shall be in the form prescribed in the Schedule hereto (Form I.C.—G 3), and shall be headed "Application by Parties for Interpretation." The Clerk of Awards shall thereupon immediately forward to the Court three copies of such application.

4. An application for interpretation may be initiated by any party to an award or industrial agreement, but it is necessary

that the opposite party disputing the particular point in question should concur in and sign such application before an application can be made under the preceding rule.

5. In the event of such opposite party refusing or neglecting to concur in and sign such application, or of the failure of the parties to agree as to the nature of the question to be set out in the application, the applicant shall forward to the nearest Inspector of Awards four (4) typewritten copies of his views and contentions, and it shall be the duty of the Inspector to frame an application and to forward four (4) copies of the same to the Clerk of Awards. Such application shall be accompanied by copies of the views and contentions (if any) of both parties, and a copy of his own views and contentions (if any), and shall be in the form prescribed in the Schedule hereto (Form I.C.—G 4).

6. If either or all of the parties to an application or affected by the same shall desire that the Court should hear evidence or argument of counsel on the subject, they shall intimate such desire to the Clerk of Awards by memorandum in writing, and, subject to the direction of the Court, the Clerk of Awards shall file the four copies of the application, and set the matter down for hearing upon the list of business for the next sitting of the Court.

7. Should the Court, upon perusal of an application filed under these rules, decide that it requires to hear evidence or argument of counsel on the subject, it shall return the three copies of the application to the Clerk of Awards and direct him accordingly, and he shall file the three copies of the application, and set the matter down for hearing upon the list of business for the next sitting of the Court. He shall also immediately notify the parties of such direction of the Court.

GENERAL.

8. The Court considers that in every case where the facts are clear, and there is no ground for seeking to enforce a penalty, the Inspectors of Awards should carefully consider whether the matter can reasonably be treated as a case for interpretation, but the Court does not desire to interfere with the discretionary powers of Inspectors in such matters.

PUBLIC TRAFFIC REGULATIONS.

1. THE Officer Commanding the Coast Defences directs that the following regulations be adhered to by the masters of all vessels entering or leaving the Ports of Auckland, Wellington, Lyttelton, and Otago from this date until such time as may be notified.

ENTRANCE TO THE PORT.

Time of Arrival of Vessels.

2. SHIPOWNERS and shipping agents are advised to time the arrival of vessels so that they may arrive off the examination anchorage between sunrise and sunset. By so doing they will facilitate the entry of their vessels into port.

Notification of Time of Arrival.

3. Shipowners and shipping agents will notify the Chief Examining Officer, the Harbourmaster, in advance, the probable time of arrival and description of their vessels, in order to facilitate recognition by the Examining Officer.

Examination Steamer and Signals indicating whether Port is open or closed.

4. All vessels desirous of entering the port, with the exception of H.M. ships, fleet auxiliaries, and army transports,

will proceed to the examination anchorage. Here they will be met by the examination steamer. This steamer may be recognized as follows:—

By Day.—A blue ensign, and at the foremast head the special pilot flag (white and red horizontal) surrounded by a blue border. When the port is closed, three red balls vertically in addition.

By Night.—Three lights vertically, 6 ft. apart, conspicuously displayed at the end of a yard so as to show an unbroken light round the horizon. When the port is closed these lights will be red; when it is open they will be white. In addition to the signals on the examination steamer, when the port is closed, similar signals will be shown at the signal-stations on Mount Victoria, Auckland; Beacon Hill, Wellington; Toloa (Adderley) Head, Lyttelton; and Taiaroa Head, Dunedin.

Examination Anchorages.

5. The examination anchorage is shown at the harbour-entrances of the above-named ports on the Admiralty Chart. While at this anchorage vessels will not communicate with the shore, lower any boat, or change their position without the permission of the Examining Officer.

Permission to proceed Inwards from the Examination Anchorage.

6. Vessels will not proceed in harbour from the examination anchorage until they have been boarded by the Examining Officer and given the special signal for the day or night. This signal is to be shown until the vessel is tied up at the wharf or anchored in the port.

Permission to proceed Outwards from the Examination Anchorage.

7. Vessels will not proceed outwards from the examination anchorage without receiving permission to do so from the Examining Officer. This, however, does not apply to those vessels which have been in port and are proceeding to sea with the permission of the detaining authorities (the Chief Customs Officer).

Pilotage.

8. Pilotage between the examination anchorage and the port is compulsory, except for H.M. ships, fleet auxiliaries, and army transports.

Port Dues.

9. Port dues will not be levied on vessels not proceeding inwards from the examination anchorage, provided that they have come there solely to give information regarding friendly or hostile warships and hostile merchantmen, and have made use of the port for no other purpose.

Entry of Tugs, Fishing-boats, &c.

10. Entry of tugs, launches, and fishing-boats unprovided with the means of making special signal: Such vessels will report to the examination steamer, who will signal to the examination battery. When an acknowledgment has been received, permission will be given by the Examining Officer for the above to enter the port.

Control of Movements in Port.

11. All movements within the port will be controlled by the officials of the above-mentioned Harbour Boards.

Warning re approaching H.M. Ships, &c.

12. Vessels or boats are forbidden to approach the following without the permission of the Officer Commanding the Coast Defences: H.M. ships, fleet auxiliaries, and army transports in port, forts and their electric-light stations.

Disregard of this regulation will render the offending vessel or boat liable to be fired on without warning.

Regulation Lights.

13. All crafts are required to show the regulation lights by night.

VESSELS LEAVING PORT.

Permission to leave Port.

13. Permission to leave port must be obtained from the Detaining Officer, the Chief Customs Officer. This permission will take the form of the usual clearance certificate. Any vessel leaving the port without permission is liable to be fired on.

Amendments to Public Traffic Regulations.

15. Amendments to these regulations will be published, and they will be posted on a notice-board in the respective Harbour Board offices. Copies of such amendments will be sent to the shipping companies, offices, and agents.

SCHOOL FOR THE DEAF, NEAR SUMNER, CHRISTCHURCH.

UNDER THE CONTROL AND SUPERVISION OF THE EDUCATION DEPARTMENT.

Director: Mr. J. E. STEVENS.

FOR Deaf Children of sound intellect. The pupils are taught to understand and use ordinary speech. The full charge for board and education is £40 a year, but less is accepted from parents who cannot afford to pay this amount. In case of necessity admission is free.

By the Education Act it is compulsory for deaf children to come under instruction at the age of six, and to continue until the age of twenty-one unless the Education Department previously grants exemption. Though a child is, as a rule, best fitted to begin the school course at the age of six, advice should be obtained as soon as any sign of deafness is observed.

The following classes of deaf children are admitted to the School for the Deaf (sound intellect being always a necessity) :—

1. Children born deaf, or who have lost their hearing before learning to speak.
2. Children who can hear a little, but are too deaf to be taught in a public school.
3. Children who have lost their hearing after having learned to speak.

The Act imposes upon every parent, teacher of a school (either public or private), constable, or officer of a charitable or kindred institution who is aware of the place of residence (either temporary or permanent) of a deaf child, and the householder in whose house any such child resides, an obligation to send notification of the fact to the Minister of Education, giving the name, age, and address of the child; and any neglect or failure to comply with this provision involves liability to a fine.
